Plane Crash in Hardeman County

A single engine fixed prop aircraft crashed as it attempted to land on Highway 18 near Buster Woods Road between Middleburg and Hickory Valley on December 19.

The pilot, Eric Mingleorff, 73, of Cordova, told Hardeman County Sheriff John Doolen and reporting Deputy Wesley Lovelace that he had engine problems and realized he would not be able to make it to the Hardeman County Airport. He then made the decision to attempt to land on Highway 18, but caused damage to the nose, the tail, and wings. The crash was reported and dispatch sent out an alert at 4:35 p.m.

Mingleorff was observed with non-life threatening injuries to his forehead, bridge of the nose, and an injury to his left hand.

The Federal Aviation Administration and the National Transportation Safety Board were notified and will handle the investigation of the incident.

Two Haywood Fugitives Sought and Caught

Two men originally sought to be questioned on a shoplifting charge were the subject of an overnight man-hunt that ended with their capture within thirty-six hours.

On December 28 at approximately 8:00 p.m. Reserve Officer Todd Carter responded to a possible shoplifting at the Dollar General Store in Hornsby. Carter blocked a Black GMC Sierra from exit while waiting on other deputies to make the scene after a license check had the vehicle being connected to an aggravated assault charge in Haywood County.

As Carter received the information over the police radio, two of the men fled on foot. Carter was able to detain the other, identified as Chad R. Johnson, 40, of Stanton. Johnson was found to have an outstanding warrant for failure to appear in Haywood County.

Meanwhile, the other two, Coltin D. Elrod, 18, of Stanton and Damien E. Lee, 23, of Toone went west and north respectively.

A search of the vehicle yielded "multiple bolt cutters and crow bars" as well as keys with multiple re-

motes and keys for several brands of vehicles. There was also mail and checks that did not match the names of those identified in the vehicle.

Further investigation into identification of the suspects had truck's registration in last completed in 2017 to a name that was not among the three suspects and the expiration sticker on the plate for 2020 came back to Mt. Moriah Baptist Church on Mt. Moriah Drive in Whiteville.

Also, according to the report, the ignition on the vehicle was loose and the wiring underneath the dash and steering wheel was pulled out and appeared to have been tampered with.

Hardeman County Deputies caught Elrod on December 30 at 5:00 a.m., near Fire Tower Road and Lee was caught that same morning at 7:00 a.m. on Mitchell Street in Hornsby.

The three are being held in the Hardeman County jail pending a hearing on January 28. Details of charges against the three are in the Hardeman County Arrest Report on A7.

Sharing Her Tree Around the World by Ginger Tester

Memories of many Christmases on the farm as a young girl have inspired Carla Raines Turner to do something special with her Christmas tree this year. She is dedicating it to all men and women of the Armed Forces both at home and abroad. A native of Bolivar, Turner remembers her mother, Opal Mae Raines instilling the traditions of taking cedar and pine, berries and vines, and turning their home into a special place where loved ones came to enjoy the fragrances and flavors of the season out on Silerton Road many years ago. Turner's father Otho Edledge Raines, "a quiet and peaceful man would tell the story of Christmas" with loved ones gathered around.

Turner's father served in WW I in France and Germany. Her brother Jack Raines served as well, but in WW II, and his son Jackie Raines was sent to Vietnam. Turner's son, Chad W Turner, has served more recently in the 90s in the Middle East.

As Turner gazed at her tree, she recalled where each ornament came from. Some from her mother, some from friends and other relatives, and one from her daughter Mara Toleana, who was lost to breast cancer. The ornaments are from various times, but with a special meaning to her. "I felt so special growing up with so many blessings and I wanted to share this with those who serve our country" she said.



Bolivar Seeks to Preserve Historical Building

In 1873, Bolivar African American free men established the United Sons and Daughters of Charity as a local self-help and benevolent organization to assist African Americans. With little or no education, very few skills, and a lack of material possessions these people formed the organization to aid and assist each other. The Charter for the United Sons and Daughters of Charity was approved and signed on January 13, 1873 in the District Chancery Court and held before Honorable H. J. Livingston, Chancellor in Hardeman County, Tennessee in the town of Bolivar. Organization founders were Nathan Bills, Joseph Bright, Abram Miller, William Miller, and James Smith.

They agreed to meet monthly and pay monthly dues to benefit members of their families in the event of sickness or death. These organizers recruited additional members and met house to house, took donations, and pooled the funds to assist people. The initiation fee to join was .50 cents; members were also expected to pay .25 cents for monthly dues. This group was one of several similarly benevolent organizations that was formed in Tennessee during the Reconstruction era. These organizations shared their resources in order to help African Americans.

In 1909 the United Sons and Daughters of Charity organization purchased property on East McNeal Street to expand their services. The property was purchased from Edgar Galloway and wife Sarah E. Galloway of Bolivar, Tennessee for the sum of fifty (50.00) dollars. According to the Bolivar Sanborne Map of 1913 the Hall was located across from the segregated Episcopal Church and next to the Union Cemetery. A tragic fire broke out in the 1920's from Baker Manufacturing Company and spread from the Market Street location, down the hill and all the way to McNeal Street and burned the Hall building. Funds had to be raised to rebuild the facility. The present structure was constructed in 1928 and now stands as a one-story weatherboard frame that rests on a brick pier foundation with a hipped metal roof. The building has the original double, four panel wooden doors, four over four double hung windows, covered with



wooden shutters and original metal latches. This building continued to serve the black community for various community uses. This was the first public building for African-Americans. The neighboring churches were St Paul CME and Springfield Baptist Church. Many churches used the building for social gatherings as they hosted gospel music groups, boxed-suppers and special events. This structure served as a church for ministers who were not pastors of churches. Many congregations that did not have their own building met there for worship service.

Over the years the United Sons and Daughters of Charity continued to flourish and membership dues increased as members increased. Sick benefits were paid in the amount of \$3.00 per week, with death benefits of \$100 and \$20 for grave opening. The organization was well maintained by many locals with over 300 members.

In the 1940's a young musician visited Bolivar in the early part of his career to assist the organization and promote his talent. According to locals B.B. King traveled to many towns to perform in the beginning of his music career. He came to Bolivar and performed at the local McKinnie Café in order to raise money for the Sons and Daughters. He would sometime play in as many as four towns a night. Others that assisted and performed at the McKinnie Café were Muddy Waters and Joe Hill Louis, One-Man Band.

In the 1970's the building served moreover as a Mason hall and industrial labor union meeting facility that served civil and employ-

ment rights for various industries and companies located in Bolivar.

Many church groups joined the organization. The United Sons and Daughters of Charity continued to hold a membership roll until the late 1990's. The members met quarterly and paid benefits to the families of its members in the event of sickness or death. In the years of 1979 through 1986 there were 110 members. On January 13, 1990 the United Sons and Daughters held the 117th anniversary under the long-term presidential direction of Mr. John T. Hudson. At that time there were 158 members. The theme song of this event was "Make New Friends-Keep the Old, one is Silver-the other is Gold. Past presidents of the organization were Stonewall Bills, P.T. Judge Miller, Charlie Miller, Henry C. Polk and James R. Grimes.

The United Sons and Daughters of Charity Lodge Hall building is located on E. McNeal St. and was listed on the National Register of Historic Places on November 9, 2005, for its strong degree of integrity in setting, workmanship, materials and historical significance to the local Black community. The United Sons and Daughters of Charity Lodge Hall is the oldest African American community building still in existence in Bolivar and Hardeman County.

Editor's Note: The City of Bolivar is working on a National Register of Historic Places building that is pertinent to black history for Bolivar and Hardeman County. A Preservation Grant with the TN Historical Commission to preserve this building is being sought.

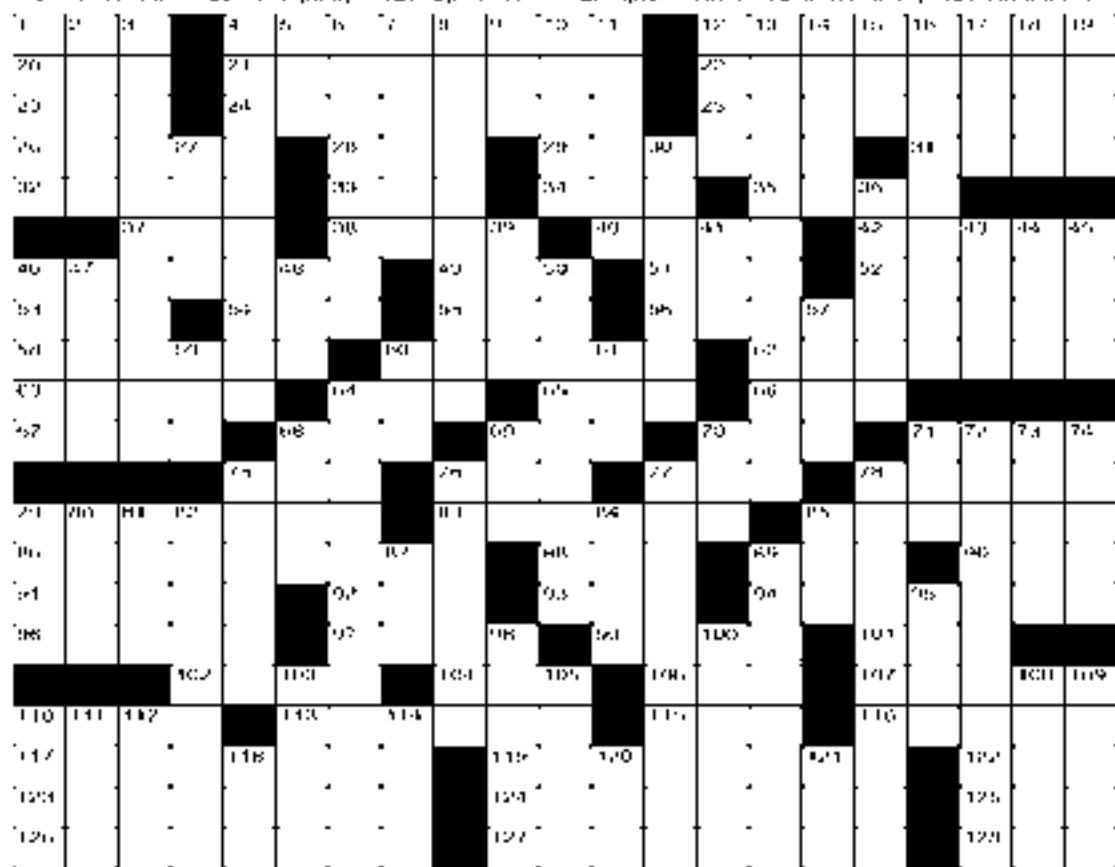

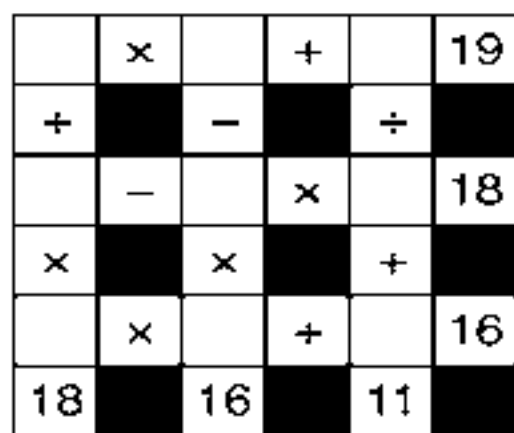

Faith

Advent: Week 4 by Jeff Capshaw

Last week's lesson concerned the person and work of John the Baptist. In spite of a temporary lapse in faith while in prison, John validated Jesus. But Jesus also validated John's ministry. More importantly, however, both Jesus and John claimed each other was the fulfillment of the Old Testament's promises about the Messiah and His Kingdom.

Moreover, Jesus encouraged John's faith by reminding him that Jesus' miracles verified himself as the fulfillment of the Old Testament Messianic promises. Recall that Jesus told John, "the blind receive their sight and the lame walk, lepers are cleansed and the deaf hear, and the dead are raised up, and the poor have good news preached to them" (Matthew 11:5).

The Gospel lesson for this final Advent reflection is from Matthew 1:18-25. Matthew begins, "now the birth of Jesus Christ took place in this way. When his mother Mary had been betrothed to Joseph, before they came together she was found to be with child from the Holy Spirit" (1:18).

Obviously, Jesus was not conceived by ordinary means. According to Scripture, Mary was a virgin. This conception was such an extraordinary event that her fiancé, Joseph, thought she had been unfaithful. Yet, he loved her enough to offer to put her away discreetly. To punctuate this miracle, Matthew says that Joseph "knew her not until she had given birth to a son. And he called his name Jesus" (v. 25).

Joseph must have been heartbroken, but his fears were allayed by the Angel of the Lord. "Joseph, son of David, do not fear to take Mary as your wife, for that which is conceived in her is from the Holy Spirit. She will bear a son, and you shall call his name Jesus, for he will save his people from their sins" (1:20-21).

Matthew frequently cites the Old Testament in his Gospel, and these citations serve a purpose. Coupled with the Angel's annunciation, a highlighting effect occurs. In other words, this is important! Here Matthew cites the Prophet, Isaiah. "All this took place to fulfill what the Lord had spoken by the

prophet: "Behold, the virgin shall conceive and bear a son, and they shall call his name Immanuel. . ." (1:22-23). Not only is this a fulfilled Messianic promise, but the packaging calls for readers to pay close attention fully to understand Jesus and the entire Gospel story.

It is also helpful to reflect on the two names Jesus is given in the passage: "Jesus" and "Immanuel." The name Jesus is derived from the Hebrew name, Yeshua, and it means to deliver or to rescue. At the end of v. 23, Matthew translates "Immanuel" for his readers: saying it means, "God with us." Yes, Jesus is the Savior, the one who rescues his people from their sins. But make no mistake about it, because Matthew could not have been more intentional nor clear. God himself saves us. "Hail the Incarnate Deity."

Open Records Council



The Office of Open Records Counsel serves citizens, media, and local governmental entities as a resource for issues related to Tennessee's public records and open meetings laws.

In enacting the Tennessee Open Meetings Act, the General Assembly declared it to be "the public policy of the state that the formation of public policy and decisions is public business and shall not be conducted in secret." T.C.A. § 8-44-101. The Tennessee Public Records Act was enacted to give citizens of Tennessee "... the fullest possible public access to public records". T.C.A. § 10-7-505 (d). As a service to our community the Tennessee Comptroller's Office of Open Records Counsel has agreed to provide a free training session in Hardeman County. This informative training will help citizens, public servants and private businesses understand the obligations of public meetings and the access process to public records. This event will answer the following questions and many more:

- What constitutes a Public Meeting?
- What are the obligations of conducting a Public Meeting?
 - Notice to the public
 - Meeting minutes
 - Public accommodation
- What Public Records are to be created and kept?

Middleton Grad Helping to Make a Difference

As part of a Ball State University immersive learning course, Middleton, Tennessee, resident Ben Bishop and his classmates left their typical college classroom for middle and high school ones, striving to attract a diverse, younger generation to the computer science (CS) field.

“One possible explanation for the lack of diversity in computer science and low numbers of people entering the profession is simply the lack of exposure to CS and computational thinking (CT) at an early age,” said Dave Largent, the faculty mentor and associate lecturer of computer science. “Current elementary and high school curriculums expose all students to English, mathematics, social studies, and the sciences, but seldom CS or CT.”

To address this issue, Bishop, a dual master’s program student

in TESOL/linguistics, and 10 computer science majors worked closely this past semester with teachers and administrators of three Muncie schools: Northside Middle School, Burris Laboratory School, and Central High School. The team delivered detailed lesson plans and other valuable resources that incorporate CS/CT topics and concepts into common curriculum, while also offering computer programs, in-class presentations, classroom activities, and CS/CT training for teachers.

Bishop’s primary goal was to assist in ensuring the resources’ applicability beyond CS and CT and into broader fields of mathematics, statistics, and science. He helped spearhead the revitalization of the resource website, <http://www.cs.bsu.edu/cs4ms/>, and implemented applied linguistics theory to generate impactful

interactions with students.

“This unique experience prepared me for the computational side of linguistics as well as fortified my skills in course/resource design,” Bishop said. “And the opportunity to collaborate at length with those outside my department allowed me incredible interdisciplinary discourse, all aimed at one goal: getting more people of more diverse backgrounds into one of the most important STEM fields.”

Bishop aims to inspire students about CS and its myriad opportunities in hopes that the middle and high schoolers will consider CS as a future career. The CS addendum to the curriculum also helps the schools meet the Indiana academic standards for CS, introduced in 2016.

After graduation, the master’s student plans to work in high



school or middle school language arts and teaching English to speakers of other languages (TESOL) programs before pursuing a doctoral degree.

“Ball State is founded on the principles of those with abilities and resources helping those without,” Bishop said. “I believe that

this project allows for the students of Ball State to echo that mission, giving their time and effort in order to share their experiences and expertise with those who need it most. I can hardly think of any better way to honor the spirit of Beneficence than doing just that.”

Are Your Financial and Tax Advisors Talking?
 Now that we've closed the book on 2019, it's officially Tax Season. As you prepare your tax returns for the April 15 deadline, you might already start looking for opportunities to improve your tax-related financial outcomes in the future. And one important step you can take is to connect your tax professional with your financial advisor. Together, these professionals can help you take advantage of some valuable strategies:

Roth vs. traditional IRA – If you're eligible to contribute to a Roth IRA and a traditional IRA, you might find it beneficial to have your financial advisor talk to your tax professional about which is the better choice. Generally, if you think your tax rate will be higher in retirement, you might want to contribute to the Roth IRA, which provides tax-free withdrawals (if you're older than 59 1/2 and have had your account at least five years). But if you think your tax bracket will be lower when you retire, you might be better off with the traditional IRA, which offers upfront tax benefits – specifically, your contributions may reduce your annual taxable income in a given tax year. Your tax advisor may have some thoughts on this issue, as well as how it might fit in with your overall tax picture in retirement.

Taxable vs. non-taxable income – Turning taxable income into non-taxable income can lower your current year's tax bracket. Depending on your income, you could potentially subtract your traditional IRA contributions (or your SEP-IRA contributions if you're self-employed) from your taxable income. And even now, it's not too late to affect the 2019 tax year, if you still haven't reached the IRA or SEP-IRA contribution limits. Before you file your 2019 tax returns, your tax professional can tell your financial advisor how much you would have to contribute to your traditional IRA, SEP-IRA or similar account to potentially lower your taxable income. If you make the contribution, your financial advisor can illustrate how it would impact your retirement picture and make a recommendation on how to invest the money. (You can fund your IRA with virtually any type of investment – stocks, bonds, mutual funds, and so on.)

Capital gains taxes on mutual funds – You might think you have total control over taxes related to your mutual funds. After all, you decide how long to hold these funds before selling shares and incurring capital gains taxes. However, mutual fund managers are usually free to buy and sell new investments as they see fit, and some of these sales could generate capital gains taxes for you. If these taxes are relatively large in any one year, your tax professional may notice and could relay this information to your financial advisor. This doesn't necessarily mean these mutual funds are inappropriate for you; they still may be suitable for your goals, risk tolerance and time horizon. But the tax aspect may be of interest to your financial advisor, who might recommend more tax-efficient investment options.

Your investment and tax pictures have many overlaps, and by ensuring your team of advisors is working together, or at least communicating with each other, you can increase the chances of getting your desired results.
