A third motion to hold Hardeman County Mayor Jimmy Sain in contempt of court for failing to honor an agreed consent order has brought a change of representation and a potential bombshell in the eight month-old standoff between Mayor Sain and Hardeman County Sheriff John Doolen.

Doolen explained his reason for the filing, done by Attorney Roy Herron of Dresden.

"I didn't have any choice," Sheriff Doolen explained, "but to defend our deputies and jailers who protect the public. They make thousands of dollars less than others nearby and so little that several of their families literally qualify for public assistance and food stamps. We finally got the mayor to agree to help some, and the county commission to their credit approved funds to raise deputies' and jailers' pay

a bit. But ever since then, the mayor has refused to pay these men and women who risk their lives for all of us."

Sheriff Doolen stressed that not a dollar of the funds sought to improve his employees' pay would go to him. Sheriffs' salaries already are set by state law.

Attorney for Mayor Sain, Amber Griffin Shaw of Covington, hired in late January to represent Mayor Sain, did not address the contempt charge, but instead said in her motion to set aside the consent order that the original lawsuit itself was not handled according to the

"When any lawsuit is filed, we must follow the law and the statutes. The sheriff's case is no exception. Unfortunately, we have had to file this motion to ask the court set aside the

consent order previously signed, because it isn't valid and is not enforceable. It does not follow the law of the State of Tennessee, as set out in our motion," said Shaw.

She elaborated, stating, "This is not a private lawsuit between two parties; this is a lawsuit requesting that public funds, \$102,000, be paid a certain way, to the sheriff's office. Because of that, and Mr. Herron's request for the citizens of Hardeman County to pay \$174,000 of his attorney's fees in connection with the suit, we have to proceed with the utmost caution and carefully follow the law, which has not been done, and now requires the consent order to be set aside or invalidated."

One of Shaw's initial points in her motion is that the special circumstances of this type of continued on A7







Tomato Soup with Cupid Croutons

- **Ingredients** 2 tbsp. olive oil
- 1 medium onion, chopped
- 2 cloves garlic, chopped
- 3 c. lower-sodium vegetable or chicken broth 1 28 oz. whole peeled tomatoes
- 2 bay leaves
- 4 slices white bread
- 1 tbsp. butter 1/2 tsp. sugar
- **Directions** In 5- to 6-quart saucepot, heat oil on medium. Add onion and garlic; cook 10 minutes, stirring. Add broth, tomatoes, bay leaves and 1/2 teaspoon salt. Heat to boiling on high.

Reduce heat; simmer 20 minutes, stirring occasionally. Meanwhile, trim crusts from bread. With heart-shaped cookie cutter, cut 4 hearts from bread slices; toast hearts. Stir bread scraps into soup.

Remove and discard bay leaves. Stir in butter and sugar. In batches in blender or with immersion blender, blend soup until smooth. Stir in 1/4 teaspoon pepper. Serve topped with heart croutons.

The Gospel: Part 2 by Jeff Capshaw

Last week's column began a new series about the Gospel. Essentially, it defined what the word "Gospel" means and rehearsed the word's Latin and Greek forms as well as its English etymology. The Gospel means "good news."

For example, Mark opens his book, "the beginning of the gospel [good news] of Jesus Christ, the Son of God" (1:1, brackets added). In Matthew, when the word Gospel is used, it is in collocation with the word "Kingdom," as in "Gospel of the Kingdom." So, not only is the death, burial, and resurrection of Jesus good news, but so is the inauguration of God's reign on earth and the dawning of the new age in the person of Jesus the Messiah.

I Corinthians 15:1-4 is the most comprehensive explanation of the Gospel in the Bible. Paul writes, "now I would remind you, brothers, of the gospel I preached to you, which you received, in which you stand and by which you are being saved, if you hold fast to the word I preached to you—unless you believed in vain. For I delivered to you as of first importance what I also received: that Christ died for our sins in accordance with the Scriptures, that he was buried, that he was raised on the third day in accordance with the Scriptures . .

According to Romans 15:19, Paul said, "so from Jerusalem all the way around to Illyricum, I have fully proclaimed the gospel of Christ." So, in addition to its being the content of Paul's preaching throughout most of the Mediterranean world, the Gospel saves sinners: both religious and non-religious ones. Just as he indicated elsewhere, "for I am not ashamed of the gospel, for it is the power of God for salvation to everyone who believes, to the Jew first and also to the Greek" (Romans 1:16).

Paul also answers the simple question. "What is the Gospel"? He doesn't just give an opinion. Rather, he provides the most authoritative answer. The Gospel he preached and that saves sinners is "according to the Scriptures." What Scriptures"? The only possible answer is the Hebrew Scriptures, or what Christians today call the Old Testament. The Gospel Paul preached and explains in 1 Corinthians 15 isn't something de novo (anew). Instead, all parts of the Gospel were anticipated in the Old

Testament. There isn't one Gospel for Abraham and Moses and another Gospel for Paul and the Church: more about this in a forthcoming column.

Finally, Paul went on to say (vv.5-8) that Jesus, who arose according to the Scriptures, was seen alive. "... he appeared to Cephas, then to the twelve. Then he appeared to more than five hundred brothers at one time, most of whom are still alive, though some have fallen asleep. Then he appeared to James, then to all the apostles. Last of all, as to one untimely born, he appeared also to me." Do you believe the eyewitnesses? Do you believe the good news of Scripture?


OBITUARIES

JOHN LOFTON

DECEMBER 8, 1946 - FEBRUARY 3, 2020

John Lofton, 73, of Walnut, MS, formerly of Middleton, passed away Monday, February 3, 2020 at Mississippi Care Center in Corinth.

Born in Corinth, he was born December 8, 1946, son of the late Morris and Eulah May Haley Lofton, spending his school years in the Middleton area, and graduated from Walnut High School in 1964. He attended Delta State College, but was drafted into the US Army, serving from 1968-71 and was on



tour in Vietnam from 1968-69. While in the Army, he was awarded the Bronze Star Medal for Heroism in connection with military operations against a hostile force. Pfc Lofton distinguished himself by heroic actions while attached to the 3rd Squadron, 4th Cavalry in the Republic of Vietnam. He was described in the May 29, 1969 edition of the Bolivar Bulletin-Times as follows 'with complete disregard for his own safety, exposed himself to the deadly holocaust of the exploding projectiles as he assaulted the enemy emplacements. His valorous actions contributed immeasurable to the defeat of the enemy force and success of the mission.' The article went on to mention several times Pfc Lofton set aside his own safety for the success of the missions and defeat of enemy forces. His efforts not only awarded him the Bronze Star, a high honor in the military, but he also received the Army Commendation Medal with "V" Device for heroism while serving as a cannoneer with A Battery, 1st Battalion, 8th Field Artillery and the Army Commendation Medal with "V" Device (First Oak Leaf Cluster) for heroism. After his time served in the military, he returned to work some for TGT and did some carpentry with his brothers, prior to becoming disabled. Mr. Lofton was a faithful member of Calvary Baptist Church.

Services were 11 a.m. Thursday, February 6, 2020 at Shackelford Funeral Directors in Middleton with Nate Foster officiating. Burial was 1 p.m., Friday, February 7, 2020 in Pleasant Grove Baptist Cemetery in Brookhaven, Mississippi.


PATRICIA WEAVER

Quoting Tenn. Code Ann., the officers shall name in the petition the county mayor as the party defendant thereto. A copy of the petition shall be served on the county mayor, who shall file an answer to the petition within five (5) days from the date of service of the petition, either admitting the allegations of the petition or denying same, or making such answer as the county mayor deems advisable under the circumstances. Whereupon, the court shall promptly in term or at chambers have such a hearing on the application, on the petition and answer thereto, as will develop the facts, and the court may hear proof either for or against the petition. The court may allow or disallow the application, either in whole or in part, and may allow the whole number of deputies or assistants applied for or a less number, and may allow the salaries set out in the application or smaller salaries, all as the facts justify.

Shaw added in her motion that no request for a hearing was made by the petitioner and that no request has been found in writing from Herron.

"Instead," Shaw writes, "Petitioner filed for a Motion for Default Judgement on July 24, 2019. No hearing was requested, as was required by the statute for the relief sought. No motion hearing was set for the Motion for Default Judgement."

Shaw also disputes paying of the attorney fees, saying, "It is clear in both Orders, the county is the identified party by which fees and expenses are to be paid. This is in clear violation of statute and case law, and the Orders must be set aside... Since the October 15, 2019, consent order does not contain the necessary party agreement, fails to identify the correct party for payment of fees and costs, and fails substantively as set forth above, it should be vacated/set aside. If it is set aside, there should be no order granting attorneys' fees and costs, since this Motion stemmed from the October 15, 2019 consent order."

Herron's office released this statement: "Four months ago the Mayor agreed to the Consent Order. Four months ago the mayor had the county attorney present the Consent Order to the county commission which approved the Order by a vote of 15-to-1. But now, unfortunately, the Mayor wants to renege on his word.

"All the Hardeman County jailers and deputies are underpaid, and some of their families qualify for food stamps because the Mayor has repeatedly refused to honor his word or the court order. He has repeatedly denied them the small pay raises authorized by the court order.

"County Attorney Chip Cary last September warned the mayor and county commissioners in a letter, 'This case has the potential to bankrupt the county.'

"County Attorney Chip Cary also wisely advised the mayor and commissioners, 'This case should be settled.' And Attorney Cary on behalf of the Mayor negotiated the Consent Order that resolved many of the issues. But now instead of heeding the county attorney's advice, or the court's order, the mayor is wasting even more tax dollars on new litigation. I have dealt with six previous attorneys who have attempted to represent the mayor, none of whom even attempted to set aside the consent order.

"The motion to set aside the order is ill-founded. It is wrong on the facts and wrong on the law. It is yet another waste of the tax dollars of the hard-working people of Hardeman County.


"The consent order signed in October is both valid and enforceable. The mayor's claim that the law will


not permit him to pay these deputies and jailers is woefully inaccurate. "What the mayor's motion really is about him trying to avoid being held accountable for his repeated acts


of contempt for the Circuit Court and acts of contempt for the county's jailers and deputies. "The sheriff's motion for contempt and for sanctions asks that the court assess damages for the mayor's misbehavior and that the mayor be ordered to 'personally reimburse the county.' It seeks to shift the burden of the litigation costs and attorneys' fees from the county's taxpayers to the mayor "for willfully, intentionally, and lawlessly demanding that the mayor's employees violate the law and the order of this Honorable

"Respectfully, I really wish the mayor would listen to one of his seven lawyers and pay these deputies and jailers. If the mayor would do what he agreed and the court ordered, the tax money could go to Hardeman County law enforcement instead of out-of-county lawyers."

According to Hardeman County Circuit Court Clerk Billy Davis, the issue is scheduled to be heard February 27 at the Hardeman County Criminal Justice Center.



Consequently, it's a good idea to build up your financial resources in other ways, so contribute as much as you can afford to your 401(k) and IRA during your working years. If you do become disabled, it may be possible for you to tap into these funds without incurring a tax penalty, though regular taxes may still be due.

Protection if you need care – If you were ever to need some type of long-term care, such as an extended stay in a nursing home or the services of a home health care worker, you might find the costs to be considerable – and possibly a severe burden on your spouse or partner. In fact, the average cost for a private room in a nursing home is about \$100,000 per year, while a home health aide costs about \$50,000 per year, according to Genworth, an insurance company. And Medicare typically pays only a small percentage of these expenses. To protect your spouse or partner – not to mention your grown children – from possibly having to deal with these costs, you might consider purchasing long-term care insurance. As an alternative, you could purchase a "hybrid" policy that combines long-term care benefits with those offered by a traditional life insurance policy. So, if you never needed long-term care, your policy would pay a death benefit to your spouse or partner or another beneficiary you've named.

Protection when you're gone - If you were to pass away, would your spouse or partner have the financial resources to continue the same lifestyle, pay the mortgage or, if you have children, provide for their education? If the answer is no, then you need to maintain adequate life insurance. How much is enough? There's no one right answer for everyone. You might hear that you need a death benefit that's worth seven or eight times your annual income, but the actual amount should be based on a variety of factors - your age, size of family, current income, spouse or partner's income, and so on. A financial professional can help you determine the appropriate amount of coverage.




