# Sheriff vs. Mayor (and Nobody |

Hardeman County Mayor Jimmy Sain, through legal representation, has asked the courts to ask Attorney Roy Herron of Dresden to "remove nonparties from the certificate of service, correspondence, and continued communications" in regards to filings in the Hardeman County Sheriff John Doolen vs. Hardeman County Mayor Jimmy Sain case that began last July.

"Petitioner's Counsel continues to confuse the proper parties in this case. At no time have Hardeman County, or its Commissioners, been party Resondents in this matter," begins the motion filed by Amber Griffin Shaw on behalf of Sain. "Yet in each pleading, piece of attorney correspondence, notice, or other matter, sent by Petitioner's counsel, he insists upon including the county attorney, who is not of record in this matter, as well as each commissioner. Such is unnecessary, and is unfairly increasing the expenses in this matter (for instance, if Mr. Herron sends out a mailing, it can be up to \$9.00 in postage costs to each commissioner who receives one, and there are approximately eighteen commissioners). The Respondant, in an effort to restrict costs of this matter, respectfully requests the court to require Petitioners counsel to properly serve only the parties with the necessary correspondence, pleadings, notices, and other matters related to this case. Any effort to include nonparties is simply an artificial way to increase costs and fees, otherwise."

Herron wasted no time in labeling it as a "gag order."

"The mayor is asking the court to issue a gag order to keep the people's elected representatives, the county commissioners, from knowing what is happening. Such a Gag Order would violate the sheriff's first amendment rights and the rights of the citizens of Hardeman County," he began, adding, "These are public records and the public has a right to know."

Shaw says Herron is missing the point of the motion.

"The motion filed by the mayor as to the certificate of service is a legal housekeeping motion. Rule 5.02 of the Civil Rules of Procedure is what is followed by the parties in a lawsuit. It requires that when documents filed with the court are sent in, the lawyer has to certify that the other party got the paperwork. That's it – and Mr. Herron thinks that the commissioners are part of this lawsuit, even though

he didn't sue the county or its commissioners. The mayor is simply requesting that the rules be followed, because sending out legal correspondence and filings to individuals that aren't part of a case is not what the rules say to do," she wrote.

But Herron continued to state the public was being denied a basic right.

"The mayor is asking that the court order that the sheriff's counsel 'serve only the parties,' in other words just the mayor and the sheriff, with all 'matters related to this case.' But why should the commissioners and the people be denied their right to know?

Shaw says no one is being denied information, as it is all part of the public record.

"Anyone is welcome to get copies of all filings. It's concerning that such a routine housekeeping motion could be twisted into a 'gag' order of some sort, when it is probably one of the most basic rules of a lawyer's practice," she added.

Herron also belittled the mayor's attempt to settle the continued on A2

Search and rescue teams worked the river, but found no sign of Pulse. The vehicle, partially submerged when found, left the roadway near mile marker 16 eastbound on Highway 64.

Pulse was still missing as of press time on February 26.

case.

"The mayor now claims to be worried about the expense, but he's the one who is trying to blow up the settlement agreement that was brought to the commission by then-County Attorney Chip Cary and approved thirteen-to-one (13-1). The mayor is the one costing the taxpayers thousands and thousands by fighting about what was resolved back in October," said Herron.

Shaw says Herron is the one causing delay.

"The press release sent by the attorney for the sheriff is the latest example of misunderstanding how the law works. Unfortunately, it appears that keeping the pot stirred with fake news is more important than getting a resolution to this matter.

"Instead, Mr. Herron is doing what he can to delay. He's cancelled the motion for sanctions against the mayor, after telling everyone it would be February 27. The mayor has never been sanctioned in this case. Thursday's hearing should be about getting this case back on track and being able to enter a legal order (instead of the defective one that was filed) to fix the budget and make sure the hardworking sheriff's deputies are paid properly."

Herron also says extra expense is not being caused by sending files to commissioners, as it has been done electronically.

"We have not mailed those commissioners anything while the mayor's seventh lawyer has been in this case. We have only emailed the commissioners copies of documents that they might want to know about. There is zero expense to the Hardeman County taxpayers when my paralegal hits a button and in three seconds adds the commissioners as a group of email recipients when she already is emailing the mayor's lawyer."

Shaw says Herron is drowning the case in paperwork.

"He is now trying to get the other motions on the docket delayed. To what end? The latest filings in this case are not required – what is best for all involved is a resolution. The mayor has asked for the sheriff to sit down and work out a valid order as to the \$102,000. Such requests are ignored. Instead, more motions are filed, and press releases are issued about things that aren't part of a salary dispute. The only person that benefits from this is the lawyer, whose fees continue to increase."

Hardeman County Sheriff John Doolen says he has wanted the commissioners to have the information without having to go search for it themselves.

"If protecting people from criminals isn't the people's business, I don't know what is. And if it's the people's business, I want the people to know what is happening as we try to get deputies to protect them and get our deputies paid enough to keep them on the job," said Doolen.

"I told our attorney that we don't have any secrets from the citizens or their elected representatives, the county commissioners. And I instructed our attorney to email copies of everything to the commissioners so that they know exactly what is happening. The mayor may not like it, but I still think it's the right thing to do," he concluded.

Shaw asked that the motion to "remove nonparties from the certificate of service, correspondence, and continued communications" be heard March 24, at 9:00 a.m., in the Hardeman County Circuit Court.

Editor's Note: A gag order (also known as a gagging order or suppression order) is defined as an order, typically a legal order by a court or government, restricting information or comment from being made public or passed onto any unauthorized third party.

# **Libraries Get Training Funds Grants**

State Senator Dolores Gresham announced that three county libraries will receive Training Opportunities for the Public (TOP) grants made possible by the Tennessee Broadband Accessibility Act and a partnership with the Department of Economic and Community Development and the Tennessee Secretary of State's Office. Training Opportunities for the Public grants provide funding for trainers, hardware and software for free technology training classes for communities.

"Making sure our libraries have the most update technology is imperative to a rural district like ours," said Senator Gresham. "Providing access to new software and training programs for members of our community







## The Gospel: Part 4 by Jeff Capshaw

In this series, the word Gospel is defined as the "Good News," and 1 Corinthians 15:1-8 is the hallmark passage which explains the contents of that Gospel. Jesus died, was buried and rose again the third day, according to the Hebrew Scriptures. Not only that, but after Jesus' resurrection, he was seen by many, including Paul himself.

Furthermore, last week's installment reminded the reader that the Apostle was not ashamed of the Gospel because "it is the power of God for salvation" (Romans 1:16). Furthermore, the Gospel is necessary for the salvation of both religious Jews and non-religious Gentiles. Why? Because "all have sinned and fallen short of the glory of God" (Romans 3:23). "There is none righteous, no not one" (Romans 3:10).

But why did Paul say he was not ashamed of the Gospel? Last week's article pointed-out that some in the Greco-Roman world (not unlike man today) thought that events like resurrection simply cannot occur. Even if Jesus did rise from the dead, it doesn't follow that it had or has anything to do with anyone then or now. What difference does it make? Paul had a theological reason for why many didn't believe the Gospel then, and it also applies

In this series, the word Gospel today. That reason is found in 2 defined as the "Good News." Corinthians.

He wrote, "and even if our gospel is veiled, it is veiled to those who are perishing. In their case the god of this world has blinded the minds of the unbelievers, to keep them from seeing the light of the gospel of the glory of Christ, who is the image of God" (2 Corinthians 4:3-4). This text provides a biblical reason for why people reject the Gospel.

According to this verse, the Gospel message is hidden to unbelievers. They simply cannot see it, because their minds are blinded by Satan (the "god of this world"). There are different kinds of physical blindness. According to the National Federation of the Blind, "the statutory definition of 'legally blind' is that central visual acuity must be 20/200 or less in the better eye with the best possible correction or that the visual field must be twenty degrees or less."

Unbelievers have a congenital

and complete blindness of their minds from birth. They are blinded by Satan, and they cannot understand and, consequently, believe the Gospel, unless God intervenes by his grace. Even as Paul says in Ephesians, "and you were dead in the trespasses and sins in which you once walked, following the course of this world, following the prince of the power of the air, the spirit that is now at work in the sons of disobedience. .." (2:1-2).

The "prince of the power of the air" is the same as "the god of this world." Physical blindness is bad, but spiritual blindness is even worse. Both take a miracle to cure, and only the Gospel can cure spiritual blindness. Can you see the Gospel, or are you still blinded by the god of this world?



Phinnesse, Rodgerick Robinson, and Telvin Polk were named to the regular season all-district team.



# That Championship Season: 2010



This season, the Bolivar Bulletin Times will look back at ten years ago, following week by week the 2010 Bolivar Central Tigers State Championship season.

February 23, 2010: Bolivar met Liberty for the third time in the season, this time for the district title.

The Tigers trailed 38-36 with one quarter to play, but managed to tie the game at 48, sending the contest to overtime. Bolivar made 7 of 10 free throws in the extra frame while holding Liberty to just seven total points and winning 61-55. O'Neal Woods led Bolivar with 20 points, while

Murphy added 10. For the game, Bolivar went 17-25 from the line, while Liberty could managed to make only 9 of 19 from the stripe.

February 27, 2010: Bolivar opened the region with a home game against Milan. Milan, who came in 18-13 on the year, led the Tigers 22-19 at the half before Bolivar inched away in the second half, eventually winning 55-42, mostly on the strength of holding the Bulldogs to only a basket in the third quarter.
