Ruiz Tragedy Ends with Convictions

The conviction of Taylor Lucas Robinson, 20, of Bolivar, on January 22 brought the total number to four who will serve time for the murder of Michael Ruiz on March 20, 2018.

Ruiz, 19, of Bolivar perished that night when he was shot while washing dishes at El Ranchito Mexican Restaurant in Bolivar. Ruiz was a senior at Bolivar Central High School and on path to graduate in 2018.

The shooting occurred at approximately 9:00 p.m. that evening when two gunmen entered the back door of El Ranchito demanding money. But while video surveillance shows Ruiz appearing to be complying with the demands of the men, he was shot and later pronounced dead at Bolivar General Hospital.

Sentencing for Robinson and Lavonta Lamar

Douglas, 19, of Bolivar for first-degree murder and attempted aggravated robbery is set for March 27. Douglas was convicted on January 15.

Two that pled guilty to lesser crimes were John Curtis Gray, 21, of Bolivar and Javon M. Blakemore, 19, of Bolivar.

Gray pled guilty to second-degree murder on September 19, 2019 and received a sentence of 17 years, with no chance of parole. With time off for good behavior, Gray could serve as little as 85% of the sentence.

Blakemore, who pled guilty to second-degree murder as well, received a 13.5 degree sentence with no chance of parole. Blakemore pled guilty on April 18, 2019. Blakemore could serve as little as 85% of the time, if he earns time for good behavior.

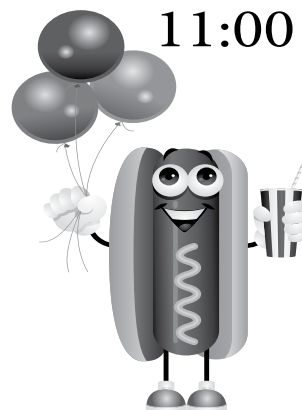

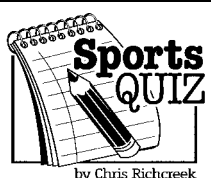

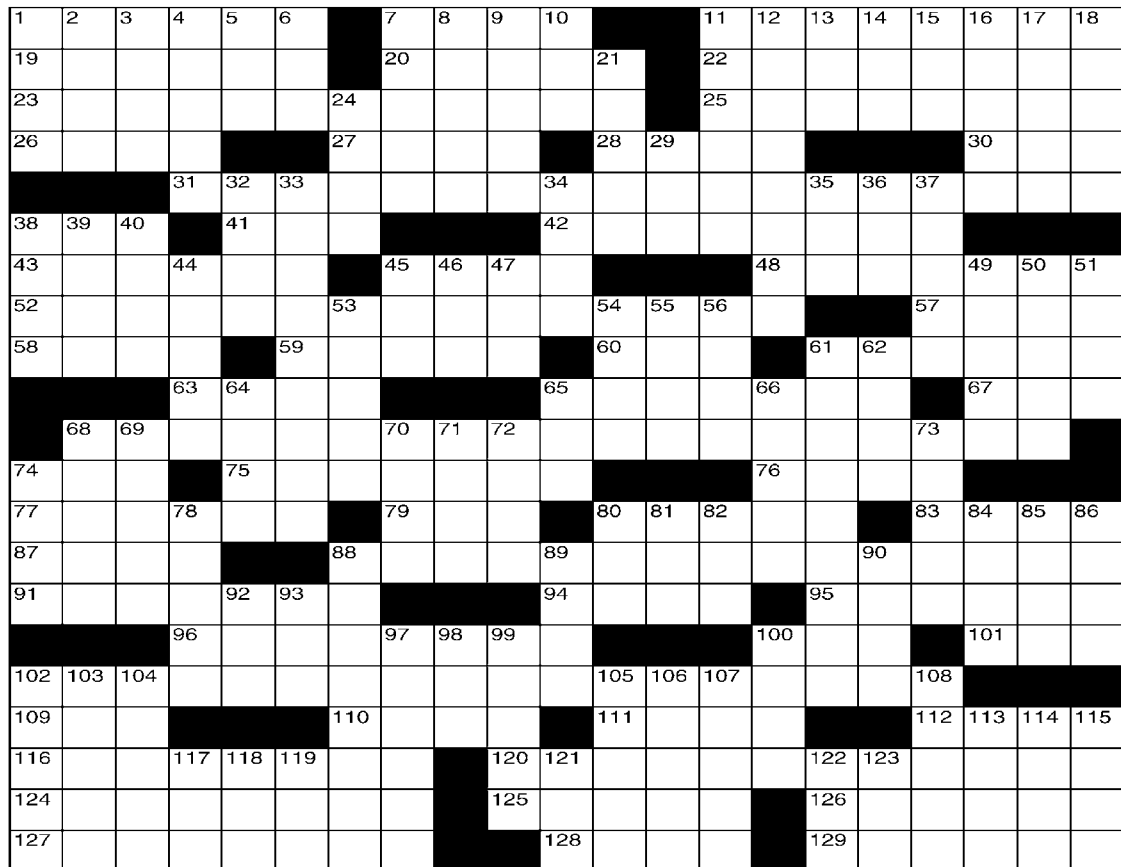

FAITH

Living in the Present by Jeff Capshaw

This month's columns featured biblical topics for a New Year. They included (1) forgetting the past because it isn't much you can do about it. (2) Forgiving yourself: it doesn't do any good to pummel yourself with guilt. Ask the Lord to forgive you and move on. (3) Finally, learning to be content or satisfied with current things and circumstances: that will take some practice, but it pays in the long run.

This final installment for the series is hope. A Christian view of hope is different than the typical usage of the word. Someone might say, "I hope it doesn't rain today, or "I hope I win the lottery." But that is a "hope-so" brand of hope. On the other hand, Christian hope is a "know so" flavor of hope. For example, Romans 8:24-25 says, "for in this hope we were saved. But hope that is seen is no hope at all. Who hopes for what they already have? But if we hope for what we do not yet have, we wait for it patiently (ESV)." This is a future hope colored with certainty.

A familiar passage on hope is Jeremiah 29:11. The prophet writes, "for I know the plans I have for you, declares the Lord, plans for welfare and not for evil, to give you a future and a hope." For believers, hope is in the Lord, in His goodness and faithfulness to his people. Even as the writer of Hebrews claims, "let us hold unswervingly to the hope we profess, for He who promised is faithful" (10:2).

Knowing the context of the Jeremiah passage is helpful.

Growing by David Coy

When we find ourselves or someone we know in the beginning of our or their journey with grief, shock greets the person mourning. With shock there appears the feeling of dismay or the mixed feeling of sorrow and relief because of expected loss and the minimized of continued misery of the now deceased loved one. It is never easy to let go of someone for which we felt deep affection and admiration. Richard Cabot and Russell Dicks in the work, *The Art of Ministering to the Sick*, reports that families are extremely fatigued when their loved one who has suffered during the last few days of their illness, passes. Whether the loss by death is expected or unexpected there is a growth process that the mourner will need to achieve. A return to a happy healthy mindset in the absence of the deceased should be the desired end result.

Most of us put one foot in front of the other fulfilling each day's responsibilities. With assistance of supporters, the goal is acceptance of the new reality and a return to a normal routine without struggling twenty-four seven. Erich Lindemann in his work *Symptomatology and Management of Acute Grief*, in Crisis Intervention that mourners have seven needs: Support from others, emancipation from the deceased, acceptance of the pain of bereavement, expression of sorrow and sense of loss, verbalization of hostility and guilt, formation of new relationships, and finding meaning in life. All of these can be achieved whether anyone who is walking the journey with grief understands the specific steps identified above or not. Yes, there is a growth from pain and sorrow to acceptance of the new reality and building a meaningful and joyous life. Success does take work and support and is achievable. This is Sunrise Aftercare, sunrise@sfdcares.com

Notice to whom Jeremiah is writing! He said, "these are the words of the letter that Jeremiah the prophet sent from Jerusalem to the surviving elders of the exiles, and to the priests, the prophets, and all the people, whom Nebuchadnezzar had taken into exile from Jerusalem to Babylon" (29:1).

God's chosen people were suffering captivity in Babylon. Yet, the Lord tells them to carry on with their lives. Moreover, he warns them, "do not let your prophets and your diviners who are among you deceive you, and do not listen to the dreams that they dream, for it is a lie that they are prophesying to you in my name; I did not send them, declares the Lord." In other words, don't listen to the wrong voices. Listen to me! Their suffering was necessary, but it is

Romans 15:13 says, "may the God of hope fill you with all joy and peace as you trust in him, so that you may overflow with hope by the power of the Holy Spirit."

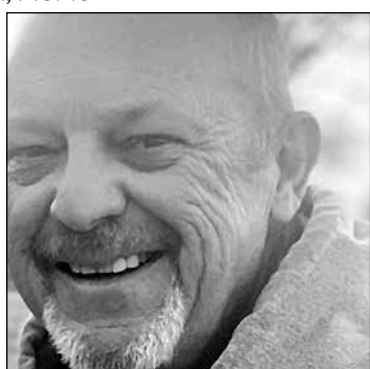

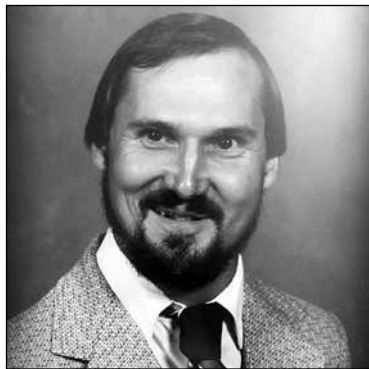

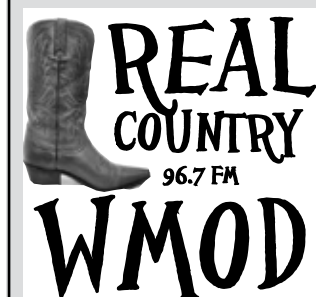

Don't Play Politics with Your Portfolio

You're probably aware this is an election year. During the next several months, the candidates will discuss issues that should greatly interest you as a citizen. But as an investor, how concerned should you be with the results of the presidential and congressional elections?

Maybe not as much as you might think. At different times, the financial markets have performed well and poorly under different administrations and when different parties have controlled Congress. And after all the votes are counted, outcomes in the investment markets can be unpredictable. - Following a long-term strategy – In pretty much all walks of life, there are no shortcuts to success – and the same is true with investing. You need to follow a long-term strategy based on your goals, risk tolerance and time horizon, and you need the patience and perseverance to keep investing in all markets – up, down and sideways.
- Avoiding mistakes – Many people think of an investment mistake as failing to “get in on the ground floor” of some company that ultimately grew to huge proportions. But it's pretty hard to become an early investor in companies like these, many of which start out as privately held businesses without any stockholders. After Election Day, regardless of the outcome, you can help keep your portfolio on track by not playing politics with it.

That Championship Season: 2010

This season, the Bolivar Bulletin Times will look back at ten years ago, following week by week the 2010 Bolivar Central Tigers State Championship season.

February 3, 2010: Bolivar lost its first district game of the season, 60-53 to Liberty Tech in Jackson.

Bolivar trailed 32-21 at the half and managed to close the lead to 38-35 at the end of three quarters, but even when Liberty only made nine of eighteen free throws in the final quarter, it was enough. De-Andre Barnett led Liberty with 14 and Kendall Anthony had 13 for Liberty, while Bolivar was led by Jay Murphy with 14 and Ricky Tisdale (11) and Kegan Fuller (10) were also in double figures.

February 5, 2010: Trying to avoid their second district loss in a row, the Tigers found themselves down 55-45 to Jackson



Central Merry in the fourth quarter. But Bolivar scored the last 16 points of the game to win 61-55.

Jay Murphy, who had 20 points, had 13 points in the final quarter, including going 9-11 from the free throw line. Bolivar got 22 from Ricky Tisdale, 10 from Tevin Coleman and the only other player

to score was O'Neal Woods, who had 9. Bolivar outscored JCM 22-7 at the charity stripe.

Bolivar was now 19-4, with a 10-1 district record. But the next week had matchups with Jackson South Side, McNairy Central and a rematch with Liberty Tech.

Hardeman Healthy Outreach Enters Second Year Promotes BE MORE Campaign by Dr. Amy Elizer

During 2019, University of Tennessee Extension's Hardeman Healthy Outreach assessed community assets and residents' ideas about opportunities and challenges for eating more healthfully and moving more throughout Hardeman County. The project began measuring and marking walking paths, as well as funding exercise benches for public locations. As the project enters 2020, work continues in the towns and now includes work sites and churches.



For example, vending machine and food pantry assessments are being conducted that can ultimately improve the healthfulness of foods being offered in each. The farm-to-school supplement grant allows for work with local fruit and vegetable producers to assist them in finding new potential markets for their crops in the county.

"For the past year, we talked about helping people access healthier food and physical activity to prevent or reduce chronic disease. We will continue this work, but the 'BE MORE - Healthy Choices Add Up' campaign encourages people to start making changes for a more healthful life," said Dr. Amy Elizer, UT Extension specialist. "I've been asked what BE MORE means." she continued. "It's really about feeling your best and having better quality of life--more life to enjoy with family and friends, more laughs, more memories--because you've made healthy choices."

The first and third Mondays of each month Elizer hosts the BE MORE Hardeman walking podcast on the project's Facebook page @BeMoreHardeman. The podcasts offer a mix of information and encouragement for those wanting to get and keep better health. "Ramona Spencer was my first interviewee. As a long-time type II diabetic, she was tired of taking medication and just not feeling well. She started walking and eating more fresh fruits and vegetables. She lost a tremendous amount of weight that resulted in taking less insulin and other medications. I hope that our work helps the county have more Ramona's and prevents other people from developing chronic disease."

This project is funded by the CDC's High Obesity Program (HOP) and is working with The University of Tennessee Extension to improve access to food and physical activity opportunities throughout Hardeman County. 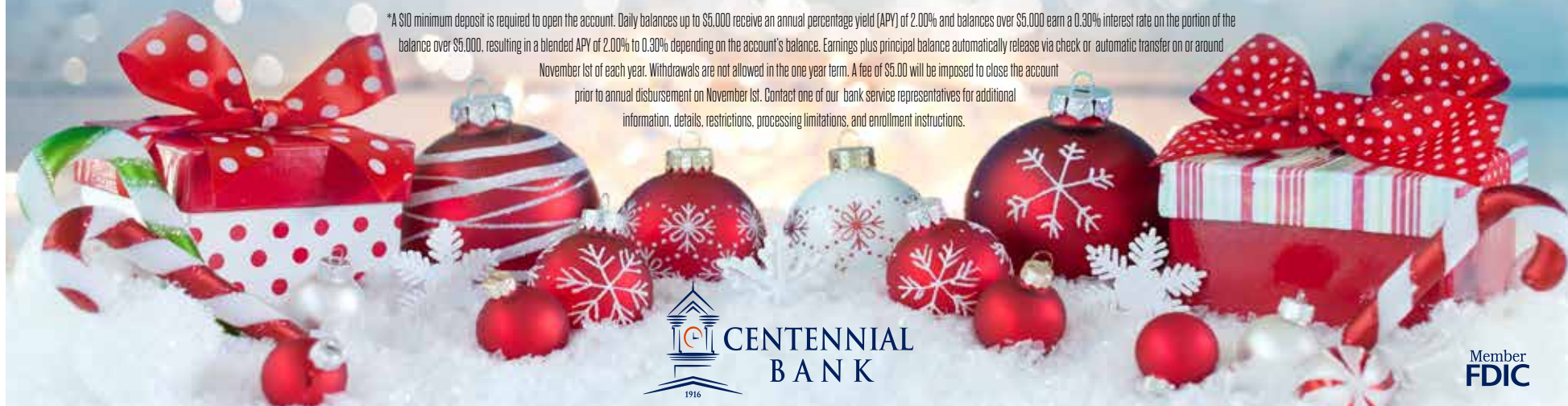

Lee Asking for Abortion Reform

Governor Bill Lee announced that he will submit comprehensive pro-life legislation to the Tennessee General Assembly this year, including the prohibition of an abortion where a fetal heartbeat exists. This legislation would make Tennessee one of the most pro-life states in the country.

"I believe that every human life is precious, and we have a responsibility to protect it," said Gov. Bill Lee. "Today, Tennessee is taking a monumental step in celebrating, cherishing, and defending life at every stage. I'm grateful to be joined by so many leaders in our state who are boldly standing up for our most vulnerable."

This legislation would build upon successes in other states while incorporating innovative approaches to enhance existing law, including provisions such as:

- Prohibiting an abortion where a fetal heartbeat exists;
- Requiring a mother to undergo an ultrasound prior to an abortion;

• Prohibiting an abortion where the physician is aware that the decision to seek an abortion is motivated by the race, sex, or health or disability diagnosis of the unborn child.

To protect against legal challenges, the new law would also include a creative "ladder" provision, modeled after Missouri law, of sequential abortion prohibitions at two-week gestational age intervals, along with severability clauses for each step of the ladder.

"As someone who takes seriously the cause of life, I am ecstatic to support this legislation. The many provisions of this bill represent great leaps forward for the cause of life in Tennessee. The destination has always been clear. The issue has been identifying the proper vehicle. We now have the proper vehicle. This comprehensive, tiered approach is our best chance of advancing the cause of life without sacrificing the gains we have made. I appreciate the great

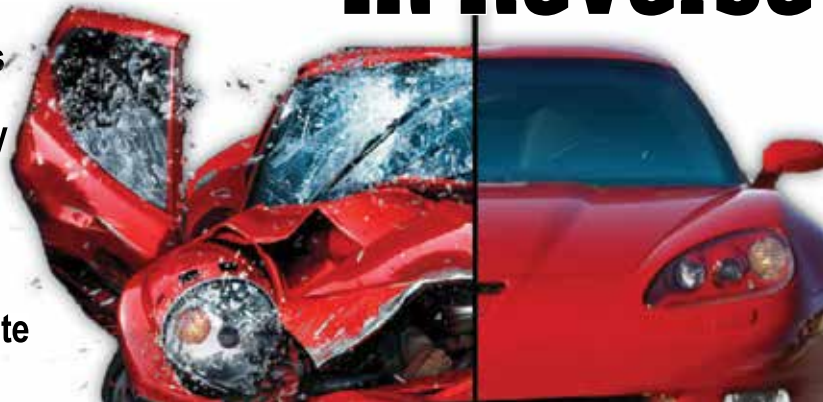

Quinco Offers Scholarship to High School Students

Once again this year Quinco Community Mental Health Center will award scholarships to eligible students in the five counties of our service area. A \$1000 one-time scholarship will be awarded in each of the five (5) counties of our original service area.

Students will be selected for the scholarship prior to graduation. The members of the governing board of Quinco will review the applications and select the recipients of the scholarships. The scholarships will be presented at graduation services or Awards Day ceremonies. Payment of the scholarship will be made directly to the accredited college or university chosen by the student upon the student's admission. The \$1000 scholarship will be a one-time award.

Any high school senior that lives in Chester, Decatur, Hardeman, Hardin, or McNairy County, who also attends a high school in one of the above counties, and who meets the eligibility criteria may apply for this scholarship.

To be eligible the student must (1) be a senior expecting to graduate in the current year; (2) meet residence requirements as stated above; (3) have a grade point average of 2.5 or above; (4) plan to pursue a course of study in one of the following fields: psychology, medicine, nursing, social work, sociology, counseling, or other health related field; (5) complete a declaration of interest application. This application must be postmarked by March 16, 2020. Applications will be available to the principals and/or guidance counselors at each of the high schools. Each application must have a representative reference form attached to be considered.

Reflect, Redefine, and Move Forward

As we reflect on the year that was 2019, we look forward to an equally successful 2020. We accomplished a great deal in 2019, and we expect that trend to continue into the decade of the 20s.

The City of Bolivar experienced new growth in 2019 welcoming several new businesses including pharmacies, retail, restaurants, and more. We launched a new city government website in 2019 which includes a blog with news and information as it happens. A new community garden to be located at Pleasant Run Creek Park is also in the works for 2020.

The streets and sanitation department purchased a new automated sanitation collection truck. The addition of the new

truck, purchase and issuance of the collection carts, development of new code initiatives, and a focus on the beautification of Bolivar is a collaborative effort between the streets & sanitation department, code compliance office, and city officials that will be strengthened and enhanced in 2020.

Great strides were also made in the public safety sector. The Bolivar Police Department has successfully undertaken a proactive approach to community policing in an effort to engage the citizens of Bolivar. The Bolivar Fire Department developed and implemented a community risk reduction program in 2019 in collaboration with the Tennessee State Fire Marshal's Office seeking to reduce the incidence of fire by strategically implementing educational programs.

Breakout sessions begin at 9 a.m. They include presentations on farm bill changes, soil testing for precision agriculture, weed management and seed treatment effectiveness.

All visitors will reconvene at 11 a.m. to hear from Wesley Tucker, a field specialist in agricultural business from the University of Missouri. Tucker will discuss effective methods for coaching, motivating and retaining good employees.

Conference goers will also meet the newly established Tennessee Corn Promotion Council and hear an update from Executive Director Carol Reed. Parks Wells, executive director of the Tennessee Soybean Promotion Council will recognize winners of the state's 2019 soybean yield contest.

A complimentary lunch will be served at noon and will be immediately followed by the conference's keynote presentation, "Filter the Kool-Aid Before You Drink It," led by Robert Nielsen of Purdue University.

Producers, Commercial Applicators and Certified Crop Advisors can obtain certification points at the conference.
