County Schools Get TVA Grants

Bolivar Middle School and Middleton High School were awarded grants of \$5,000 each by the Tennessee Valley Authority, in partnership with Bicentennial Volunteers Incorporated for a STEM (science, technology, engineering, and math) education project.

"Our students were thrilled that I was able to add drones and solarpowered cell phone chargers to our Makerspace Program," said, Deana Sain, Library Media Specialist at Bolivar Middle School. "We'll be using the grant for career development and energy conservation ideas in our Makerspace."

The grant award is a part of \$600,000 in competitive STEM grants awarded to 142 schools across TVA's service territory. The competitive grant program

Senate Education Committee Chairman Dolores Gresham (R-Somerville) announced today that she will not be a candidate for reelection in 2020. Gresham made the announcement in an email to constituents in Chester, Decatur, Fayette, Hardeman, Hardin, Haywood, McNairy and Henderson Counties in the 26th senatorial district.

"It has been the honor of my life, surpassed only by my service in the U.S. Marine Corps, to serve the people of Tennessee, especially children," said Sen. Gresham. "I am very thankful for the support, friendship, and kindness of my constituents who have entrusted me to represent them for the past 18 years."

Gresham served six years in the House of Representatives before being elected in 2008 to three consecutive terms in the Tennessee Senate. She was appointed chairman of the Senate Education Committee as a freshman senator, presiding over the committee during a time of tremendous student progress at the K-12 level. Her tenure as chairman also saw unprecedented growth in access to post-secondary education at Tennessee's colleges and universities.

"There will be no weaning process," Gresham said after announcing her retirement. "I will continue to fulfill my promise to constituents to serve them to the fullest as their senator until my successor is elected in November."

Gresham is carrying several Bill Lee to ban abortions after a heartbeat is detected and a comprehensive bill to increase literacy in the early grades. During her tenure, Gresham sponsored major

What Happened in October? Part II

The story of the settlement of Hardeman County Sheriff John Doolen's lawsuit against Hardeman County Mayor Jimmy Sain has deepened as a county commissioner has said he contacted Hardeman County Attorney Chip Cary last fall in order to hopefully settle the lawsuit between the sheriff and the mayor.

According to county commissioner Justin Howell, his records indicated he likely spoke to Cary on October 2, but no later than October 3, about ideas of how to settle the lawsuit and the procedure on how to get a special called meeting set to discuss the matter.

The information came forth after Sain's and Cary's sworn testimony appeared to be in conflict during the February 27 hearing on the consent order signed during the eventually held meeting on October 8 that, for the time being, settled the lawsuit.

Employees of the mayor's office and other county commissioners also have stated that Cary did not offer full or complete details of the agreement until during the meeting that night and Sain's letter to the commissioners earlier in the day on October 8 was to inform them of his conversation with commissioner Johnny Lanier, detailing a stall in the talks with the sheriff to settle the case.

Sain's letter to the commission said Doolen had agreed to many points as of October 4, but that more requests were added on October 7, seemingly pushing the meeting to October 15. However, an agreement was reached and a meeting was held on October 8, which resulted in a vote that, on paper, resolved the conflict.

low-income children an opportunity to receive a quality education. She also initiated a series of bills in 2018 to address sexual misconduct by teachers to ensure children are safe in the classroom.

"This is not a retreat," the former Lt. Colonel said as she pledged to continue to work to improve education in Tennessee. "In the words of General Chesty Puller, "I'm attacking in a different direction." Puller, who was a distinguished U.S. Marine Corps officer, was the most decorated Marine in U.S. history.

Gresham has served as Chairman of the Education Committee for the State Council of State Government's Southern Legislative Conference. She also

served as Vice Chairman of the Education Commission of the States.

In other leadership roles, Gresham has been a champion of Tennessee farmers and advancing agriculture in Tennessee. She and her husband, Will, live on their cattle farm in Fayette County.

Lt. Governor Randy McNally said, "Dolores Gresham has devoted her life to serving others. She served all Americans with great distinction in the United States Marine Corps and every Tennessee citizen as a member of the Tennessee House and Senate. She has been a strong conservative voice and a fierce advocate for her constituents. Her departure will certainly leave a void. I am grateful for her friendship and plan to continue soliciting her wise counsel. She will be greatly missed as a member of the Senate."

Senate Republican Leader Jack Johnson (R-Franklin) said, "Both in service to our county and our state, Senator Gresham exemplifies the Semper Fi motto of the U.S. Marines as 'always faithful.' Bolivar's Walley Announces Run for State Senate

Dr. Page Walley, former State Representative and current Vice Mayor of Bolivar, announced he is running for State Senator from the 26th District. Since Senator Dolores Gresham announced she will not be seeking re-election, voters from across the district have reached out to Walley and encouraged him to

Walley served five terms in the Tennessee House of Representatives and six years in executive branch leadership under Republican governors as Commissioner of the Tennessee Department of Children's Services and the Alabama Departments of Children's Affairs and Human Services. Under his leadership, Alabama became the first state to exceed federal court expectations by fundamentally reforming its child and family

Currently, Walley-a clinical psychologist and licensed minister-works as Chief Public Policy Officer at Saint Francis Ministries, one of the nation's largest social service providers and advocacy organizations. He partners with local, state, and

federal officials to address the complex needs of children, families, and communities.

"Working with communities in West Tennessee and nationally has shown me firsthand the struggles people face in order to provide for their families. Nothing is more important than the safety and well-being of children and families. As a popular state legislator who served on the Agriculture, Finance, and Health and Human Services Committees, Walley was also known as a problem-solving consensus builder who held more than 800 "Listening Meetings" throughout his district. Walley is a sought-after speaker both here and abroad on issues of faith, family, and community well-being.

"During the coming weeks, I will visit citizens in communities across the 26th District to learn what they want from their Senator, and to respectfully earn their support."

The district includes eight West Tennessee counties. They are: Chester, Fayette, Hardeman, McNairy, Hardin, Henderson, Decatur and Haywood.

Templeton Declares His Candidacy, Too

Jai Templeton, Tennessee's former Commissioner of Agriculture, declared his candidacy for the Tennessee Senate in District 26. Three-term Senator Dolores Gresham recently announced her decision not to run for re-election. Templeton will seek the Republican nomination for the district that includes Chester, Decatur, Fayette, Hardeman, Hardin, Haywood, Henderson, and McNairy counties.

"I believe my experiences serving as Agriculture Commissioner, McNairy County Mayor, and



family farmer uniquely qualify me to serve our rural communities," Templeton stated. "I'm pro-life, pro-Second Amendment, and I support President Trump's America First agenda. My values are in line with most people here in southern West Tennessee," remarked Templeton.

Templeton is a sixth generation family farmer with timber, cattle, grain, and cotton farming operations in McNairy and Hardin counties. He is the Community Development Manager for Centennial Bank in Adamsville. Templeton served as Commissioner of the Tennessee Department of Agriculture from 2016-2019. He was elected McNairy County Mayor in 2006 and re-elected in 2010. Templeton was a Field Representative for former Congressman Ed Bryant and has been an apprentice auctioneer for 20 years.

Templeton holds a Bachelors of Science degree in Business Administration from Union University. He has served on the Agri-Center International Board of Directors since 2013. Templeton is Chairman of the McNairy County Republican Party and was a Delegate to the 2004 Republican National Convention.





Corned Beef & Irish Slaw

Ingredients For the Corned Beef:

2-3 pounds corned beef brisket (with spice packet) 4 whole garlic cloves (lightly smashed)

4 cups water

1 pound baby red potatoes 1 pound baby carrots

1 tbsp olive oil

1/2 tbsp garlic salt

For the Irish Cabbage Cole Slaw:

1/2 cup mayonnaise

1 tbsp honey

1 tbsp light olive oil

1 1/2 tsp Dijon mustard 1 tsp caraway seeds

salt, to taste 3 cups finely shredded red cabbage

3 cups finely shredded green cabbage

2 tbsp dried or fresh parsley



Instructions For the Corned Beef: Pour water into the bottom of an 6 quart (or larger) Instant Pot. Place brisket into the pot (if the brisket has a fatty side, put it fat side down.) Sprinkle spice packet on top of the brisket and place lightly smashed garlic cloves on top as well. In a bowl or large ziploc bag, toss potatoes and carrots with oil and garlic salt. Place veggies around the sides of the brisket. Lock lid on top of Instant Pot and pressure cook on HIGH for 45 minutes. While the corned beef is cooking, begin making the cole slaw.

For the Irish Cole Slaw: In a large bowl, whisk together mayonnaise, honey, olive oil, Dijon mustard, caraway seeds, and season with salt (to taste). Gently toss the dressing with sliced red and green cabbage and fresh parsley. Cover and refrigerate until ready to serve. To finish: Once corned beef and veggies have finished cooking, allow the pressure to naturally release for about 10 minutes then release the valve and allow steam to escape. Once

steam has escaped, and pressure has released, carefully remove the lid. Place carrots and potatoes on a serving platter; cover with aluminum foil to keep warm. Place corned beef on a large cutting board and allow to rest for 5 minutes. Slice corned beef against the grain and place on top of platter. Serve immediately with Irish Coleslaw.



Will Your Money Last as Long as You Do?

What do your fellow citizens fear most? Almost half of them -49% – are most afraid of running out of money during retirement, a higher percentage than the 44% whose chief concern is failing health, according to a recent survey by Aegon Center for Longevity and other groups.

What steps can you take to help ensure your money will last as long as you do?

Here are a few suggestions:

- Estimate your longevity. None of us can say for sure how long we'll live. However, you can make some educated guesses based on your health and family history. And once you do have at least a ballpark figure, you can then determine about how much money you may need to last the rest of your lifetime. A word of caution: It's probably going to be more than you think. Health care costs alone can run into the hundreds of thousands, even with Medicare.
- Determine when you'll retire. Your retirement age will have a big impact on how long your money can last. The longer you work, the more you can contribute to your retirement plans, such as your IRA and 401(k). Plus, if you have health insurance through work, you should be able to cover some of the out of pocket health care costs you'd normally have to pay if you're retired.
- Invest as much as you can in your retirement. During your working years, contribute as much as you can afford to your IRA and your 401(k) or similar employer-sponsored retirement plan. And every time you get a raise, try to increase the amount you put into your employer's plan.
- Protect yourself from long-term care costs. The average cost for a private room in a nursing home is about \$100,000 per year, while a home health aide costs about \$50,000 per year, according to the insurance company Genworth. Medicare typically pays just a small portion of these amounts, so you may want to purchase a long-term care insurance policy that will pay for qualified long-term care costs. Or you might consider a "hybrid" policy, which combines long-term care protection with life insurance. So, if you never needed long-term care, your hybrid policy would pay a death benefit to your beneficiary, but if you did need the care, your policy would pay benefits toward those expenses.
- Choose an appropriate withdrawal rate. During your retirement, you'll need to withdraw money from your IRA, 401(k) and other retirement accounts. But you'll want to avoid taking out too much each year, especially during the early years of your retirement. It's important to establish an annual withdrawal rate that's appropriate for your needs, taking into account your age, sources of income, lifestyle and other factors.

The Gospel: Part 5 by Jeff Capshaw

Last week's column cited 3 passages from the New Testament which explicitly mention the Gospel for ancient Israel. What they have in common may be unfamiliar to some, but they are significant. The article also noted that how readers understand those texts will depend largely on their view of the relationship between the Old and New Testaments (Galatians 3:8, 1 Corinthians 10:4, and Hebrews 4:1-2).

Last week's article concluded that, although readers may quibble over the interpretation of these passages, it is undeniable that the New Testament says the Old Testament saints had the Gospel preached to them. From Genesis to Revelation, the universal and timeless message is the same; the Gospel of Jesus Christ and no other saves sinners. Even as Acts 4:12 says, "and there is salvation in no one else, for there is no other name under heaven given among men by which we must be saved."

In this week's column, the discussion centers upon Genesis 3:15. Some scholars refer to this passage as the Protevangelium or «the first mention of the Gospel» in the Bible. This is part of a larger context in which the LORD himself announced the consequences of the Fall of Adam and Eve.

Those consequences for Eve are pain in childbirth, desires contrary to her husband's (Adam), and that she would be ruled by him. For Adam, the consequences of the Fall would be a ground cursed with thorns and thistles, hard labor for food, and worst of all, death!

However, for the serpent (the Personal Agent of Sin-Satan), the LORD says, "I will put enmity between you and the woman, and between your offspring and her offspring; he shall bruise your head, and you shall bruise his heel."

It is interesting that the Hebrew text of Genesis 3:15 speaks about the enmity between the serpent and the woman, and between the offspring of both. The personal pronoun (Hebrew-"hu") in the words addressed to the serpent, "he will strike at your head," is masculine. Although one shouldn't make too much of a case for the gender of words (masculine, feminine, neuter), it is significant that the seed to come of the woman would be a man.

Although beyond the scope of this article, one can trace that





"seed of the woman" from Adam and Eve's son, Seth, to Enos and from Enos to Cainan and so on. As a matter of fact, in Luke's Gospel, he does just that (3:23-38). He traces the linage of Jesus from Joseph back to Adam. Therefore, there is nobody else to which Genesis 3:15 could refer other than Jesus the Messiah of Israel. It is the same Jesus who was crucified, died, was buried and rose again the third day according to the Scriptures (1 Corinthians 15:1-4).

Therefore, before the Fall, God already had a plan of redemption in place. The first mention of that plan is found in Genesis 3:15. It too is the Gospel (the Good News)



in the Old Testament.



A court hearing of your case has been scheduled for the 29th day of April, 2020, at 2:30 o'clock p.m., at the JUVENILE COURT OF WALKER COUNTY, Walker County Courthouse, LaFayette, GA 30728.

If you fail to appear, the court can terminate your rights in your absence.

If the court at the trial finds that the facts set out in the petition to terminate parental rights are true and that ermination of your rights will serve the best interests of your child, the court can enter a judgment ending our rights to your child.

The Editor's Inbox...Letters to the Editor

Have you noticed or even missed the Little Courthouse Museum? Most never knew it existed or ever toured to see what is there. Some may think very little or couldn't care less about preserving our local history, our old buildings, and antique artifacts in our town. They may also think it is just too boring. But history is interesting, fun, and exciting. Why our forefathers came here, and how they lived, worked, and played can be intriguing and fascinating to learn about. Stories of how our area of the country was settled are just full of adventure and wild times. How fortunes in this county were made with the fur and lumber trade long before cotton was king. Times change, sometimes for the better, sometimes not. Hardeman County is letting our past, our history, slip away.

We have in Bolivar, a "county owned property" that should be the "Crown Jewel of the County", but here lately, it has not received the attention it so rightly deserves. But first a short history of the building: The Little Courthouse was built almost 200 years ago in 1824 on our Court Square. It is one of only (3) three such log courthouses in America still





standing, and the only one with a jail. Did you know David Crockett gave speeches here, while running for state representative in our courthouse? Our first County Court Clerk, Thomas Hardeman, desk is still there. A few years later, the county grew and needed a newer larger courthouse. In 1827, the log courthouse was sold and moved intact to its location today (215 E. Market St), and a new brick courthouse was built on the same spot where the log courthouse set. The county bought the original old log courthouse building in 1967, until that time the building was used as a doctor's office and a private residence.

The building belongs to the citizens of Hardeman County. APTA was asked to take control and restore the building. For over (50) fifty years APTA has tried to maintain the building and promote it as our Hardeman County museum. We represented the building with our county's history and with artifacts from the beginning of the county through today. The Little Courthouse Museum, collected artifacts through loans and donations, and manned it for tours and special events. The building has not been open for tours since September 2016 due to mold in the building. The mold was due to poor installation of an A/C unit causing the upstairs ceiling to fall and mole take hold inside the building. Since the APTA lease agreement expired two years ago, and the County Mayor will not renew the lease or talk with our Chapter of APTA about the future of the building, we as a Chapter are at a loss. The artifacts in the building are at risk of mole damage, as well as the rest of the building, while it just sits in limbo.

Three years ago, APTA wrote letters personally to each county commissioner, after being turned away from trying to state our problems to the commissioners at the County Commission Meetings held multiple times during the year by the County Mayor. The letters we wrote to each County Commissioner were met without any response from all our commissioners. After another year of being put on the back burner, grants, that could help our cause, go towards water features on the courthouse lawn and other projects, I feel it is up to you, the taxpayers of Hardeman County. We are asking for your support to get things moving again, while there is still time to save our Crown Jewel.

The Hardeman County Chapter of the Association for the Preservation of Tennessee Antiquities (APTA) is a small chapter, with (2) two local properties to maintain. We have spent over \$26,000 in the past few months just on The Pillars (home of settler, John Houston Bills). The repair maintenance at The Pillars is from storm water damage, we attained there last year. We still have more repairs to do at that site. With about 50 members, it is impossible for us to keep all the repairs needed for both properties. We need your support to keep both properties open and in good repair. We are only asking the County to repair the building they own, so APTA can continue to use it to promote Hardeman County's rich history. What can you do? Contact the County Mayor (Phone: (731) 658-3266) and tell him The Little Courthouse needs to be preserved, for our future lies in preserving our past.



County Addresses Coronavirus

County officials met on March 10 to discuss the potential growing threat of the COVID-19 virus, commonly known as coronavirus.

The Tennessee Department of Health has confirmed one additional case of COVID-19 in Middle Tennessee, bringing the

state's total number of confirmed cases to four.

The patient is an adult female in Middle Tennessee. TDH is working closely with local health officials to support the ongoing investigations of COVID-19 cases. The overall risk to the public remains low as CO-VID-19 is not currently widespread in Tennessee or the United States.

Case Management Update

- Effective today, TDH will post COVID-19 updated numbers online by 2 p.m. each day at www.tn.gov/ health/cedep/ncov.html.
- The TDH State Public Health Laboratory is now running COVID-19 testing seven days a week to assist public health authorities and health care workers in identifying cases and treating individuals.
- The Tennessee Department of Health oversees 89 county health departments.

Recommended Precautions

Tennesseans are encouraged to take routine precautions used in guarding against respiratory viruses:

- Wash your hands often with soap and water. Use alcohol-based hand sanitizer if soap and water are not
 - Cover your mouth and nose with a tissue when coughing or sneezing
- Don't touch your eyes, nose or mouth with unwashed hands
- Stay home if you are sick
- Stay away from people who are sick

COVID-19 Symptoms

Most patients with confirmed COVID-19 infection have mild respiratory illness with fever, cough and shortness of breath. A smaller number of patients have severe symptoms requiring hospitalization.

The hearing on February 27, which is scheduled to be continued on March 17, is an attempt to put aside the Consent Order agreement signed on October 8, as Sain's attorney, Amber Griffin Shaw, maintains the procedure for settling the conflict was botched and many points of the agreement were not in the power of the county commission to grant. It is unclear how the two parties would proceed if the October 8 agreement

Shaw also asked for Doolen's attorney fees to be set aside during the February 27 hearing. Roy Herron of Dresden had bills in excess of \$170,000 presented in October, with other work done on the case since then. At the February 27 hearing, Judge Weber McCraw agreed to set the fees aside and take up the issue at a later

In the February 27 hearing, Sain and Cary differed on whether Sain himself had asked Cary to get back involved in the case in October after Cary had resigned in mid-September from his post as County Attorney and the level of involvement Sain had in the settlement talks during the first eight days of October.

That Championship Season: 2010



This season, the Bolivar Bulletin Times will look back at ten years ago, following week by week the 2010 Bolivar Central Tigers State Championship season.

March 8, 2010: Bolivar hosted Trezevant in the sub-state game that would send the winner to Murfreesboro. The defensive struggle between the two clubs saw a 9-8 lead for Trezevant after the first quarter. Bolivar scored their eight points on six free throws and a basket by Kegan Fuller, but Ricky Tisdale took over in the second quarter, scoring nine of Bolivar's 14 points as the Tigers grabbed a 22-17 lead.

The Tiger defense kept the lid shut on Trezevant in the third quarter as well, holding them to only seven points. Trezevant only scored in double figures in the fourth quarter as Bolivar won 50-38. Tisdale led the Tigers with 17, while O'Neal Woods had 10, including hitting 4-4 from the line in the final stanza. Bolivar scored 21 of their 50 from the free throw line, while Trezevant went 5-11. Bolivar was heading to Murfreesboro, but so was Liberty.


