## Prepping for COVID-19

Following directives by Tennessee Governor Bill Lee, Hardeman County closed down schools and other government concerns within the county were threatened as the COVID-19 Virus, known as Coronavirus, became a national story.

After issuing an order to suspend in-person court proceedings across the state, Lee asked for the schools to shutdown statewide as well.

"As the response to COVID-19 evolves, I urge every school district in Tennessee to close as soon as practically possible...we understand the tremendous burden school closure places on families, and we will continue to work with both the federal government and school districts to ensure we continue essential supports like meals for students in need. Every Tennessean has a role to play in preventing the spread of COVID-19 and I urge Tennesseans to be quick to help neighbors as new needs surface with the closure of schools."

### Schools and More Close in Hardeman County

Hardeman County Schools complied almost immediately, closing schools until Monday, April 6.

Across the county, government offices remained open, but the only library remaining open is the Lee Ola Roberts Library in Whiteville, while libraries in Middleton, Bolivar and Grand Junction closed.

"Our library is the only source of services for our people," said Whiteville Mayor Aubrey Phillips. "It is the distribution point of commodities and it's the only place some of our people can use to get the internet."

my Sain said county offices will stay open until it is necessary to close them.

"We would need people in the county to be infected before we would close," he said. "We have a plan in place if that happens."

Sain added that while this is similar to the flu each winter, the county is asking for extra precautions.

"We are asking the public to refrain from attending public gatherings to slow the spread of the virus as it passes through the county," he said.

As of the morning of March 18, the Tennessee Department of Health reported 73 cases, with the nearest case reported in Shelby County. No county bordering Hardeman County has reported a confirmed case.

The City of Bolivar has taken a similar path.

"I would like to communicate to our citizens that we are exercising caution, not panic, in our decision to reduce non-essential services. At this time, the Bolivar Senior Center, Bolivar-Hardeman County Library, Bolivar Municipal Center community room, and the Bolivar Municipal Center gymnasium are all closed to the public," said Mayor Julian McTizic, adding for the time being that all other city services and city administrative offices are open for routine business.

Churches have varied in their responses to the virus.

On March 17, First Baptist Church in Bolivar announced they will not have services March 21 or 28, but that their offices will remain open as will their child-care services.

The First United Methodist Church in Bolivar will also forgo services for the next two weeks, with limited office hours available.

The church of Christ in Middleton is planning to have both Sunday services on March 22.

St. James Church in Bolivar will not be open until further notice, as directed by Bishop Phoebe Roaf of the Diocese of West Tennessee.

Antioch Missionary Baptist Church in Whiteville is considering alternative ways to hold services.

Zion Temple Worship Center in Bolivar had no plans to close at press time, although precautions are being taken to protect attendees.

### Chamber Opens Director Job

The Hardeman County Chamber of Commerce has opened the position for a full-time Executive Director, looking to replace Laura Hall. Hall, departed at the end of February, taking a position with the University of Memphis.

### Election Slate Starting to Fill

With about two weeks left to file petitions for the August elections, two positions on the Hardeman County School Board remain open, while the Whiteville election is growing more crowded by the day.

Vying for three aldermen positions in Whiteville are incumbents William Charles Phillips, Emily M. Rosson, and Tommy L. Turner along with Deborah A. Burkeen, Ernest L. Pirtle, and Betsy L. Johnson. The mayor's race is also popular, with incumbent Aubrey Phillips facing Gene A. Bowden and Hulon L. Crisp.

The Hardeman County School Board's three spots in play this election cycle have only one candidate as of March 18, with only Jerry Crisp turning in his petition for District 3, Position 1 while the other two spots remain unfilled.

Unclaimed so far include the District 3, Position 3 seat held by Terry King and the District 2, Position 2 spot held by Beverly Bodiford.

Also running in August is Russell DeBerry for the Hardeman County Commission District 7, Position 1. DeBerry, who is running unopposed, was appointed in November, replacing Bobby Doyle, who resigned in order to focus on his position as the Hardeman County Director of Schools. Also on the ballot is Assessor of Property Josh Pulse, running unopposed.

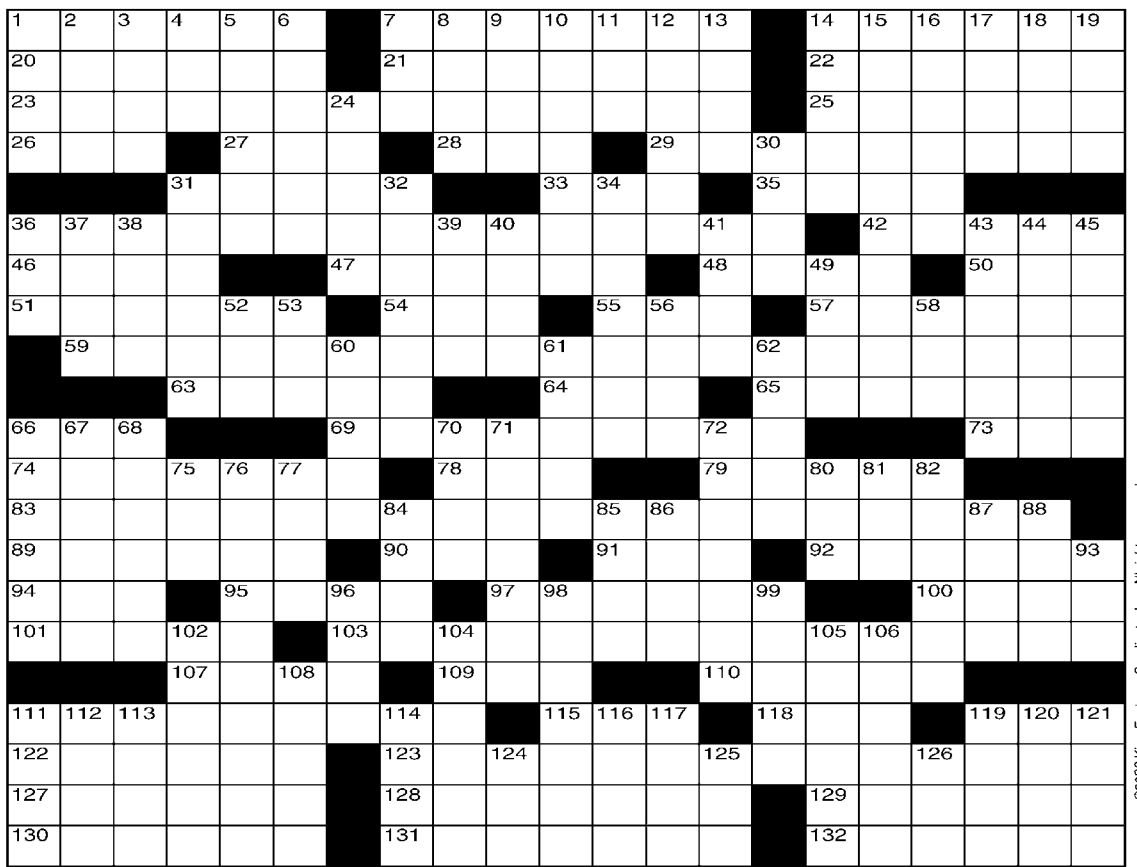

## Lasagna Rollups

### Ingredients

- 1 (28-ounce) jar spaghetti sauce, divided
- 1 (2-pound) container ricotta cheese
- 2 cups mozzarella cheese, divided
- 1/3 cup grated Parmesan cheese
- 3 eggs
- 1 tablespoon chopped fresh parsley
- 1 teaspoon salt
- 12 to 14 lasagna noodles, prepared according to package directions

### Directions

Preheat oven to 375 degrees F. Pour half the spaghetti sauce over the bottom of a 9- x 13-inch baking dish. In a large bowl, combine ricotta cheese, 1 cup mozzarella cheese, the Parmesan cheese, eggs, parsley, and salt until well blended. Spoon cheese mixture over lasagna noodles, distributing evenly, and roll up tightly. Place rollups seam-side down in prepared baking dish; top with remaining sauce. Sprinkle with remaining mozzarella cheese. Bake 35 to 40 minutes, or until heated through.

**Don't Let Fears Drive Your Investment Choices**

First, the coronavirus rocked the financial markets. Then, oil prices dropped more than 20 percent after a breakdown in OPEC production discussions. Not surprisingly, the markets took another nosedive. Yet, despite these events, this recent market volatility may well be attributed more to fear than the forces that usually drive the markets. And the large decline in interest rates will make home purchases and mortgage refinancing even more attractive – again, positive moves for the economy.

We've been here before. From the time the markets bottomed out in early 2009 until just a few weeks ago, stock prices climbed about 300 percent. Yet, during that time, we also saw three separate market drops of more than 15 percent, similar to what we're seeing now. These market corrections always feel unsettling, but it's important to recognize that they are actually a normal part of the log-term investing process.

So, given these factors, how should you respond to the current situation? Instead of simply selling your stocks in an attempt to cut your losses, review your portfolio to see if it is properly balanced between stocks, bonds and other investments in a way that reflects your goals, time horizon and risk tolerance. Those investors with properly balanced portfolios are not seeing the same level of decline as those whose holdings are almost entirely in stocks. And while diversification can't guarantee profits or protect against all losses, it can help reduce the impact of volatility.

Here's another suggestion: Look for good buying opportunities, because they are certainly out there. A well-managed company with a solid business plan that produces quality products and services is going to be that same company after the coronavirus and oil price panics subside – and right now, that company's stock shares may literally be "on sale."

While it's not easy for you to look at your investment statements today, remember that you're investing for goals that may be decades away. By keeping your eyes on this distant horizon, so to speak, you'll be less likely to over-react to the news of the day – and more likely to follow a long-term strategy that can work for you.

## The Crisis and the Christian

In the past few days, the United States has experienced near unprecedented events. The Corona Virus pandemic is afoot and has significantly altered the lives of millions of Americans. The unanimous opinion of most experts is that things will get worse before they get better. There are even worst-case scenarios which predict possibly millions of Americans becoming infected with thousands losing their lives. The novel nature of this virus makes it difficult to predict.

So, how then should believers think in light of this pandemic? I certainly am not a medical expert, but those who are urge us all to exercise common sense. Follow the drills of hand washing, social distancing, covering coughs and sneezes, and listen to the medical authorities.

From a Christian Worldview perspective, we must embrace the fact that we live in a fallen world. The Hebrew words *adam* (man) and *adamah* (ground) are closely related and show the related consequences of Adam's disobedience on the ground from which he was taken (Genesis 2:7, 3:17). The ground (*adamah*) that was destroyed in the days of Noah is the same ground that God said He would not curse again (Genesis 8:21)" [<https://answersingenesis.org/blogs/simon-turpin/2016/06/27/five-effects-of-the-fall-in-genesis-3/>].

In the midst of the curse on the environment, there was the promise from the Lord (as indicated last week) of a "curse-reverser," and the promise warrants repeating here. He said, "I will put enmity between you and the woman and between your offspring and her offspring; he

There is a promise of reversing that curse and, tacitly within that promise, is the promise of a completely renewed creation. Paul explicitly spells this out in Romans. "For the creation waits with eager longing for the revealing of the sons of God. For the creation was subjected to futility, not willingly, but because of him who subjected it, in hope that the creation itself will be set free from its bondage to corruption and obtain the freedom of the glory of the children of God. For we know that the whole creation has been groaning together in the pains of childbirth until now" (8:19-22).

Regardless of what befalls us and our environment in the future, just remember that isn't the last word. Jesus has the last word. "And he who was seated on the throne said, 'Behold, I am making all things new'" (Revelation 21:5).

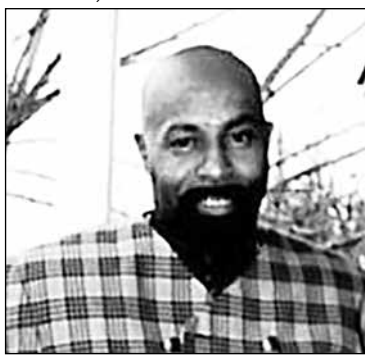

**NOTICE OF EFFECT OF TERMINATION JUDGMENT:** Georgia law provides that you can permanently lose your rights as a parent. A petition to terminate parental rights has been filed requesting the court to terminate your parental rights to your child. A court hearing of your case has been scheduled for the 29th day of April, 2020, at 2:30 o'clock p.m., at the JUVENILE COURT OF WALKER COUNTY, Walker County Courthouse, LaFayette, GA 30728.

If you fail to appear, the court can terminate your rights in your absence.

If the court at the trial finds that the facts set out in the petition to terminate parental rights are true and that termination of your rights will serve the best interests of your child, the court can enter a judgment ending your rights to your child.

If the judgment terminates your parental rights, you will no longer have any rights to your child. This means that you will not have the right to visit, contact, or have custody of your child or make any decisions affecting your child or your child's earnings or property. Whether or not you decide to hire an attorney, you have the right to attend the hearing of your case, to call witnesses on your behalf, and to question those witnesses brought against you.

## That Championship Season: 2010

*This season, the Bolivar Bulletin Times will look back at ten years ago, following week by week the 2010 Bolivar Central Tigers State Championship season.*

**March 17, 2010:** Bolivar began their state tournament run in Murfreesboro with the last team to beat them in the glass house as the Tigers drew Knoxville Fulton. The grind saw the Tigers get out to a 16-9 lead at the end of one, but lead by only three at the half and gave back even more to have a tie game at 30 with one quarter left. Fulton led 35-32 with 5:50 remaining. They never scored again.

After a free throw from Jay Murphy, Kegan Fuller hit a three pointer with 4:26 left to give the Tigers the lead at 36-35. Fulton turned the ball over with 3:54 left and didn't see it again until 1:09 remained. But Fulton's Jalen Steele, who beat the Tigers the year before at the buzzer, turned the ball over with five second left, sealing the Tigers' 38-35 win. Tevin Coleman was the only double figure scorer for Bolivar with 12 points and led the Tigers with nine rebounds.

**March 19, 2010:** Bolivar's 64-58 overtime win over Marshall



County saw them make up a seven point deficit in the final quarter as the Tigers managed to foul out Marshall County's two leading scorers and one other player in the overtime period as the Tigers outscored their opponents 14-8, making 12-16 from the free throw line. Jay Murphy led Bolivar with 25 points, while Ricky Tisdale had 20 and O'Neal Woods had 10.

**March 20, 2010:** Liberty. Again. The Tigers had beaten them three times already during the season, twice in the playoffs, but had to do it one more time for the gold ball. Kooper Kessler got the Tigers

out to a fast start with three three-pointers in the first quarter and 11 points as the Tigers led 17-14. Jay Murphy then took over, scoring 24 points on the night, including 11-12 from the free throw line to claim MVP honors. The Tigers shot 27-37 from the line while Liberty only made 10 of 21.

Three Liberty starters fouled out of the game, making a total of seven players that fouled out versus the Tigers in the three tournament games in Murfreesboro. The Tigers shot 84 free throw versus 48 for their opponents in the tournament.
