## Mayor vs. Councilman in Bolivar

Bolivar Mayor Barrett Stevens will seek his third term while councilman Julian McTizic hopes to become the youngest Bolivar Mayor in history.

Stevens, who is a native of Bolivar, defeated Brenda Woods, Willie McKinnie, and Ken Kowen in 2009 and beat Woods in a two-way race in 2013.

McTizic, 30, who is finishing his first term as a Bolivar City Councilman, is a life-long Hardeman County resident as well.

The city council will have some new faces as well as Page Walley is the lone candidate running for the Bolivar District B, Position 4 slot currently held by Randy Hill, who did not run after two terms in office. Walley, who was a Tennessee State Representative from 1990-2000, is running for a municipal spot for the first time in his career.

One of the three city council positions that have multiple candidates is District A, Position 4, currently held by Willie McKinnie. McKinnie, who ran an unsuccessful campaign for mayor in 2009 is seeking his second term as a city councilman. He defeated Eric Hill in 2013. Also a candidate for District A, Position 4, is Jonathan Joy, who unsuccessfully ran for city council in 2005 and 2009, losing in 2009 to Teresa Golden in a three-way race involving Laurie Miller. The third candidate for the spot is Raven Taylor, who is seeking city office for the first time.

The District B, Position 2 spot has four candidates: Suzanne Rhea, who is running for the first time after being appointed in April 2015 after the death of her spouse, David; Jimmy Howell, who ran in 2005, losing to Milton Basden; and

newcomers Bethany Miller and Paul Fuller.

Running for District A, Position 3, held by McTizic, is Melvin Golden. McTizic is not prohibited from running concurrently for city council and mayor in the same election year, but McTizic will only run for mayor. Also running for that slot is Mauricio Beauregard.

Early voting is scheduled for April 26-May 11. Election Day is May 16. The last day to register to vote in the 2017 Bolivar City Elec-

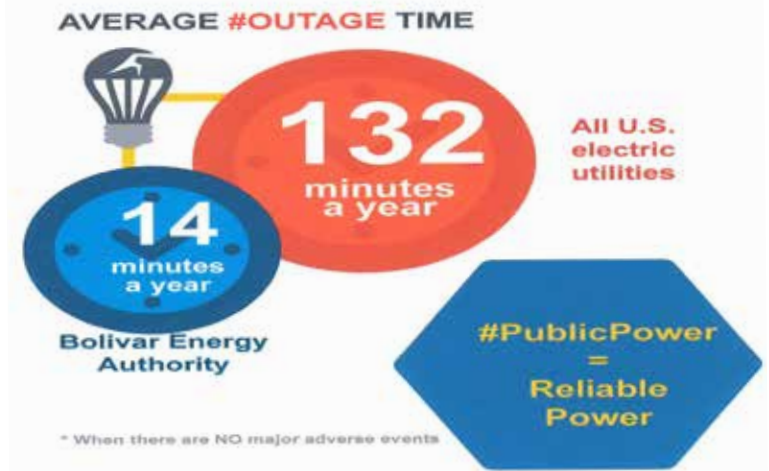
tion is April 16, 2017.

WMOB Radio, WOJG Radio, and the *Bolivar Bulletin Times* will join together to bring the 2017 City of Bolivar Candidates Debate on April 25, 2017 at the Bolivar Municipal Center.

The 2013 Bolivar City Elections saw Barrett Stevens defeat Brenda Woods 791-645, gaining 55% of the vote.

Bolivar is the only municipality in Hardeman County that does not hold its elections in federal election years.

# OUR COUNTY

## Hardeman County Remembered by Lisa Coleman

The first settlement in what would come to be known as Pocahontas came about as part of a bequest from Dr. William H. Fleming who willed to Thomas, John, and Douglas Rivers land that was located at the forks of the Tusculum and Hatchie Rivers, for the purpose of building a town. The town was first located on a bluff site near the Hatchie and was known as Ray's Bluff. Farming and logging were the two big industries in Ray's Bluff, along with a blacksmith shop and a general store. When the stagecoach line was established, it missed the river settlement by about three miles and a community known as Matamora Hill became home to the stage line, a hotel, and a number of homes.

When the first Memphis-Charles Railroad train tracks came through the area, many residents moved closer to the rail line and the town of Pocahontas was established and named (I've always been told) after the Native American princess. Matamora Hill and a site known as Davis Bridge saw fighting during a Civil War battle there on October 5, 1862. Today Davis Bridge and Matamora Hill are part of the Shiloh National Military Park, giving us our very own National Park in our county. Many Civil War historians and experts (including the Civil War Trust) call this area one of the most pristine battle sites in the country; the area remains today much as it did on that long ago October afternoon.

The town and the people began to rebuild their lives and communities after the war years and Pocahontas boasted a number of



businesses including dry goods, grocers, cabinet makers, buggy and wagon makers, and a host of others. The town endured another disaster in February of 1871 when a tornado destroyed most of the businesses and churches. By 1888 the little community was thriving as a railroad stop and as a center of logging industry in the area. Logs would be marked with each logging camp's mark and then would be floated down the Hatchie River to the mills. Milled logs and finished lumber could be easily loaded on rail cars that passed through, taking good Hardeman County lumber all across the country.

The Leah Institute was a popular girls' finishing school, located in a magnificent 2-story, red brick building that still stands in town today (the Joyner-Carr house), by the railroad tracks. Young ladies came from all over West Tennessee and North Mississippi to learn the art, manners, customs, and responsibilities of being a young lady of the time. One student gives the school and the county

a connection to former President Bill Clinton; his great-grandmother, Frances Ellen Hines Blythe, attended school there in 1873 and 1874.

This photo, from about 1910, shows the train depot and the enormous rail yard located in Pocahontas. The photo was taken by a lifelong Pocahontas resident and its local photographer, Miss Henryetta Campbell. The photograph made its way to me when I had the great blessing of making the acquaintance of a couple of dear ladies in Pocahontas, Mrs. Esta Lee Lamberth and Mrs. Josephine McGee.

Next time you are going that way, turn off of Highway 57 and visit the markers at Hardeman County's national park at the Davis Bridge site and at Matamora Hill. Go to town and listen for the sound of the train in the distance, and remember all the fine folks who made their homes and lives along this stretch of the railroad. See y'all on the next stop of our virtual train trip around our county.

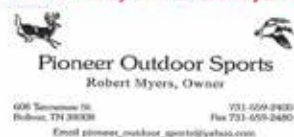

I've just been chatting with my dear friend and former professor of youth ministry, Michael Holt. The years have shown God's enduring blessing to both of us. The years have also thrown Mike Tyson style punches at the both of us. What is left after the two of those truths collide is reality.

Michael delivered a series of talks as a youth pastor and conference speaker that resonated with countless people. Using the wonderful children's book, "The Velveteen Rabbit" as his main illustration for his four part series, he talked about what it meant to become real. Authenticity and genuineness tend to require a lot of chopping away at things we pretend to be. Our spiritual walks gets tougher in some ways but clearer at the same time. Only after we have thrown ourselves at the mercy of Christ over a lifetime do we experience what we now have. We have, in a sense, become more real.

Time has a way of showing us our true strengths, our utter weaknesses and the cracks in our character. Our world views begin to solidify and the consequences of our actions and beliefs take a well-defined shape. The neces-

sity of our dependence on God is deeply understood. Our fallen nature has been revealed enough times to actually give us a grasp of how needy we are. We have become real, real wrecks physically and real redemptions spiritually. The inverted arc of success has us coming back to the place we naively embraced as younger men, our cry for Jesus to save us. The simplicity of that plea has never been more vital to us.

I am not questioning the reality of the Christian faith in the sense of it becoming more real. To be born again into the family of God is a reality that sometimes escapes notice. Becoming a Christian is the first step toward authenticity. We were created by God for His glory, and to become real means to embrace that reality from the start. There is no replacement, however, for a faith that has been time-tested, battle-hardened and refined by the fires of hardship. It is not that we are more Christian, but we are more confident that the truths we embraced were both necessary and vital.

This I would suspect brought up memories of losing his mother when he was nine as this was the second significant woman in his life to depart his life through death. He was defeated for a run for Illinois House Speaker in 1838. Only one of his four sons lives past 18 years of age. Defeated for run for nomination for U.S. Congress in 1843. He was rejected for land officer position in 1849. He was defeated for run for U.S. Senate in 1854. He was defeated for run for nomination for Vice President in 1856. 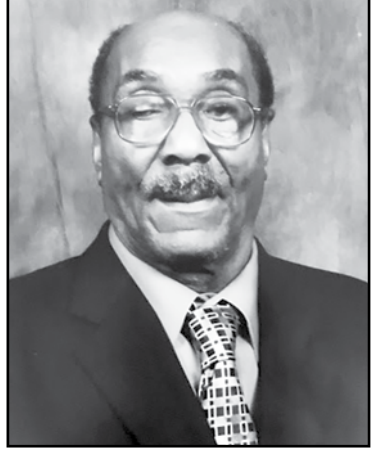
On March 17, 2017, Mr. Benjamin F. Avent, Sr. departed this life at Pine Meadows leaving behind his precious family.

## Bacon Wrapped Meatloaf

**Ingredients**

- 1 tablespoon olive oil
- 1 onion, grated on large holes of a box grater
- 1 garlic clove, finely chopped
- ¼ cup ketchup
- ¼ cup apple cider vinegar
- 3 tablespoons dark brown sugar
- ¼ teaspoon cayenne pepper
- ¼ cup low-sodium chicken broth
- ½ cup chopped fresh parsley
- 2 large eggs
- ⅔ cup fine breadcrumbs
- ½ cup finely grated Parmesan
- 1 tablespoon kosher salt
- ¼ teaspoon freshly ground black pepper
- 2 pounds ground beef chuck (15% fat)
- 6 thin strips bacon

**Directions**

Preheat oven to 350°. Line a rimmed baking sheet with foil, then parchment paper. Heat oil over medium in a small skillet. Cook onion and garlic, stirring occasionally, until very soft, about 4 minutes. Transfer to a large bowl. Meanwhile, bring ketchup, vinegar, brown sugar, and cayenne to a boil in a small saucepan, reduce heat, and simmer, stirring occasionally, until slightly reduced and syrupy, about 5 minutes. Transfer 2 tablespoons ketchup mixture to a blender; add broth and parsley and blend until smooth. Set remaining ketchup mixture aside. Add broth mixture, eggs, breadcrumbs, Parmesan, salt, and pepper to onion and garlic; mix to combine. Add beef and mix well with your hands to combine. Transfer meatloaf mixture to prepared pan and form into a long log (about 12"x5"), smoothing surface. Spread reserved ketchup mixture over top and drape bacon in a crisscross pattern over loaf, tucking underneath. Bake until an instant-read thermometer inserted into the center registers 165° and bacon is crisp, 70-80 minutes. Let rest 10 minutes before slicing.

## SWTDD Offers USDA Rural Loans

Southwest Tennessee Development District has partnered with USDA Rural Development to offer grants/504 loans to Bolivar residents who are unable to finance necessary home repairs through other sources.

USDA rural housing programs are available to qualified applicants in eligible "rural areas" under the agency's unique statutory definition of "rural." As defined by the USDA website, "A rural area is open country which is not part of, or associated with an urban area; has a population not in excess of 10,000, if it is rural in character; or has a population in excess of 10,000 but not in excess of 25,000 outside Metropolitan Statistical Areas, and has a serious lack of mortgage credit for low-and moderate- income households." Bolivar meets the criteria to apply for Rural Development home loans as well as 504 loans/grants for home repairs.

In order to qualify for a 504 Loan, an applicant must meet the following criteria: you must be the homeowner and occupy the house, lack sufficient resources or income to make the repairs or to obtain affordable credit elsewhere, have a family income below 50 percent of the area median income, have sufficient income to repay the loan at a 1% fixed interest rate over 20 years, be a U.S. citizen, have the legal capacity to incur obligations or have a court appointed guardian conservator who is empowered to obligate the applicant in real estate matters, and have a credit history that indicates a reasonable ability and willingness to pay debts when due.

When an elderly applicant has income so low as to be only able to repay a portion of the amount needed for repairs and improvements, a grant may be used for the balance. A total grant may be provided to an elderly applicant whose income is so low as to have no Section 504 repayment ability.

Section 504 Loan funds may be used to pay the cost of repairs and improvements (including weatherization) such as: repair or replacement of roofs; energy conservation improvements, such as insulation, caulking, storm windows and doors, etc.; installation of wood burning stoves that meet development standards; repair or provision of structural supports, and replacement of severely deteriorating siding when it constitutes a health or safety hazard; addition of a room to an existing dwelling; provision or repair of sanitary water and waste disposal systems; reasonable connection fees or prorated installation costs

## Bolivar FD Completes Training Course

Members of the Bolivar Fire Department completed Advanced Extrication training on April 8, 2017. The 40-hour training course was provided by the Hardeman County Rescue Squad through the Tennessee Association of Rescue Squads.

Vehicle extrication is the process of removing a vehicle from around a person who has been involved in a motor vehicle accident, when conventional means of exit are impossible or inadvisable. A delicate approach is needed to minimize injury to the victim and those rescuing, during the extrication.

Basic extrication processes consist of essential steps to ensure the best likelihood of survival for the victim. Once arriving on scene and assessing damages, a medically trained person enters the cabin to perform first aid on the casualty: mid-level assessments, stops any bleeding if possible, puts a cervical collar on the patient (extrication operations are likely to provoke vibrations), and provides oxygen first aid help to ensure a more successful outcome for the victim. As soon as access is gained to the patient, the next step is to secure the vehicle to prevent the unexpected movement, and the movements of the suspension, either of which could cause an unstable trauma wound or cause injury to the rescuers. A vehicle should never be moved, it should always be secured on location. After the conveyance has been secured and access gained to the victim/s, the EMS team then enters to perform more detailed medical care. Continuous protection of the patient from the extrication itself, using hard and soft protection is done at all times. The deformation of the structure and cutting a section of the roof/doors can take several minutes; this pre-extrication time can be used for medical or paramedical acts such as intubation or placing an intravenous drip. When the roof or door has successfully been removed, it's now time to focus on safe removal of the accident victim, especially respecting the head-neck-back axis rectitude of the spine. The last step is usually performed with a long spine board: the casualty is pulled up on it while an extrication splint (KED) can help to immobilize the spine during this operation.



for utilities, which cannot be paid from other funds; electrical wiring; necessary repairs to mobile homes including placing the mobile home on a permanent foundation; payment of fees and expenses incidental to making plans and obtaining the loan, such as legal and architectural fees, and similar purposes; repair or remodeling to make homes accessible and useable for handicapped or disabled persons; application packaging fees for private or public nonprofit organizations; establishment of escrow accounts for taxes and insurance, including flood insurance. Grant funds may only be used to pay for repairs and improvements resulting in removal of identified health and/or safety hazards or to repair or remodel dwellings to make them accessible and useable for household members with disabilities.

Section 504 Loans and Grants may NOT be used to: assist in the construction of new dwellings; make repairs to a dwelling of such poor condition and quality that, when the repairs are completed, the dwelling would probably continue to be a substantial hazard to the health and safety of the family; provide grant assistance (lifetime) exceeding \$7500; make a loan exceeding \$20,000; make a loan or combination loan and grant exceeding \$27,500, make grants to applicants under 62 years of age; pay for off-site improvements except those involving fees and costs for utility connections; refinance debts or obligations other than those involving fees and costs for utility connections; purchase or install equipment (range, refrigerator, etc.); pay packaging fees to a for-profit entity; site preparation (grading, seeding, foundation planting, etc.); construct a deck; install a driveway; or for landscaping.

Provide CERTIFIED PROOF of U.S. Citizenship or Lawful Permanent Residency (no photocopies). Submit fully completed application at any full-service Driver License Service Center location. Applicant is required to present a photo ID to the department at the time of filing the application. Pay non-refundable application fee payable by cash, certified check, or money order. When the application is processed at the driver services center, the applicant will be given instructions on being fingerprinted.

Last week the non-partisan private act bill failed to pass in the state legislature. This act would have banned both political parties from having partisan primary elections or caucuses in Hardeman County, prohibited candidates from publicly declaring party affiliation, and kept the parties from promoting candidates. The legislature acted appropriately, and here's why. Private acts are discriminatory since they are "special laws" that treat one group/county differently from others. They are inappropriate when there is a general law that applies to the situation. It's not that the state thinks we are "too dumb to govern"; it is a matter of abiding by existing law that applies to all counties.

That law states that county political parties may nominate candidates by primary or caucus or candidates can opt to run as independents. Every election cycle the local election commission asks the parties to declare how they will choose their candidates. In Hardeman County, the Democratic Party asks members/potential candidates who attend our meetings (which are open to all Democrats) what they want to do. Without exception, they always opt for a primary because they want the voters to choose the best Democrat to run in the general. The Republican Party has a similar process although they seldom run a candidate. However, they also reserve the right to do so if they choose.

If the county legislative body feels the established law isn't working, they should express their concerns with the chairs of both political parties and with the voters in order to work out a solution--not send a resolution to the legislature to pass a private act to circumvent the law. They must "respect the process".

I can think of only one reason why 11 commissioners and the county mayor would want to FORCE everybody to run non-partisan. HCDP now has a "primary board", their only function to determine candidates running as Democrats ARE bona fide Democrats. Baseline criteria is that they have voted Democrat in 3 of the last 5 state/national primaries. Are there former "Democratic" candidates who would not meet that standard now?

*A private act is either lawful or against the law. And from all the information we have gathered, it is not against the law for Hardeman County to do away with partisan elections. Other counties have done it, such as Fayette County, in recent years. They may do it by agreement, but it does not violate law. So a law would be completely appropriate.*

*When the state legislature feels a vote of 11-5 isn't good enough for them, yes, they are saying we are "too dumb to govern" or don't know what we are doing. They refused to honor our legislative decisions. They didn't respect our commission.*

*As far as the creation of a primary board, I ask that the HCDP exercise caution as it will only serve to narrow and (to use a favorite term of the Democratic Party) DISENFRANCHISE voters in Hardeman County by selecting candidates prior to primaries. At least before, anyone could run. What the HCDP proposes could give very few people power normally reserved for the many. And your last paragraph about "Bona Fide Democrats" says to me that your party cares more about someone kissing the HCDP ring than about which candidates will do the best job for Hardeman County.*

*As a side note, I'm fairly certain the HCDP already knows who meets the made-up standards of a "Bona Fide Democrat." Hence, the requirement, that will, according to my research, only disqualify ONE current democratic party officeholder who has plans to run. Hmmm...*

*The National Primary proved this. The Democratic Party picked Hillary Clinton. I believe if they had let the PEOPLE in the democratic primaries choose, Bernie Sanders would be President of the United States. It's a warning of what might happen if the HCDP considers a plan to "select" candidates for office in Hardeman County. You might pick an unelectable candidate. (I voted for Gordie, by the way.)*

*I'm not a Democrat, I'm not a Republican. I don't care what the Hardeman County Commission chooses. But what I want is for them to decide it with the help and input of their constituents, not a bunch of lobbyists and Nashville elitists. And they did. 11-5.*

*To undo an 11-5 vote is, plainly put, tyranny. When the unaccountable govern against the wishes of many, that's tyranny.*

*If you want 11-5 to change, don't call Nashville. Run for office. Put forth ideas that will help Hardeman County go forward. We can always use the help of someone that wants Hardeman County to win. And I ask, who do you want to win? The Democrats? Or Hardeman County?*

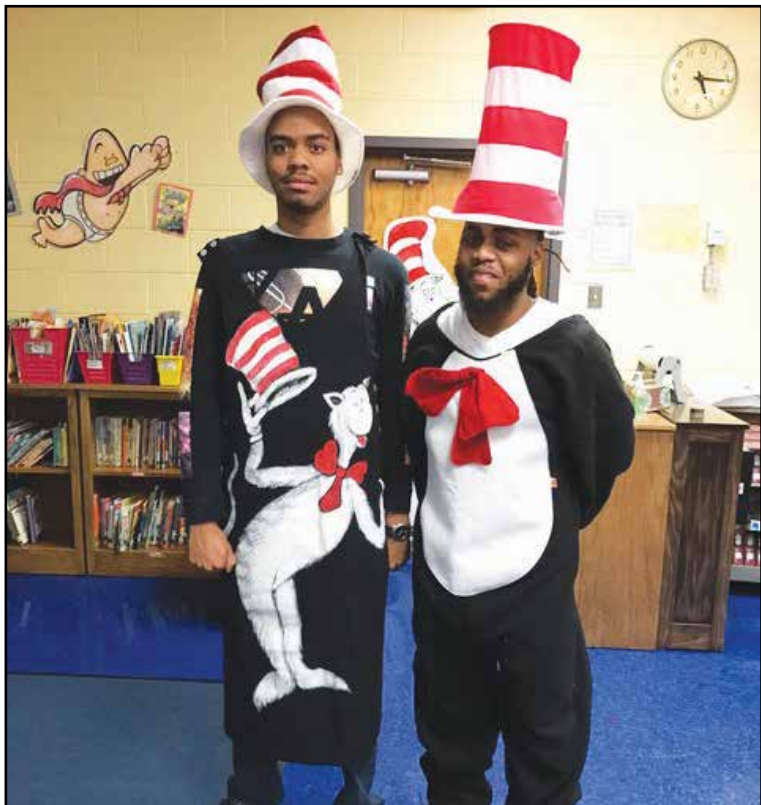
# OUR SCHOOLS

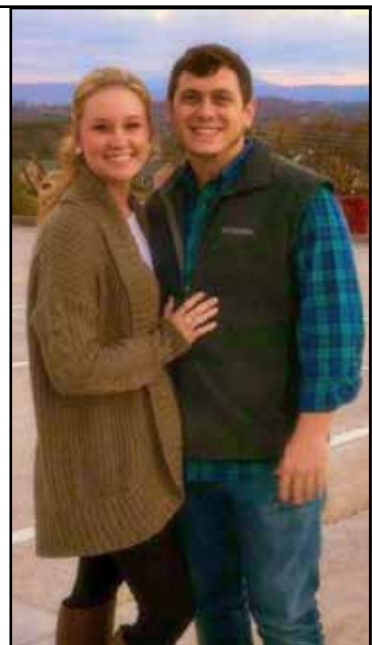

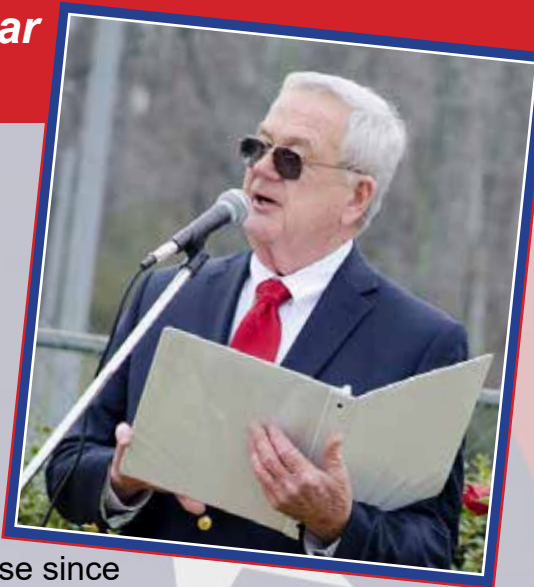
