County Keeps Pulse, Gresham and Shaw

With one exception, incumbents enjoyed election night in Hardeman County as voters chose to keep their leaders for another term.

Incumbent Josh Pulse defeated challenger John Vickers for Assessor of Property, with Pulse gaining 69% of the vote by winning 12 of 13 precincts. The only precinct Pulse did not win was Lacy, which went 75-58 in favor of Vickers.

The Hardeman County Commission will have a new face as Johnny Weems won the District 2, Position 2 race, beating Gary Barber and Winfred Ray.

Weems will assume the unexpired term of Donald McTizic, who resigned in January.

The other county commission spot up for grabs was already in the hands of incumbent Connie Young,

who ran unopposed for the District 4, Position 1 slot.

Voters in five precincts selected Matt Knight as the District 3 Road Supervisor. Knight won four of the five precincts, losing only in Whiteville by a 109-107 margin.

The Hardeman County School Board re-elected three incumbents, as Beverly A. Bodiford, District 2, Position 2) Jerry Crisp, District 3, Position 1, and Terry King, District 3, Position 3, ran unopposed.

The only incumbent to lose was Whiteville Mayor James Bellar, who fell to Aubry Phillips. (see below right).

Meanwhile, the Town of Whiteville sent three incumbents back to city hall as William Charles Phillips (127 votes), Emily Moore Rosson (124 votes) and Tommy L.

Turner (193 votes) all reclaimed their spots over challengers Dorinda Keeling (51 votes) and Susan G. Melton-Piper (62 votes).

For Tennessee Congress, both Senator Dolores Gresham and Representative Johnny Shaw won primary challenges, while the 94th District in the Tennessee House of Representatives will have a race in November to determine the winner after contested primaries.

State Senator Dolores Gresham won a close race with Bob Shutt, winning 53% of the vote in Republican Primary in the 26th District.

State Representative Johnny Shaw easily defeated Ernest Brooks II in the Democratic Primary in the 80th District with 72% of the vote, including winning Hardeman County with a staggering

88% of the vote.

There are no candidates that will oppose either Shaw or Gresham in November.

The open seat in the 94th District will have Ron M. Gant facing Daniel M. Harris in November. Gant received 68% of 7,888 votes cast in the Republican Primary while Harris got 54% of the 1,787 votes cast in the Democratic Primary.

The results are unofficial until certified by the Hardeman County Election Commission. They plan to certify the election results on August 15, at 5:00 p.m. at the Hardeman County Election Commission office located at 106 S. Porter Street in Bolivar.

TSPMA continues to serve maintenance supervisors by offering training and guidance to keep schools moving forward and to better serve the children and educators of the state of Tennessee.

Randy will be recognized by the Board of Education at the August board meeting, scheduled for August 18.

Bellar Loses Election; Resigns Post

With the voters of Whiteville choosing Aubrey Phillips as their new mayor on August 4, incumbent James Bellar tendered his resignation on August 5 to city hall.

The duties of the Town of Whiteville will be administered by Vice-Mayor Richard Hamilton until the election results are certified by the Hardeman County Election Commission and Phillips can be sworn-in.

Phillips' total of 122 votes was good enough to give him the victory over Bellar, who had 81 and Leon Crisp, who received 80 votes.

Bellar was Mayor of Whiteville for 22 years, taking over from Jack Cooper.

His time in office included becoming part of a national story over the town's fight to keep a Christian cross atop the Whiteville elevated water tower from 2011-2012.

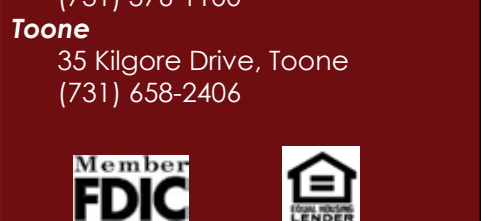

Pinson Mounds Comes to Whiteville Library

As summer break comes to an end and Monday morning starts a new school year, the Lee Ola Roberts Library in Whiteville had their last guest on last Thursday. On Thursday afternoon, right after lunch, 14 kids and five adults gathered around the picnic tables to hear the presenter. The presenter was Amanda Gurganus, a Park Ranger with Pinson Mounds. Although she didn't bring any animals, the other things she brought told history.

Gurganus brought replications of artifacts that were used in the time before electronics or even cars! The replications were objects that older civilizations used to survive. For instance, the kids learned that a deer antler could be used for many different reasons like a knife. Gurganus talked about a technique called flintknapping. Flintknapping is what is used when you want to make a rock into a certain



shape. She talked about how a deer shoulder bone would be used as a shovel or even spoon. She brought out a chunky stone made from sandstone and explained that older civilizations would use it in a game involving spears. As she finished, she laid all the objects out for the kids to observe. Towards the end,

she read a book to the kids called *The Book With No Pictures*. Later on, the kids received a snack. Even though the summer food program at Whiteville's library ended, there are still plenty of opportunities to take advantage of. The library has resources for ACT prep, computers, and much more.

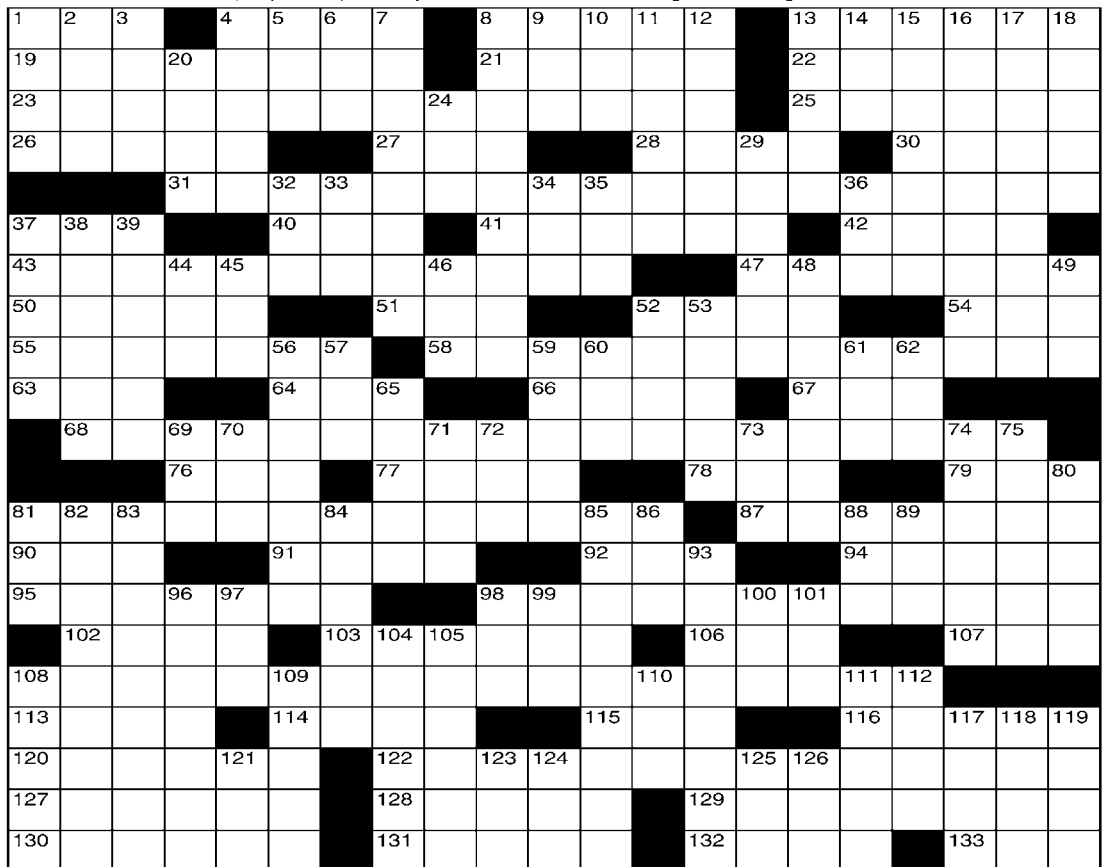

Somewhat Easy (depending on who you are) Ice Cream Sandwiches

- Ingredients**
- 1 pint vanilla ice cream or frozen yogurt
 - 1 1/2 cups fresh strawberries or peaches, chopped (optional)
 - 1/3 cup butter, softened
 - 1/3 cup granulated sugar
 - 1/4 cup packed dark brown sugar
 - 1 1/2 teaspoons unsweetened cocoa powder
 - 1/4 teaspoon baking powder
 - 1 egg
 - 1/2 teaspoon vanilla
 - 1 1/2 ounces unsweetened chocolate, melted and cooled slightly
 - 1 1/3 cups all-purpose flour
 - Purchased colored granulated sugar or white non pariels (optional)
- Directions**
1. Let ice cream or frozen yogurt stand for 15 minutes to soften. Stir in fresh chopped fruit, if using. Spread mixture evenly in a 15x10x1-inch baking pan. Cover and freeze until firm.
 2. Preheat oven to 350 degree F. Beat butter in a large mixing bowl with an electric mixer on high speed for 30 seconds. Beat in granulated sugar, brown sugar, unsweetened cocoa powder, and baking powder until just combined. Beat in egg and vanilla until combined. Stir in melted chocolate. Beat in as much of the flour as you can with the mixer. Stir in any remaining flour.
 3. Divide dough in half. Roll each portion of dough out on a lightly floured surface to 1/8-inch thickness. Cut with a 3-1/2-inch decorative cookie cutter. Cut out centers with a 3/4-inch decorative cookie cutter, if desired. Reroll any dough scraps. You should have a total of sixteen 3-1/2-inch cookies. Place cutouts on ungreased baking sheets.
 4. Brush cookie tops with water and sprinkle with colored granulated sugar, if desired. Bake for 8 to 10 minutes or until edges are firm. Cool on cookie sheet for 1 minute. Transfer cookies to wire racks to cool completely.
 5. To assemble, let ice cream or frozen yogurt stand for 5 minutes to slightly soften. Cut with the same 3-1/2-inch cookie cutter used for the cookies (will have 8 cutouts). Set out 8 of the cookies with the "wrong" side up. Place an ice cream cutout on top of each cookie. Top with a second cookie, pressing slightly to seal to ice cream.
 6. Wrap each ice cream sandwich individually in plastic wrap; freeze at least 2 hours. Let stand at room temperature for 5 minutes before serving. Freeze for up to 1 month. Makes 8 sandwiches.



For an easier method, do not spread ice cream in pan. Refreeze after stirring in fruit until firm yet spreadable. Spread about 3 tablespoons of the ice cream on half the cookies and top with remaining cookies. Press together.

Remember the Fish

I hate going to the store and getting distracted long enough to forget what I went for. That's probably why I am always seeing people's scribbled shopping lists on the ground in store parking lots. It can be annoying or in the case of forgetting something more important, like picking up a prescription, it can be harmful. For the most part, though, forgetting something on a list, fish, for instance, you just end up adapting your meal. Old Bay seasoning doesn't go quite as well with chicken, however, so let it be a reminder! When we forget important things, those that defy a list, then you run into trouble. You forget the speed limit, a stop sign or a dose of insulin, and there could be serious consequences. Still worse, there is an active form of forgetting, where we distract ourselves long enough to repress thoughts of someone or somewhere else. When that someone is God, there is no greater tragedy.

Jesus warned in a very picturesque way not to become simply dismissive and flippant in our faith. He preferred us to be hot or cold, to not fall in the middle of lackluster belief. When we forget God in our daily affairs or actively push the Spirit of God aside long enough to feel okay about our sin, we are open to all sorts of evil,

even as believers. That kind of faith is spat out on the ground of spiritual defeat.

The people of Nineveh, from the king downward, had chosen to dismiss God's instruction. The entire city, a metropolis of its day, turned to evil. They weren't just your open society, your non-judgmental community, they had become evil in God's sight and were considered by the people of the day to be notorious. That's a strong word. They were literally known for their badness. This may be something today that would get you in the headlines and press, but it's not the kind you want if you hope to please God.

God wanted to save the people of this great city, so He sent His messenger Jonah, to warn them. The almost comical way Jonah responds turns tragic. God tells him to go one way, and he instantly goes the other. Whether by fear or disgust that God would want to save THESE people, he disobeyed. What Jonah didn't realize was that he had entered head-first into the same sin the people of Nineveh fell into. God gives you instructions directly on what is best, and you go the opposite way. It's like reverse repentance.

I want you and me to remember the fish. It took a drastic wake-up call for Jonah. Only after near ship-

wreck and being swallowed and taken into the depths of the sea did he cry out to God. Once He delivered the warning to the people of Nineveh, they too turned dramatically, surprisingly to God. The King even ordered the people to stop eating, wear the ashen clothes of humility and repent. The nation was saved, in essence, because Jonah first and finally obeyed God and the people responded.

Remember the fish, when you knowingly turn from clear instruction. Remember it when you fail to share God's message with those "other" people who are notorious for sin. Those are the people God is calling to repentance. Jesus, who came to call the sick to repentance, wants you and me to cross cultural barriers to plant seeds of true faith in the most unlikely of people. Who knows, perhaps they too will turn and shock everyone with humble repentance. When you think of someone as too sinful, remember the fish, for we are not far from residing there ourselves.

Sunrise: Helping Children 3

by David Coy

Previously we have explored the developmental grief responses of youth ages 2 through 4 and age 9-11. We learned their concept of death is seen as reversible. The younger grief response may be intense but brief, the older age more verbalization with concern for how and why. This week, we examine youth between the ages of 9 through eleven. This week, we examine youth between the ages of 9-11.

Their concept of death begins the same as the previous two age groups in that they see death as reversible but are beginning to see it as final. They also may view death as punishment. In responding to their grief they may ask specific questions. Perhaps even expressing a desire for complete detail, wondering what is the right way to respond? It is during this age group when they will begin to understand mourning. There is the wish to be taken seriously, no matter how shallow we adults may think his or her concerns seem. They may wish to be included in family discussions about the changes brought about by the death.

As adults, our challenge will be to accept his and or her way of grieving as our own. While this age-group may understand death intellectually, they may have great difficulty understanding it emotionally. The son or daughter may begin to worry that they also may die and their questions may be colored in their worries and perception that what has happened might also happen to them or someone else. Our concern should arise in the parents or guardians minds if it is noticed that a marked disruption develops in the home or school relationships and responsibilities. When a child's attention and focus harms school performance; wherein assignments are incomplete or not turned in then there is something that needs to be addressed. If an adult or peer notices a child isolating them self from social interaction, then it may be time to seek professional assistance. Sitting on the bench outside I was distracted by a 30-minute newspaper interview and found myself waiting in the midst of 150 Bernie supporters chanting "Open the door", "No unity, no way", "Ax the super-delegates".

After snapping pictures of a peaceful protest by Bernie supporters, environmentalists, BLM, and some other groups on Sunday, we visited Independence Hall and stood in the very room where the Constitution was written and signed. Awe-inspiring at least. Next stop was the Liberty Bell across the street. I expected to see a huge structure, but I was thrilled nevertheless to be in the city where our nation was born.

Philadelphia was a welcoming place with banners on every street corner. Hotel staff gave us fist bumps when they found out we were there for the convention. But boy was it ever hot!! And boy were the arena seats ever tight! The lines were long at the food vendors so we learned to pack a few granola bars. Gavel time was at 4 each day followed by an invocation, color guard, pledge to the flag, and the national anthem. There were some "barnburner" speeches each day as well as some that were "not so hot". The most exciting time for me was the roll call on Tuesday night. It had been rumored earlier in the day that Senator Sanders was going to nominate Secretary Clinton so we didn't know if roll call would even make it to Tennessee. Anticipation was high, and we were elated when South Dakota and Tennessee put her over the top.

The final night was exciting too culminating with Hillary Clinton's acceptance speech and the release of what seemed like 2000 balloons and a ton of confetti. There were fireworks on the stage and a lot of cheering and tears of joy. Both Randall and I were very honored to help make history with the nomination of the first woman to be on a major party ticket.

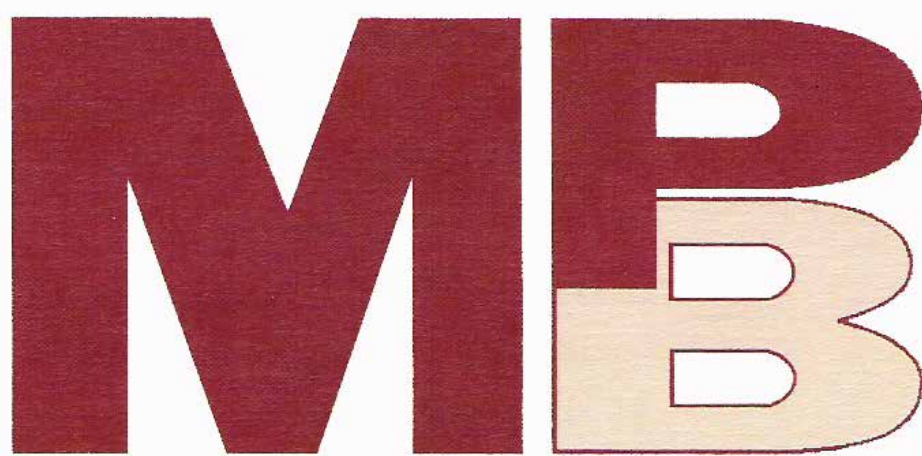

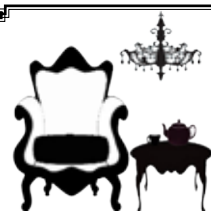

Hardeman County Remembered by Lisa Coleman

In 1782 George Washington, who was then the Commander-in-Chief of the Continental Army created the Badge of Military Merit, which we know today as the Purple Heart. The medal represents outstanding courage, sacrifice, commitment, and heart in duties performed in military service. August 7 is a day set aside as Purple Heart Day to honor the more than 1.7 million combat-wounded Purple Heart recipients.

I am so, so proud of the recipient of the Purple Heart in my family (and am proud of all those who have served in various branches of our military). My sweet, quiet cousin, James Kestler was born in Hardeman County but spent most of his life in North Carolina. After the war, he worked as an upholsterer for 50 years, and he and his wife, Doris, raised their family in North Carolina. He always remembered the visits they made for many years to see the folks back in Hardeman County. James and Doris celebrated 73 anniversaries

together; he passed away in 2015.

Like so many men of his generation, James didn't talk a lot about his World War II experiences until just a few years ago; he served in the U.S. Army with the 38th Battalion 2nd infantry. James says that his unit wasn't told where they were going, they just did what they were told. Orders eventually took he and his unit to France, where they waited for a week off of the coast of Normandy. On June 7, his unit landed on Omaha Beach; he remembers that there was still firing going on all around the beach. "They were just firing those things. It was the biggest fireworks display I had ever seen", he said. One of his most vivid memories is that of fellow soldiers he found lying dead along the beach. "I saw a row of dead Americans. I saw right there where we landed, and right along the base, back from the water a little way, they had them racked up in stretchers."

Just a little over a week later, on June 16, 1944, James was wound-



ed in action. He would spend time in a hospital in England convalescing before coming home for a 30-day furlough. He was awarded a Purple Heart for his actions in Europe; he doesn't talk about that much. He attended a banquet a couple of years ago honoring all of the Purple Heart recipients in North Carolina and was proud to be the oldest one in attendance.

Thank you, James, and all of the other Purple Heart recipients. Y'all forever remind us of who and what makes up real heroes in our world.

Tales from the Yellow House by Lee McAlpin

The social and entertainment calendar at the Yellow House never had too many dates filled in, at least not for entertainment. But the Shelly's, Bear Ice and Coal, Middleton Drug Store calendars of which we always had two or three on the walls, did have dates denoting times to plant corn, turnip greens, peas and beans, birthdays, and dates that school would let out for the hoeing and cotton picking seasons.

Most of our entertainment was created by us. Most every night there was music at our house, joined by other musicians in the community. Mom was a really good fiddle player. She won several first place prizes at fiddlers contests. She told me that one time her prize was a quart jar of cucumber pickles that she was glad to get. When she was in her late nineties, she would tell me to get her fiddle out of the case for her.

Even with her fingers crippled with arthritis and her hearing impaired, she loved music so much, she would struggle and play a few tunes. Later, when she was one hundred, I would roll a TV set over close to her chair so she could sit and pat her feet to the music. She always wanted me or brother Don to learn to play the fiddle. I tried, but it always sounded like a choking hippo. Don did learn a tune or two, but was attached to the guitar. Mom gave my nephew one of her fiddles and he learned to play and she got to hear him before she passed away. Music is something that some people love and you just got to play it to pacify your soul.

Mom was also a good play writer. She wrote and directed several plays at the Pocahontas school.

Slim Rhodes and his band from Memphis came to the school several times and did a show. I was in hog heaven when I could afford to attend. I could just see myself up there on that stage playing music. One time the late, great Johnny Cash came and did a show at the school. I could not scrape up fifty cents to go, but brother Don went and got an autographed photo of Johnny.

There was a movie theater, or "pitcher" show as most people called it, in Pocahontas that showed movies every Saturday night. The wooden benches were attached to elevated platforms with seats in the rear about six feet from the floor. These seats were where the courting couples sat. It took quite a bit of effort to climb and reach these seats.

The favorite movies of the whole community were westerns or oaters as they are called today. There was also a continuing serial short movie shown before the main movie. This serial always ended at an important place in the film on purpose to get people to come back the next week to see what was to happen. In the middle of the main movie there would be a pause, the lights would come on while the second roll of film was placed on the projector. This was also the time to go into the cafe for an RC cola and a moon pie if you had the money.

I wonder what the audience would have done if some of the scenes that are shown now in movies and on TV were to have appeared on that screen in Pocahontas. At that time I suppose that the movie owner would have been run out of town and a lock as big as one at Soledad Prison would have graced the front door.

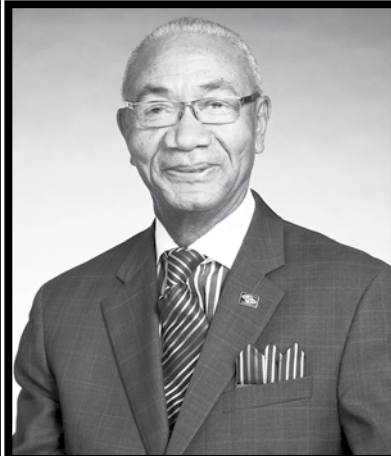

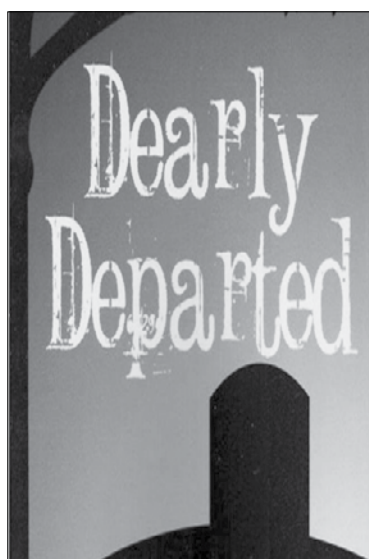
Arts Council to Present *Dearly Departed*

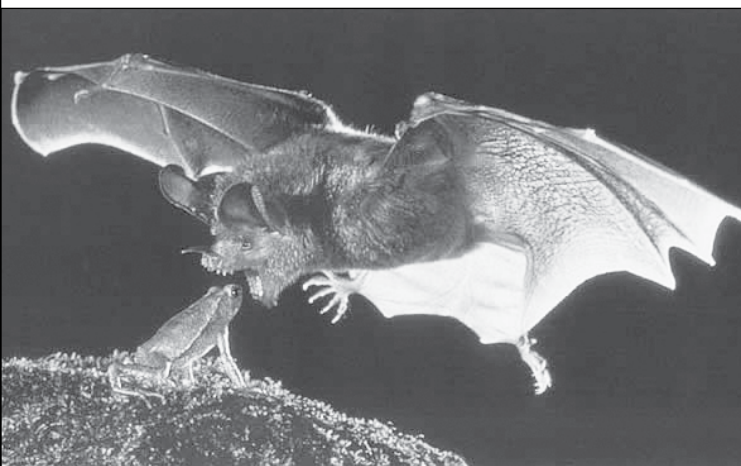

Bats: Not Just for Halloween

When the days start getting shorter and the holidays approach, bat imagery will be everywhere. They are a cultural icon during October. However, here in West Tennessee, we see our real life bats mostly during the summer months. As soon as dusk approaches, they start darting through the treetops and feasting on all of the pesky bugs. I cannot even count how many bats I've seen when driving down the road to watch the sunset, while taking a walk in the dying summer heat, or how many have darted over my friends and my head during night time swimming. To me, bats are actually a sign of summer. Also, the places with the most bats tend to be the least buggy which is a blessing in the summertime. When you see bats and swallows over a pond or swamp, it is a very good thing.

Bats get a bad rap sometimes though. Maybe it has to do with being pictured side by side with witches, black cats, and broomsticks. Media portrays them as bloodsuckers and omens of evil. As a matter of fact, out of over 1,000 different types of bats, only three are genuine bloodsuckers and they do not even live within the United States. Actually, the fifteen different types we have living in Tennessee are pretty cute in a batty kind of way. Not all of them even live in caves. If they did, I would be wondering where the West Tennessee caves were with as many bats as we have in the summer. The ones that are probably the most common around here live in tree cavities and man-made structures during the summer and spring months. Did you know that a bat can eat up to half their body weight in insects? That is a lot of annoying mosquitoes, one of the main bloodsuckers a Tennessean actually has to fear, gone when you multiply the number of bats swooping the air. A fun fact off of twatchablewildlife.org is that a colony of 100 evening bats can consume over 1.25 million insects in a season.

Bats are fascinating and underappreciated little mammals. With their being the only flying mammals, having echolocation, and being our free pest control let us give them a moment of appreciation. Bats, like all of our wildlife, need protecting. Managing and conserving their ecosystem is a huge part of that. On a small scale, there are things called bat houses. My family had one when I was little and they are "pretty cool" for lack of better words. As trees come down and small ecosystems are ruined, bats need a place to go. If it is between your shed or attic and a designated box, where would you rather have them go? Think of it as a rental home for bats. You give them a place to live, they eat your bugs. If only pest control companies were so cheap. Bat houses can be bought, but building them can be a fun family project.
