CodeRed Comes to Hardeman County

Hardeman County will partner with CodeRed, a company that provides an instantaneous emergency notification system accessed through smart phone technology.

"It has been a goal of our emergency response departments throughout the county to acquire a notification system like CodeRed. Time is of the essence when emergencies occur and Hardeman County is one of the largest counties in the state. Timely warnings to our citizens will save lives. Weather, missing persons, criminal activity or public notices can go out to 27,000 citizens in minutes. With CodeRed, emergency agencies can identify targeted areas and notify that area of concern. CodeRed is a big deal for Hardeman County. Saving lives is a big deal for Hardeman County," said Mayor Jimmy Sain.

Town Hall meetings scheduled for Hardeman County municipalities will be held to sign citizens up for the app and brief them on how the technology will work. The schedule is below:



Hardeman County Eligible for Assistance

The U.S. Department of Agriculture (USDA) has designated three counties in Tennessee, including Hardeman, as eligible for natural disaster assistance for bordering counties in Mississippi as a primary natural disaster area due to a recent drought.

Tennessee counties that are eligible are Hardeman, McNairy and Hardin Counties. Twenty-six counties in Mississippi, including Tippah County, were designated.

"Our hearts go out to those Mississippi farmers and ranchers affected by recent natural disasters," said Agriculture Secretary Tom Vilsack. "President Obama and I are committed to ensuring that agriculture remains a bright spot in our nation's economy by sustaining the successes of America's farmers, ranchers, and rural communities through these difficult times. We're also telling Mississippi producers that USDA stands with you and your communities when severe weather and natural disasters threaten to disrupt your livelihood."

Farmers and ranchers in the following counties in Mississippi also qualify for natural disaster assistance because their counties are contiguous.

These counties were designated natural disaster areas on November 30, 2016, making all qualified farm operators in the designated areas eligible for low interest emergency (EM) loans from USDA's Farm Service Agency (FSA), provided eligibility requirements are met. Farmers in eligible counties have eight months from the date of the declaration to apply for loans to help cover part of their actual losses. FSA will consider each loan application on its own merits, taking into account the extent of losses, security available and repayment ability. FSA has a variety of programs, in addition to the EM loan program, to help eligible farmers recover from adversity.

Other FSA programs that can provide assistance, but do not require a disaster declaration, include the Emergency Conservation Program; Livestock Forage Disaster Program; Livestock Indemnity Program; Emergency Assistance for Livestock, Honeybees, and Farm-Raised Fish Program; and the Tree Assistance Program. Interested farmers may contact their local USDA Service Centers for further information on eligibility requirements and application procedures for these and other programs. Additional information is also available online at http://disaster.fsa.usda.gov.

Hardeman County Commissioners have voted "yes" on every Private Act proposal that has been placed before them during the last two years. The first one was to add the garbage bill to home owners' property tax bill and the second was to dismantle voter's right to elect individuals to office at the County level based on political party affiliation.

Both acts on the part of Commissioners diminished Hardeman County Citizens choices to participate in a most fundamental democratic process of being able to select how they manage their affairs: To decide what is in their best interest. To put ones home in jeopardy because they do not have and cannot pay both their property tax and their annual garbage bill at the same time is unconscionable.

The most recent proposal that passed on the first reading is to do away with partian elections at the county level that deprives citizens of a fundamental right. The tragedy is multiplied because the individuals most adversely affected by this proposed action were and are not permitted to decide for themselves. There has been no public hearing nor town hall meetings. To me, that is the most grievous act imaginable.

Current rules allow candidates to choose how they wish their name to appear on the ballot for an office. One can run as a Democrat, a Republican or an Independent. The beauty of the current situation is that if you do not want a party label, you can run as an Independent.

For the reasons mentioned above, I urge citizens to express their views on this issue to their County Commissioner and ask them to vote "NO" when this issue is again before them for consideration. Monroe Woods

During the winter months, the state codes requires a percentage of fresh air to be pumped in all commercial buildings that are occupied by a large number of people, such as the Hardeman County Jail. This is for safety to maintain the required amount of fresh air to substain human life, in case of a premature rupture in the heat chamber allowing carbon monoxide to poison the people in the building.

I'm sure everyone would be curious and concerned as to who it might be. It was more unknown then, as you were more at the mercy of natural process and less with medical intervention. The poet is less concerned with who, as he infers that we are all connected. It doesn't matter so

much who it is, the bell tolls for him at someone's passing, for he and the community are at a loss regardless of who it is.

The average person passes without much fanfare. People in impoverished and war-torn countries die at alarming rates, but they don't make our radar. Our distant relatives pass and we sense loss, but when a pop icon passes, we act like God is losing His mind. We have made our heroes much bigger than they deserve and have allowed ourselves to believe we truly knew those people. It's even more pronounced in movies, because we have repeatedly watched some characters and identify with them more than the real-life actor. We are also moved by music and develop a connection with a total stranger, especially those who reveal a lot about themselves in lyrics and interviews.

"The LORD cares deeply when his loved ones die" (Psalm 116:15, NLT). He cares about the sparrows, and He cares about the people the world has forgotten. Maybe we should think it less odd that famous people pass away, and instead mourn the people of humble stature in life. Perhaps we should spend less time memorializing the overtly celebrated and start comforting the families who have lost someone close. I mourn anyone's

Livestock Feed Rules Take Effect January 1

With the new year just days away, livestock producers will have new federal rules to follow when feeding their animals.

Beginning January 1, a licensed veterinarian must approve and supervise use of certain medications in livestock feed.

"Antibiotics are vitally important for fighting illness and maintaining livestock health," state veterinarian Dr. Charles Hatcher said. "However, we must make sure that drugs don't develop resistance. These new rules will move us toward the elimination of antibiotic use for production purposes, while still allowing producers to use prescribed antibiotics to treat and control disease."

The Food and Drug Administration (FDA) will require producers to have a veterinary feed directive (VFD) in order to feed certain antimicrobial drugs. Before a producer can obtain a VFD, their licensed vet of record must examine and diagnose the livestock in question. Producers must then provide the VFD to their feed manufacturer or supplier. The Tennessee Department of Agriculture routinely inspects feed manufacturers. Any mills that mix antimicrobials into livestock feed will be required to show proof of the VFD during inspection. Extra-label use of a VFD drug in an animal feed for weight gain or feed efficiency is prohibited.







Middleton High School has introduced two new programs this year. Juniors have ACT prep class which is designed to help students better prepare for the test. The mission of this program is to help students that often get in trouble and, in Coach Burkley's words, "Help them to find themselves." The class takes place on Tuesday and Thursday for middle school. High school students have class every day during third or fourth period. Not only does he help students, but he helps his basketball players as well. Mrs. Angela Howell (7th grade science teacher) also helps with this program. Adult Education Opportunities Increase

Statistically, 1 in 4 people within Hardeman County do not have a high school diploma, but with a turnaround time of less than a month for most students, the GED process is being quickened so adults can apply for those jobs who may have not allowed them to apply previously without a diploma. "We're trying to really quicken it because we know we have employers who need people to work and we know we've got people who need to get to work within this county, and if we keep them in classes for months, it can hurt those opportunities," said Alex Beene, Lead Instructor for the Tennessee Adult Education Center.

Last year the output of Hardeman County Adult Education graduates was very, very low. Since taking over in July, Beene has seen increased graduate numbers for Hardeman County to over 150%. Current numbers and estimates show that Hardeman County could finish the year with a 300% year over year increase. No other county in the state of Tennessee has this much increase year over year.

Students come in and take a pre-test that evaluates what you would make on the actual test, if you pass it great, if not, the center works with you until you're able to pass. All students now qualify for a voucher from the State where all classes are free. "We want to make sure students know there's no cost to take classes, and if they can pass the practice test which we'll work with them on, there's no cost that deal with tests."

Adult Education classes are Mondays and Wednesdays from 9 a.m.-noon in Bolivar at 615 Moss Lane and at The Grand Junction Library Wednesday afternoons from 1 p.m.- 3:30 p.m. In early 2017, Alex hopes to start Literacy classes in Grand Junction and eventually expand to Bolivar. "If you are rough on those core reading skills, if you need stuff at a basic level-reading, math, things like that, we're going to have additional classes to meet those needs."


