owe Commits to West Virginia University

Bolivar Central quarterback Trey Lowe announced that he plans to attend West Virginia University in the fall of 2018, ending months of sifting through offers from dozens of college football programs for the three-star quarterback.

Lowe, who is part of the ESPN 300 best football prospects for the class of 2018, narrowed his choices down to seven teams in June: West Virginia, Arkansas State, University of Illinois, University of North Carolina, University of Houston, Southern Miss, and the University of Memphis.


In April Lowe moved into the ESPN 300 and was ranked at the 22nd best quarterback in the nation.

Last season, Lowe completed 93 of 159 passes for 1,628 yards and 20 touchdowns versus only eight interceptions. Lowe also ran for six touchdowns.

A two-sport star, Lowe also was named to the All West Tennessee Baseball team this season after posting a .471 average with 22 RBI, and four home runs for Bolivar Central.

Lowe is believed to be the first Bolivar Central athlete to commit to a Big 12 school, and would be the first to be on the roster of a Power Five conference in football since Mason Ross was a walk-on at Mississippi State in 2014. Photo by Nicka Smith.

GJ Library Project Continues





Work on what will become the new Grand Junction Library continues to make progress at the former site of Grand Junction High School, according to librarian Wanza Taylor.

The expanded space, which will include classrooms dedicated to the Hi-Set program, children's classes, 4H, new business startup training, genealogy classes, technical training, and more will allow the library to function fully at all times.

"In the past, we have had to have our classes in the main room of the library which made it difficult for people to use the library," explained Taylor. "But now we will even have room for more books and resources as well as classrooms.'

Taylor is hoping the Hi-Set program, which helps train people to gain their high school equivalency, will use the library as a testing center.

Hardeman County Remembered by Lisa Coleman

Last week I told you about some of my precious pea-shelling memories. There was another aspect to gardens and vegetables that I got to experience for a number of years and that was the pressure cooker. We ate vegetables fresh, we would freeze some, and then there would always be some to can.

When I was little the way I "helped" with canning was to count the jars as the seal made its distinctive "pop" sound to let us know everything was set and ready. I worked my way up the canning hierarchy to things like washing jars and filling jars, but I knew I was in the big leagues one year when my Granny (Alma) Kiestler told me,

"Missy (her nickname for me), let's can us some beans." So I helped her unearth the pressure cooker at her house (it would usually be in the little cellar, but sometimes it ended up in a stray closet somewhere), and we were in the canning business.

The pressure cooker that Granny had was in use for a long, long time. I think she said she got it in the 1940s and we used it up until just a couple of years before she passed away, so as we say in the South, we used that thing awhile. After all the bean snapping, can washing, and jar filling, we were ready to put the cans in the pressure cooker. The first time I loaded up the pressure cooker with those big quart jars (and mind you, I was in my late 20s then) I thought about all the jars and all the hands in our family that had used that pressure cooker to do just what I was doing - preserving the good food for our winter meals.

Granny and I would use the pressure cooker off and on for many more years, but the last year we used it, well, I thought we were going to meet Jesus in her kitchen. By then the pressure cooker was approaching 60 years of use. I think one of her brothers had made at least one handmade wooden handle to replace the originals. And the dial; oh mercy, that dial. The dial would spin around (not the needle on the dial, the whole dial) and the higher the pressure got, the dial is wobbling, the handles were vibrating, and I knew we would soon be at the Pearly Gates in a storm of green beans, shredded glass, and pressure cooker parts. I do remember asking Granny if she thought we should stop, and she said, "No, Missy, we only have a couple dozen more jars to go, I think it will hold out." Let's just say the cooker did hold out, and my prayer life improved that day because I think I prayed that thing through every cycle.

I love old/vintage kitchen utensils and items, and still use several in my kitchen. My old crank sifter is the absolute best in the world for making flour for cakes light and airy. I have a couple of Granny's old mixing bowls I use on a regular basis. But that pressure cooker was on its last leg that day, and I think Granny finally got rid of it. I was ok with not having that particular vintage item in my kitchen collection.

And, y'all, those green beans out of that last pressure cooking were some of the best tasting ones we ever canned.



One of my favorite teachers (age 50) called me Tuesday night, July 4, and asked what I was doing. Since the fireworks show was rained out, I was just watching TV and unwinding from the day. I asked her if she read the copy of the text of the Declaration of Independence I gave her on Sunday. She said "she had not had time to read it. Nobody cares about that stuff anymore." I replied "that's why the country is going down the toilet."

Needless to say the conversation ended quickly. I was upset at this and could not get to sleep until after midnight. I came close to crying for my country. I can vividly recall when and where I heard about: 1) the surrender of Germany, May 7, 1945 and 2) the surrender of Japan September 2, 1945. I was 7. In both instances I ran home to tell my mother. My Dad, age 35 with a wife and

2 children would not have to go. My uncle, single and a bit older would soon be home.

I will not repeat the entire text here. It is easily available on line in 30 seconds, maybe 1-2 minutes to print it. It seems to me that all of us in the US should start calling it what is really is; not July 4th, but Independence Day. This is what it was called when I was young and for some decades after. Now it is only a holiday, it is not called by its correct name, and all but a small minority of us only celebrate the day off, make merry, and forget the rest.

The document only covers 3 type written pages. There are basically 5 parts to it:

Introduction, one long sentence: When in the course of human events, it becomes necessary....

Preamble 5 long sentences: We hold these truths to be self-evident, that all....

That to secure these rights, Governments are instituted...

Indictments: A list of 27 factual grievances that the writers of the Declaration agreed were important to the undertaking of separating the 13 colonies from Britain to become a separate country.

1.•1316.

September 30, 2017

Denunciation: A description of all the appeals made over the years to Britain to address the listed indictments. We must....Enemies in War, in Peace Friends.

Conclusion: We therefore, the Representatives....mutually pledge to each other our Lives, our Fortunes, and our sacred Honor.

Signatures: There were 56. I do not know how many lost their sacred Honor, but among these brave men who found it very hard to keep their fortunes (modest or not) or their lives, or both.

Tax Free Holiday Returns

Tennessee retailers will not collect sales tax on more than 150 different items during the 12th annual sales tax holiday.

From July 28 through July 30, shoppers can save nearly 10 percent on clothing, school supplies and computers, as students prepare for the back-to-school season. State and local taxes will not be collected on clothing, school and art supplies that cost \$100 or less per item and computers that cost \$1,500 or less.

The Department of Revenue wants to remind people that this weekend of savings is not exclusive to students or Tennesseans. Anyone who wants to shop in Tennessee during the last weekend of July will be eligible to save on sales tax.

"The sales tax holiday for back-to-school items is another way to put more money back in the pockets of Tennesseans. We encourage Tennesseans to take advantage of this tax break as they prepare their children for the upcoming school year," Governor Bill Haslam said.

Legislators passed a new law in 2016 moving the sales tax holiday a weekend earlier than it has been in the past. The sales tax holiday is now the last weekend in July, instead of the first weekend in August. This year, the sales tax holiday begins Friday, July 28 at 12:01 a.m. and ends Sunday, July 30 at 11:59 p.m.

"We want to remind Tennesseans about this important opportunity for savings. It's available to everyone and only happens one weekend a year," Revenue Commissioner David Gerregano said.

Are You Ready to Be an Entrepreneur?

July is Independent Retailer Month. As you know, local stores bring vitality, creativity and economic growth to their communities, so it's worth celebrating those "mom and pop" shops. But they aren't the only entrepreneurs in the country – about 10 percent of workers in the U.S. are self-employed, according to the U.S. Bureau of Labor Statistics. If you're thinking of joining these ranks, you may want to prepare yourself financially.

For one thing, you may need to pay more in taxes, depending on your income. Self-employed individuals typically have to pay twice the amount in Social Security and Medicare taxes because they have to cover the portion that employers normally pay.

Also, unless you're fortunate enough to have a spouse who can put you on their employer-based health insurance, you'll need to find your own, at least until you're eligible for Medicare.

Furthermore, you will need to take charge of your own retirement savings. Fortunately, several retirement plans are available to the self-employed. These plans typically offer tax-deferred growth potential and tax-deductible contributions.

Here are a few options to consider:

Owner-only 401(k) — This plan, which is also known as an individual 401(k), is available to self-employed individuals and business owners with no full-time employees other than themselves or a spouse. For 2017, you can put in up to 25 percent of your annual income as an "employer" contribution, and you can defer up to \$18,000 (or \$24,000 if you're 50 or older). The sum of your employer contribution and your salary deferrals cannot exceed \$54,000, or \$60,000 if you're 50 or older.

SEP IRA — If you have just a few employees or are self-employed with no employees, you may want to consider a SEP IRA. You'll fund the plan with tax-deductible contributions, and you must cover all eligible employees. As an employer, you can contribute the lesser of 25% of your compensation (if you're also an employee of your own business) or \$54,000.

Solo defined benefit plan - Pension plans, also known as defined benefit plans, are still around — and you can set one up for yourself if you're self-employed or own your own business. This plan has high contribution limits, which are determined by an actuarial calculation, and, as is the case with other retirement plans, your contributions are typically tax-deductible.


SIMPLE IRA — A SIMPLE IRA, as its name suggests, is easy to set up and maintain, and it can be a good plan if your business has fewer than 10 employees.

Although planning for your retirement is important, you also need to prepare for unanticipated short-term expenses, such as a major car repair or a new furnace. While everyone should be ready to meet these needs, it's especially important if you're self-employed and have a variable income. So, work to build an emergency fund containing three to six months' worth of living expenses, with the money kept in a liquid, low-risk account.

You may find self-employment to be quite rewarding - but you'll likely enjoy it even more if you make the right financial moves.

Researchers believe anxiety is caused by the brain unable to produce and or regulate sufficiently two neurotransmitters called Gaba and Serotonin. It is believed anxiety may be exacerbated by poor diet, stress, or other causes yet unknown.

It is an unhealthy mix to attempt to self-treat anxiety and or depression with recreational drugs, whether alcohol, or alcohol tobacco and or marijuana combination. It does not help a person learn to manage the anxiety or depression and it may seriously diminish performance in one or more areas of function, such as employment. If there is someone you know who struggles with anxiety and or depression be very concerned if they are coming in very late after their work or school hours have ended. They may be exhibiting self-treatment symptoms of someone who is struggling and not coping or managing well their condition. They are in need of support. Whether professional or others, whether prescribed medication and counseling or going to to another healthy option, they need to face their circumstances in an honest and healthy manner. 





Sobriety Checkpoint Notification

New Law Requires Training for Health Pros

The Tennessee Suicide Prevention Network (TSPN) announced the passage of the Kenneth and Madge Tullis, MD, Suicide Prevention Training Act of 2017, signed into law by Governor Bill Haslam on June 21. The legislation requires licensed behavioral health and health professionals in Tennessee to complete two hours of suicide prevention training every five years.

The bill represents a goal of TSPN to ensure that behavioral health professionals in Tennessee are trained in suicide prevention, intervention, and postvention protocols. "This kind of training was always encouraged among professionals in our state, but not explicitly required," explains Scott Ridgway, MS, TSPN's Executive Director. "Now, people in Tennessee can be assured of the knowledge that the

behavioral health professional they work with, or the one they entrust their loved ones to, will be able to help them through a suicide crisis."
