Money for Good Grades

Hardeman County's upgrade from A- to A+ on bond ratings gave the county an immediate boost in the fund balance, as a refinance at 2.18% of a part of the debt on the Hardeman County Criminal Justice Center complex will save more than \$1.6 million over the life of the loan.

"It's a great day for Hardeman County," said Mayor Jimmy Sain. "With the advice of financial advisor Scott Gibson of Cumberland Securities and financial advisor John Lawrence of WG Advisors, we made the correct call on timing the market for the best rate. We had expected to get a rate in the middle two percent range as we tracked other surrounding counties that recently refinanced.

"With the new S&P rating of A+ on this issue and right timing of the market, we were blessed with a rate saving us over \$1.6 million on the life of the loan. This is \$1.6 million that our taxpaying citizens will not have to pay on the CJC. It makes me proud for each of them."

John Lawrence of WG Advisors said that improving the financial condition of the county led to the savings.

"The much improved S&P rating combined with a low interest rate environment allowed the county to get a much improved cost on this debt," he said.

According to Sain, the county will now wait until next year to refinance the other half of the note, and hope for the same savings on the other \$9 million. Counties are only allowed to refinance \$10 million per year, so it will have to Sain estimated that the \$1,020,000 yearly payment will drop to \$940,000. The county expects to close the new deal on \$9.1 million on August 22, 2016.

Citing "strong budgetary performance" and "very strong liquidity" Standard and Poor Global Ratings assigned its A+ long term rating to Hardeman County's series 2016 general obigation bonds. Previously, the rating was A-. The new rating was announced last week.

They Voted. You Still Have Time



Voter turnout in Hardeman County has been lower than expected through the first 12 days of early voting, according to the Hardeman County Election Commission totals.

Through July 26, 1,369 had voted, with 783 declaring for the Democratic Primary and 532 Republican. Fifty-four voters declined to vote in the primaries and voted only in the general election. With two days left, voters will have to hustle to equal 2012's 2,223 who voted early.

Early voting in Hardeman County will be until July 30 from 9:00 a.m. to 4:00 p.m. weekdays and from 9:00 a.m. to Noon on Saturday. Election Day is August 4.

County-wide, voters will choose between incumbent Josh Pulse and challenger John Vickers for Assessor of Property. Other county spots on the ballot are two commission seats, three school board spots, and a road supervisor position.

Voters in Whiteville will have to choose three aldermen from a list of five and a mayor from three candidates. Running for mayor are incumbent James R. Bellar, challenged by Leon Crisp and Aubrey Phillips.

Voters will also select candidates for the November elections in pri-

TWRA to Fund Shooting Range



Hardeman County's Lone Oaks Farm has announced the Tennessee Wildlife Resources Agency (TWRA) will donate \$2.6 million for the first phase of a shooting range.

"The shooting range, like all of Lone Oaks, will be open for a fee to anyone who wants to practice or just have a good time shooting," said Barry Sumners of the TWRA. "We have been told that phase one of the construction will create a shotgun range."

Dr. Ben West of Lone Oaks says it will provide a unique opportunity for people in Hardeman County.

"There is one (a shooting range) in Fayette County and one in Madison, but they are small compared to what we are planning," he said. "And very few in the state with trap, skeet, five-stand and traditional sporting clays, like we are going to build."

West addded that part of the facility will be a hunter education classroom, which will be used for other firearm related instruction as well.

OUR COUNTY Tales from the Yellow House by Lee McAlpin

Toys that we had at the Yellow House didn't come from Toys R Us, but Junkpiles R Us. There were several junk piles and junk gullies around the community where everyone would discard their junk, and we would find a lot of treasures in these places.

We did not have computers, other than our brains, which is the most amazing computer thats been invented. No X Boxes, Guitar Heroes, Rock Band, Playstations 1,2, and 3. We had no cell phones on which we could text. Our text was our school books. We did make our play phones from two tin cans and a long piece of string. I think all the new electronic gadgets are great, but we had to invent all our toys. There were no store bought ones for us. We let our imaginations create a lot of our toys. In a seven inch long piece of two-by-four, we could image a dump truck, or some other motor vehicle. A few times we would bore a small hole in the overhanging eave of a terrapins rear shell, tie a string to a bottle, let him or her pull it through the dust and dirt for our road graders. Now that's being inventive in conjuring up things to play with. My sisters had some of the ugliest stuffed rag dolls I have ever laid eyes on. They were hand made witht their eyes, noses and mouths painted on with fingernail polish. But to them they imaged beautiful little cooing angel babies to be burped, changed and scolded for not sleeping, or for wetting their diapers. I guess for them, beauty was only rag deep.

Nearly every boy in the neighborhood had a sling shot, and wanted red rubber innertubes for the slings. If you had one of them, you were rich as Donald Trump. You could always trade a pair of red innertube slings for a dozen marbles with a steelie thrown in, a turtle, frog, or even a Roy Rogers comic book. I made a lot of my toys. I had seen photos of tight rope walkers. I was always delving into the more dangerous kinds of activities, so I decided that I wanted to be one of these daring persons. I had found an old sawmill belt which I stretched from a catalpa tree in our yard to a post set in the ground about twenty feet distance. I did about 8 feet before my fall, which was quite hard and picked up a few bruises. I kept trying until I could gracefully walk the distance with my arms flailing for balance. Then I graduated to a guywire. That was my downfall. My first trip on the guywire was only about two feet, where at that time I fell, hitting straddle first on the wire and whimpering in a high-pitched tone. That ended my quest to be a high wire walker.


Another time, two friends dared me to leap from the overhead railroad bridge in Pocahontas using a bed sheet for a parachute. They told me if I would go first, they would do it. I have learned since that time to not go first. I bailed off from atop the bridge



bannister, expecting an easy floating ride to the railroad rocks below. Wrong. I hit the rocks like a ton of lead on my left foot with my underwear right up around my neck. I can still feel that landing today. Of course the other dudes never attempted the jump. But I later got revenge with one of them when I talked him into jumping from the top of his car port using his mothers umbrella for a parachute. He took a hard fall also, as the umbrella reverse folded up like a wet sheet, thinking back, my sheet wasn't wet, but it folded up. He also got a spanking for ruining the umbrella. I came through it all without any broken bones, but multiple bruises and scars, some which I carry today. There use to be a flourscent green critter that we called a June-bug. You always seen them in June of each year. Me and brother Don would catch the critters, tie a length of thread to one of their hind legs, hold on to the thread and let the thing fly around above our heads until he collapsed from exhaustion. Kind of bad, but we never killed the critters. They would rest awhile and fly off into the clear blue yonder.

One day I caught what I thought was a June-bug. I tied my string to his hind leg, but he wouldn't fly. I noticed he was brown instead of green like the other ones I had caught. While fussing trying to get the critter airborne, my Mom came by and told me to turn that thing loose. She told me that this one was a tumble bug. A critter that is more accustomed to rolling a round ball

of manure across the barnyard, than entertaining a kid by flying in circles with a string attached to its leg.







Once again, a benefit that helped only the wealthiest citizens, but will cause significant financial distress soon in Tennessee.

3. Similar legislation a few years back in Kansas and Louisiana has brought financial disaster to their governments. Our legislators have planted the seeds for the same disaster.

4. While the state gladly accepts federal assistance for public school funding, our current state senator voted to refuse to accept similar assistance from the federal government for health care, and as a direct result, several hospitals have already closed and our own Hardeman County Hospital is hanging on by a thread. We will all suffer as we travel to be with relatives in distant hospitals rather than here at home.

5. Demand common sense from your legislator and senators by exercising your vote wisely this year.

6. Ask yourself, what has your state senator done that helped your budget or your local government's budget.

7. Give Bob Shutt of Savannah, Tenn. an opportunity to serve as our state senator. He will vote wisely for all, not just special interests.

8. Being conservative does not mean losing common sense with regard to running a sound fiscal government with fair taxation policies.

Sunrise: Helping Children by David Coy

Children's concept of loss whether by death or other causes depends upon many different circumstances. This week we will examine children between the ages of two to four years of age. Their response to grief depends upon different criteria. At this age they view death as reversible. They may show an intense but brief response. Their life is totally involved with the here and now, very much in the present. They may be prone to ask questions repeatedly.

Children in this age group need an understanding tone of voice and demeanor from those adults in their life when a traumatic loss has occurred in their life. It would be helpful to provide an open invitation for them to express what they think and how they feel in whatever way they can, even if they use drawing or some other way of expression. They need to know that our posture with them is one that says, we are together in happy times as well as difficult times of sadness and there are no secrets. It would be reassuring to them if we had been through something similar and could give them the comfort that they and we will take care of one another through all of this.

Children do grieve, just not the same as others. Remember, we are all individuals and will mourn differently, but at this age they are still developing into the Mr. or miss that we will come to know when they are in their teens. Many factors affect their response: gender, age (mental, emotional development), religious and ethnic customs, and relationship with the deceased or involvement with the loss, prior grief experiences, circumstances of the loss, and etc. Children feel the pain of loss or they radiate the feelings of their guardians. They often express their grief through behavior. Their grief may be internalized or be displayed in a cycle, going from periods of what seems to be normal behavior to periods of irritable or sad behavior. This

Ingredients

- 1 cup desired salad dressing
- 8 ounces beef flank steak
- 2 small yellow and/or red sweet peppers, halved
- 1 ear fresh sweet corn
- 2 green onions, trimmed
- Nonstick cooking spray
- 2 cups torn romaine lettuce
- 4 cherry tomatoes, halved
- 1/4 of a small avocado, peeled and thinly sliced (optional)

Directions

- 1. Divide 1 cup of desired dressing into 2 parts.
- 2. Trim fat from steak. Score both sides of steak in a diamond pattern by making shallow diagonal cuts at 1-inch intervals. Place steak in a resealable plastic bag set in a shallow dish. Pour one portion of the salad dressing over steak; set remaining dressing aside. Seal bag; turn to coat steak. Marinate in the refrigerator for 30 minutes.
- 3. Coat sweet peppers, corn, and green onions with cooking spray.
- 4. For a charcoal grill, place steak and corn on the grill rack directly over medium coals. Grill, uncovered, until steak is desired doneness and corn is tender, turning steak once halfway through grilling and turning corn occasionally. For steak, allow 17 to 21 minutes for medium rare (145 degrees F) to medium (160 degrees F). For corn, allow 15 to 20 minutes. Add sweet pepper halves to the grill for the last 8 minutes of grilling and green onions to the grill for the last 4 minutes of grilling, turning frequently. (For a gas grill, preheat grill. Reduce heat to medium. Place meat and then vegetables on grill rack over heat. Cover and grill as above.)
- 5. Thinly slice steak against the grain. Coarsely chop sweet peppers and green onions; cut corn from cob, leaving kernels in "sheets." To serve, divide romaine lettuce between two bowls. Place steak, grilled vegetables, tomatoes, and, if desired, avocado slices on lettuce. Drizzle salads with the reserved portion of salad dressing.



Parenting is never an easy job – and, unfortunately, it can be espe-

cially difficult if you're doing it on your own. As a single parent, you face many challenges, not the least of which are the financial ones. But by following the suggestions below, you may be able to make life easier - for you and your children.

Investing Tips for Single Parents

Create a "safety net." On any given day, you could incur an unexpected – and unexpectedly large – expense, such as major car repair, a new furnace or a toothache-inducing bill from your dentist. Your daily cash flow may not be enough to cover these bills, and you won't want to tap into some of your long-term investments or retirement accounts. So you'll need to build a "safety net," or emergency fund, containing three to six months' worth of living expenses, held in a liquid, low-risk account.

Purchase adequate life insurance. With sufficient life insurance, you can provide your survivors with a level of comfort and security. You might have heard that you require coverage worth seven or eight times your annual earnings, but there's really no one "right" answer for everyone. A financial professional can assess your situation and recommend an appropriate amount, and type, of life insurance.

Consider disability insurance. As a single parent, without the support of a spouse's income, you could run into serious financial difficulties if you were to become ill or injured and had to miss work for an extended period. Your employer might offer disability insurance as an employee benefit, but it may not be enough to meet your needs. So you could consider adding private coverage.

Save for retirement. It's not always easy to simultaneously save for your retirement and your children's college education. You will have to decide on your own priorities, but keep in mind that your children may have access to grants, loans and scholarships, whereas you have to rely on yourself for your retirement income. Consequently, you may want to put in as much as you can afford to the retirement accounts available to you, such as an IRA and your 401(k) or other employer-sponsored plan.

Establish your estate plans. All parents need to develop their estate plans – but it may be even more essential for single parents. Your estate plans should include at least these three documents: a will, a power of attorney and a health care power of attorney. A will allows you to name a guardian for your children and specifies how you will pass your assets on to them. A power of attorney gives someone the legal authority to make financial and other decisions for you, while a health care power of attorney authorizes someone to make medical decisions on your behalf if you become incapacitated. You may also need to create other arrangements – such as a living trust– but in any case, you will need to work with your tax and legal professionals to develop comprehensive estate plans.

Single parenthood can offer every bit as much joy as any other family situation, but it will require you to plan carefully and take advantage of every opportunity to help ensure financial stability for your children and financial freedom for yourself.


Bishop Releases Sixth Book

Bishop's publication efforts of books and articles have led to him receiving awards from the Tennessee Civil War Preservation Association and the Arkansas Division of the Sons of Confederate Veterans. He also makes appearances and presentations about the content of his books to various organizations in Tennessee, Mississippi, Arkansas, Kentucky, Virginia, and Georgia.

Bishop's most recent publication begins by noting a Civil War event or situation for each day of the year. In turn, the basic meaning or idea of each topic is related to and connected with a scriptural verse or passage. The basic premise of the daily devotional is that each day's entry is one page in length and will examine a specific aspect of the War Between the States. Issues involved with various battles, diseases, homesickness, individuals facing death, and governmental activities of the period from 1861 to 1865 are examples of some of the themes Bishop discusses in the manuscript. Verses from the King James version of the Bible serve as the scriptural references.

While Pelican Publishing of Gretna, Louisiana, a suburb of New Orleans, was the publisher of Bishop's previous books, Balboa Press performed the services for A Civil War Devotional. Bishop explained, "Pelican preferred to pass on pursuing the printing of a religious work. That is a sign of our times and one that proves the need for any strategy to put God's word into the hands of readers."

Randy Bishop and his wife Sharon, a teacher at Middleton Elementary, are life-long residents of Middleton and members of Middleton church of Christ, where he serves as a deacon. A Civil War Devotional is



dedicated to Sharon, someone who Bishop says is a prime example of a Christian. Randy and Sharon have two sons, Jay and Ben.

Copies of A Civil War Devotional are available in paperback or hardcover and can be purchased from Bishop, Balboa Press, or a host of internet sites. His previous books, The Tennessee Brigade, Mississippi's Civil War Battlefields, Civil War Generals of Tennessee, Kentucky's Civil War Battlefields, and Tennessee's Civil War Battlefields are available from Bishop, Pelican Publishing, or most major on-line or brick-and-mortar book stores.

Message from the Chamber: Cave People by Kandy Shackelford

Have your heard the recent use of this term? We have some of them right here in Hardeman County, CAVE PEOPLE. It stands for Citizens Against Virtually Everything. Recently I read an article that spoke of these folks, and it lended some very good advice. I want to share with you some of the ideas the article approached as well as some of mv own.

First, there is a tendency for us to think us vs. them. The article pointed out that we should never think that way because it is always us. And as I think further on that concept I start to wonder why some folks have a tendency to be negative. Comments like"that is not how we've always done it" or "that will never work HERE" are sometimes legitimate statements, but there is always the chance that it might. I also like to think that if something hasn't worked yet that we haven't completed our efforts. Have you ever tried to put something together without having the instructions? It takes a lot of trial and error, and that is life my friends. The point is to keep trying until it all fits together

properly. And that means you need to use all the parts and you need the right tools! Sometimes we overlook the parts necessary to complete the job because they didn't seem to be important or we didn't understand their usefulness. And sometimes those pieces to the puzzle are the folks that made those negative comments. They have usefulness, we just haven't yet figured out how to configure them into the process. But we certainly cannot leave them out because they are a vital part of the finished product.

The article went on to state that the way we hear those negative words will determine how we respond to them. For instance, how much differently would you feel about those negative words if they came from a trusted friend who you think genuinely wants the betterment of all concerned. Would vou hear them differently? Perhaps you allow that person to explain further their thinking and you might come up with an answer that would FIX a problem you have been dealing with a long time.

The important thing to remember



is that we are ALL important pieces to the puzzle. We should never consider ourselves separate from others (us vs. them) but consider everyone as important as the other. Just because you meet some opposition in what you are trying to accomplish does not mean that it is a bad idea, it just might mean that you don't have all the parts and/or tools to put it all together...just yet.




