From the Other Side of the Desk

My job, they told me, was to report on all the local sports, both college and high school. Perfect. Right up my alley. And then they dropped the bomb. I had to do a Man on the Street interview for each week. I would take a picture of five local citizens and ask them a question, such as, "Do you plan to vote this year?" My first few weeks featured mostly people I knew. My boss then made a rule I couldn't use anyone under 25 years old. Then another rule that I couldn't be related to them. And then he said that I couldn't give them \$10 or offer to wash their car. So I hung out at the post office, a solitary figure with a notepad and camera stalking people as they came to get their mail. It was pathetic. For a while I was IN the post office, until people complained. Then I was on the front steps of the post office until later I moved (involuntarily) to the sidewalk in front of the post office. Then I moved to the Trade-more Shopping Center out near Interstate 64. Normal people didn't want to talk to me. The people that would, well, their answers weren't all that newsworthy. **Question:** Where do you see yourself in five years? **Answer:** Well, unless they move this bench, I'll be right here. You gonna eat all of that banana? The pictures were due Sunday and the copy on Monday morning. The film went into a dropbox. The slot was about three feet above the floor. So one week after killing myself and getting no results, I had an idea. I took the film out of the camera, put the cap on very loosely and dropped it into the box. "Bad news," my editor told me. "The film cap popped off when you dropped it in the slot and the photos were ruined. So we'll do two questions next week." Hmm...I hadn't thought of that. *Darrell Teubner, Editor*

McTizic Sworn into Office

Julian McTizic began his term as Mayor of Bolivar as he was sworn into office Saturday, July 1 at the Bolivar Municipal Center. Along with McTizic, newly elected council members Jonathan Joy, Page Walley, and Melvin Golden were sworn in along with returning member Suzanne Rhea by Hardeman County General Sessions Court Judge Boyette Denton. Following the ceremony, the council elected Page Walley as deputy mayor. McTizic then changed the way standing committee reports are presented to the council and to un-appoint council members over departments of the city. According to the directive, from this point forward, department heads will present the standing committee reports at monthly city council meetings. "Doing things this way will help

Fireworks at Whiteville Meeting

An appearance and statements by a former mayor was the beginning of a heated exchange during the regularly scheduled meeting of the town council in Whiteville on July 3. Former Whiteville Mayor James Bellar appeared before the panel, bringing questions of the hiring of the city administrator, surplus military equipment acquired by the city, sanitation services, and zoning issues. "I was involved in a lot of town meetings during my 33 years of service to the town but this was probably the most heated I have ever been involved. I have no ax to grind with this guy as I do not miss being involved," said Bellar in a letter to the editor. "But as a private citizen, I will hold him accountable." The visit from Bellar was partly in response to the 16 Whiteville firemen that walked out from the department last week over a disagreement over equipment and purchases. Bellar gave up the office of mayor last August, when he was defeated by Phillips in the election. Phillips' total of 122 votes was good enough to give him the victory over Bellar, who had 81 and Leon Crisp, who received 80 votes. Bellar was Mayor of Whiteville for 22 years, taking over from Jack Cooper in 1994.

Hardeman County Remembered by Lisa Coleman

Summertime and gardens and farmers markets are truly wonderful things and we are blessed in abundance with all of them here in Tennessee. They all always remind me of all the things I learned while I was shelling peas, usually with my Granny (Alma) Kiestler and her brother (my Uncle Denver Smith). When I was younger I thought I just like to shell peas (and I do), but as I've gotten older it is the memories and stories associated with pea-shelling time that were really the best part.

I loved to help shell any of the things that came from the garden – peas, beans, butterbeans – but my favorite was always peas, when you would get one tall basket filled to overflowing with purple hull peas, a big bowl for your lap, and another empty basket for pea shells. It was a good way to pass some time on a Tennessee summer afternoon, made even better when I had the great blessing of being in the company of an older family member.

My Granny Kiestler and I would shell peas under the big shade trees at her old house and on the front porch of her other house. Sometimes she would let me talk about things that are big and important when you are small in the world, or she would let me tell her stories I read from books. There was an ease and a rhythm to the pea-shelling and talking and listening, along with the hard-to-describe smell of freshly shelled peas that just recently came off of



the vines that were rooted deep in the good dirt of West Tennessee and Hardeman County.

Mostly I would ask my Granny to tell me the stories of her growing up years in and around Cloverport. She would always tell me that everybody always had to work hard; she would talk about liking school but said she only got to finish the third grade. She always encouraged my brother and me to study hard and learn all we could at school. She told me about her brothers and sisters who died young, and she would talk about long days spent picking cotton and how Aunt 'Cille was the littlest one there but she could out pick everyone, even all the men. Granny would tell me Bible stories and she would always remind that the red words in the Bible were the ones that Jesus said and that you should do like He said.

Sometimes Uncle Denver would be around for the pea shelling and he and Granny would talk about all their brothers and sisters and tell the stories of long ago, that really weren't so very long ago, and they would wonder what happened to friends and neighbors they'd known down the dusty roads of their childhood. They would both talk about memories of when electricity came through the countryside and how you could listen to the radio right in the living room; the Saturday night Grand Ole Opry was always a favorite, it seems.

Yep, as much as I enjoyed the pea-shelling, it was the sweet, kind folks and the priceless stories they shared that cause me to have such fond memories of a task as simple as shelling peas. Y'all, those priceless, precious, pea-shelling memories surely are wonderful to me.

The Death of Self-Sacrifice

The longer we all live, the more we hear of death. Tragedies seem to unfold at a faster pace than ever before. Although mankind has always been unkind to its own, the rate of news reports of mass killings, terrorist attacks and disasters climbs every year. Partly because the world is speeding toward its end as man continues to rebel against God. It's also the fact that news is as close as a cell phone. Everyone has become a journalist of sorts. When I went to high school, there would be the occasional fight in the hallway, but now you can see a steady YouTube stream of them from high schools everywhere. The bad news is no surprise, but I have found it surprising how little people are willing to step in and help.

A video that still troubles me is the first time I viewed news coverage of a knockout game. Kids videotaped a friend walking around and punching unsuspecting people on the street. The goal was to knock someone out. The video I saw showed a young man walk up to a much older man standing on the sidewalk and hitting him so hard in the face that he collapsed. We have since exported this

"game" to other countries and it is now played in London and around Europe. When a group of six people watch someone helplessly being beaten and not one steps in to stop it, there is a breakdown in our moral conscience. I would suggest there is an even deeper force at work than mere timidity.

With the publicity of recent mass shootings, public safety officials have developed a three step plan for those caught in the vicinity of a shooter. The first rule is to flee. This certainly is a typical flight response for most creatures. To survive you must remove yourself from the danger. Secondly, we are told to barricade ourselves from the danger. Either in hiding or with shielding structures, we are to buffer ourselves from approaching danger. This is stressed as a lesser choice than fleeing. Lastly, we are to fight or attempt to disarm the perpetrator.

Once called the fight or flight response, we are being taught to reverse the order and naturally fly from danger. The new flight or fight approach calls us to care for ourselves beyond all others. Even in fighting, it is framed as a last resort to save ourselves. Rarely

I am saying only that we reflect on the words and actions of Christ and condition our hearts and minds accordingly.

"My command is this: Love each other as I have loved you. Greater love has no one than this: to lay down one's life for one's friends" (John 15:12-13, NIV).

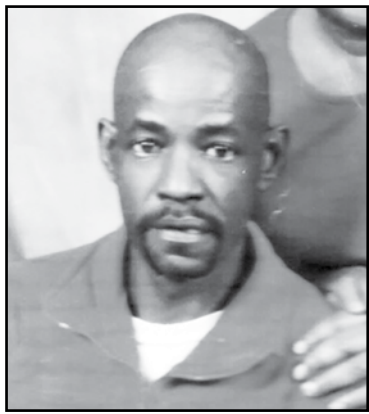

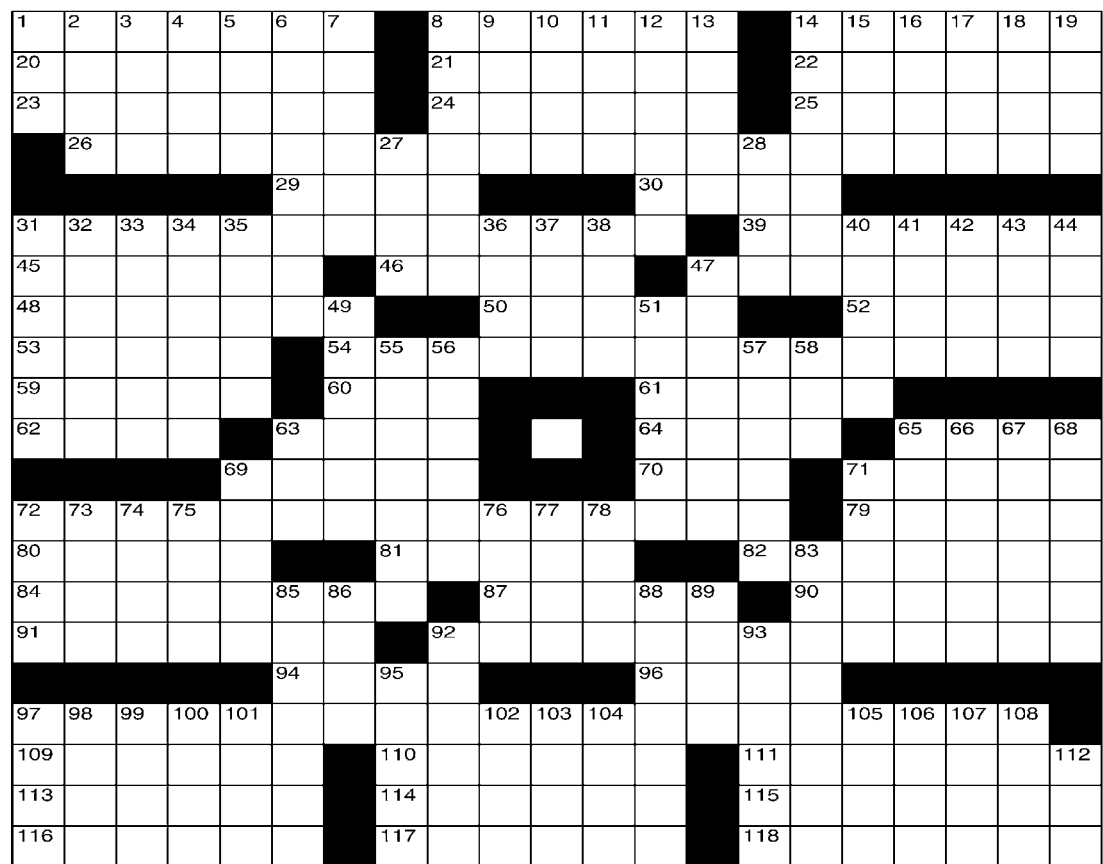

- 1/3 cup snipped fresh basil or desired herb
- 1 tablespoon mayonnaise

- 1/4 teaspoon salt
- 1/4 teaspoon ground black pepper

- 2 medium roma tomatoes, thinly sliced
- 1 medium avocado, seeded, peeled, and thinly sliced

- Dry-roasted sunflower kernels (optional)

Directions: In a small bowl stir together corn, onion, basil, mayonnaise, sour cream, vinegar, salt, black pepper, and sugar.

Fill each bun from Grilled Hot Dogs with 1/3 cup of the shredded lettuce. Arrange tomato slices on one side of buns and avocado slices on the other side of buns. Place grilled frankfurters in buns. Top each frankfurter with about 1 tablespoon of the corn mixture. If desired, sprinkle with jalapeño peppers and sunflower kernels. Pass the remaining corn mixture.

When working with chile peppers, wear plastic or rubber gloves. If your bare hands do touch the peppers, wash your hands and nails well with soap and warm water.



Roadways will then be checked over a number of days for any debris subsequently dumped at the site. Trail cameras will then be checked and a warrant will be issued for whomever the car is registered to via tag number and fines of up to \$500 could be assessed for a conviction.

The Hardeman County Highway Department is responsible for 653 miles of county roads and 125 bridges. Tennessee's Uniform Highways Laws and a private act for Hardeman County governs the department for all roads that are classified as a county maintained road.

In 2015, Hardeman County received \$38,600 from the Tennessee Litter Grant Program. The amount of funding a county receives is determined by a formula based on population and road miles. The Litter Grant Program supports a variety of programs and activities that help reduce litter throughout Tennessee. Through the efforts with collaborative county partners, the Litter Grant Program is responsible for removing an average of 11,300 tons of litter each year. Over the 33-year history of the program (1983 to 2016) this equates to the removal of more than 310,000 tons of litter from our roadways.

With transparency and complaints from the public. If someone has complaints or concerns that the board discusses at meetings, then we can address those grievances right then and there. It won't be the place to fix those concerns, but at least the department heads, the mayor, and city council members can hear them and citizens can put names with faces. This will cut out that middle man and provide citizens an opportunity to ask those department heads any questions they may have rather than putting it on someone else's shoulders to find out the answers for them until days after the meeting, or never getting it addressed at all. Council members aren't in these departments every day, they don't truly know what happens, they have to call and get library numbers from Bailee for example, to present at the monthly meetings," he said.

Prior to the change, city department reports were presented by council members who were appointed by the mayor and approved by the council.

As far as the immediate future, McTizic said he was taking it one day at a time.

"No one has lost their job yet, the street lights still come on at night, and the sun still rises and sets. 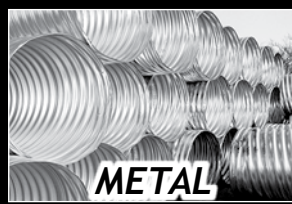

Tales from the Yellow House by Lee McAlpin

Life at the Yellow House on July the fourth went on as usual with no special activities. Sometimes our aunt and uncle who lived in Covington would come visit us. They were well off as we called it, with a new car that always smelled of Aunt Ruth's expensive perfume. Me and brother Don would sneak out and set in that car and pretend that we were driving down some paved highway miles away from Pochontas. Aunt Ruth was always dressed to the nines and always made a fuss over us kids. I remember one time on their visit, our extra treat for the meal was fried bologna, that Dad had somehow managed to buy. I was in the kitchen, along with Mom and Aunt Ruth and hungry as ever, smelling that bologna frying. I told Mom that I wished that we could have that good of a dinner every day. It embarrassed Mom and I guess that is why Aunt Ruth grabbed me and gave me a big hug.

I guess that the biggest fireworks display on the fourth that we had was striking a match to light one of our coal oil lamps. We had two of the lamps. Someway we accumulated an Aladdins lamp, which burned coal oil, but had a mesh mantle which lit up the old Yellow House like a dozen GE light bulbs. We thought we were on Broadway with that fancy lamp. One thing that we were



thankful on the fourth of July was the fact that we were out of the cotton patch for awhile. Mom was busy canning vegetables from the garden, and us kids were busy washing and sterilizing mason canning jars, and picking and breaking green beans.

Being out of school gave me time to ramble in the woods surrounding the Yellow House. I enjoyed walking along the creek and looking at the wild animal tracks. My Pa Pa Barkley trapped a lot for animal hides and passed along his lore of animal tracks to my Mom who passed them on to me. Sometimes in the summer, we would dam up this little creek and make us a swimming hole to go skinny dipping in. It was never over knee deep but to us it was a lake. The water was always muddy and its a wonder we did not have malaria

or some other dreaded disease.

When us boys was sloshing around in our swimming hole, we played a game called New Moon. One person would try to run or swim past a line of other people. If he was tagged, he had to go under the water and stick his hind end up out of the water and the rest would holler new moon. I have not seen this game on the summer olympics as of yet, but they may add it in the near future.

What Can Investors Learn from the All Stars?

Next week, the 2017 Major League Baseball All-Star Game will be held in Marlins Park in Miami. If you're a baseball fan, you may tune in to admire the skills and grace of the players. And if you're an investor, you can learn some valuable lessons from the All Stars, including these:

• **Alertness** – Most of us can only dream of having the outstanding reflexes of major league ballplayers. But we can develop a similar trait: alertness. Just as a ballplayer who wants to steal a base needs to be alert to the pitcher's delivery and the strength of the catcher's throwing arm, you should be vigilant about investment opportunities and the potential need to make changes to your portfolio.

For instance, you might realize that, over time, your portfolio has become too top-heavy with the same types of investments. Since these investments are likely to move in the same direction at the same time, you could take a big hit during a market downturn. Consequently, you may want to diversify among a wider range of vehicles, including stocks, bonds, government securities and others. While this type of diversification, by itself, can't guarantee a profit or protect against all losses, it can help you reduce the effects of volatility on your portfolio.

• **Patience** – When you watch the best hitters – such as those appearing in the All-Star Game – you will notice that most of them are very patient, willing to wait for several pitches until they get the one they feel they can hit. As an investor, you, too, need patience. The investment world contains many myths, one of which is that it's possible to get rich quick by finding "hot" stocks when they're cheap and selling them after a meteoric rise. But these events are actually pretty rare. The most successful investors are typically the ones who invest steadily, through good markets and bad ones, and who follow a long-term strategy appropriate for their needs, goals and risk tolerance.

• **Preparation** – During the All-Star Game – or, for that matter, during any game – the ballplayers will know exactly what to do in almost any given situation. To take one example, consider what happens when a runner is on first base and the batter hits a ground ball to the shortstop. Almost without thinking – because he's already prepared for this very scenario – the shortstop will flip the ball to the second baseman, who is already standing on the bag, because he too is ready for this play. The second basemen completes the double play by immediately throwing to the first baseman, who is also in the right place, standing on first base.

When you invest, you also need to be prepared for certain situations and how you'll respond. When your children head off to college, you should know if and how you'll help them pay for it, maybe because you've prepared by saving in a 529 plan or another college-savings vehicle. When the day comes for you to retire, you should know how you'd like to tap into your retirement accounts, such as your 401(k) and IRA.

By being alert, showing patience and preparing for your goals, you can put some of the All-Stars' skills to work when you invest — and by doing so, you might improve your personal "box score."

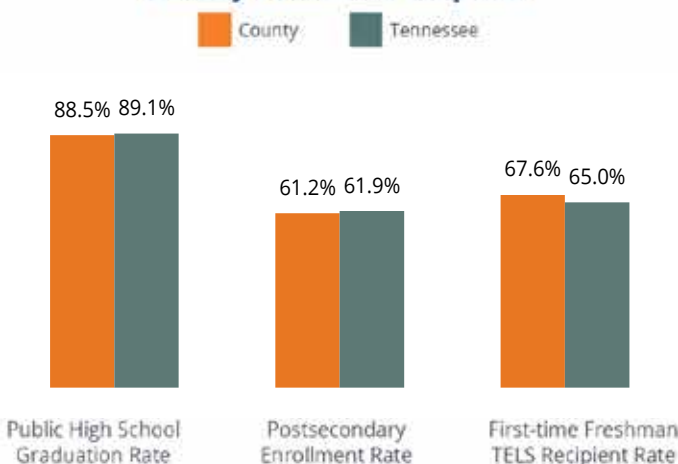

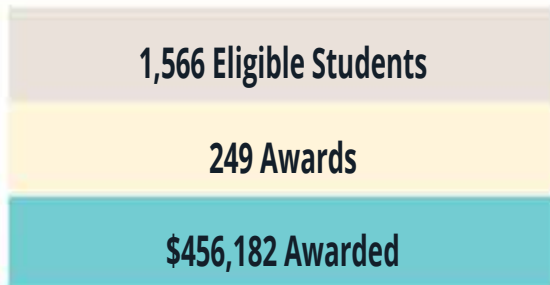

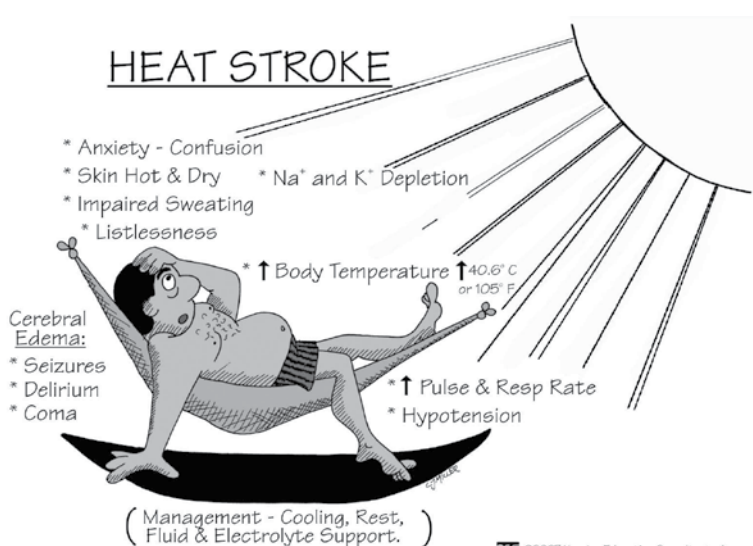
Summer Safety: Heat Stroke vs. Heat Exhaustion

Unless a rare cool front comes through, highs in the upper 80s and in the 90s, with even higher heat indexes, are here to stay for a while. The higher the heat index creeps above 90, the higher the risk of heat-related illness. The two most dangerous heat-related illnesses are heatstroke and heat exhaustion. While they have similarities and are linked, it is important to know the difference and how to treat them.

Heat exhaustion can occur after exposure to high temperatures and is often accompanied by dehydration. The symptoms include: confusion, dark-colored urine (dehydration), dizziness, fainting, fatigue, muscle or abdominal cramps, nausea, vomiting, diarrhea, pale skin, profuse sweating, and a rapid heartbeat. There are two different kinds of heat exhaustion: water depletion and salt depletion. Water depletion is characterized by excessive thirst, weakness, headache, and loss of consciousness. Salt depletion is characterized by nausea and vomiting, muscles cramps, and dizziness.

Heat exhaustion can be treated by cooling and hydrating. If you feel as if you're getting too hot and might be suffering from heat exhaustion, get out of the heat and rest, preferably in an air-conditioned environment or at least in the nearest cool and shady environment. Drink plenty of fluids (not caffeine or alcohol) and remove any tight or unnecessary clothing. Also, take a cool shower, bath, or sponge bath and apply other cooling measures like fans or



ice towels. If those measures don't help within fifteen minutes, seek emergency medical help. Do not take heat exhaustion lightly. Heat exhaustion can progress to heatstroke.

Heatstroke, also known as sunstroke, is the most serious heat illness and is considered a medical emergency. It can kill or cause damage to the brain or other internal organs. It often progresses from milder heat illnesses (heat cramps and heat exhaustion), but it can strike even if there are no previous signs of heat injury. If you suspect someone has heatstroke, call 911 immediately and give first aid until they arrive. Heatstroke results from being in high temperatures for too long and being dehydrated, which makes the body temperature control system fail. The medical definition of heatstroke is that the core body temperature is greater than 104 degrees. The symptoms include: throbbing headache; diz-

ziness and light-headedness; lack of sweating (despite the heat); red, hot, and dry skin; nausea and vomiting; rapid heartbeat (strong or weak); rapid, shallow breathing; behavioral changes (confusion, disorientation, or staggering); seizures; unconsciousness.

Call 911 if you suspect someone is showing signs of heatstroke. While you wait for medical help, administer first aid and try to lower their body temperature. Move the person to air-conditioning – or at least a cool, shady area. Remove any unnecessary clothing and fan the air while wetting his or her skin with water from a sponge or garden hose. Apply ice packs to the person's armpits, groin, neck, and back because they are rich with blood vessels close to the skin. Immerse the person in a shower or tub of cool water. If the person is young and healthy and suffered heatstroke while exercising vigorously, you can use an ice bath. However, DO NOT use ice for older adults, young children, those with chronic illnesses, or anyone whose heatstroke occurred without vigorous exercise. Doing so can be dangerous.

When possible, stay indoors during the hottest parts of the day. When outdoors, take frequent breaks in the air-conditioning or shade, drink plenty of water, and monitor yourself for signs of heat exhaustion or heatstroke.

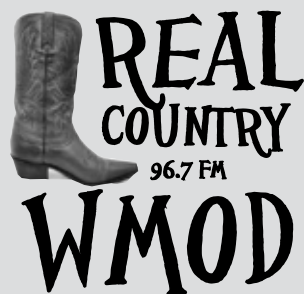

JSCC Cyber Defense Program Gets Elite Fed Designation

Jackson State Community College was recertified through 2022 as a National Center of Academic Excellence in Cyber Defense Two-Year Education by the U.S. National Security Agency and Department of Homeland Security.

The five-year designation puts Jackson State among an elite group of institutions offering computer information technology courses that meet rigorous federal standards and sets graduating students apart from others, said Dr. Tom Pigg, Dean of Computer Information Technology and Health Sciences. Recognized as leaders in the field, only about 40 community colleges and 200 four-year universities across the country have the designation.

"It's very important; it's huge, to say the least," said Pigg. "The benefit is that, because of the rigor required to get the designation, students will have this recognition that they attended a school that is a National Center of Academic Excellence."

Graduates often find work protecting national security information systems, commercial networks and critical information



infrastructure in both the private and public sectors.

The National Security Agency launched the program in 1998 to reduce vulnerabilities to the country's information infrastructure. Its goals are to promote higher education and research while producing professionals with cyber defense expertise.

The program was expanded to two-year colleges, technical schools and government training centers in 2010, and Jackson State

was first designated in 2012. "This is a fairly young designation for community colleges," Pigg said.

Ground Cover for Carefree Summer Gardening

If your yard contains shady or partially shady areas where grass will not grow, or if a slope makes mowing difficult and dangerous, ground cover may be the answer to your dilemma.

Forming a dense cover, these low-growing plants spread quickly. Not only do they add beauty to the environment, but they also prevent soil erosion and water loss. Most gardeners agree that grass is the best ground cover, but it is not suited to all locations.

Numerous conditions determine where ground cover works best, but the following locations are the most frequent places.

- Unusually wet or dry areas
- Beneath shrubs in beds or borders
- Banks or steep slopes bordering the yard
- Shady to partially shady areas near buildings
- Beneath trees where roots grow close to the surface

Prepare the bed as for any planting. Remove all weeds and continue weeding until plants are established.

Add a soil amendment, such as organic material or fertilizer to the entire area—not just to separate holes.

Choose from leaf mold, compost, or well-rotted manure to improve clay or sandy soils. For best results, take a soil test. Use three pounds of commercial fertilizer, such as 5-10-5 per 100 square feet, and mix into the soil when adding other soil improvements.

Plant in late fall or early spring. Apply mulch one to two inches deep the first two seasons to encourage rooting or runners. At this time of the year, avoid setting out in the heat of summer. Think about the plants you will set out this fall.

Once established, these plants prevent perennial weeds in your garden. Acting as an insulator, the ground stays cooler in summer and warmer in winter. Plus, they provide a habitat and cover for beneficial insects and other predators.

However, there are disadvantages. Slugs, snails, and other pests frequent the areas. If these insects are a problem, avoid slug-susceptible plants. The plants also compete with others for nutrients and moisture. Some varieties become too vigorous and choke out other plants. Others become invasive and must be controlled.

The following are recommended for easy maintenance. Common names are given.

- Ajuga (dark purple and variegated)
- Baby's Tears
- Bishop's weed (variegated)
- Creeping phlox
- Crown vetch
- Fescue
- Hosta
- Ivy
- Liriope or Turf lily
- Pachysandra
- Pearlwort
- Vinca (Periwinkle or Trailing Myrtle)

Once established, ground cover turns a barren garden plot into one of beauty and can simplify your yard work.
