## McTizic Elected Mayor of Bolivar

Bolivar City Councilman Julian McTizic led by thirty votes through two weeks of early voting and held on to win the city of Bolivar Mayor's race by 73 votes over two-time incumbent Mayor Barrett Stevens.

"I'd like to thank the citizens of Bolivar. Thank you, thank you, thank you. You believed in a change. You believed in me. You believed in us working together to make Bolivar better. I won't let you down. I look forward to working with the council and the citizens to make a Better Bolivar. I cannot individually thank all the people by name without forgetting someone, so I'll just say a tremendous thank you to everyone on my campaign. Thank you to all my family, my mom, my dad. Demetria and my boys, these past six months have tested me. Tested us. But that's just it. It was all a test to see if we were ready and we are."

McTizic, who at 30 will be the youngest mayor in Bolivar history, got his margin of victory in the

East Bolivar precinct, where his 229-128 difference was enough to overcome Stevens' 452-424 margin in West Bolivar.

Mayor Stevens, who served for years as a Bolivar City Councilman and for eight years as mayor, said his disappointment won't diminish his love for the city.

"I was disappointed. We had a little turn out. But I do appreciate the love of the citizens of Bolivar, even those that didn't vote for me. It's their decision. We had a good race. My opponent has been a good opponent. I'm going to continue to love Bolivar. I love all of its people, I'm gonna work for them. Bolivar's my town and I love it. And I'm going to retire."

The Mayor, who will relinquish



his post on June 30, said he won't be bored.

"I've got plenty to do. I've got hobbies. I fish, I woodwork, I build wheelchair ramps for my neighbors, people that need it or whoever. I have church work. I've got a lot of stuff to do. I'm not unem-

ployed."

Stevens' tone changed the following morning however, when he posted to social media that "our city leaders have done a fabulous job" and that he hopes, "our new mayor will have sense enough to *continued on B2*

## Hardeman County Remembered

This week's virtual train trip in our county takes us to Whiteville. Whiteville is one of the oldest settlements in our county, originally started as a trading post in the early 1800's by Dr. John White. It was known then as Whiteville Post and was located about two miles from where we know Whiteville today.

A ready water supply from Clear Creek made that area a natural place for a town site, but the town would not be there for long. The stage lines were laid out around 1821 and to be near to that, the town site was moved and one and a half miles west. The town grew rapidly along this busy (well, 1800's busy) roadway. The town was referred to by Mr. John Bills as "a thriving settlement"; the town had a post office, a school, doctors, lawyers, stores, a hotel, and a saloon.

The town would make its last move in the late 1880s. The old Tennessee Midland Railroad (later the N.C. and St. Louis Railroad) came through the area and the town moved to be close to the rail line. There is an old railroad story that says with the Tennessee Midland went bankrupt it was purchased by a gentlemen for an incredibly low price and that he sold it 24 hours later to the N.C. & St. L for a million dollar profit. Not a bad 24 hours!

This photo is the old Whiteville depot and the Duncan Hotel (thanks to Mrs. Betty Perry and Mrs. Betty Pepper Fleet for sharing the wonderful old photo). The



Duncan Hotel was convenient for passengers traveling on the trains without a diner car. Travelers could spend the night or enjoy a hot meal for only 25 cents before continuing on their journey. Depots along the rail line would telegraph to the next stop if the train was on time, if there were any problems, and so on. That telegraph message into Whiteville would be delivered to the Duncan Hotel so that as passengers stepped off the train and into the hotel they would be greeted with a hot meal and plate full of piping hot biscuits, right out of the oven. That's right, piping hot biscuits without any cell phones, computers, or tweets – just the miracle of the message of dots and dashes going over the telegraph lines.

As the years went on, many ladies would take the morning train from Whiteville to go into Memphis to meet friends, have lunch,

or go shopping (or all three!) and be back home by nightfall. That same train carried many men from the area off to wars and blessedly brought many back. Folks would pass through only long enough to enjoy a meal at the Duncan Hotel, while others got off the train in the lovely little town and put down roots. I'm sure there were many children who waved as the train passed by and folks who marveled at the places it could take them. There was probably more than one little boy who tried to run away from home on the train, or so I've been told.

Again, as happened in many places in our county, the hotel closed down and the rail lines were eventually taken up, so the rumble and rattle of the engine and the long, plaintive whistle across the evening's sky are only memories. But, oh, y'all, what marvelous memories they are!

Years ago, I would watch a show on television called Feed the Children, and wonder to myself if all the needs these people spoke of were real. On Saturday April 15, our flight of over twenty hours landed on the African soils of Kenya, but Feed the Children never prepared me for the hardships I was about to bear witness to.

I am Apostle Latese Jones, Overseer and Founder of Healing Hearts Church in Bolivar, Tennessee. My mother, Prophetess Emily Woods, Son Jeffery Jones, Jr. and Ms. Dominique Fair accompanied myself to form our mission team with the goal of spreading the word of Jesus Christ. God Blessed us with safe travels to and from Kenya so that we could be a blessing to others in his name. Everything about this experience made my team and I more humble and grateful for everything God has provided us with.

We visited the churches and homes of many while we were there. Most homes have no inside toilets, no stoves, no air conditioners, and no ice. Only those who are considered to be rich have washing machines or dryers. Churches are made of tine with dirt floors. 95% of the population still walk by foot and the animals travel the roads that are unmarked dirt paths. Some people traveled as far as 15 miles over hillsides and the dirt roads on foot just to come to church to hear the Word of God!

The most humbling experience of all was seeing how all the people loved Jesus, even though they all have so very little. Realizing it was not about me; but serving others through God, I gave what I



had away down to a ring that was on my finger. Which I gave to the eldest grandmother in the church. My vow before I left Kenya was to go back this year and help repair a church that we visited while helping as many people as possible by providing bottled water, food, bibles, personal hygiene kits, and

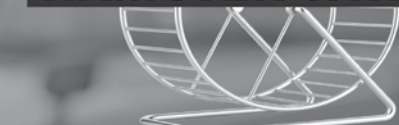

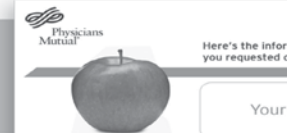

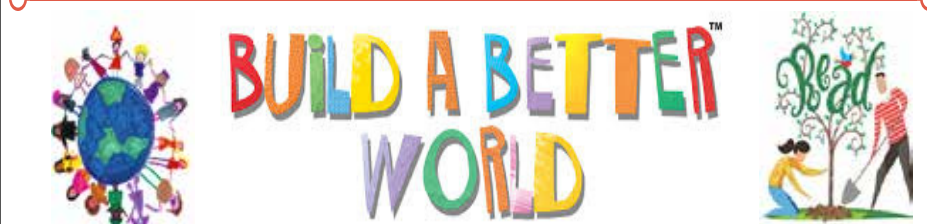

We tend to sow our wild oats when we are young women and men. Some might say we are getting it out of our system. I suggest that we have terribly mishandled our life planning.

I dreamed once that Jesus was returning. The sky turned multiple colors and the sun grew brighter. I could hear music and knew in the dream that Jesus was coming back. I started running toward the girl I was dating at the time, saying out loud as I ran, "But Lord, I'm not married yet!" I woke up and realized I had some longings,

some things in the life bucket list I felt I deserved before I went to meet Christ.

During those same years, I was passionate about sharing the Gospel with anyone who would give me a few moments. I led several family members to Christ and dozens of strangers. 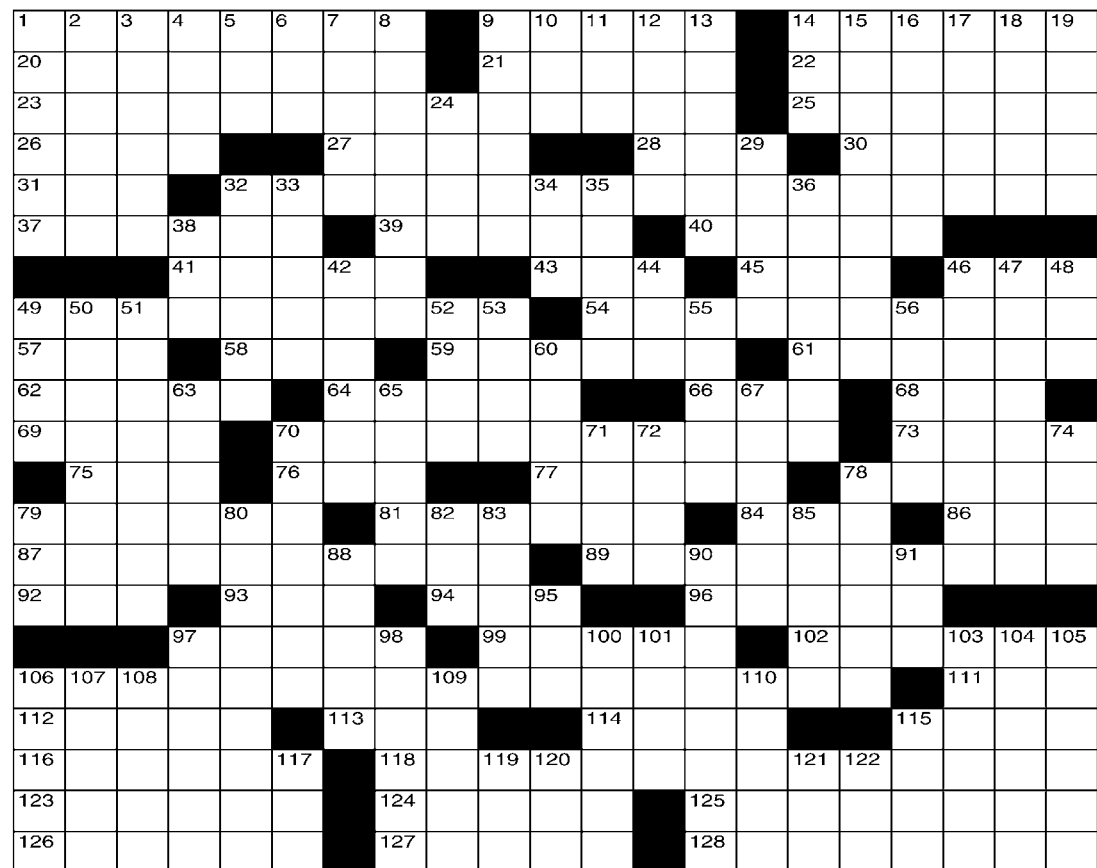

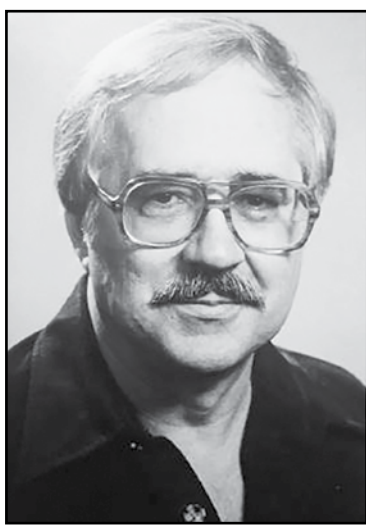

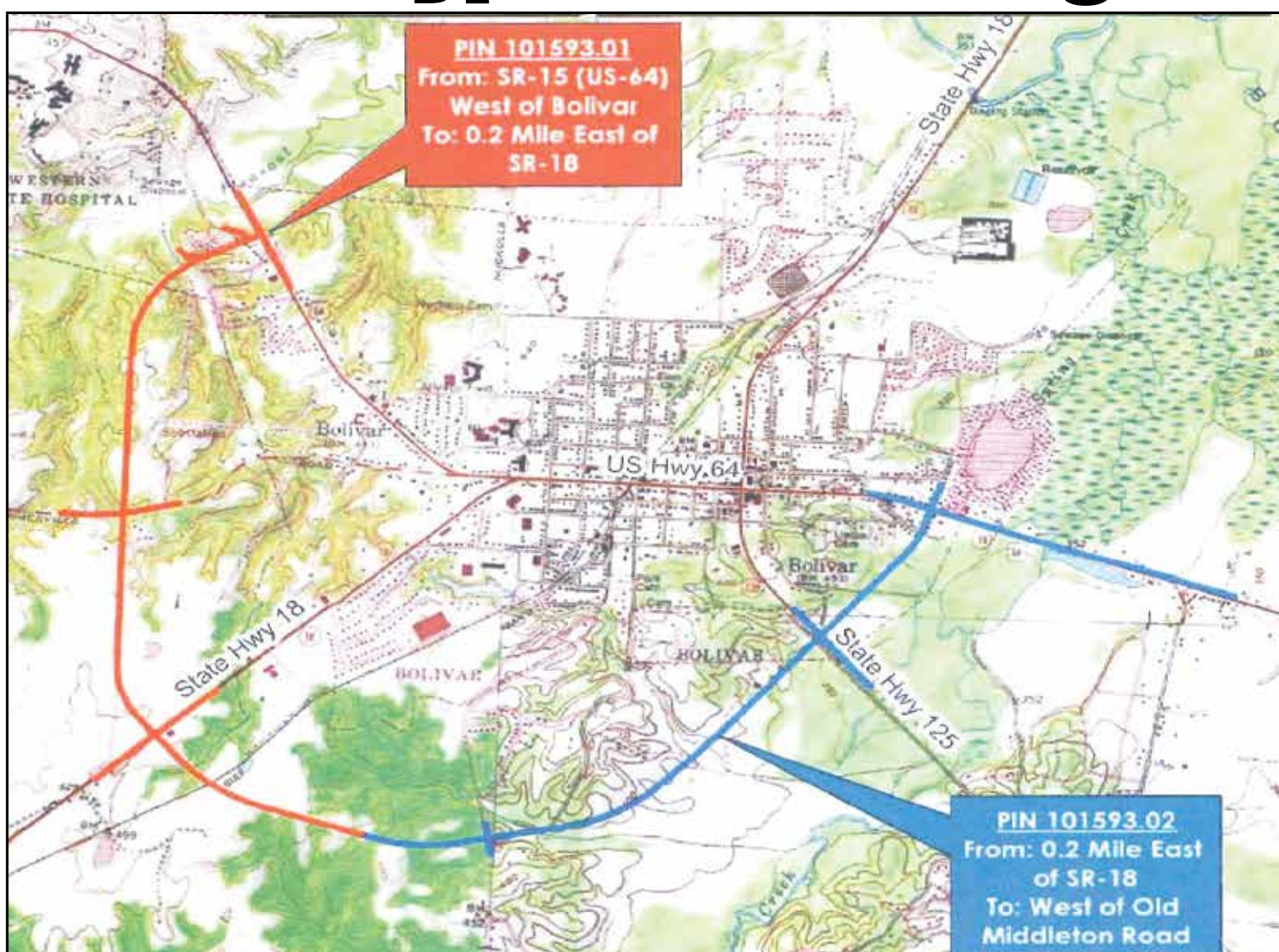

## County Narrowly Passes Budget on First Vote

Hardeman County Mayor Jimmy Sain broke an 8-all tie to pass the 2017-2018 Hardeman County Budget on the first reading.

The budget will be published to give the public a chance to view it, followed by a second reading and vote that is scheduled to take place June 20.

Mayor Sain broke the tie after a spirited debate that centered on the county schools funding. The budget passed did not give a tax rate, but Sain says the tax burden will not be increased.

"We have no plans to raise the rate of \$2.55," explained Sain. "Every surrounding county has a lower tax rate. We need to compete in West Tennessee. That means keeping the rate low and living within our means. Our committee is smart, conservative, and has been proven very successful in the past three years."

The Hardeman County Budget Committee consists of Chairperson Jerry Watkins, Junior Jimmerson and three county commissioners: Elmer Cobb, Jackie Sain and Jim Daniel.

The budget is expected to be printed in the May 25 issue of the *Bolivar Bulletin Times*.

The Hardeman County Election Commission will meet to certify the results of the May 16 election in Hardeman County on Tuesday, May 23 at the election commission office at 106 S. Porter Street in Bolivar. The public is welcome to attend.

## New First Responders Facility Taking Shape



After a long layoff between agreeing to build it and getting started, Hardeman County EMS began work on their building at the corner of Lucy Black Road and Highway 64.

In August of 2015, the Hardeman County Commission approved the building of a new ambulance service that will share space with the Bolivar Fire Department at the corner of Lucy Black Road and Highway 64.

The vote was 9-5 in favor with Major Wilburn, Anthony Pulse, Johnny Lanier, Mac Vaughan, and Viscen Morrow voting against. Donald McTizic and Elvis White were absent from the meeting.

Sain said the lack of space and poor condition of the building was also adding to the expenses of the department and a new facility was needed. Initial estimates were that the building would be completed in early 2016.

## Is Your Portfolio "Healthy"?

May is National Physical Fitness and Sports Month. If you can exercise regularly, you'll help yourself feel better, control your weight and even reduce the chances of developing certain diseases. But why not extend the concept of "fitness" to other areas of your life – such as your investment portfolio?

And to help maintain a healthy portfolio, you can draw on some of the same principles that apply to keeping your body in good shape.

Consider, for example, one of the things that happen when you exercise – namely, your body uses more oxygen. As an investor, you may need your portfolio to get "oxygen" in the form of infusions of new investment dollars. However, this type of injury will likely be much more severe if your portfolio is over-concentrated in just one asset class and the downturn primarily affects those exact assets. But if you own many different types of assets – stocks, bonds, government securities, and so on – you may reduce the impact of a downturn on your portfolio. Keep in mind, though, that this type of diversification can't guarantee profits or help you avoid all losses.

While exercise is essential to maintaining good health, it isn't the only factor involved. You should also get regular checkups with a medical professional, who can run various tests to measure changes in cholesterol, blood pressure, heart function and other areas. To help ensure your portfolio is healthy, you also need to chart its progress over time. And that doesn't just mean determining if you're getting the growth you need, though that's obviously of great interest to you. You also need to evaluate whether your portfolio has gotten out of balance, which can occur without your doing anything at all. To illustrate: If you start out with a certain percentage of one type of investment, such as stocks, and these stocks grow to a point where they now take up a bigger share of your portfolio, you may be taking on more risk than you had intended.

Consequently, you should review your portfolio at least once a year to evaluate both its performance and its balance. Once you've compared where you are today with where you were a year ago, you'll be in a better position to make appropriate changes if needed.

Do what it takes to keep yourself physically fit – but also take steps to ensure your investment portfolio is in good shape. It's vitally important to your future – and you can do the work without even breaking a sweat.

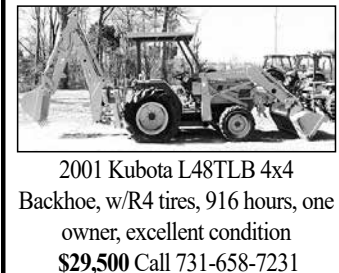

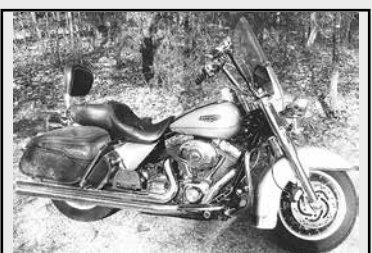

## May is Better Hearing and Speech Month

Pine Meadows along with their Speech-Language Pathologist wants you to know May is Better Hearing and Speech Month. With more than 795,000 strokes occurring every year in the U.S. across the age spectrum it is critical that all Bolivar residents adopt preventative lifestyle habits, know the warning signs, and understand the treatment options available to themselves and their loved ones should a stroke occur.

Although more common in older adults, strokes are trending upwards in younger Americans. Not all strokes are preventable, but certain lifestyle habits can reduce a person's risk of having one dramatically. Maintain a healthy diet, low cholesterol, exercise regularly, limit your alcohol consumption, and refrain from smoking, and you're well on your way to stroke prevention.

Patients who arrive at the emergency room within 3 hours of onset of their first symptoms often have less disability 3 months after a stroke than those who received delayed care, states the CDC-thus, recognizing the signs and taking quick action is the key. If you suspect someone is having a stroke, learn this acronym: FAST

Face: Ask the person to smile. Does one side droop? Arms: Ask the person to raise both arms. Is one arm weaker? Speech: Ask the person to repeat a simple phrase. Is the speech slurred or strange? Time to act is NOW if you see any of these signs! Call 9-1-1 right away.

Of the 795,000 Americans who suffer strokes annually, more than 130,000 die. For those who survive a stroke, quality of life becomes an important issue. In addition to regaining physical abilities such as the ability to walk, get dressed, and bathe independently, one's capacity to communicate may also be severely damaged by a stroke.

"A person's ability to communicate is the foundation of just about everything they do, and every interaction they have, said Bolivar based Speech-Language Pathologist Mackenzie German (pictured above) of Pine Meadows. "Beyond just having their basic needs met, the degree to which communication skills are restored affects stroke survivors' social interactions and relationships, employment status and success, and overall satisfaction and participation in life. Seeking treatment from a speech-language pathologist can make a transformative difference in helping people enjoy a fulfilling post-stroke life."

One of the most common communication challenges that follow a stroke aphasia, a disorder that affects a person's ability to understand or produce language. About 25-40% of stroke survivors acquire aphasia. Other communication difficulties include slurred

speech due to weak muscles and difficulty in programming muscles for speech. Besides these challenges, speech-language pathologists help with cognitive challenges following a stroke-which may include memory and problem-solving skills- and swallowing problems that result from weakness and/or incoordination of muscles in the mouth and throat.

"During Better Hearing and Speech Month, we want stroke survivors and their loved ones to know that speech-language pathologists are here to help," German added. "We offer a range of therapeutic services to meet the challenging needs of these individuals."

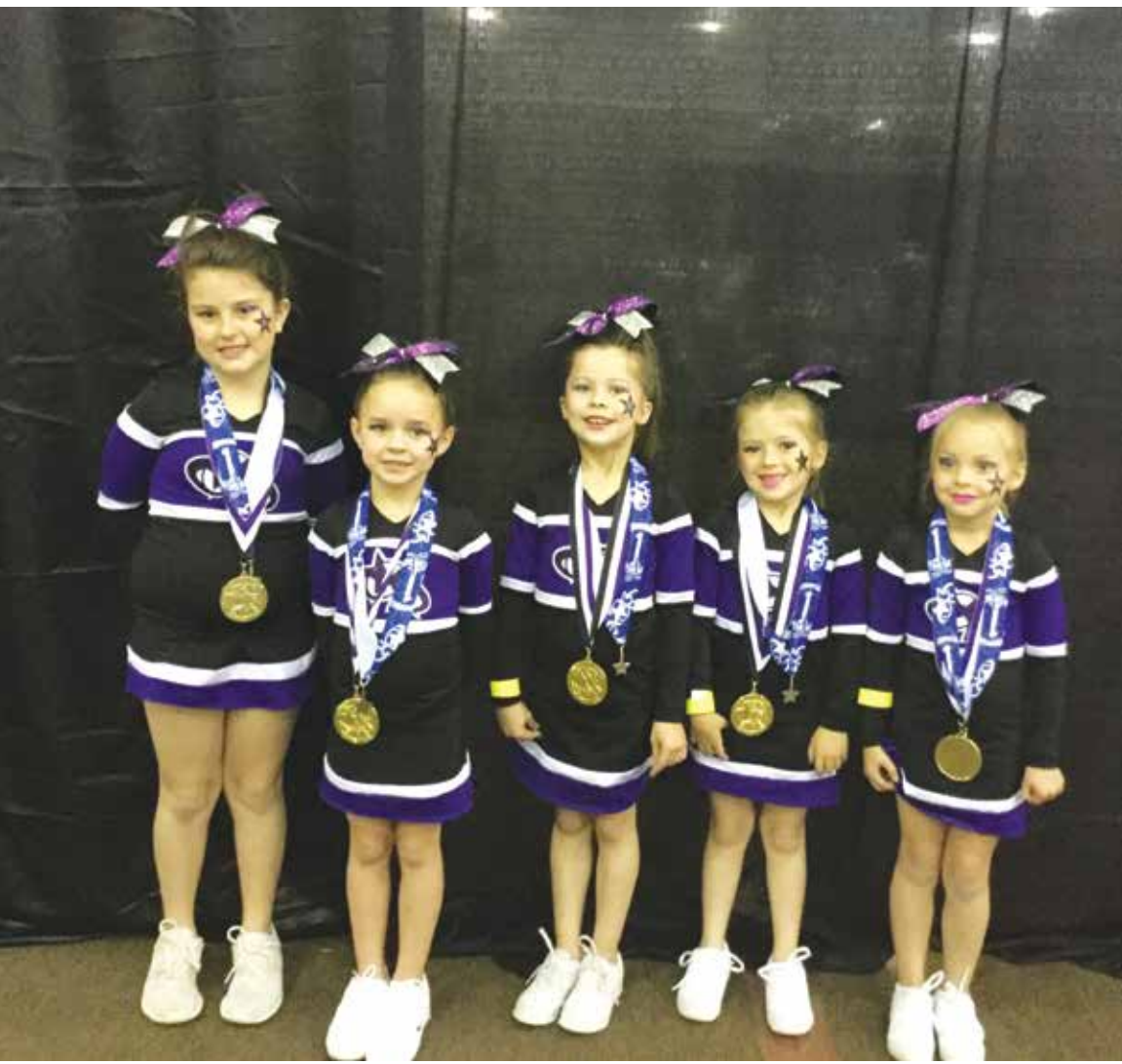
