Allen White School supporters and alumni received some long awaited good news at a town hall meeting at the Bolivar Municipal Center on May 11. Announced by State Representative Johnny Shaw, a \$90,000 grant has been approved by the State of Tennessee towards the re-construction of the historic building after a 2012 arson severely damaged the site.

The school was started in 1905 as Hardeman County Training School, a school for African Americans that held classes in a Masonic Lodge building. The school was led by Jessie C. Allen, who is one of the two men

Hardeman County Remembered by Lisa Coleman

As the last few weeks have certainly shown you, I do love trains. My love of trains goes back to my childhood and I think it is imbedded in my DNA.

I grew up near the train tracks and the sound of the train coming through was part of the background of my childhood. I remember my Dad taking us down the street to be closer to the tracks and he almost always seemed to know just when to take us so that we could see the train go by. He also taught me how to lay a penny on the track and have the train flatten it, which, when you are a kid, was a pretty awesome thing to get to do. I always loved the chance to ride a train whether it was a real one or even a small one at a fair or theme park.

My Dad's first job was working for the Illinois Central railroad. He helped out a neighbor who worked for the IC doing lots of job, mostly from about Gibson County down into North Mississippi. He was about 13 years old at the time. In talking about it with him recently he told me that he didn't get paid for working for the railroad; I asked him if he got to be around trains all day and hang out at the depot sometimes. He said yes, and I told him that was his paycheck!

My great grandfather, Albert Luke Lanier was another train man in my family. He worked as a telegraph operator for the railroad for many years, up and down the line in Tennessee and Mississippi. He was even the telegraph operator in Grand Junction for a few years back in about the 1920s, a job which had been held years earlier by none other than Thomas Edison.

My brother says I am the only person who likes it when you have to stop and wait for the train to



cross. When I worked in Jackson, Tennessee I would take a particular route either to or from work some days just because I knew when the train would be coming through and I would get a chance to stop and watch and listen to it. Marvelous.

I like trains because they are nostalgic and such an amazing part of our American history. I like trains because they get you where you are going faster than you could get there, but you have to sit back and enjoy the ride. I like trains because it is fascinat-

ing to me that something so large and heavy and mechanical cuts across the countryside on such impossibly small rails. I love the sound of the lonesome whistle cutting through the night sky either reminding you of why you had to leave or stay or of someone or someplace down the line you want to see. I like the noise and steam and smoke and the rumble and rattle of the big iron horse on the rails.

I surely do love trains, y'all. Remember to wave at the engineer whenever you get the chance.

Saturday nights in Kemah, Texas are marked by loud, classic and flashy cars. This past week I saw everything from a classic '57 Chevy to a row of a dozen Corvettes. There were even a couple of Lamborghinis parked side by side. If you like cars at all, it's an impressive showing. I was not there to see the show, however. I needed to grab a couple of things at the market while waiting to pick up my daughters. After taking a look around, I drove off to the other end of the parking lot and noticed another car with it's hood up. The '97 Ford Escort had really put the miles in, and the car looked well-used. Inside, a woman with pink hair sat next to a guy in sunglasses who appeared to be sleeping.

"You guys ok?" I always ask when someone has a hood up and nobody seems to be working on anything.

"I don't know what is wrong with it." The lady was personable as the guy stayed sleeping or drifting in thought in the hot sun. She described what she heard and gave some helpful clues.

Ironically, I had a flat tire just a couple of miles away. I had my daughters in the car at that point, and we pulled to a vacant lot near a sidewalk. People begin to walk way around us, probably fearing I was up to something sketchy. Eventually, a guy did ask if we needed help, but I had made a call and gotten the tool I needed.

Sunrise: Overcome Fear by David Coy

When I was a teenager I was an introvert of far greater degree than I consider myself to be today. I took my very first public speaking course in high school. It was an afternoon class and the night before each class when I knew I was to speak before my classmates I did not sleep well. The day of the class my stomach was in knots and my palms were coated with sweat. I became more anxiety filled the closer the hour of class approached. Sometimes some people who lose a significant loved one experience anxieties and fears in their life. Now that

they are alone and have been used to being a part of a dynamic duo, the adjustment to being single has many unknowns connected with their knew life.

With the unknown aspects of this new life may come anxiety or fear. Where does a person go from here? How do they begin and where? One person shared with me they were very capable in the past in dealing with life's changes and challenges, but now it is all so overwhelming. That is anxiety speaking. Maple Corn Muffin and Sausage Sandwiches

Ingredients

- Nonstick cooking spray
- 1/3 cup unprocessed wheat bran
- 1/3 cup whole wheat flour
- 1/3 cup cornmeal
- 1/2 teaspoon baking soda
- 1/2 teaspoon baking powder
- 1/8 teaspoon salt
- 1 egg, lightly beaten
- 1/2 cup buttermilk
- 3 tablespoons maple-flavor syrup
- 1 tablespoon vegetable oil
- 16 ounces bulk turkey breakfast sausage
- 2 teaspoons Dijon-style mustard
- 2 small red and/or green apples, cored and thinly sliced
- 2 tablespoons maple syrup

Directions

Preheat oven to 375 degrees F. Lightly coat twelve 2 1/2-inch muffin cups with cooking spray; set aside. In a medium bowl stir together wheat bran, flour, cornmeal, baking soda, baking powder, and salt. Make a well in the center of flour mixture; set aside. In a small bowl combine egg, buttermilk, 3 tablespoons syrup, and oil. Add egg mixture all at once to flour mixture. Stir just until moistened (batter should be slightly lumpy). Spoon batter into the prepared muffin cups, filling each about one-third full. Bake about 10 minutes or until a wooden toothpick inserted in the centers comes out clean. Cool in muffin cups on a wire rack for 10 minutes. Remove from muffin cups. Cut each muffin in half horizontally. Meanwhile, in a medium bowl combine sausage and mustard. Shape mixture into twelve 2 1/2-inch-diameter patties. Coat a medium nonstick skillet with cooking spray; heat skillet over medium-high heat. Add patties; cook about 6 minutes or until brown, turning once. To serve, place bottoms of muffins on a serving platter. Top with half of the apple slices, the sausage patties, the remaining apple slices, and 2 tablespoons syrup. Replace tops of muffins. If desired, secure with wooden skewers.

On "529 Day," Think About College Savings Plans

You probably won't see it on your calendar, but May 29 (5/29) is 529 College Savings Day, or 529 Day for short. This day, named after the 529 plan, a popular college-savings vehicle, is designed to promote people's awareness of the need to save and invest for the high costs of higher education. And that need has never been greater. Consider the following:

College prices keep moving up. College costs just keep rising. For the 2016-2017 school year, the average cost (tuition, fees, room and board) was about \$20,000 for in-state students at public universities and more than \$45,000 for private schools, according to the College Board. These costs are likely to continue climbing.

Student debt is at record levels. Of the Class of 2016 graduates who received loans - about 70% of the total student population - the average individual debt was \$37,172, a record high, according to a study cited by CBS News.

What can you do to help your children graduate from college without having to provide a big "IOU" in exchange for a diploma? In the spirit of 529 Day, you might want to consider investing in a 529 plan. It's certainly not the only means of saving for college, but it does offer some attractive benefits.

For starters, contribution limits are quite high - you can accumulate more than \$200,000 per beneficiary in many state plans. And you can typically invest in the 529 plan offered by any state, even if you don't reside there. If you do invest in your own state's plan, you may be eligible for state income tax incentives.

Also, all withdrawals from 529 plans will be free from federal income taxes, as long as the money is used for a qualified college or graduate school expense of the beneficiary you've named - typically, your child or grandchild. (Withdrawals for expenses other than qualified education expenditures may be subject to federal and state taxes and a 10% penalty on the earnings portion of the distribution.)

Furthermore, you have complete control of your 529 plan assets. You decide who will get the money and when he or she will get it. You can even change the beneficiary to another family member.

Keep in mind, though, that your 529 plan will be counted on the Free Application for Federal Student Aid (FAFSA), although schools typically only consider up to 5.6% of parental assets when calculating financial aid. And distributions from a parent-owned 529 account used for one year's college expenses will not usually reduce next year's financial aid eligibility. (For more information on how a 529 plan might affect your child's financial assistance, you may want to consult with a college's financial aid office.)

If you can find a 529 Day event in your area, you may want to attend so that you can learn more about the many aspects of saving for college. But even if you can't personally take part in 529 Day, give some thought to a 529 plan - it might be part of the solution for helping your children earn a relatively debt-free degree.

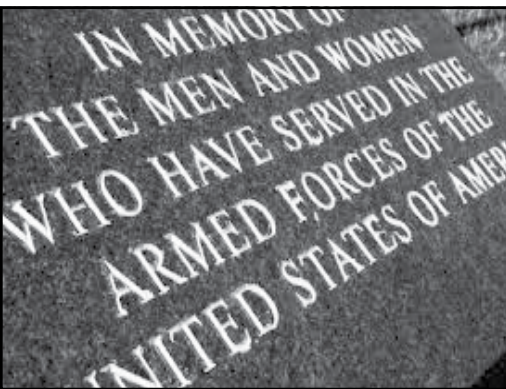

A Permanent Way to Celebrate Memorial Day

by Calley Overton

Memorial Day is not just the unofficial kick-off to summer and an excuse to fire up the grill. Originally called Decoration Day, it is a day to remember those who have died serving our country. One way to do so is to see if the deceased veterans in your family are eligible for a government headstone or marker noting their service. VA benefits include a headstone or marker, a memorial headstone or marker, or a medallion.



The VA provides a headstone or marker for veterans who died on or after November 1, 1990, regardless of whether the grave is marked with a privately purchased headstone or not. A headstone or marker is also provided for the unmarked grave of veterans who died before November 1, 1990. The memorial headstone or marker is furnished for placement in a cemetery to commemorate a deceased eligible veteran whose remains do not rest in a cemetery. There is also a medallion that an eligible veteran may receive instead of a government-furnished headstone.

Applicants can be the deceased's next-of-kin, a person authorized in writing by the next-of-kin, or a personal representative authorized in writing by the deceased.

You must attach a copy of the deceased veteran's discharge certificate or a copy of other official document(s) establishing qualifying military service to make a claim. The deceased's Social Security number is essential for finding the discharge in a government database. A resource for Hardeman County applicants are our local funeral homes. For example, if the deceased's funeral was held at Shackelford's Funeral Directors, they can provide assistance in finding the required information for the headstone or marker.

Preparing a Workforce for the Future by Jessica Simmons

Hardeman County's unemployment rate rose from 6.1% in March of 2016 to 6.5% in March of 2017. But just because there's a rise in unemployment numbers, doesn't mean that there aren't jobs to be found within our county. All that is needed is the desire to work, have the ability to show up on time, and be able to meet the needs of employers in our region.

Mayor Jimmy Sain hosted a workforce development training workshop at the municipal center for job seekers to provide them with needed skills such as; building a resume, emphasizing the value of workplace learning, and to address the hiring demands of employers from the onset. The goal is to place workers in jobs where there are career development and advancement opportunities. Workforce development is based on the common-sense concept that a better educated workforce is more likely to create success for their employer. Mayor Sain's goal was to teach that everyone starts somewhere. "No one starts out at supervisor pay. You have to work your way up, no matter where you start out. It just takes a little time and effort."

Mayor Sain introduced speaker Jim Pierce, Vice President of Operations at Kilgore Flares Corporation in Toone to speak on their



hiring dilemmas. Currently needing to hire around 25 employees to meet their contract demands for the government, Kilgore keeps running into the problem of potential personnel being able to pass a background check and drug test. Pierce offered graduates from the program a job if they could pass an ATF background check, drug screening, and complete the other steps Kilgore must follow due to government involvement with

their programs. A few of the employers the mayor has to potentially offer jobs to his students; Hardeman County Sheriff's Department, Taco Bell, O'Reilly Auto Parts, Auto Zone, and others.

Her emphasis for the graduates was to keep "moving forward".



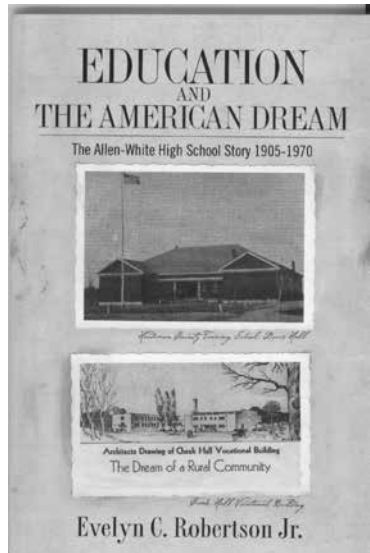
Allen White School Gets Grant

that Allen-White School was later named for. Circa 1918-1920, the school's own building was built on donated land with a \$4,000 bank loan obtained by the school's trustees, matched by a \$4,000 donation from the Julius Rosenwald Fund.

The school's second namesake, J.H. White, became school principal in the 1928-1929 school year. In 1930, the school added a junior high school program and in 1932 it expanded to include the four grades of high school. The school's first high school class graduated in 1933. Allen-White was Hardeman County's only high school for African Americans and enrolled students from throughout the county; some students had to find room and board in Whiteville in order to attend.

The building was acquired by an organization associated with the El Canaan Missionary Baptist Church and listed on the National Register of Historic Places in 2005. Destroyed in an arson fire in May of 2012, it has been a hope of alumni and supporters to rebuild it and turn it into a museum to showcase African American history and culture in education.
