CUPVILLE, NE -- Makers of styrofoam, plastic, and paper cups are planning a march on a West Tennessee town in protest of the Bolivar City Council approving alcohol at certain events in the city.

"We're not going to put up with this," said Bill Gorman, President of the Hidden Agenda Beverage Cup Company. "We have been instrumental in keeping a drinker's drinking in a public a secret for years and we're not about to give up on our share of the marketplace in Bolivar."

The march is expected to take place in time for the Smokin' Downtown BBQ Festival in October.

HARDEMAN COUNTY, TN -- Law Enforcement Officials will be out in full force on October 7, 2017 between the hours of 9:30 a.m. and 1:30 p.m., checking for motor vehicle operators eating Rotary Chicken on the way home from pickup across the street from Bolivar Hardware and Lumber. "We just want to make sure people realize the seriousness of eating your delicious Rotary Chicken(s) on the way home instead of saving it for your family," said a Law Enforcement Guy. "We want people to use napkins and enjoy the delicious sides that go with it in a safe manner, not to mention the trouble that could arise if you show up at home with an empty sack instead of a delicious Rotary Chicken in it."

Officers will look for tell-tale signs of consuming Rotary Chicken(s) while driving (DUIRC for short) such as finger licking, big smiles, and illegal U-turns as customers go back to see if there are any unclaimed chickens left on the grill.

Council Approves Alcohol at Events

The Bolivar City Council approved allowing alcohol to be consumed at special events in the city during their regularly scheduled meeting on September 11.

The ordinance, labeled #17-006, amends the Bolivar Municipal code to "grant exceptions to the prohibition of drinking or consuming alcoholic beverages on public property."

The change, which passed unanimously at the August meeting,

Our County Remembers 9/11



Hardeman County joined the nation this past week as Hardeman County Mayor Jimmy Sain, City of Bolivar Mayor Julian McTizic, Bolivar Police Chief Pat Baker, Hardeman County Sheriff John Doolen, various pastors, along with other community leaders held a Time of Remembrance on Sunday, September 10, at the Bolivar Downtown Amphitheatre for those who tragically lost their lives on September 11, 2001.

Monday morning began with the annual breakfast buffet at Joe's Restaurant with City of Bolivar Mayor Julian McTizic, Bolivar Fire Chief Lynn Price, Bolivar Police Chief Pat Baker, half a dozen state troopers, firemen, first responders, and volunteers all in attendance. A

After a pause in the discussion, Councilwoman Suzanne Rhea made a motion to approve the change. The motion passed with four councilpeople (Rhea, Jonathan Joy, Todd Lowe, and Melvin Golden) voting in favor, two (McKinnie and Walley) voting against, and one, Tracy Byrum, declining to vote on the issue.

Groups or events wishing to have alcohol at an event or for a weekly event such as Music on the Square, will have to apply with the city council and pay a fee.

The ordinance change will take effect in 10 days, according to McTizic.

Woods Added to City Council

The Bolivar City Council appointed a new councilperson for District A, Position 3 at their monthly meeting. Tommy Woods, Hardeman County Sheriff Department's School Resource Officer in Middleton won by a 4 to 3 vote by the council after hearing from the four candidates for appointment; Betty Golden, Teresa Golden and Donnell Polk, who received the remaining three votes.

Voting for Woods were Tracy Byrum, Todd Lowe, Suzanne Rhea, and Larry McKinnie.

"I look forward to serving with Mr. Woods. I know him to be a jewel in our community and I'm excited to have him join our council as we continue working towards a Better Bolivar," said Mayor Julian McTizic.

Woods replaces Quantissia Hamer, who resigned from her District A Position 3 spot. The seat will be up for re-election in 2019.

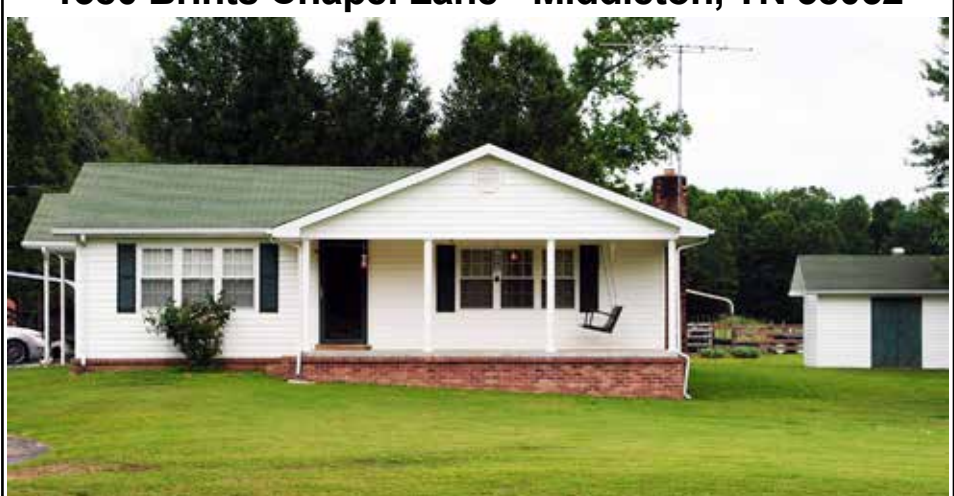



Our Part in a Public Execution

This morning, I spent several hours sitting with and interviewing a man in Houston, Texas. The man has been on a year and a half mission to bring his wife home from China. The man's wife, Sandy, was traveling with an American delegation to China to promote trade between our two countries. She was held in detention at customs and questioned by the secret police. She was then taken to a holding facility and restricted from contacting anyone except to relay a made-up story explaining her delay. The party she was traveling with had no clue what had happened to her. Her husband was also given a fabricated story. She was allowed to make one phone call only to say she would be there for an extended time. She was not allowed to say she was being held as a spy. Her husband, after finding her cell phone had not been used in over a week, filed a missing person's report. The US consulate was then able to determine that she was being held by the secret police.

This woman has been imprisoned, tortured, coerced into making statements, and given no legal representation for over a year. Her September trial will

be secret under different process than a normal Chinese public trial. It could be likened to a court tribunal behind closed doors with the Chinese version of the CIA handling the trial. Secrecy has been the key to keeping this issue from blowing up more than it has. Since so much has been clouded by her captors, the truth has been squelched from public news. It is a travesty of justice and I urge you to pray for Sandy and her husband Jeff.

Secrecy is the key to misinformation. If you can muzzle the prophet, you can mislead the people. Some of the same tactics were used to crucify Jesus. The process soon became very open to the public, however. The treatment of Jesus, from his humiliating public scourging to his being nailed to a cross in front of a crowd, was open to the public. He was charged by the elite religious leaders and condemned by the masses. God could have kept His Son from being a public spectacle, instead he lifted Him up for the world to see. God, was in essence, making the trial of history to be clearly played out. Our condemnation was laid on Christ. By extension, we were basically held to a public trial

Pray for those who need to remember how privately and publicly we were all in trouble and how gracious Jesus has been to us. Please, also take a moment to pray for Sandy and Jeff. By the time you read this column again, her fate will have been handed down.

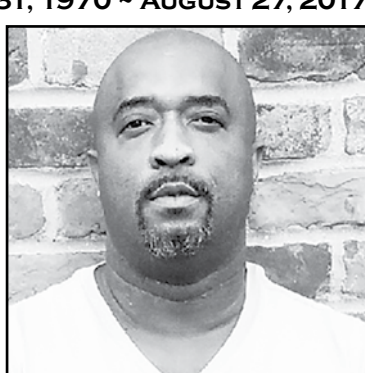

BEA Improves Metering and Service

Prior to investing in an advanced metering system six years ago, the Bolivar Energy Authority in Tennessee felt hampered in key areas of utility operations and customer service. The staff faced unsafe conditions entering yards to read meters, trudged through inconsistent billing cycles, could offer little good information when responding to high bill complaints, and considered distribution system maintenance and outage response to be inefficient and costly. Today, with the advanced metering infrastructure (AMI) from Honeywell [formerly Elster], BEA is deploying a variety of new billing, engineering, and energy usage applications proving to be very popular with utility customers and employees.

An industry leader in operations and safety, BEA maintains 1,500 miles of distribution line and serves 11,400 customers across 700 square miles of service territory covering five counties in two states. When deciding on which AMI system to purchase, BEA officials visited nearby public power systems and examined Honeywell system deployments.

"In particular, we found the Honeywell AMI system would work well for a utility like ours," said John Fortune, President and Chief Executive Officer. "Yes, price was a factor. As important, we serve a wide area but do not have a fiber backbone for network communications. We need an AMI system that provides a strong radio frequency signal, and Honeywell maintains very good relationships with the RF vendor community. The Honeywell system's ability to communicate with our legacy billing system also proved to be a major point in Honeywell's favor."

A marketing partner of Hometown Connections, Honeywell Smart Energy is enabling utilities and distribution companies to deploy advanced capabilities that transform operations, reliability, and environmental sustainability while also providing solutions that engage customers in a more meaningful way. Honeywell meters monitor energy usage for improved energy management. Plus, Honeywell Smart Energy helps utilities exceed their demand management goals through a broad array of customer engagement and energy management programs.

"So far, our AMI system is only scratching the surface of all it can do, and we cannot imagine not having it," said Tony Kirk, Vice President and Chief Financial Officer for BEA. "We no longer need to roll trucks to connect or disconnect meters. We used to struggle reading every meter every month. Now, we can read every meter several times per day. Thanks to the integration of the AMI data from Honeywell with our meter data management software, our customer service representatives view weather and account information on screen when customers call with questions about their bills. Our engineers use the AMI system to monitor functions such as distribution transformer loads, substation loads, and voltage alarms. We can often pinpoint a location of an outage before the customer even knows there's a disruption. The system enables us to reallocate metering staff to inspecting lines and maintaining the distribution system. It simplifies work tasks, improves accuracy and efficiency, and reduces the duration of outages."

Kirk emphasized the deployment of the AMI system enabled BEA to offer a prepay system that has proven so successful at revenue collection that it saved the community from a rate increase. He explained, "Today, more than 1,000 or 12 percent of our customers are using U.S. Payments' PaySite® kiosks for prepay services, as arranged by Excecleron. We have been able to collect over \$150,000 in bad debt because Honeywell and Excecleron have worked so well together."

BEA customers may access two kiosks to prepay or pay their electric utility bills 24 hours per day. One kiosk is located onsite at the utility; the other is Maxwell's Big Star in Bolivar. Prepay helps customers budget their daily usage. They pay for service prior to delivery, and as they use electricity, their credit balance is reduced daily. BEA issues to participating customers a card with a 12-digit customer/location identification number. Customers enter their I.D. number on the kiosk keypad to access their account and make a payment. Customers can pay with check or cash at no additional charge and with a credit or debit card for a \$2.95 fee.

"The kiosk program represents a huge and valuable change for us and for our customers," Tony Kirk said. "It's a win-win situation. The customers are enjoying the convenient access and financial control the kiosks offer. This frees up our customer service and administrative staff. The money collected by the kiosks is posted to our bank accounts immediately, with no risk of loss through robbery. About 20 percent of our residential customers are using the kiosks, greatly reducing the volume of mail and visits to our office."

The kiosks represent part of an expanding collection of payment and energy usage applications that are available to BEA customers and built on the Honeywell AMI platform. In addition to the kiosks, customers may use the BEA website to pay their bills online or use an interactive voice response system to pay by phone. Customers may make payments at the customer service window at the BEA office during business hours. Through the Excecleron MyUsage Mobile solution deployed by BEA, prepay customers can choose to receive a daily text or email with their account balance information.

In addition, via MyUsage Mobile, customers may obtain information about their electricity consumption via smart phone. In the near future, BEA customers will be able to use the MyUsage Mobile solution to make payments to their accounts.

To date, officials from more than 20 local utilities have visited BEA to see how the organization uses its AMI system to improve operations and customer services.

Key to the success of BEA's AMI deployment is having an IT professional on staff. "I coordinate the cybersecurity demands of the system, as well as spearhead efforts by the staff to mine all of the many benefits and features it offers," said Steve Herriman, Purchasing and IT Manager. "I am able to drive the integration of the data from the AMI system with our MDM, outage management, and billing solutions."

"We give the Honeywell technical support team very high marks," Herriman noted. "From our launch of the project over six years ago with the Elster team through the transition to Honeywell today, their personnel is responsive and very knowledgeable. The same people have been assigned to our account for a long time. They work hard to help us integrate the AMI system with a variety of software packages, and they work with us to find new and innovative ways to use the AMI data."

The proposed project is located in the area of Hornsby Loop Road, Forrest Hill Road, and Walnut Grove Road outside Hornsby in Hardeman County. The Town of Hornsby plans to replace up to 5,500 LF of existing water main with CDBG awarded funds of \$249,760.00 to address reoccurring water loss issues. A floodplain designated area of less than .5 of an acre has been identified in one section of Hornsby Loop Road that may be identified as requiring line replacement.

The Town of Hornsby has considered the following alternatives and mitigation measures to be taken to minimize adverse impacts and to restore and preserve natural and beneficial values: This project is to lay new water mains in areas with existing lines within two target zones. Minimal impact is expected with boring to be utilized where needed and all areas to be return to its original condition to the project.

The Town of Hornsby has reevaluated the alternatives to building in the floodplain and has determined that it has no practicable alternative. Environmental files that document compliance with steps 3 through 6 of Executive Order 11988 and/or 11990, are available for public inspection, review and copying upon request at the times and location delineated in the last paragraph of this notice for receipt of comments. This activity will have no significant impact on the environment for the following reasons:

- The project will only be conducted in the narrow boundaries of the current right-of-way.
- The portion of road that crosses a floodplain is less than one half of one acre.
- Conditions may be improved by eliminating any water loss/leakage in the area.
- The area identified in the floodplain may not be chosen as an area to have the water main replaced.

There are three primary purposes for this notice. First, people who may be affected by activities in floodplains and those who have an interest in the protection of the natural environment should be given an opportunity to express their concerns and provide information about these areas. Second, an adequate public notice program can be an important public educational tool. The dissemination of information about floodplains can facilitate and enhance Federal efforts to reduce the risks associated with the occupancy and modification of these special areas. Third, as a matter of fairness, when the Federal government determines it will participate in actions taking place in floodplains, it must inform those who may be put at greater or continued risk.



September is Suicide Prevention Month

In Tennessee, an estimated 950 men, women, and children die by suicide each year. More people die by suicide each year than from homicide, AIDS, or motor vehicle accidents. Suicide is the leading cause of violent deaths in our state, nationally, and worldwide, far above homicide and death due to natural disasters. Suicide is the second-leading cause of death among youth and young adults ages 15-24 in Tennessee and for the United States at large. According to the Tennessee Department of Health, there were 1,065 recorded suicide deaths in our state in 2015, at a rate of 16.1 per 100,000 population.

In a lot of cases, suicide can be traced to unrecognized, untreated, or poorly treated mental illness. It can happen to people of either sex, any race or ethnicity, and any economic status. The average suicide death leaves behind six survivors—family and friends of the deceased—all of who are at increased risk for a suicide attempt themselves. As if the emotional and psychological toll were not enough, suicide and suicide attempts cost the state of Tennessee \$1 million a year in medical treatment, lost wages, and lost productivity.



The Tennessee Suicide Prevention Network (TSPN) and its allies in the public health, mental health, and social service fields are joining forces to recognize the month of September as Suicide Prevention Awareness Month. During this annual observance, TSPN and its allies arrange several educational and memorial events across Tennessee. These projects help teach the public about the problem of suicide and how it can be prevented. They also give us an opportunity to remember those lost to suicide; to encourage survivors of suicide,

attempts, and people who have triumphed over mental illness; and to recognize individuals who have made notable contributions to suicide prevention efforts in our state. *Source: tspn.org*

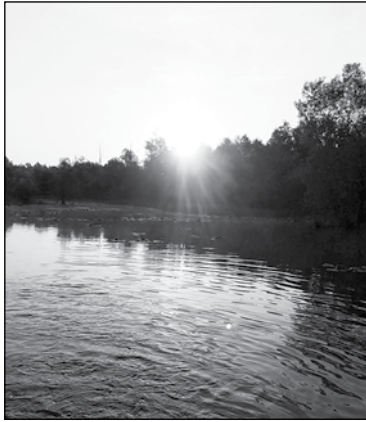

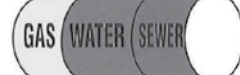

Online Voter Registration Starts continued from A1

of State Trey Hargett said.

"In addition to offering a convenient way to register to vote, I'm excited that online voter registration will allow currently registered voters the opportunity to update address changes instantly. This will eliminate paperwork and additional time spent at a polling place for voters who moved but did not notify the election commission before the election," said Hardeman County Administrator of Elections Amber Moore.

The new system will allow U.S. citizens with a driver's license or photo ID issued by the Tennessee Department of Safety and Homeland Security to register to vote online. Each online submission is checked against the department's database while securely obtaining an electronic signature already on file with the state.

The system will also help streamline the process of changing a voter's address. It allows someone to update their information instantly while reducing time-consuming data entry by state or county employees who traditionally had to manually type in what voters write on paper forms.

Tennesseans must still register online or use a paper form at least 30 days before an election to participate.

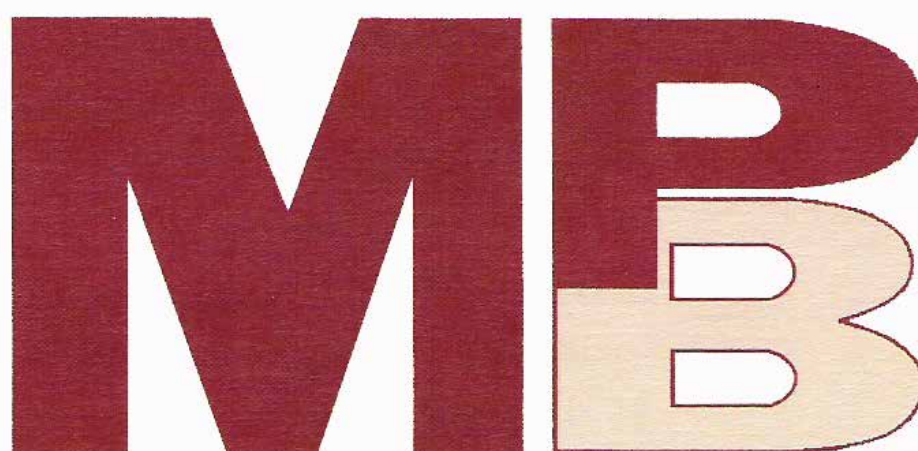

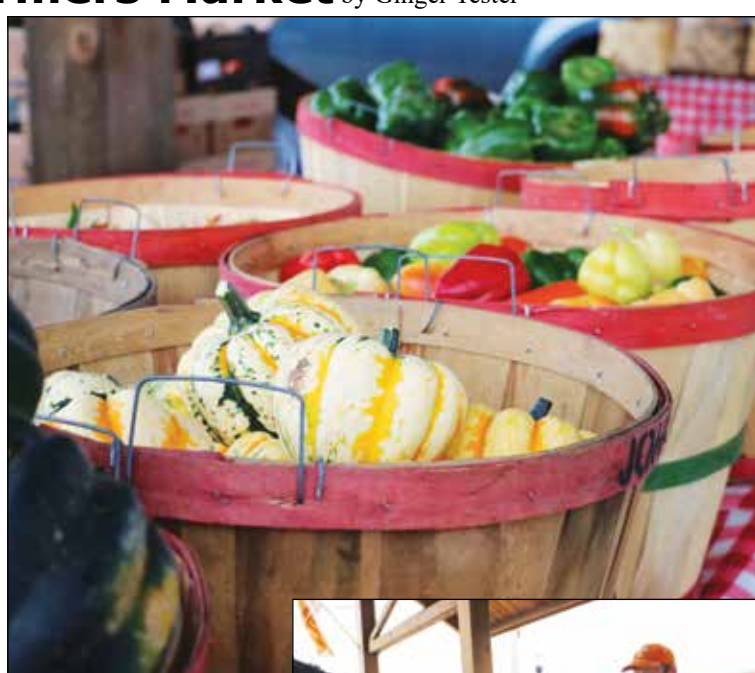
