"No Plans to Increase Taxes"

With the first meeting of the Hardeman County Budget Committee behind him, Hardeman County Mayor Jimmy Sain is confident this year's budget will not be a difficult process.

He gives credit to the county employees, especially those in leadership.

"We've completed every office holder's budget, with the exception of solid waste and the sheriff, and so far none of the elected officials have asked for extra funding this year," said Sain. "And I don't know what to expect from the sheriff's department. They haven't turned anything in yet. But they have 22 deputies, five investigators, and the chief deputy. I feel like that is adequate to run our sheriff's department."

Sain says he is committed to leaving the tax rate where it is.

"I don't plan on a tax increase," he said.

"We're going to keep treading like we have been. We cut about 10% of the budget in 2014 and we held to that. We said we were going to and we have."

Sain says the fiscal responsibility demonstrated over the past few years has paid off.

"Mary Powell, our trustee, said that for a brief period of time we had five million dollars. And she said she never remembered that happening before," he said, adding that the county needs at least \$3.5 million in order to be able to pay bills while the county waits for the February deadline for property taxes.

Sain says he feels the county has come a long way.

"My first year in office, my first day, we had to borrow \$600,000 to make payroll. We paid it back, and we haven't borrowed since. We've put back anywhere from \$900,000 to a million dollars each year. I don't know that we need to expand our fund balance to any more than we've got. But we have to maintain what we have."

Sain says this year's projects include a new roof for the 1868 courthouse. "We need to purchase another ambulance. We are going to asphalt the parking lot for the new EMS building. The Little Courthouse has been in disrepair."

And he is hoping to pass some money to employees as well.

"Every year I've been here, the employees have gotten a raise, and I'd like to continue that. We will complete our budget and see where we stand and if we have any excess we will put them into raises for employees."

The question of funding the schools is some-

Dispatch to Move from HCCJC



Hardeman County Dispatchers will have a new working space soon as the Hardeman County 911 Board elected to move dispatch from the Hardeman County Criminal Justice Center to a new building that will adjoin the current Hardeman County 911 business office.

Previously a part of the sheriff's budget, the Hardeman County 911 Board will now oversee dispatch, according to Hardeman County Mayor Jimmy Sain.

"The county didn't have a 911 dispatch center," said Sain. "So they asked the sheriff's department if they could use the reception of the criminal justice center. But it's too small. They can't heat and cool it properly. And people come in with business and questions for the sheriff's department. Dispatch should be away from everybody so they can do their job. People's lives may be at stake. They shouldn't be interrupted. Also, no one entity should be in charge of dispatch," said Sain. "it needs to be independent, an independent agency that everyone contributes to."

Sain added that both Hardeman County Sheriff John Doolen and the City of Bolivar, who have paid \$150,000 per year, but will now pay approximately 35% of costs, have been part of the discussions.

Hwy 18 Paving Begins April 15

The Tennessee Department of Transportation (TDOT) will begin work in Bolivar beginning April 15 that will re-pave Highway 18 North from Market Street in Bolivar to the Hardeman County line.

According to Hardeman County Highway Superintendent Casey Swift, TDOT estimates the work will take them until September to finish the project. The work will replace the existing highway, without widening it, according to Swift.

Hardeman County Community Health Center Milestones

1992 January - The Hardeman County Community Health Council and Board was formed to do a community needs assessment and plan for a Community Health Center in Hardeman County

April - HCCHC became a Corporation - 501(c) 3 "non-profit" with State of TN

November - HCCHC received its first federal DHHS Grant for a Community Health Center. Grant Award was \$318,750 for period 9/30/92 - 6/30/94 HCCHC hired 5 employees (Jane Wilson-Mitchell was first Executive Director)

1993 HCCHC started seeing patients at Hardeman County Community Health Center in rented clinic space at 630 & 622 Nuckolls Road in Bolivar Grant Award was \$425,000 for Year 2.

1995 HCCHC began Construction of Clinic & Office at 629 Nuckolls Rd. in Bolivar (With USDA FmHA Loan of \$518,000 for 5,000 square feet facility)

1997 HCCHC began seeing patients in the new facility in January 1997

2002 HCCHC opened Stanton Health Center in Haywood County, its first satellite clinic, in December 2002 with support from mayors & chamber of commerce. Health Center location is on Hwy. 70, leased from Town of Stanton.

2006 HCCHC constructed an annex which was 8,000 more square feet onto the HCCHC facility in Bolivar to increase patient services and accommodate business growth. Obtained mortgage from Merchants & Planters Bank.

2007 HCCHC opened Henderson Health Center in Chester County in December 2007. Rented an old clinic facility (208 N. Main Street) from the Regional Hospital in Jackson with support from mayors and chamber of commerce.

2010 We built a new (replacement) facility for Henderson at 1132 Industrial Drive through a Capital Improvement Grant of \$570,660. Moved in Dec. 2010.

2015 HCCHC first received Patient Centered Medical Home Recognition from National Committee on Quality Assurance (NCQA) for all three clinic facilities

2016 HCCHC opened HCCHC Pharmacy in-house at clinic at 629 Nuckolls Rd. to provide discounted (340B) services for our patients

2018 HCCHC opened School Health Clinic in Bolivar Elementary School in collaboration with Hardeman County School System in August 2018

2019 HCCHC purchased a Mobile Medical Van to use for community medical and behavioral health services and outreach activities in West Tennessee.

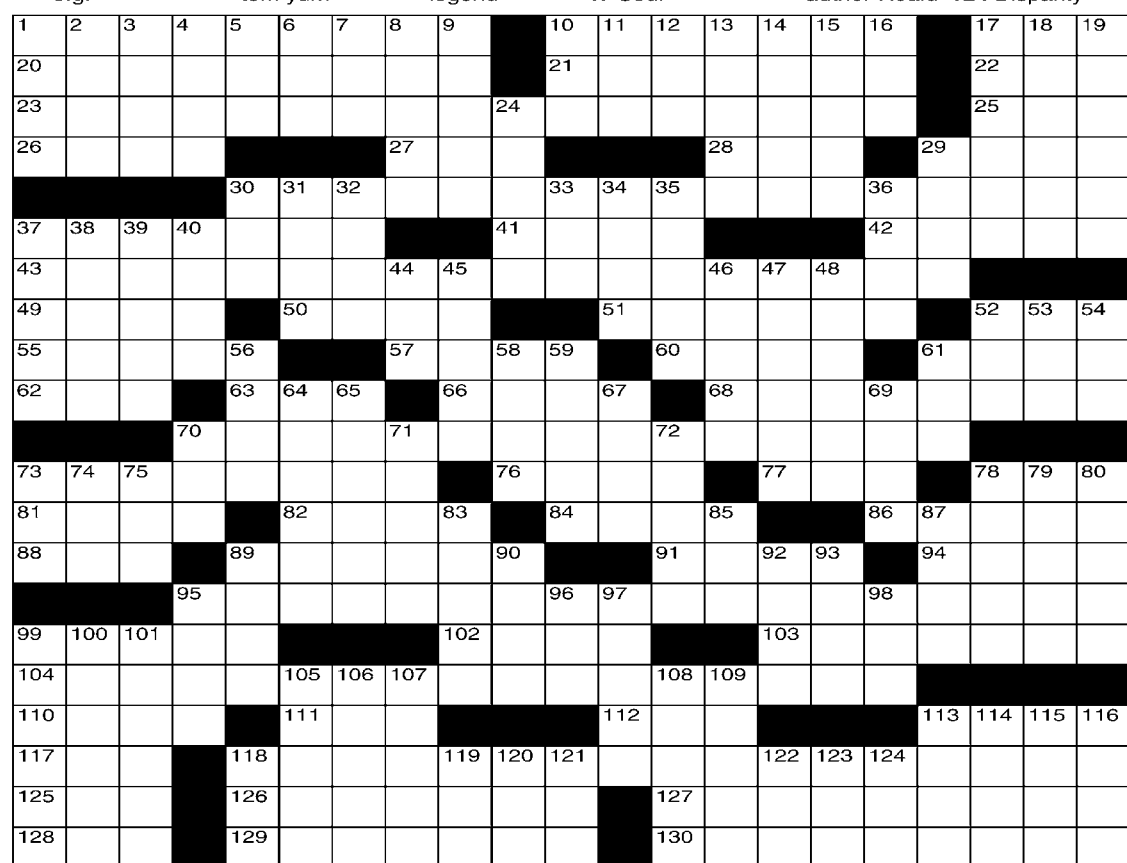

Slow Cook Smothered Pork Chops

Ingredients

- 4 bone-in pork chops
- 1 (1 oz) packet onion soup mix
- 1 (14 oz) can chicken broth, low sodium
- 1 (10.5 oz) can cream of chicken soup, low sodium
- 1 (1 oz) packet dry pork gravy mix
- 1 tsp garlic powder
- To thicken gravy:
 - 3 tbsp cornstarch
 - 3 tbsp cold water

Instructions

- In a 5-6-quart oval slow cooker, combine onion soup mix, chicken broth, cream of chicken soup and pork gravy mix. Whisk together until combined.
- Season both sides of the chops with a little bit of garlic powder. Place pork chops into the slow cooker. Do your best to spread them out and cover with the gravy mixture.
- Cover and cook on low about 4-6 hours.
- Just before the pork chops are done - whisk together the corn starch and cold water in a small bowl. Once it is smooth, pour it in with your pork chops in the slow cooker and stir gently. Cover and switch the slow cooker to high and cook for another 30 minutes (until gravy has thickened.)

To Judge or Not to Judge? Sermon on the Mount: Part 12

"You can't judge me"! While it is true that Christians ought not to be condescending, (looking down their noses), they are to exercise discernment. There is a difference.

In Matthew 7:1-6, Jesus criticizes inappropriate judgment: the hypocritical type. He commands, "judge not, that you be not judged" (7:1a). He expands the admonishment by giving a warning. Before judging another, believers ought to remember that the all-knowing Judge has his eye on all; "for with the judgment you pronounce you will be judged, and with the measure you use it will be measured to you" (7:2).

If we are inconsistent and unjustly hard on others, then things will be hard for us. Conversely, when we show grace to others, then grace will be shown to us by God. Furthermore, Paul reminds us in 2 Corinthians 5:10, "For we must all appear before the judgment seat of Christ, so that each one may receive what is due for what he has done in the body, whether good or evil."

So, what's the point? Jesus is warning against being critical of others' sins or faults, before cleaning-up our own act. He asks, "why do you see the speck that is

in your brother's eye, but do not notice the log that is in your own eye? Or how can you say to your brother, 'Let me take the speck out of your eye,' when there is the log in your own eye" (7:3-4). "You hypocrite . . ." (v.5a). Ouch!

The word hypocrite came into English from the Greek word hypokrites, which means "an actor" or "a stage player." In Shakespearean plays, for example, actors wore masks to disguise their true identities to portray a stage character. But we are not to play act in the Kingdom of God.

Instead, our behavior ought to comport with our stated beliefs. When those don't line-up, then "first take the log out of your own eye, and then you will see clearly to take the speck out of your brother's eye" (7:5b). Jesus' final saying in the passage seems a bit out-of-context, but it complements verses 1-5. He says, "do not give dogs what is holy, and do not throw your pearls before pigs, lest they trample them underfoot and turn to attack you."

Here is where discernment is needed. Without the ability to judge well states of affairs, then we can't follow the teaching. A dog can't appreciate things of sa-

Sometimes we may feel like our journey with grief has knocked us down so often we find it extremely difficult to get back up for lack of energy. A Japanese proverb if I am not mistaken says, when life knocks you down seven times get up eight. In 2 Corinthians 4:8-9 it says, "We are afflicted in every way, but not crushed, perplexed but not despairing, persecuted but not forsaken, struck down but not destroyed..." That is the mentality of success when our life and its troubles seem not to quit, we cannot quit either from getting back up on our feet and living, loving and learning. A great illustration was said of Walter Payton of the Chicago Bears on this point. Someone remarked concerning him that he was at one time the leader in ground gainer in the league, gaining more than nine miles rushing in his career. And to think someone replied, that every 4.6 yards someone was knocking him down! That is life sometimes, we feel like some circumstances in our life keep knocking us down.

Think of your own scenarios that might lead to the perception that you have been overwhelmed and overloaded with affliction, and you have been 'knocked down' frequently. What Can You Do With Your Tax Refund?

We're getting close to the tax-filing deadline. For many of us, this means it's that time of year when we get our biggest financial windfall – a tax refund. If you have recently received a refund, or are expecting to get one in the next few weeks, what should you do with it?

Invest the money. In 2018, the average tax refund was about \$2,700. Pay insurance premiums. Let's face it – nobody really likes paying insurance premiums. Yet, if you have anyone depending on you, you will certainly need life insurance, and possibly disability insurance as well. And if you want to help protect your financial resources later in life from threats such as an extended – and hugely expensive – stay in a nursing home, you also may want to consider long-term care insurance. Your tax refund could help pay for some of these premiums, boosting your cash flow during the months you would normally be making these payments.

Contribute to a college fund. It's never too soon to begin saving for college, which has grown increasingly expensive over the last several years. So, if you have young children, you may want to think about investing some or all of your refund into a college-savings account, such as a tax-advantaged 529 plan.

Pay off debts. You might be able to use your refund to pay down some debts – or perhaps even pay off some of your smaller ones. The lower your monthly debt load, the more money you will have available to invest for the future. Keep in mind, though, that you might not want to look at all debts in the same way. For example, putting extra money toward your mortgage might help you pay it off faster, but you'll also be funding an asset – namely, your house – that might not provide you with the same liquidity as you can get from investments such as stocks and bonds.

Help build an emergency fund. By building an emergency fund containing six to 12 months' worth of living expenses, you can help yourself avoid dipping into your long-term investments to pay for large, unplanned-for bills, such as a major car repair or an expensive dental procedure. Your tax refund could help build such a fund, with the money ideally being placed in low-risk, liquid vehicles.

Clearly, you can help yourself make progress toward a number of your financial goals with your tax refund – so put it to good use.



AGRICULTURE

Two from Bolivar Complete Program



Josh German and Duncan McKinnie of Bolivar and one other were honored March 12 for completing the AgStar program. The Mission of AgStar is to empower agricultural producers and agri-business people with the leadership, technological, communication and policy skills to advance the agricultural industry and promote the quality of rural life. The program included six sessions in which the participants covered subjects such as lobbying, media communication skills, issues facing agriculture and involvement in local government. One session included a two-day trip to the State Legislature in Nashville.

The graduates received a graduation plaque from Joe McKinnon, TN Farm Bureau, and Jai Templeton, Former Tennessee Commissioner of Agriculture. During the March 12 Graduation Banquet held in Jackson, Mr. Templeton spoke to the graduates about the importance of being involved in their industry and community.

AgStar is open to anyone interested in the field of agriculture in the West Tennessee area and is sponsored primarily by the West Tennessee Leadership Development Corporation. Other sponsors include Farm Credit Services, The Natural Resources Conservation Service, Tennessee Farm Bureau, Tennessee Farmers Co-op, Tennessee Soybean Promotion Council, USDA Farm Service Agency, University of Tennessee Extension, and Tennessee Department of Agriculture.

1.8% of Farmers Like the Boll Weevil???

A program that monitors for and prevents a destructive pest from being reintroduced to Tennessee cotton fields has been authorized to remain in operation.

Tennessee cotton producers voted in a statewide referendum to continue an assessment to fund the Boll Weevil Eradication Program (BWEP).

A two-thirds majority vote from Tennessee cotton farmers was required for the BWEP to remain in operation. Of the producers who cast ballots at local USDA Farm Service Agency offices, 98.2% supported the measure. Of 326 total votes, 320 were in favor of continuing the program.

Tennessee Code Annotated 43-6-425, which governs the Boll Weevil Eradication Program, provides that a referendum authorizing assessments be held at least every 10 years. The voting result authorizes the operation of the BWEP through 2028.

The BWEP was first implemented in Tennessee in 1994. The program allowed cotton producers to fund efforts in conjunction with other cotton-producing states to spray, trap, and conduct ongoing surveillance for controlling boll weevils. Tennessee was officially eradicated of the boll weevil in 2009.

The current focus of the program is to monitor for and prevent the boll weevil's reintroduction to the state. Since the beginning of the program, cotton insecticide use has been reduced 40 to 90 percent and cotton yields have significantly increased.

Tennessee ranks ninth among states for cotton acreage in the U.S. According to the United States Department of Agriculture's National Agricultural Statistics Service, Tennessee farmers harvested approximately 340,000 acres of cotton in 2017, generating more than \$234 million.

continued from A1 thing Sain is confident the budget committee can maintain. "I don't foresee any cut in school funding this year," he said, but cautioning that it is important that "maintenance of effort" be paid attention to when it comes to school funding. Maintenance of effort is a requirement that government must maintain a specified level of financial effort. This requirement is usually given in terms of a previous base-year monetary amount. "The problem is when schools lose students our maintenance of effort doesn't automatically adjust. So when we do adjust it, we're the bad guys. But we can adjust the tax rate and still fund them the same amount of money. If we're smart, that's what we'll do. The budget is fine and we don't need to take money from the schools. But we have to be careful with the maintenance of effort issue." A representative of County Technical Assistance Service (CTAS) is scheduled to come explain "maintenance of effort" as it pertains to the schools, the libraries, the sheriff's department, and the highway department on April 22. "This is mainly due to having five new commissioners," he explained. "But I would not propose cutting any funding to the schools. I think we're good."

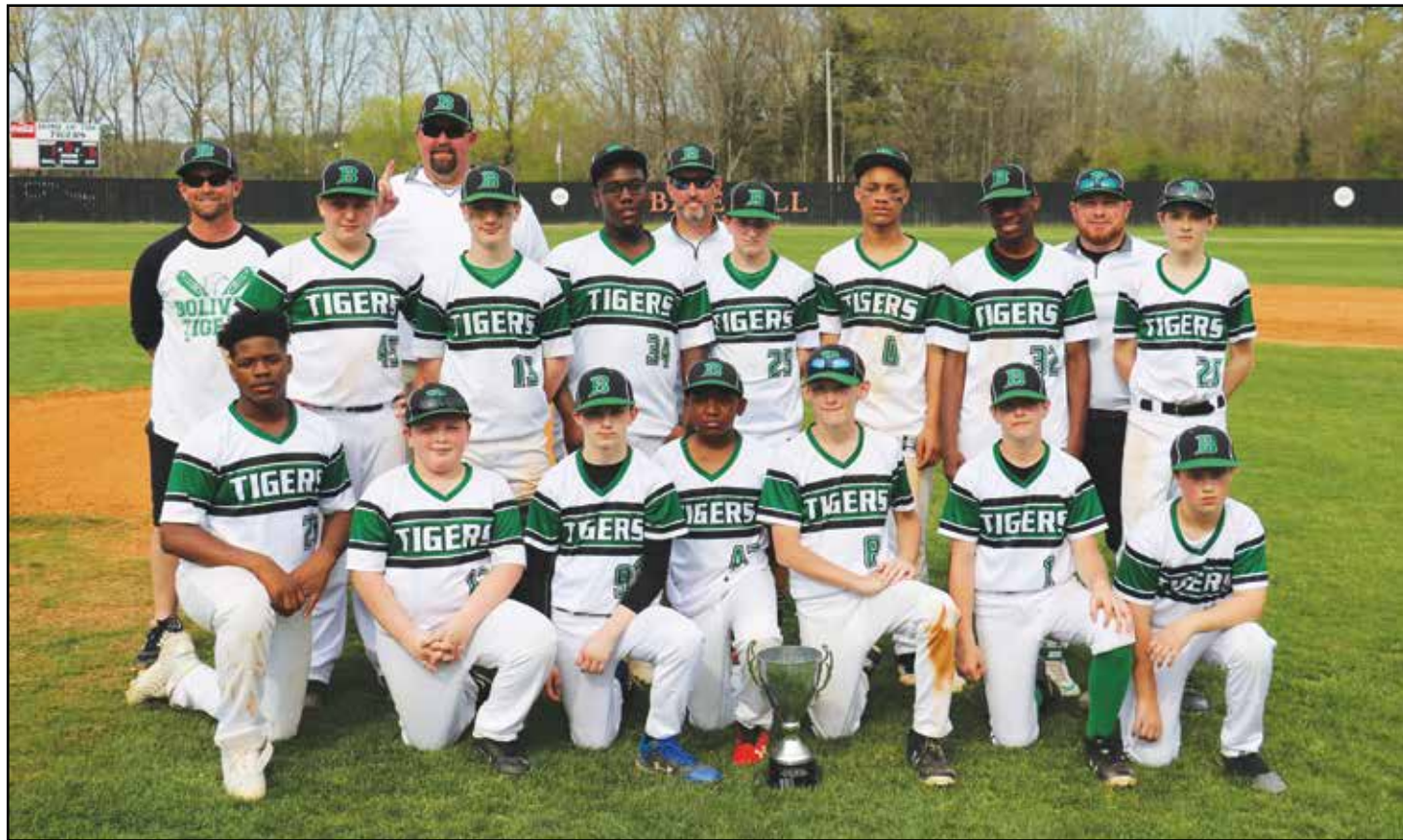
"It was a tough win, a good win," said Head Coach Jerry Rhodes. "They're a very good team and we were lucky. I'm very proud of my guys to get the win."
