It happens every spring. New uniforms, new teams, new hope. It's opening night. The crack of the bat, everyone yelling "run!" at someone who is probably already running. It's warmer, it's spring, and now that baseball is here, summer can't be far behind. The 6U leagues are the most fun to watch. Mostly because a five-year old who doesn't know the infield fly rule (or how to run, catch, or throw) isn't a source of shame for the parents. Well, let's hope not. There have been practices in the cold and the wet. Because if you didn't practice in the cold or the wet, you probably didn't get to practice much at all. Lineups are handed in. Coaches spend hours trying to figure out who to play at short-stop, first base, or on the pitchers mound. In the stands, it's like a reunion. We hadn't seen some of these folks since last summer. And there's a new little brother or sister on hand for their first game as well. The small ones trot out to the third base line for the National Anthem. It's the first game of the season, and maybe, the first game of their lives. "See that flag over there?" asks a coach. "What's that for?" "America!" comes the answer. Hats come off and go over hearts. Then two minutes of fidgeting as Francis Scott Key's greatest hit blares over the loudspeaker. Umpires confer. The clock operator/scorekeeper is in position. The coach strides out to the mound. He looks around. He tosses it to home plate... And with any luck you hear: "Run!"

Communication Breakdown

When you call for help, you want everyone to hear you. But differences between Bolivar and county law enforcement technology has been part of a potentially life-threatening communications problem since 2015.

"We went to an encrypted digital system in 2015 to protect our officers and our citizens. We didn't want people who had scanners to know we were coming or to know who made calls to the department," said Police Chief Pat Baker.

But a response to a robbery call, a phone call, and a subsequent memo in 2015 has led to a disagreement as to how the difference in technology would be dealt with.

The memo stated, "As of today's date, November 16, 2015, please do not put any of Bolivar's calls or traffic on the radio over the county radio. Chief Baker requests that no

Bolivar calls or radio traffic be given to the Sheriff's Department over the county radio, unless assistance is requested."

The memo was signed, acknowledging receipt, by nine dispatch employees.

Hardeman County Dispatch Captain Dana Knight recalls the day the memo circulated. It began with a call reporting a robbery of a cash bag from Family Dollar (then on Jackson Street) at 7:33 a.m.

"When the incident took place, we had six deputies here on shift change. I sent out the call to everyone. Later that day, Chief Baker called and asked if one of my dispatchers had sent out the call. I told him it was me," said Knight.

Baker, when asked about the memo, said he asked for the policy to be enacted on that day but denied that he had written or had a memo written for dispatch. Baker also said

he never intended the policy to be used in a potentially violent or dangerous situation. Baker also said he made the assumption that a dispatcher would have the common sense to determine when a call needed extra agencies to respond. Baker said he will work with dispatch to rewrite the policy.

"I believe every agency in the county should work together," said Baker.

Hardeman County Sheriff John Doolen said he respected the policy but after the shooting death at El Ranchito during a robbery attempt in March and the possible link to an increase in crime in Bolivar, he immediately asked dispatch to stop the practice.

"We all serve the same purpose. To protect the citizens of Hardeman County," said Knight. "A deputy could drive by an emergency situation and never know it."

Voting Numbers Down in Primary

The Democrats have thrown a party, but they're having trouble getting people to show up.

Through the seven days of early voting in 2018, only 732 have been to the polls.

Through April 23, 2014, or seven days into early voting, the Hardeman County Election Commission reported that 1,570 had voted early, more than doubling the current year's total.

The lack of choices could be a factor, as there are only four races in the Democratic Primary in 2018, versus 12 open democratic races in 2014, which included nomination races for Hardeman County Mayor and Hardeman County Sheriff.

County-wide races in the Democratic Primary include Assistant Supervisor of Highways Casey Swift running against former TDOT Supervisor Dale Dixon and a three-way race for the democratic nomination between Billy Davis, Tonya Ellison Perry, and Charles "Butch" Gatlin.



Miss Luez is Looking for Answers



The Luez Theatre Committee will ask for help from Hardeman County in determining the use of the circa 1948 theatre that is scheduled to complete renovations in mid-summer.

A questionnaire, located on A12, is being distributed in hard-copy form and on Facebook with questions ranging from content to the question of alcohol being served in the theatre.

"This theatre has belonged to Hardeman County for a long time," said Luez Committee Chairwoman Cathy Frost. "And we intend to make sure it still serves the people as it did when Miss Luez was running it."

Questionnaires can be returned to the Bolivar Bulletin Times offices at 200 E. Market Street in Bolivar.

The theatre was shuttered in 2012 and purchased by the Bolivar Downtown Development Corporation in 2013 with the goal of re-establishing the theatre as a center of entertainment for the county.

The Hardeman County Chapter of APTA will conduct its 44th Heritage Home Tour on May 5-6.

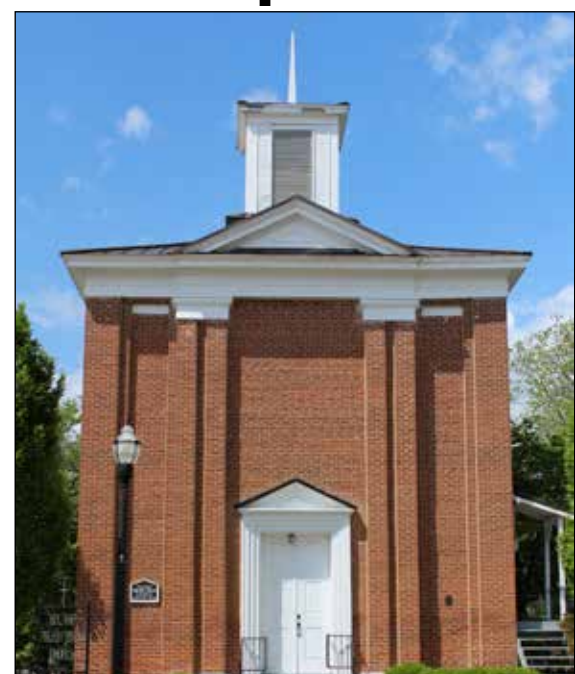
The tour will be from 10:00 a.m. until 5:00 p.m. on Saturday and on Sunday, May 6, from 1:00 p.m.-5:00 p.m.

The list of tour sites are as follows: The McNeal Place, The Pillars, The Columns, St. James Church, Ingram Hall, (lunch on Saturday only - \$10 extra) Polk Cemetery with live characters, The Presbyterian Church (see right) and newly remodeled Luez Theatre. Homes on tour will be feature docents in proper era dress, that will be telling stories about the historical properties, homes and their owners.

The Pillars, Bolivar's oldest brick home that was once a smaller federal style brick home built around 1826 by Robert Murray who sold it to Catherine Lea, wife of Saturday Evening Post publisher John Lea of Philadelphia in 1828. John Houston Bills, a successful settler purchased the house in 1837. Over the next thirty years, Bills oversaw the expansion of the house into its present form and furnished it through buying trips to New York, Boston, and Philadelphia. The home still has most of the original furnishings and artworks. The house once accommodated such notable guests as Andrew Jackson, David Crockett, Sam Houston, James K. Polk, and Jefferson Davis. The Pillars also served as a military headquarters and hospital during the Civil War.

The Tuscan-style villa of The McNeal Place is also on the tour this year. At The Columns, Miss Ingram's children's cottage will be on display, too. At St. James Church

Miss Tennessee to Visit Bolivar for Fun Run

The Third Annual Let Love Glow 5K and Fun Run, hosted by Team Mica Fund and Pathways Behavioral Health to raise awareness of suicide prevention, will be held on Saturday, April 28, in downtown Bolivar.

The race will feature a special guest, Miss Tennessee Caty Davis, whose platform focuses on Attacking Addiction: Prevention, Recovery and Restoring Families.

"Caty is a beautiful person inside and out," said Erin Holcomb, founder of the Team Mica Fund, which is administered by The Community Foundation of Middle Tennessee in Nashville, Tennessee. "While her platform focuses primarily on substance abuse, oftentimes that and suicide go hand-in-hand."

Attendees will have the opportunity to hear Caty Davis' story and meet her in person at the event. Festivities will begin at 5 p.m. and will include a silent auction, a chip-timed 5K race, along with a small awareness walk around the courthouse. Participants are encouraged to register in advance for the 5K and to create teams to support the \$12,000 fundraising goal.

Awards will be given to the 5K runners in each age group, with an award being given to the overall female and male winner. Age groups include: 12 and under, 13-19, 20-29, 30-39, 40-49, 50-59, and age 60 and up.

"With the money raised from last year's races in Bolivar and Jackson, we were able to touch nearly 2,300 people in West Tennessee," Holcomb said.

"We reached these individuals through trainings, seminars, wellness fairs, community nights, support groups, and our new #YouAreLoved campaign. These races really fuel our ability as a volunteer-run organization to provide these services for free to the entire West Tennessee community."

All funds raised will benefit the Team Mica Fund and its efforts to reduce the number of suicides in West Tennessee, thus helping save lives.

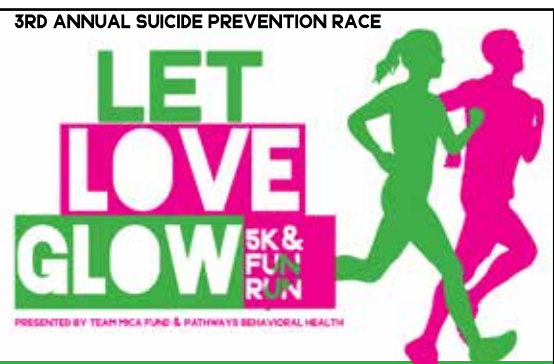

Hardeman County Remembered by Lisa Coleman

Last week I told you about a exciting, red-letter, hallelujah genealogy day I had several years ago when I connected my Coleman lines to Dr. & Mrs. Archer Allen Coleman who lived at The Columns in Bolivar from 1861 to sometime in 1868. I love it when those things happen.

Dr. and Mrs. Coleman moved into the house that we know as The Columns in early 1861, just a few months before the start of the Civil War and lived in the house throughout the war years. The house served as a hospital during the war, and although a steadfast Confederate sympathizer, Dr. Coleman took care of Union soldiers injured in the war along with those who had contracted smallpox. His service spared his family and his home from injury and destruction when the Union army left Bolivar after years of occupation.

I was recently contacted by a lady who told me that she, too, was related to Dr. Coleman by way of another of our intersecting Coleman family lines. She and her mother were traveling and routed themselves to Hardeman County after finding out information about Dr. Coleman and The Columns, and, she wondered, was I also another Coleman cousin? After she and I and her mother talked we did



indeed learn that we were Coleman cousins. When you get a couple of genealogists together we always have the best time talking about all of the ancestors we have "met" in our journeys; the conversations are even more fun when you find new cousins!

So on a lovely, warm, Southern spring afternoon just a few days ago, I had the great pleasure to meet and spend time with Patsy Coleman Smart and her daughter Darlene Smart Smith, my new-found Coleman cousins from San Antonio and Boerne, Texas. What a treat! Thanks to the lovely folks at The Columns, we were able to meet up and spend a good deal of our afternoon at the house, talking about the Colemans who once

lived there and what their lives were like when they lived in that place. I was also able to "introduce" them to Miss Elizabeth Ingram and tell them about her family's history as well. We visited the graves of Dr. Archer and Louisa Coleman at Polk Cemetery and paid our respects to them and the Neelys and Polks that intersect in our shared family lines as well.

For a few hours, the music parlor at the lovely old house was again alive with Coleman ladies who visited and shared family stories like I hope Louisa did all those years ago with her cousins. Y'all, I just love it when stories and cousins and genealogy all work out this way.

God doesn't tend to build a broad interstate for everyone to follow, but instead, He weaves a delicate, strong thread like a divine spiderweb. I have witnessed this intricate plan in my own life at times, even when I was oblivious to most of it.

One of my dear friends served as a missionary in Korea. His family was instantly immersed in a language and culture he didn't know. He worked diligently to care for those around him, but in the meantime, found himself in a lonely place. He and his wife had three children and a fourth unplanned child was on the way. The neighbors and members of the church there all cautioned him to keep a small family with fewer responsibilities. In fact, the culture deemed it unwise to have more than two children. The families all around him, literally thousands, had only one or two children.

My friend's wife miscarried their

fourth baby, and they were deeply grieving the loss. My friend said he never felt more alone than the moment he realized nobody in the community understood their loss. They felt it was almost convenient that they were able to have a smaller family. One particularly close Korean friend came to their home and prayed for the family. She then admitted "I am very sad because you are very sad. I'm sorry I don't understand your sadness, but I feel sad that you are sad." That was the moment that he felt nearly abandoned in this foreign land. He decided to go to a Western church service that weekend and stay for the prayer service. The church found, during a prayer time, what had happened. My friend got an understanding embrace and an offer to plan a memorial service. They invited Korean friends, and the resulting service helped them to grieve the loss of their child. A tree was planted in the baby's memory on the church grounds.

My friend soon realized that the population of the school where he taught was always one-quarter or at most one-third female. Each subsequent class revealed the same. After three classes, he questioned and found that the people practiced gender-based abortion. Wanting boys to carry on the family name, the families were limiting their

3. Saving Faith Involves A Complete Compliance to God's Word.

Compliance is simply obeying the commands of our Heavenly Father. In order to have saving faith, we must walk in obedience— NOT in disobedience! Our faith and obedience go hand in hand for it to really be the kind of faith that God wants from His people (Hebrews 5:9; James 2:14-26). In Hebrews chapter 11, God honors the people of saving faith that show their faith by their actions. Notice the reoccurring language of the text, "*By faith Abel offered to God a more excellent sacrifice.*" (Heb. 11:4) "*By faith Enoch....pleased God.*" (Heb. 11:5) "*By faith Noah.... prepared an ark for the saving of his household, by which he condemned the world and became heir of the righteousness which is according to faith.*" (Heb. 11:7) "*By faith Abraham obeyed when he was called to go out to the place which he would receive as an inheritance.*" (Heb. 11:8) "*By faith Sarah herself also received strength to conceive seed, and she bore a child when she was past the age, because she judged Him faithful who had promised.*" (Heb. 11:11) "*By faith Moses, when he became of age, refused to be called the son of Pharaoh's daughter, choosing rather to suffer affliction with the people of God than to enjoy the passing pleasures of sin.*" (Hebrews 11:24-25) More examples could be cited, but these are enough to show us what God approves of and expects of us today! Could you imagine if Noah had faith-alone in God and never built the ark? What if Abraham had stayed in his homeland, when God called him to leave? And would the walls of Jericho have fallen if the Israelites had not marched around them as God instructed? (Heb. 11:30) For us to be people who have saving faith, we must not only acknowledge God's will— but also do it (Matt. 7:21; I John 5:1-5). God's word even uses belief and obedience interchangeably in John 3:36, when Jesus said, "*He who believes in the Son has eternal life; but he who does not obey the Son will not see life, but the wrath of God abides on him.*" (NASB) The biggest deception that Satan has ever used is to get people to believe only and feel justified without any obedience to God. James even goes so far as to say— that if, "*You believe that there is one God. You do well. Even the demons believe—and tremble!*" (James 2:19 NKJB) The demons have a faith, but not saving faith! That's why the scriptures plainly tell us, Jesus is "*....the author of eternal salvation to all who obey Him.*"

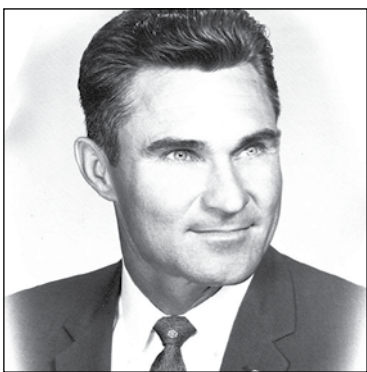

Toone

This week's article is dedicated to my alma-mater, Toone School. As a former student of Toone School, I have always had very special memories of my years there. Although my family always had a farm and weekend house here, we lived in Memphis until I was 10. After moving here permanently, I started Toone School in the 4th grade. The classes were small, so each teacher had split-classrooms and taught two different grades in that room. While one grade was being taught, the students in other grade on the opposite side of the room sat quietly and read and studied their text books. If possible, I always tried to finish my homework during that time so I could go out and play when I got home. Some of the subjects and discussions included both grades, and we all went to recess and lunch at the same time. When the weather permitted, baseball was the preferred game at recess for the boys. The girls sports were quite limited back then, because they all had to wear dresses and couldn't get them dirty, so they played hop-scotch and a few other games outside, or they could go to hang-out in the gym. Since the school did not provide our baseball equipment, each student who played had to bring his own glove, bat and ball. Occasionally some of the older boys would hit a long home run, and the ball was lost in the thick kudzu vines in a big gully down the hill. If no one had an extra baseball, we would all chip in and one of us would run right down the street to Mr. Eddie's general store to by a new one. Of course we weren't supposed to leave the school grounds, but the principal would make an exception for a new baseball. Most days we were not even supervised by a faculty member, and that's when you had a chance to settle the score with a fellow student with a good fight. Back then a fight was usually just a few punches thrown or a good cuss fight, and you never worried about the other kid pulling a knife or a gun. Getting a black-eye or a fat lip in a good, clean playground fight was a right of passage for a kid in those days.

On rainy or cold days we played basketball or dodgeball downstairs in the gym, or you could choose to go up onto the stage area to spin a top or play with your yo-yo.

Also, back in those days many of the older boys and some of the faculty members smoked, so the school had morning and afternoon breaks so those students could go down the hill behind the school for a smoke. If you were lucky, you were picked by the teacher to leave the classroom to dust the chalkboard erasers by taking them down the hill and beating them on the big oak tree where the older boys went to smoke. Since the principal also taught the 7th and 8th grade classes, she was out of her office most of the day, so she would appoint a student to run down the hall to answer the phone when it rang. This was a highly-prized job because it gave you a chance to get out of class for a few minutes and grab a drink of water and swipe a piece of candy out of the bowl on the office desk. Yes, it was a good time to be a kid, and most of us actually looked forward to going to school, but if you mis-behaved, you paid for it by having to stand in the corner in silence, or maybe having your hand spanked with a hard, wooden ruler, and if you did something really bad, you had your rear-end heated-up with a homemade wooden paddle, and usually you would get another good spanking when you got home! I always wondered how my Mother found out so quickly when I got a paddling at school. I guess the school called her and ratted me out!

Toone School has a long history in Toone. I went to their website to learn more about it, and read a very interesting history of the school. The property for the construction of Toone School was deeded to the county in 1928, and construction of the original wooden-sided building soon began. That building was replaced by the current brick structure in 1950-51, and had other updates and additions in the 70s and 80s. The school was originally a high school, but was changed to a grades 1-8 in the early 60s, and the high school grades were then merged with Bolivar Central High School. When the elementary school at Silerton closed in 1966, those students were moved to Toone School. A Kindergarten class was added to the school in 1968, and the school continues to operate as a K-8 feeder school for the middle school and high school in Bolivar. TES has been recognized as one of the top schools in the county, and we are very proud to have this fine school as part of our community. Go Bobcats!

I hope you enjoyed this short trip down memory lane. I'll get back to my regular format next week. Until next time . . . talk to your neighbors!

By 1966, she was going blind due to diabetes. She lived with a lot of pain, discomfort and handicaps until she passed away in 1978. I cannot ever remember her complaining or blaming anyone for anything. She read her Bible every morning and every night. She prayed constantly. I remember her expressing gratitude for everything she had." It is my opinion and I believe the opinion of many of her students that she was truly an inspiration in all our lives.

Keep Your Investment "Ecosystem" Healthy

April 22 is Earth Day. First observed in 1970, Earth Day has evolved into an international celebration, with nearly 200 countries holding events to support clean air, clean water and other measures to protect our planet. As an investor, what lessons can you learn from this special day?

Consider the following: Avoid "toxic" investment moves. Earth Day events show us how we can help keep toxins out of our land, air and water. 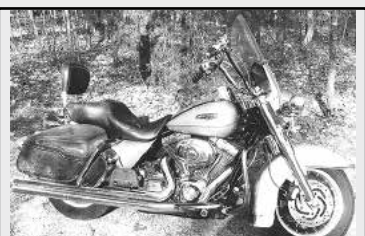

Appraisal Time is Upon Us

by Josh Pulse Hardeman County Assessor of Property

2018 is a Reappraisal year for Hardeman County. It is state mandated that all counties in the state undergo a reappraisal either every 4, 5, or 6 years. In Hardeman County we are on a five year reappraisal cycle, so the last time we went through a reappraisal was in 2013.

The purpose of the state mandated reappraisal is to bring all property values to current market value. In the next few days, the Hardeman County Assessor of Property office will be mailing Assessment Change Notices to every property owner in the county who owned property as of January 1 2018. THIS IS NOT A BILL!! It is a notification that your assessment value has changed due to current sales data, as required by law. The notice will have the appraised value of the property, the use value (Greenbelt) if applicable, the current assessment, and the previous assessment. If your assessment is higher than your previous assessment, that means your property value went up. If your assessment is lower than your previous assessment then that means your property value went down. It is my goal to inform every citizen of Hardeman County about the process of Reappraisal as we continue to provide the most transparent administration of the local assessment process possible.

One very important thing to point out is that you will not see a tax amount due on this notice. That is because the Assessor of Property office does not set the tax rate. The tax rate is set by the County Commission and the City Councils in your respective municipalities. The Assessor of Property does not set the budget, nor does the Assessor of Property collect the taxes. We value the property based on current sales to restore equality and treat everyone fairly.

Frequently Asked Questions:

Q: What is a Reappraisal and why is it conducted?

A: Reappraisal is conducted in Hardeman County pursuant to Tennessee State Law, TCA 67-5-1601, which requires each county to periodically update property values to reflect current market value. This process eliminates inequities that happen over time by changes in the real estate market. Reappraisal works to ensure fairness to all property owners.

Q: How is Market Value Determined?

A: Value is based on calculations of collected sales data from all real estate transactions in Hardeman County taking into consideration other factors affecting real estate value such as age, quality,

condition, and location of the property. We also use the cost approach and income approach to value commercial properties. All of which are standard appraisal methods. The best indicator of current market value is qualified (willing buyer and willing seller) prior year sales to determine reappraisal values.

Please remember this is not changing the property value from last year. This is changing the property value from our last county wide state mandated reappraisal which was in 2013. We will be having informal hearings on the new values in our office the week of April 23 -27. If you have any questions or concerns, please give us a call or come by our office and we will be happy to assist you.

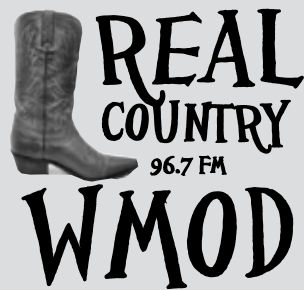
