Homecoming for Randy Ray

Randy Ray left Hardeman County in 1958, hitchhiking, the day after he graduated from Middleton High School. He went to Memphis because that's where his ride was going.

His latest return to the county last week was in his jet.

When the 1958 Middleton alum noted in his speech at Middleton High School on April 18 that he hadn't been back to Middleton High School since he graduated, he also remembered he was told this was as far as he'd ever get.

"They said, 'You can't go to college, you're going to be a farmer.' But I did go," he said. "I found out if I joined the army, they would pay for it. My Dad had to come down to sign for me to go. He signed with an 'X'."

After being educated on the GI Bill, which included time at the Massachusetts Institute of Technology, Ray's journey went from Honeywell International, writing software, to his own company where he managed to get the contract of a lifetime in 1977: contract work on the Space Shuttle project for NASA.

He got it with an idea he got from going to the Middleton Post Office.

"I came up with a simple idea, using the box system the post office used," he said, explaining his idea was to give each NASA technician his or her own personal screen with the information they needed. "The others couldn't write the program. We could."

"I was there with multi-million dollar companies and the most we had ever done in a

year was two million," he said. "They asked me what I was doing there...they told me I couldn't get the contract, but I got the contract," he said, noting his first commission check was for six million dollars. "I had a goal of being a multi-millionaire by the time I was 35. When I got the check, I was 32 years old."

But Ray was just getting started. The next 40 plus years have seen him build schools and hospitals in Uganda, China, Ecuador, India, and Kenya and medical clinics in Kenya, Uganda, and Ecuador.

"We do medical exams, we dig wells," he said. "I feel good about what we are doing in the world."

"We built orphanages. It's been an interest-

Bates Estate Auction April 27



The former estate of Charles Larry Bates will be put on the auction block on April 27 in southern Hardeman County.

The court-ordered auction of property and other items will go to the highest bidder, with no exception, says John Roebuck, "The highest bidder is going to win. There is no reserve."

The items include a 12,000-square-foot mansion, three other houses including a 5,000-square-foot luxury home, a cottage and a cabin; an RV; a speedboat; a Ford pickup truck; and a Jeep.

The sale will go toward paying approximately 400 people a total of \$21 million Bates gained in a scheme that offered them huge profits in the precious metals market. Bates, who made his religious-themed pitch on radio outlets nationwide, was sentenced to 21 years and 10 months in prison in September of 2017.

Customers had given \$87 million to First American Monetary Consultants to buy precious metals. But prosecutors maintained and the jury decided that the defendants kept the money for their personal use. By 2009, the company had more than \$26 million dollars in unfilled orders, according to court documents.

The auction will take place April 27, beginning at 10:07 a.m. For details, see advertisement on A2.

ing journey for sure. Daddy always said to bless others or my blessings would stop," he said, adding that Philippians 4:13 (I can do all things through Christ who strengthens me.) were his "marching orders" in life.

He at a young age learned what it is like to do without. And from that came a passion for helping kids. "We lived about 15 places in Hardeman County. None of them had electricity. We know what it is like to be hungry and have no place to sleep," he said.

His brother Winfred, a Hardeman County resident and successful businessman as well, said he was inspired by the hardships of childhood too. "It gave me a drive to make something of myself," he said.

Randy Ray's company, Jeunesse Global, headquartered in Orlando, FL, has offices in 141 countries and has more than 600,000 sales people. Founded in 2009, it was recently selected as the International Company of the Year by Netcoo. The Jeunesse Arena in Rio De Janeiro, Brazil, named for the company, hosted the gymnastics events at the 2016 Summer Olympics and Summer Paralympics.

Ray, who recently donated \$250,000 to Middleton High School to help build the spectator gymnasium, plans to return for the grand opening of the facility, scheduled for later this year.

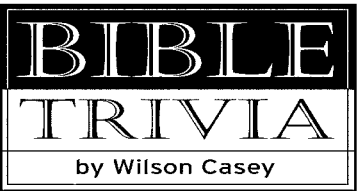

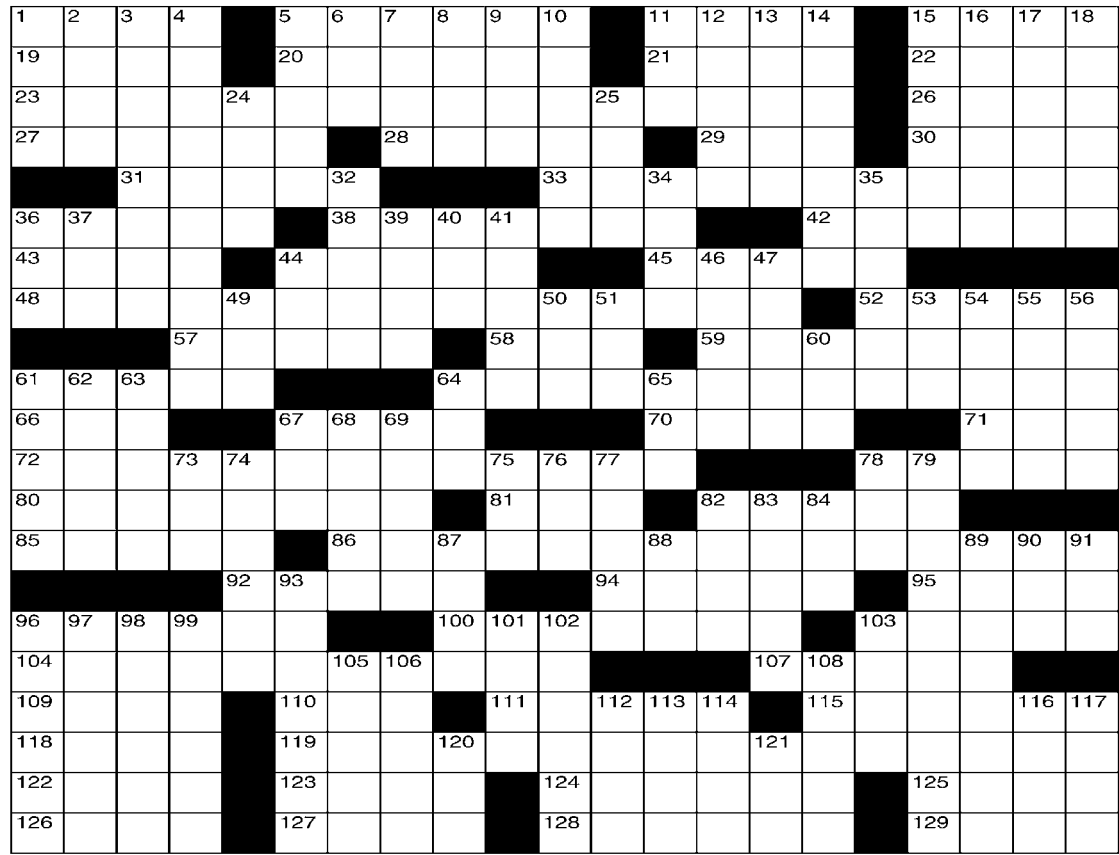

One evening, Mother and Granny were doing the wash, and I was watching. I wanted to help. When I said so, Mother said, "You're too little. You'll get hurt." That made me mad and hurt my feelings. You can probably see where this is going. I watched for my chance. When both adults finally turned around, I grabbed one of my little dresses and shoved the neckline in between the wringers. But the wringers grabbed the fingers of my left hand! It hurt terribly. I looked up. Mother and Granny were still not looking. My hand was eaten by the monster. Then, the wringers pulled my arm through. I felt more pain than I had ever known. The wringers kept turning in front of my elbow, unable to get past it. I screamed to get the attention of the adults, who also screamed and came running over. Mother freed my arm, scolding me as she did so. My arm had burst open and was bleeding. We had to drive to a neighbor's house to use the phone. It was already dark outside, and I remember the long ride into Paris to meet the doctor after hours. He declared the arm not broken and bandaged it up. I still have the scar, and a dent where the wringers turned on my arm. It was a horrible experience, made worse by the fact that family and friends kept telling me what a bad girl I was. Looking back on it, I think that if Mother had helped me put an item through the wringers I would have been satisfied. So, there are three morals to this story. One: Children, obey your parents. Two: Parents, respect and include your children. Three, stay away from killer washing machines."

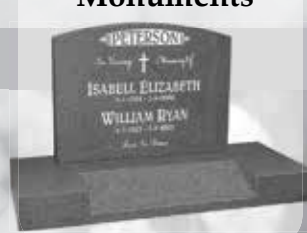

The Golden Rule. Sermon on the Mount: Part 14

by Jeff Capshaw

There are a couple of passages in Matthew's Gospel where Jesus sums up in a few words the essence of the Old Testament's ethical teaching. One is in Matthew 22:36-40, and the other is in this week's lesson.

In the first passage, a Pharisaical Lawyer tested Jesus and tried to trip him up. The lawyer asked, "Teacher, which is the great commandment in the Law?" And he [Jesus] said to him, "You shall love the Lord your God with all your heart and with all your soul and with all your mind. This is the great and first commandment. And a second is like it: You shall love your neighbor as yourself. On these two commandments depend all the Law and the Prophets."

The second instance of Jesus' tightly compressing the Old Testament's teaching about human relationships is contained in just one short verse. Jesus said, "so whatever you wish that others would do to you, do also to them, for this is the Law and the Prophets" (Matthew 7:12). Even those least familiar with Christianity know the "Golden Rule."

According to Wikipedia, "the term 'Golden Rule', or 'Golden law', began to be used widely in the early 17th century in Britain by Anglican theologians and preachers; the earliest known usage is that of Anglicans Charles

Gibbon and Thomas Jackson in 1604."

Interestingly, this "law of reciprocity" or the law of treating others as we would like to be treated is not unique to Jesus. According to some scholars, similar ethical teachings are found in many ancient cultures: Egypt, India, Greece, Persia, and Rome to name a few. Again, according to Wikipedia and quoting Simon Blackburn, "'The Golden Rule' can be found in some form in almost every ethical tradition."

Those facts do not mitigate the rule's authority, nor does it lessen its practical relevance. Since God is the source of all truth, his truth crops-up in multiple areas of human experience, even in other religious traditions. Scripture reminds us that God even reveals his truth in nature (Romans 1:19-20; Psalm 19:1-2). According to the Reformers, God's common grace often benefits or is experienced by, or intended for, the whole human race without distinction between one person and another, and it can be mediated in ways outside the Christian Scriptures. This should not be confused, however, with saving grace.

Jesus said that the world will know that we are his disciples—not by the Church we attend, nor by our outward appearance, nor by the friends we keep—but by loving



Fixed Annuity Could Help Extend Lifespan of Retirement Accounts

It's almost impossible to save too much for retirement. After all, you could spend two, or even three, decades as a retiree. And retirement is not cheap – even if you maintain a relatively modest lifestyle, some of your expenses, especially those involving health care, may continue to rise over the years. Consequently, you will need several sources of reliable income – one of which might be a fixed annuity.

Fixed annuities are essentially contracts between investors and insurance companies. When you purchase a fixed annuity, the insurer will guarantee the principal and a minimum rate of interest. This means the money you invest in a fixed annuity is designed never to drop in value. (However, this guarantee is based on the claims-paying ability of the insurer that issues the annuity.)

So, when you reach retirement, it's a good idea to establish an appropriate annual withdrawal rate, based on your retirement plan balances, Social Security, lifestyle, longevity expectations and other factors. You may want to work with a financial professional to determine a withdrawal rate that's suitable for your needs.

If you can count on the income from a fixed annuity, you might be able to take out less each year from your traditional IRA and 401(k), giving these accounts more tax-deferred growth opportunities. Plus, if you don't withdraw all the money from these accounts during your lifetime, you can include the remainder in your estate plans.

A fixed annuity's potential to help you extend the lifespan of your IRA and 401(k) can clearly be of value to you. Still, a fixed annuity does carry some issues about which you should be aware, such as surrender charges for early withdrawals, along with other fees. Also, if you take withdrawals before you reach 59½, you likely will face a 10% penalty. And annuities can have tax implications, so before you start taking withdrawals, you will want to consult your tax advisor.

Is a fixed annuity appropriate for you? There's really no one correct answer because everyone's situation is different. However, if you consistently max out your IRA and 401(k) contributions, and you still have money left to invest for retirement, you might want to think about an annuity. An income stream you can't outlive – and that may help you protect your other retirement accounts – is worth considering.

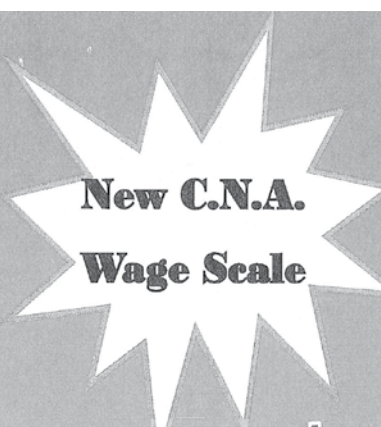

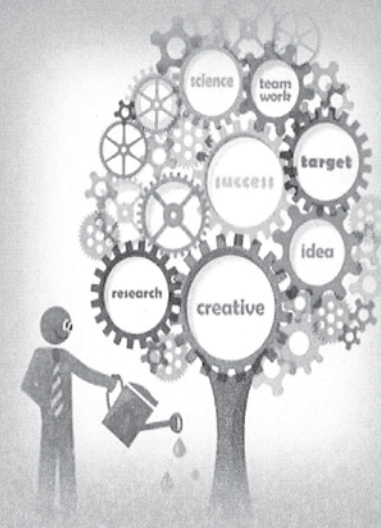

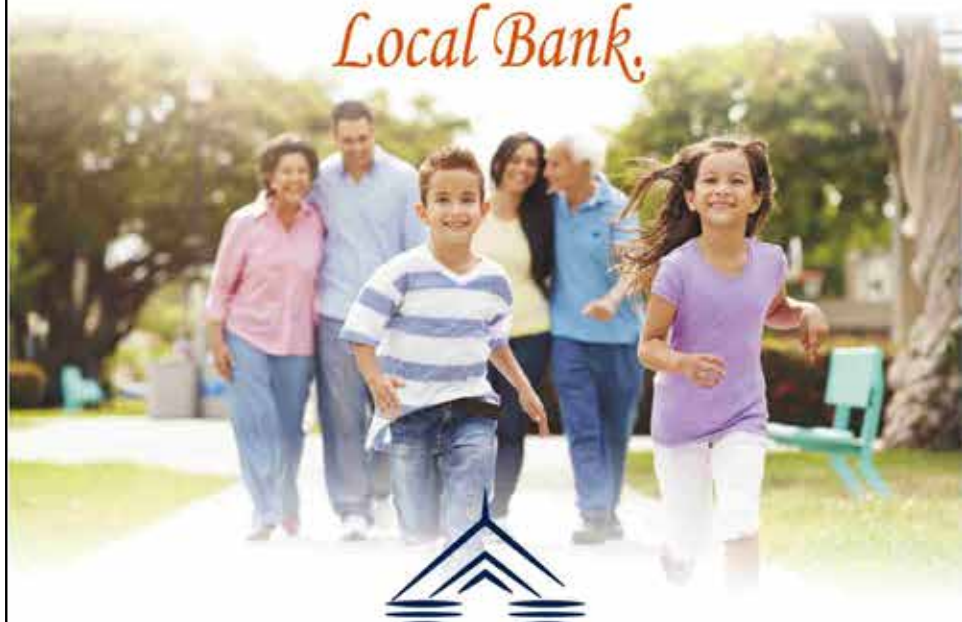
