From the Other Side of the Desk

I've interviewed quite a few people over the years on the radio and the results vary; sometimes the problem is me, sometimes it's them.

The council debated the issue but finally voted to allow Mayor McTizic to ask the State of Tennessee to allow Bolivar to change the grant, but agreeing that if the state refused, the city would cut some of its losses and send the state \$23,378 to reimburse the grant for expenses already paid (half of \$46,757 used for signage, an engineering fee, and

> The vote was 7-1, with Councilwoman Suzanne Rhea voting against allowing the mayor the discretion in the matter.

A brief history:

• The land housed The Boat Dock, which operated as a bar until the owner sold the land and building to the City of Bolivar in 2014. The purchase was made with help from a grant from the state of Tennessee that required an agreement to make the area into a park. Bolivar's fifty percent share of the purchase was \$60,000.

· Early work on the project resulted in the Hatchie River Park being dedicated on October 17, 2015.

• In 2016, the Southwest Tennessee Development District voted the Hatchie River Park and Nature Center as the district's "Project of the Year." • A matching grant to expand the facility to include a museum and an outfitter location for boating and canoeing were approved by the state on June 28, 2017, when Mayor Barrett Stevens signed an agreement with the State of Tennessee for \$486,350. This took place two days before he left office, giving way to Mayor McTizic on July 1, 2017.

• The lone bid received by the city to complete the project was opened on April 24, 2018. It totaled \$608,600, which would require Bolivar to put \$142,000 more into the project. Brad Grantham of Grantham Construction offered ways to cut the cost of the project, such as eliminating the outfitter's hut, and was critical of TLM, who designed it. "They (TLM) didn't think this thing through," he said.

"They did not look at the land and the building for its best potential."

McTizic, while pointing out that although the project was something he inherited when he took office, said there was a chance for a moderately happy ending.

"We can make it a park without the grant. We can do something that we don't have to be accountable for to the state," he said, noting that if the city were to continue the project continuing to use the grant, they were bound by contract to fund its operating as a museum for the foreseeable future.

McTizic was fairly certain the state wouldn't be interested in allowing a change in the terms of the grant.

"We told them what we were going to do and they gave us the money to do it," he said. "They continued on A12



Take Steps to Control Your Investment Taxes

Tax Season is finally over. Of course, how much you pay in taxes depends on a variety of factors, many of which you can't control. But you might give some thought to how you can manage your investment-related taxes.

Here are some suggestions to consider:

Contribute to your employer's retirement plan. If your employer offers a 401(k) or similar plan, such as a 403(b) or 457(b), contribute as much as you can afford. The more pre-tax dollars you put in to your retirement plan, the lower your taxable income. Your employer also may offer a Roth 401(k) option, under which you invest after-tax dollars, so your annual income won't be lowered and your withdrawals will be tax-free.

Contribute to an IRA. Even if you have a 401(k) or similar plan, you may still be eligible to contribute to an IRA. With a traditional IRA, your contributions may be fully or partially deductible, depending on your income level; with a Roth IRA, contributions are not deductible, but your earnings can grow tax-free, provided you've had your account at least five years and you don't start taking withdrawals until you're $59\frac{1}{2}$.

Follow a "buy-and-hold" strategy. You can't control the price movements of your investments, but if you do achieve gains, you can decide when to take them - and this timing can make a substantial difference in your tax situation. If you sell investments that you've owned for one year or less and their value has increased, you may need to pay capital gains taxes at your personal income tax rate, which, in 2018, could be as high as 37 percent. But if you hold investments for more than one year before selling them, you'd be assessed the long-term capital gains rate, which is 0, 15 or 20 percent, or a combination of those rates.

Consider municipal bonds. If you're in one of the higher tax brackets, you may benefit from investing in municipal bonds. The interest on these bonds is typically free of federal taxes, and possibly even state and local taxes. Interest from some types of municipal bonds may be subject to the alternative minimum tax (AMT). However, because of the new tax laws, the AMT exemption amounts were increased significantly.

You might be wondering what these new laws mean to investors. In terms of your regular investment activities, the effect might not be that significant. The tax brackets for qualified dividends and capital gains - such as those realized when you sell stocks - will remain about the same. This means that most investors will continue to pay 15% to 20% on long-term capital gains and dividends. Consequently, the new tax laws shouldn't really affect you much in terms of your decisions on buying and selling stocks or investing in companies that may pay dividends. Of course, it's still a good idea to consult with your tax advisor on how the totality of the new laws will affect you.







Sunrise: Overcome Bitterness

It has been said bitterness is like an acid which does greater damage to the container in which it is stored than the object on which it is poured. Some suggest that violent scenes in visual and or audio entertainment illustrates that advertising violence may tend to spread violence, but the fact is only because beneath the surface there are already the seeds of violence among many people in their thoughts and attitudes. When a person feels they have been made to be unimportant or be bullied into a self perception that they are of less worth than anyone else and invisible to everyone else, they may become resentful. Dr. S. I. McMillen in None of These Diseases, states, "Our emotions are neither good nor bad. It is their use or misuse which makes them positive or destructive."

The difficulty arises when the individual who thinks they have been wronged, ridiculed or ignored becomes angry as a result. If their anger is not diffused in a healthy manner it may grow into resentment and then to bitterness. Dr. McMillen says that when an individual thinks they have been wronged, their pride has been wounded, they may feel like 'getting even.' Anger can be a healthy emotion that can spur us to appropriate action, but if left to its own devices it can be destructive to ourselves and to others. One theory describes three ways of dealing with anger.



4. A Life-long Commitment to God.

Saving faith does not stop at the moment of salvation from our past sins, but is a life-long walk with God in faith (Hebrews 5:7; Hebrews 12:1-2). Commitment is defined as, "the act of binding yourself to a course of action." (Definitions.net) God wants us to stay committed to serving Him- not just for a while, but all of our days. (I Peter 1:17; Hebrews 3:14) It is equally as important that we look at our conversion to Christ as the time we began to belong to Him as a bride to her husband. Paul makes that relationship in Ephesians 5:23-33. Therefore in Acts 11:20-23, when there were some from the city of Antioch who were converted to the Lord, Barnabas went to strengthen their faith and commitment to God— "When he arrived and saw evidence of God's grace, he was overjoyed and encouraged everyone to remain fully committed to the Lord." (verse 23, CEB) Paul spoke concerning his commitment in 2 Timothy 1:12, "For this reason I also suffer these things; nevertheless I am not ashamed, for I know whom I have believed and am persuaded that He is able to keep what I have committed to Him until that Day." He was devoted to God in spite of suffering at the hands of Gentiles, Jews, and false brethren (2 Corinthians 11:24-26). Paul was determined to persevere in the race that he started there in Damascus (Acts 9:18; 22:16; II Timothy 4:7). We too, can only have real saving faith when we stay faithful to the call of God through the gospel (Hebrews 10:38-39).



Rather than writing on a different topic each week, I will introduce a topic this week and expand upon it in the coming weeks. It is something to which everyone can relate, because everybody relies on it everyday, whether they are aware of it or not. We all rely on some kind of a worldview.

In this first installment, I will answer three questions. What is a worldview? How does a worldview work? Why is it important to be aware of our worldview?

First, what is a worldview? The dictionary defines worldview as "a particular philosophy of life or conception of the world." Put simply, a worldview is the way in which we understand everything we experience daily. A worldview, then, is like a filter through which we interpret all of reality.

Another way to think about a worldview is the way in which we answer the four big questions that even some of the most important thinkers in history have raised. Where did I come from? Why am I here? What is the meaning of life? What happens after this life?

Answers to those four fundament questions are dictated by our worldview. More specifically, how we answer the big questions will depend upon whether or not we have religious or faith beliefs.

Second, how does a worldview work? Three examples serve to illustrate how worldviews work. First, a worldview works like a pair of colored spectacles. If I were to put on a pair of "rose-colored glasses," then those glasses give all I see the appearance of being "rose-colored." Next, a worldview works like a Google Maps app on a smartphone; it helps me to navigate my way through life. Thirdly, a worldview works like a "connect-thedot-puzzle." It helps me to "connect the dots" of life, to make more sense out of life in a more consistent way.

Third, why is it important to be aware of our worldview? We ought to desire consistency in answering the four big questions: origins, meaning, morality and destiny. Also, the more conscious we are of our worldview the better equipped we are to see reality in more consistent ways. We are able more consistently to navigate our way through life, to more consistently make difficult decisions and to more consistently make sense out of the many facets of life, especially the confusing ones.





OUR COUNTY Hardeman County Remembered by Lisa Coleman

Four years ago this week I had one of the best things ever happen to me – my dachshund-girl, Elsie, came to live with me. We had a dog or two when I was growing up, but I had always wanted to raise a dog from a puppy, and Elsie fulfilled that wish; she chewed up a few things along the way, but that was part of our experience.

It was a rainy, April, spring Sunday afternoon when I went to pick her up. She was the dog-daughter of two of Susan English's dogs, Bella and Juno, and was part of a litter of four. Susan handed me the puppies (Elsie and a brother) and Elise immediately took a long look at me, gave me a big lick across my face as if to say, "yep, you'll do; you can be my person". I had not told anyone the name I picked out because I thought she should hear it first; that got me another big lick across the face.

She was a wee, tiny thing – just six weeks old and barely three pounds. She did well being away from her momma and settled in right away to her new place. As I said, we learned a lot about what a little dog could chew up (her record was one 4-day stretch where she chewed up 3 dog beds, a pair of flip-flops, a section of my bottom kitchen cabinets, and 2 dog toys). I never knew how much stuffing was in one dog bed until Elsie "introduced" me to those facts.

Elsie came to me at a time when I was getting adjusted to new medications for my rheuma-

toid arthritis that made me quite sick for a few weeks. She always knew - and still does - when I wasn't feeling so well and needed extra puppy kisses and cuddles. She still has a very keen sense of when I am not feeling well, not able to move as quickly, and she sticks right with me; she will often get right in front of my face as if she is assessing me to be sure I am doing fine. She has been through surgeries with me and through the loss of my Mom, and has stayed right by my side during all of them.

Elsie reminds me every day of pure, unconditional love. She is always, always glad to see me whether I have been outside for 5 minutes or gone for hours. She is still curious about new things and tries to figure them out; she stands guard over our house, yard,

and street from her perch in the window. No squirrels, folks out walking, cars, children on bicycles, or any of those pesky birds go by our house without a hearty bark from her; she cannot understand why those birds will not stay out of "her" yard. She loves to play catch with me and does a pretty good job of it; she doesn't understand why she can't go under the sofa anymore and looks at me with a very puzzled expression whenever a stray ball or toy goes under there. She knows exactly where I keep her treats, and loves to cuddle with her face right up next to mine.

Y'all, I am grateful every day for this sweet, smart, sassy, silly, loving dachshund-girl who blesses my life, and I am forever thankful that Susan shared one of her Bella's babies with me.

even said no when we asked if we could change the roof from tin to shingles."

McTizic said the project was dooomed from the start.

"We didn't have enough money in the budget. It was never going to work."

McTizic added that if they continued with the grant, the entire project would have to be completed by June 1, 2019.

Prior to making the motion to allow McTizic the freedom to act on the city's behalf, Councilman Larry McKinnie said, "We need to tell the state we can't do it. Send them a check and let's do what we want to do. Build a park."

The Hatchie River, which runs diagonally through Hardeman County, is believed to be the only major river of West Tennessee that has never been impounded, channelized, or otherwise modified by human activity to any major degree.

All eight council members were present for the meeting.
