Lawler Sues for \$3 Million+

World-renown wrestling legend Jerry "The King" Lawler has filed a wrongful death suit against Hardeman County, Hardeman County Sheriff John Doolen, and numerous employees of the Hardeman County Jail, in regard to the circumstances surrounding the 2018 passing away of his son, Brian Christopher Lawler.

In the suit filed July 26, Lawler, through his attorney, is asking for compensatory damages of \$3 million, plus punitive damages if the jury believes they are warranted. Also, the suit, in part, asks for "proper policies and training to address the provision of timely and adequate protection and provision of medical and mental healthcare, particularly in situations such as those addressed in this Complaint..." The suit also asks for attorney's fees and costs to be paid by Hardeman County.

In addition to Doolen, the lawsuit, filed by attorney Jeffrey S. Rosenblum of Memphis, names individuals Leonard Brown, Ellen Futrell, William Gonzalez, and Judy Wiggins as defendants.

Christopher was in the Hardeman County

Jail after being arrested in early July 2018 on charges of DUI and felony evading arrest. According to the narrative from the Hardeman County Sheriff's Department, Lawler, 46, was discovered after hanging himself in his cell on Saturday, July 28; he was given CPR and airlifted to the MED in Memphis. After tests revealed no brain activity, he was removed from life support after consultation with family, and pronounced dead the afternoon of July 29.

In the months following the death, Lawler asked for an investigation, refuting reports of suicide, saying that it "didn't pass the smell test" in regards to the narrative provided by the Hardeman County Sheriff's Department. However, the narrative of the lawsuit now agrees with the suicide assessment made in March of 2019 by the Tennessee Bureau of Investigations and blames the Hardeman County Sheriff's Department for not preventing his death.

The lawsuit narrative also states that Christopher was "unfairly arrested for allegedly driving under the influence and other related charges."

Christopher was best known for his career in the World Wrestling Federation (now known as WWE), where he performed as Brian Christopher and Grand Master Sexay and won 44 titles within the United States Wrestling Association.

Lawler appeared twice in Hardeman County in early 2018, performing as the featured wrestler at Bolivar Central High School on April 20 in a fundraiser for the school, and was the guest speaker for the school's annual Hi-Lite Reel program on May 10.

According to his website, Attorney Jeffrey S. Rosenblum concentrates his legal practice in the areas of wrongful death, catastrophic injury, medical malpractice and civil rights law.

Three million dollars is equal to an 83.3 cent tax increase in Hardeman County, at \$36,000 per penny, which would be near a 33% increase in the tax rate. The availability of the county insurance to cover the costs of a loss in a wrongful death suit is unknown.

As of press time, Hardeman County had yet to respond to the lawsuit.

Councilman Joy Gets Trial Date Vincent Wins Vol State Award

Bolivar Citycouncilman Jonathan Joy is scheduled to appear before Judge J. Weber McCraw in Circuit Court on September 18 for his trial on charges of theft and official misconduct.

Joy was charged in May with one count of theft over \$1,000 and one count of official misconduct. Joy allegedly overbilled Hardeman County for the sale and installation of five air conditioning units. Joy, who is the owner of Joy Heating & Air, was hired to install new air conditioners at multiple county facilities between August 2017 and June 2018.

Investigators determined that Joy installed air conditioners that were rated for less tonnage than what the county ordered, and then billed the county for products with more tonnage. For example, in January 2018, Joy installed a 6-ton air conditioning unit at the Hardeman County Health Department, and then invoiced the county for a higher priced 7.5-ton product.

Investigators determined that Joy overbilled the county \$1,609 for the sale and installation of five air conditioning units.

Joy, who was elected to city council in 2017, will be up for re-election in 2021. If convicted, Joy would be removed from the council, according to the City of Bolivar charter.

The trial is scheduled to take two days.

Master Gardenders Begin Classes by Lee Sammons

UT/TSU Extension is offering a unique opportunity for gardeners – young and old, new or experienced to engage in both classroom and practical learning of a wide variety of gardening and home horticultural topics. The Hardeman County Extension Office is now accepting applications for the fall Master Gardener Course. All classes will be held at the Hardeman County Extension office 200 East Market Street in Bolivar on Tuesday mornings 9:00 – 12:00 a. m. beginning August 13 and ending November 12.

The Master Gardener program is a volunteer service program for the University of Tennessee Extension. 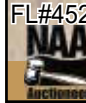

How Does Social Security Fit Into Your Retirement Income Strategy?

It might not be on your calendar, but Aug. 14 is Social Security Day. Since it was enacted on Aug. 14, 1935, Social Security has provided some financial support for millions of Americans during their retirement years. While Social Security benefits, by themselves, probably aren't enough to enable you to retire comfortably, they can be a key part of your overall retirement income strategy – if you use them wisely.

To help you make decisions about Social Security, you will need to answer these questions:

When should I start taking my benefits? You can take Social Security once you reach 62, but if you wait until your full retirement age, which will probably be between 66 and 67, you'll get much bigger monthly checks, and if you wait until 70, you'll get the biggest possible payments. Before deciding when to begin receiving your benefits, you'll need to weigh a few factors, including your estimated longevity and your other sources of income.

How should I consider potential spousal benefits? If you are married, or if you're divorced but were married for at least 10 years, you could receive up to half of your spouse's full retirement benefit (offset by your own benefit, and reduced if you claim early). If you outlive your spouse, you could claim survivor benefits, which can provide either your own benefits or 100% of your deceased spouse's, whichever is larger. Consequently, the higher-earning spouse might want to postpone taking benefits for as long as possible to maximize the survivor benefit.

How much can I earn without reducing my Social Security benefits? If you are younger than your full retirement age and you are receiving Social Security, the Social Security Administration will withhold \$1 from your benefits for each \$2 you earn over a certain threshold (which, in 2019, is \$17,640). For the year you reach your full retirement age, your benefits could be withheld by \$1 for every \$3 you earn over \$46,920. But once you reach your full retirement age, you can earn as much as you want without your benefits being withheld, although your benefits could still be taxed, depending on your income.

How much of my pre-retirement income will Social Security replace? Generally speaking, you should expect Social Security to replace slightly more than a third of your pre-retirement income. However, the higher your income during your working years, the lower the replacement value of Social Security will be.

What other sources of retirement income should I develop? Contribute as much as you can afford to your IRA and your 401(k) or similar employer-sponsored retirement plan. You may want to consult with a financial professional, who can look at your entire retirement income picture and recommend moves to help you achieve the lifestyle you've envisioned for your later years.

Keep in mind that your decisions about Social Security filing strategies should always be based on your specific needs and health considerations. For more information, visit the Social Security Administration website at socialsecurity.gov.

One final word: You may have concerns about the stability of Social Security. While no one can predict the future, many potential solutions exist to put the program on more solid footing. Consequently, try to focus on the actions you can control.

Lemon Lava Cake

Ingredients

- 1 box lemon cake mix (ingredients listed on back of box; eggs, oil and water)
2 (3.4 oz) boxes instant lemon pudding
1/3 cup sugar optional
2 cups cold milk
1 1/4 cup water
powdered sugar for dusting

Instructions

- Preheat oven to 350°F degrees.
Spray a 9 x 13 baking dish with nonstick cooking spray.
Prepare cake mix according to package directions.
Pour batter into baking dish.
In a separate bowl, combine dry pudding mixes with sugar, milk and water. Whisk briskly for 2 minutes until it begins to thicken.
Spoon pudding mixture over cake mix batter. Once it is on there, it is hard to spread out since it kind just ends up sinking into the batter.
Put a large baking sheet underneath your baking dish before sliding it in the oven.
Bake for about 55 minutes to one hour.
It's a bit tricky to tell when it is done because the pudding layer in it always stays a bit jiggly. So, what you want to do is take a toothpick and insert it into the middle of the cake. If it only comes out with pudding - you are good. If you still see gooey cake batter on it, then you need to bake it for a bit longer.
When it's finished baking, allow it to cool for about 20 minutes. This will allow that pudding layer to thicken up a bit more.
Then serve with a bit of sprinkled powdered sugar on top.

Changes in Hardeman County Bus Routes

Hardeman County Schools is making some changes in our bus routes for the 2019-2020 school year. Below are the schools and routes that will be affected. We ask that you review this information carefully and call us at 731-658-3444 if you have any questions about which bus your student will be riding and the approximate time for pick up in the mornings. We also ask that you be patient with our drivers as we implement these changes to our routes. These changes are also posted on the district website at: www.hardemancountyschools.org Thank you.

Below are changes in bus routes for the Toone and Bolivar zones that may impact your students.

- Buses #1 and #5 are being eliminated.
- Bus #31 will pick up current route plus students zoned for Toone on Pine Top, Harris and Isaac Jordan Roads
- Bus #9 will cease to pick up on McNeal Street, which runs in front of the Columns. Bus #9 will pick up Hwy 125 North, Fitts-Ross Rd, Ebenezer Rd, Hwy 100 toward Bolivar from Pine Top Rd, Naylor Rd and Cloverport Rd, which are zoned for Bolivar. Bus #9 will continue to pick up students on Main Street, entering Bolivar on Hwy 18 North. This includes most of Bus #1's old route.
- Bus #58 will cease to pick up on Elmview Street. Bus #58 will pick up the rest of its current route, adding McNeal Street, Madison Street, Butler Street, West Jackson Street and the area around Bolivar Municipal Center, North Washington Street and the area around the Bolivar Library. These areas include parts of Bus #1's and Bus #9's route in Bolivar.
- Bus #60 - Current Route and add Elmview Street, which is off of Sain Rd.
- Bus #6 will keep current route and will add Walton Road and Vildo Road, between Old Hwy 64 and New Hwy 64. Bus #6 will not pick up students north of New Hwy 64. These are students that were a part of bus #5's and bus #13's old routes.
- Bus #13 will no longer pick up on Vildo road between Old Hwy 64 and New Hwy 64, the area beside/behind the Hardeman County Fairgrounds and will no longer pick up on Jackson Street or Lee Street. Bus #13 will pick up all of Vildo Road, north of New Hwy 64, and Walton Road, North of Hwy 64. This is part of Bus #5's old route. In addition, Bus #13 will pick up on Pleasant Creek Lane, which is across from Joe's Restaurant.
- Bus #11 will continue its current route and add Jackson St. and Lee St.
- Bus #25 will cease to pick up students behind Jervis, Young Road and Roger Avenue. Bus #25 will pick up all students in the Country Club Area, including Hines Blvd, Stevens Road, Lucy Black Rd, Nuckolls Rd, Janet Rd, Blue Bonnet Ln, Karen Drive and El Capitan. This includes parts of Bus #5's old route
- Bus #56 will pick up all students for BCHS, BES & BMS on Tate Rd, Young Rd and Roger Avenue, including all the area behind Jervis.

Below are changes in bus routes for the Grand Junction zone that may impact your students.

- Buses #18 and #53 are being eliminated.
- Bus #61 will pick up the area around Grand Junction Elementary School, west side of Grand Junction, area around the Grand Junction Library, west of Grand Junction on Hwy 57, Hwy 18 to Hwy 368, Hwy 368, area around CO-OP, Smith Drive and Holder Road.
- Bus #41 will pick up in Saulsbury, south of College Street, Indian Creek Road and Park Swain Road.
- Bus #42 will pick up the area on and around Van Buren Road from Lake Hardeman Road to Hwy 57 in Saulsbury. Bus #42 will not pick up/drop off on Hwy 57.
- Bus #45 will pick up on Hwy 18 South to Hwy 368 and will pick up on the roads adjoining Hwy 18 between Hickory Valley and Hwy 368, which are zoned for Grand Junction and/or Middleton High School.
- Bus #47 will pick up all students on Hwy 57, who are zoned for Grand Junction Elementary/Middleton High School and live in the Grand Junction Zone.
- Bus #19 will pick up students on College Street, Sparkman Road, Smith Road, April Subdivision, Greenville Subdivision and other adjoining roads between Saulsbury and Grand Junction.
- All Students will transfer at Grand Junction Elementary School at 7:15 AM.
- Buses #19, #45 and #47 will transfer students to Middleton High School.
- High School students from Bus #42 will transfer to Bus #19, Bus #41 will transfer to Bus #45 and Bus #61 will transfer to #47.

Below are changes in bus routes for the Middleton zone that may impact your students.

- Buses #20 and #26 are being eliminated.
- Bus #43 & #48 will continue to pick up students from Bus #26, as they picked up for the 2018-2019 school year.
- Bus #21 will pick up all students from Buses #20 and #21 on Hwy 57 toward Pocahontas and the Pocahontas area.
- Bus #21 will no longer pick up between the railroad tracks and Middleton Elementary School.
- Bus #27 will pick up/drop off students between Middleton Elementary School and the railroad tracks, Pinecrest Lane and Southwest Lane.

Below are changes in bus routes for the Whiteville zone that may impact your students.

- Buses #35 and #46 are being eliminated.
- Bus #59 will pick up all students south of Whiteville Elementary School, including Whiteville-Newcastle Road. Bus #59 will no longer pick up/drop off North of Hwy 64.
- Bus #50 will run current route and add Hwy 64 west leaving Whiteville, Day Care on Hwy 64, Ferguson Road and Mt. Moriah Street.
- Bus #16 will run current route plus all of the "In-Town" pickups to Mt. Moriah, including Maple Street, Cross Avenue, Simmons Street and Martin Luther King Jr. Street. Bus #16 will not pick up or drop off on Web Street
- Bus #44 will pick up its normal route on Hwy 100 and Vildo Road and will add Web Street, Seller Street and area around the old Whiteville H.S.
- Bus #54 will pick up all students north of Whiteville on Hwy 179 and the adjoining roads, past Mt. Moriah Street.
- Buses #16 and #50 will transfer students to Bolivar Central High School.

FAITH

Grace, Part 1 by Jeff Capshaw

In this and the coming weeks' columns, I intend to discuss the biblical doctrine of grace. It is appropriate also to express my gratitude to the Editor and Publisher of this paper for suggesting the topic of this new series.

The word "grace" is one commonly used, but we seldom stop and reflect on what it means, let alone what it entails. Therefore, I hope this series will cause readers to stop, to think and to find great joy with gratitude for this marvelous gift from God called grace. It is so much more than a buzz word.

Indeed, the entire basis of Christianity (the Gospel) is what the great preacher, Charles H. Spurgeon of Britain, once titled his book: *All of Grace*. Furthermore, grace is a quintessential doctrine of biblical Christianity, and God's grace is what separates true Christianity from all other religions on the planet.

According to Millard Erikson's Concise Dictionary of Christian Theology, grace is "God's dealing with man in undeserved ways; it is

simply an outflow of God's goodness and generosity" (p. 68). The great Reformer, John Calvin, said, "from this it is easily inferred, as I have said, that everything good in the will [of man] is entirely the result of grace" (Institutes, II.III.6, brackets added). Moreover, in the words of Karl Barth, "no one can be saved - in virtue of what he can do. Everyone can be saved - in virtue of what God can do."

The Apostle Paul mentions grace three times in the familiar but classic passage which we will revisit in the future. "But God, being rich in mercy, because of the great love with which he loved us, even when we were dead in our trespasses, made us alive together with Christ—by grace you have been saved—and raised us up with him and seated us with him in the heavenly places in Christ Jesus, so that in the coming ages he might show the immeasurable riches of his grace in kindness toward us in Christ Jesus. For by grace you have been saved

through faith. And this is not your own doing; it is the gift of God, not a result of works, so that no one may boast" (Ephesians 2:3-9).

Finally, in the New Testament, the word translated grace is the Greek word *charis* (χάρις). According to the Louw and Nida Greek Lexicon, grace is "that which is given freely and generously-gift," "gracious gift" (Vol. I. 57.103). One simply cannot earn or merit a freely given gift; else, it isn't a gift. Thus, grace is a unique gift from God, given freely out of his abundance of love, kindness, and goodness toward us.

As Julia Johnson's well-known hymn describes, it is "Grace, grace, God's grace, Grace that will pardon and cleanse within; Grace, grace, God's grace, Grace that is greater than all our sin!"

LETTER TO THE EDITOR

Will A Lake Project Lead To Higher Taxes?

In considering a manmade lake in Hardeman County, the best example to learn from is the Carroll County 1000 Acre Lake near Huntingdon. What is the history and impact of the Carroll County Lake? The first discussion of a lake in Carroll County happened in the 70's. It took about fourteen years for the lake to progress to environmental permit application in 1984 - which it failed. The effort was revived and the State House of Representatives formed the Carroll County Watershed Authority (CCWA) in 1997 according to January 19, 2009 article in the Tennessee Municipal League's "Tennessee Town & City". A more environmentally friendly proposal was developed and a new permitting effort begun in 2000 - funded by a narrowly approved \$10 wheel tax. Construction began in 2008 after several years in the permitting process. The official opening was the first day of Spring 2013. But in 2015 the lake closed when heavy rains took out the spillway. It took until January 25, 2017 to repair the spillway and close the gates to refill the lake.

So what did it cost? According to a July 3, 2018 article in The Banner of McKenzie, Tennessee - the final cost as of 2016 was approximately \$26 million. A review of CCWA annual reports found a total of \$28,784,476 in funding references between grants and bond issuances. Including \$6,187,910 granted by the city of Huntingdon, \$606,566 in Federal Grants, \$5.3 million in State grant, and \$16,690,00 in borrowed money. For a 1000 acre lake - in 2016 - not counting the wheel tax revenue applied to studies and permitting.

To get a sense of ongoing cost and revenue, the CCWA annual report ending fiscal year 2018 gives the best insight. That annual report indicates that general fund expenditures exceeded revenue by \$312,760. Of the expenditures, only \$84,953 was for construction - leaving operating expenses exceeding revenue by \$227,807. CCWA ended the fiscal year with a general fund balance of \$936,679, a long term debt due within one year of \$358,800, and a debt due in more than one year of \$10,190,464. Debt service cost in 2018 was \$483,179 in interest and \$18,000 in principal. And these costs do not include taxpayer cost toward TWRA support of the lake. The article in The Banner stated that the lake debt will not retire until year 2055 and the \$10 wheel tax is to carry through year 2034.

There was a notable rise in county property tax revenue from 2012 to 2013. But in 2016 it was decided to apply property tax revenue from lake area property to lake operations. Despite the \$10 wheel tax, the property tax diversion to lake operations, and over \$6 million of local public funds given for construction - residents are required to pay a fee for lake use and lake property owners are required to pay a \$5,000.00 onetime fee plus annual fees for lake access from their property. Since the lake opened in 2013, population has actually declined in Carroll County according to the U.S. Census Bureau. According to Carroll County Annual Audits - property tax and total tax revenues have remained relatively flat since 2013. Much, if not most, of the lake area property appears to still be in the hands of developers - suggesting a lack of demand.

So a publicly funded project whose operating cost exceeds appointed local revenue, no apparent to-date indicators of economic improvement, fees to residents for use, indicators that lake property is not selling, and the latest annual report projecting the lake authority is running out of funds. The 241 page SPRING CREEK LAKE FEASIBILITY STUDY dated March, 1995 seems to predict the situation reflected in the CCWA 2018 annual report. An apparent need for continued Federal and/or State funding. Quoted from the report "No level of recreational development considered will generate sufficient revenues to support annual operating costs and retire capital indebtedness. It appears that revenues will at best cover only annual operating and maintenance costs. Capital costs for lake facility development would essentially have to be subsidized". But the Carroll County 2018 Annual Report indicates revenues are not covering annual operating and maintenance costs. Will Carroll County, at some point, have to raise taxes because of the lake? If so - is it a benefit or a burden? It has been suggested by our county that a Hardeman lake project could require a \$40 million bond issuance.

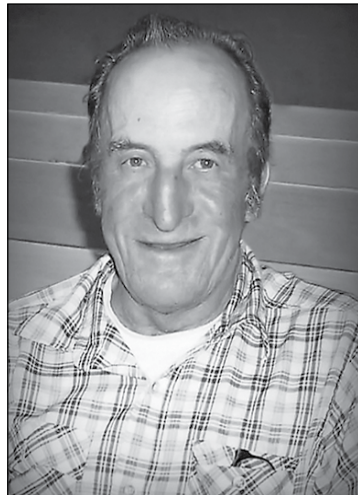
