Royal Oak Chooses Hardeman County

Hardeman County Mayor Jimmy Sain, State Representative Johnny Shaw, the Hardeman County Industrial Board, and the Hardeman County Chamber of Commerce announced on July 30 that Royal Oak Charcoal will construct a plant for lump charcoal in Hardeman County.

Estimates put ground breaking for the \$15 million project in six weeks, with an expectation of 50-70 jobs after all phases are complete at the site off Highway 179 north of Whiteville.

"Hardeman County is proud to have Royal Oak invest in our county. This plant is a perfect fit with our timber industry and our ability to supply their materials needed to produce the no. 1 lump charcoal in the US. It's a great day for us," said Sain.

Royal Oak has 10 facilities



across the southeast and is the #1 Hardwood Lump charcoal producer in the United States.

Sunrise: Grief Upon Grief by David Coy

It has frequently been said and most agree, the most tragic loss a family may endure is that of a child. Losses that would be a very close second might be loss through suicide. With all the help that exists for people who are hurting it boggles the mind why some precious soul would choose a manner which some describe as a selfish way to give up on life and inflict such misery on family and friends. Reed Robertson retells his near death experience in contemplating suicide. He said he became at first very cynical toward the life the rest of his family was living, thinking he had it all figured out. He thought he was better than everyone else. He said it eventually led to thoughts of suicide. He concluded that no one wanted to be around him as he behaved the way he did. He wrote a letter about his plan to commit suicide and his parents heard about it, possibly from his youth minister whom he told earlier. In a sit down with his dad, he was told 'that is the most selfish thing you could do, is to leave this world because you can't take it.'

Someone has said, "...there's just no mental place farther away from humanity and purpose than the hypnotized numbness that creates the false picture of despair, that forces the victim, unaware, to believe, life's legacy is over." Others have attempted just as some have committed the act of suicide. Anthony Bourdain's girlfriend at the time wrote a letter within which she is said to have stated that it was 'his choice' whether to continue with treatment and advice or not. Whether or not we think it is selfish or a choice or not, it is severely traumatic to the surviving family and friends, and some do not recover or cope well and some not at all. **Defending the Faith: Part 4** by Jeff Capshaw

Readers of this section will notice an emphasis on the Scriptures for both worldview thinking and defending the Christian faith. It is impossible to overemphasize its importance.

The Scriptures self-attest to their divine inspiration and authority. They need no external defense, because on a Christian worldview, there can be no higher or weightier evidence by which to "prove" them to be the very Word of God.

The Westminster Confession of Faith clearly emphasizes this: It says, "the authority of the Holy Scripture, for which it ought to be believed, and obeyed, depends not upon the testimony of any man, or Church; but wholly upon God (who is truth itself) the author thereof: and therefore [sic] it is to be received, because it is the Word of God" (WCF, LIV).

When the Reformational theologian, John Calvin, was asked how he knew the Bible was the Word of God, he answered so that even a child could understand.

He wrote, "as to the question, how shall we be persuaded that [Scripture] came from God . . . it is just the same as if we were asked, how shall we learn to distinguish light from darkness, white from black, sweet from bitter." Calvin went on to say, "Scripture bears upon the face of it as clear evidence of its truth as do white and black of their color, sweet and bitter of their taste."

For many, however, the Bible is just an ancient and outdated book, written much later than it claims and by religious men with a power agenda. It is full of contradictions, incredulous myths about a God (especially in the Old Testament) who urged genocide and imposed bizarre religious regulations upon Ancient Israel. Many say that the Bible insults the intelligence of our sophisticated, modern, scientific and technological era.

According to Pastor John Piper, belief in the authority of Scripture comes in three stages. First, the testimony of the Holy Spirit convinces men and women of their guilt before God (Rom. 3:19). Second, Piper writes, ". . . Jesus wins our confidence and our trust, and we take him as Savior from our sin and Lord of our life."

Finally, men and women find themselves believing the Bible and following Jesus. The best advice anyone could give to seekers is this. Find a copy of God's Word you can understand; read it for yourself. Ask Questions. See what happens.

We define influence as, "The power to sway that something or someone has to affect other people's thinking, behavior, or actions." The Bible speaks of Satan's influence over the sinful part of this world in I John 5:19, "We know that we are of God, and the whole world lies under the sway of the wicked one." Satan is referred to as the

"the god of this world" in II Corinthians 4:4 and in Ephesians 2:2 as "the prince of the power of the air." These titles refer to his influence or the power he has over the lives of the "children of disobedience." (Ephesians 2:2)

(4) Satan Uses the Music We Listen To.

Christians know full-well that music can be a powerful influence on our lives. In Colossians 3:16, Christians teach & admonish one another by singing truths from God's word. In psalms and hymns and spiritual songs, the influence for good is positive, uplifting, and shows us what is good, holy, noble, and right. Songs can influence us in our heart as we sing from the heart (Eph. 5:19). What about songs on the radio that teach the ways of the world? First of all—not all songs do this—but there are songs that do convey a message that appeals to the carnal side of man. Paul talks about the carnal-minded attitude in Romans 8:5-8. That is danger of letting what we listen to influence for what is vile, wicked, and evil in nature. This can lead us away from God and His pure ways. Songs such as "I'm gonna have you naked by the end of this song" (has lustful thoughts and actions as its theme), "I kissed a girl and I liked it!" (sung by a female artist), "I was born this way" (promotes the gay lifestyle) have had an influence in our culture. What about songs that use profanity in their lyrics? Or promote violence? Or drug use? We must be careful about the lyrics of the songs we listen to or sing. If we are not careful, we can get caught up in the good beat of a song that sends a message of approval for sinful conduct. It may be popular and on the radio, but if it is promoting evil—we should not listen to its corrupting theme. (James 1:27; II Corinthians 7:1)

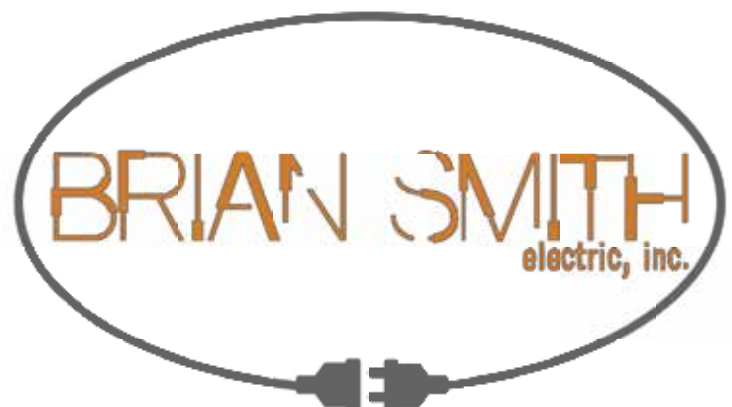

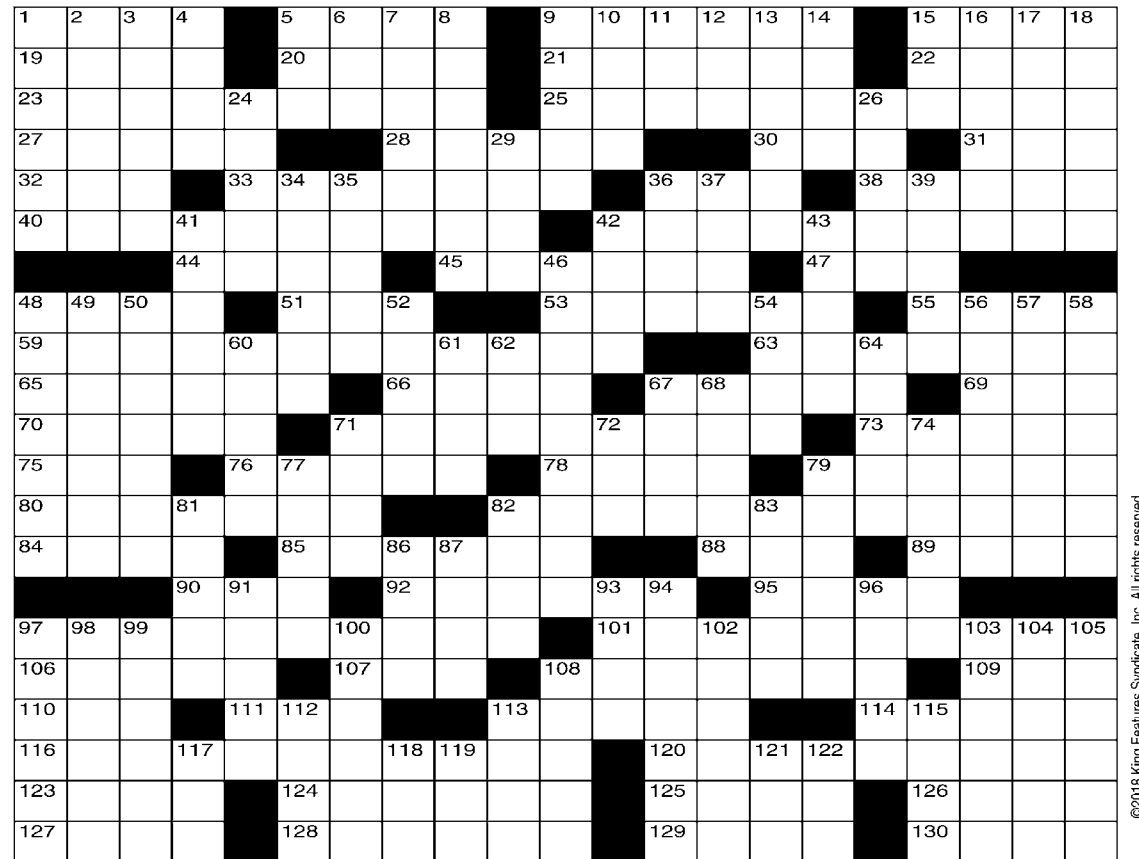

Beet Picked Deviled Eggs

Ingredients

- 1 cup apple cider vinegar, plus 3 tablespoons, divided
- 1 tablespoon granulated sugar, plus a pinch, divided
- 2 1/4 teaspoons kosher salt, plus a pinch, divided
- 1 small red beet, peeled and halved
- 12 hard-boiled eggs, peeled
- 1/2 cup mayonnaise
- 1/4 cup finely chopped fresh herbs, such as basil, tarragon, chives, plus more for garnish
- 1 teaspoon anchovy paste
- 1/4 teaspoon freshly ground black pepper
- 2 hot chilis, thinly sliced

Directions

In a medium pot, mix 1 cup apple cider vinegar, 1 tablespoon sugar, 2 teaspoons salt, and 3 cups water. Add the beet and bring to a boil, then remove from heat and let cool slightly. Pour into a large heat-safe jar or bowl (including beet). Add eggs, stir, and refrigerate at least 3 hours (stirring occasionally) or overnight for a darker shade of pink.

Remove eggs from liquid. Halve eggs (reserving the whites) and gently transfer the yolks to a bowl. Add 1 tablespoon vinegar, mayonnaise, herbs, and anchovy paste to the yolks. Season with 1/4 teaspoon each salt and pepper, then spoon or pipe the filling into the egg whites.

Place the chilis, remaining 2 tablespoons vinegar, the remaining pinch each of sugar and salt in a bowl and let stand 15 minutes. Drain the chilis, then sprinkle over the deviled eggs. Sprinkle with additional herbs, if desired. Serve.

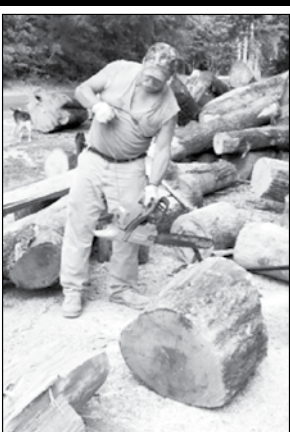
