# Waiting for the TBI Report

Hardeman County Sheriff John Doolen is waiting, like everyone else, for the Tennessee Bureau of Investigation's (TBI) report on the death of Brian Christopher Lawler, who passed away July 29 in Memphis after he was found unresponsive in a Hardeman County jail cell.

And until TBI returns the report, Doolen is going to stay silent, even though he is asked to speak about it with various news outlets almost everyday. "I've been told I can't comment on an ongoing investigation," he said. "And I won't."

All Doolen can say is that TBI is waiting for

the medical examiner's report.

"With all the tests they have to run, it can take some time," he said.

According to a statement from the Hardeman County Sheriff's Department, Lawler, 46, was discovered after hanging himself in his cell on Saturday, July 28; he was given CPR and air-lifted to the MED in Memphis.

After tests revealed no brain activity, he was removed from life support after consultation with family, and pronounced dead the afternoon of July 29.

As is standard procedure in any death at a

jail, the Tennessee Bureau of Investigations was requested by the Hardeman County Sheriff's Department to investigate the circumstances.

Christopher was in the Hardeman County Jail after being arrested in early July on charges of DUI and felony evading arrest.

Lawler was best known for his career in the World Wrestling Federation (now known as WWE), where he performed as Brian Christopher and Grand Master Sexay and won 44 titles within the United States Wrestling Association.

## Building Cleared After Bomb Threat

The Hardeman County Sheriff's Department responded to and cleared a bomb threat from the A. Schulman Company in Grand Junction early on August 20.

The threat was called in about 3:00 a.m. according to Sheriff John Doolen, and with the help of scent dog from the Canine Unit in Madison County, employees re-entered the facility around 6:00 a.m.

A. Schulman, located at 706 W. Madison Street in Grand Junction, is a leading international supplier of high-performance plastic compounds, composites and resins, which are used in a variety of markets, according to their website. They have plants in North America, Latin America, Europe, Middle-East, Africa and Asia-Pacific regions.

According to the sheriff's department, the incident is still under investigation.

## Pleasant Run Arboretum to Open



The City of Bolivar will add an arboretum to the growing attractions at the Pleasant Run Creek Park with a ribbon cutting on August 24 at 10:00 a.m.. The city, led by Parks and Recreation Director Curtis Stack, successfully completed the requirements for a level one arboretum, with 38 tree species scattered throughout the park along a one-mile trail.

"A great deal of research and work was undertaken by the parks and recreation department staff to attain this certification. This is a wonderful accomplishment for the City of Bolivar and adds an additional attraction at Pleasant Run Creek Park," said Mayor Julian McTizic.

"We would like to thank everyone who assisted us throughout the process of identifying and labeling the tree species throughout the park. We are extremely pleased to be opening this new section of the park," added Stack.

The arboretum was certified by the Arboretum Certification Program Committee of the Tennessee Urban Forestry Council in early August. TUF's certification program maintains standards for public education by state arboreta. A certified arboretum must be open to the public with trees that are labeled, properly protected, and well maintained.

Carolyn (Chandler) Vales shares memories about her school days. She writes, "While browsing around Walmart the other day, I was watching kids shopping for school supplies in preparation for the new school year. It reminded me of those years long ago when I was going back to school after summer break. Some things haven't changed, but many things sure are a lot different."

I attended Chester County High School back in the 60s. We lived on the Chester/Hardeman County line. Mr. J. L. Rush, as we affectionately called him, was our bus driver. They were our next-door neighbors, so we were among the first ones on the bus and the last ones off. We had to catch the bus at 6:30 a.m. and we got home at 4:30 p.m. There was no having our parents chauffeur us to school back then. Frankie and Leo Lambert, Frances and Bill Rush, Larry Murley, John Pipkin, my sisters, Judy and Donna and I rode the complete bus route day after day together. Carolyn Deming got on at Deانبurg. We are still best of friends, today, from riding the bus together.

We started back to school in late July. We went for about a month and then school closed for a month for cotton pickin' time. That month we attended in late July through August was no picnic either. The first years that I attended, we had no air conditioning. So, we had to endure the soggy, hot days in class with just fans. I don't think we learned very much that month. We were all certainly happy when we finally got air conditioning.

Most of us living out in the country lived on a farm and our dads were cotton farmers. So, we had to help by chopping the cotton in the summer. My sister, Donna and I did get a nice tan, though. When we were chopping alone, we would wear our bikinis and everybody thought we had been to Florida. Then, in the fall, we had to pull a cotton sack behind us and pick the fluffy white bolls by hand. I was always envious of the city kids, because they got another month of vacation while I was picking cotton.

We didn't have cellphones, texting, e-mail or Facebook back then either. We had rotary dial phones. For you kids born after 1970, that's where you stick your finger in the circles with the numbers and then twirled each number to connect your call. It also had a cord attached to it, so you had to sit or stand in one spot while you talked. Most of us were on a party line. That's where two or more households shared the same number, but a different ring. Joan Burkhead and I would talk for hours after school or until someone on the party line would ask us to hang up. Sometimes, because they could hear everything we were saying, they would just join in the conversation. We didn't have streaming or downloading our favorite music, either. We didn't even have 8 tracks or cassettes yet. We had a radio and record player, if we were lucky. We only had three channels on TV and no remote.

Yes, many things have changed, but the excitement and anticipation of starting a new school year have not."

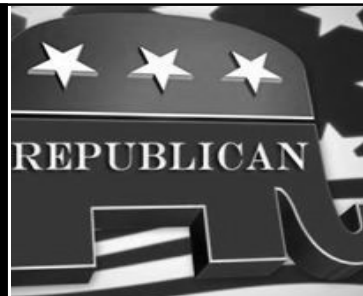

### (1) The Social Gospel is Not a God-given Work for the Church to do.

There are very clear scriptural principles that forbid Christians from acting beyond the authority of the scriptures, and especially in the collective work of the church. In 1 Corinthians 4:6, Paul exhorts us to "not go beyond what is written."

Thus, if God has "written" for the church to preach the word (1 Timothy 3:15), to edify the brethren (Ephesians 4:7-16), and to help Christians in need (1 Corinthians 16:1,2), it is to "go beyond what is written" to add basketball and banqueting. Thus, it is actually a sinful act of rebellion to go beyond what is written for the whimsical pleasure and frolicking of brethren. Also, Paul in Philippians 3:17 states: "Brethren, join in following my example, and note those who so walk, as you have us for a pattern." Thus, whatever the apostles and New Testament Christians did in the First Century is what Christians should be doing today. Did the Christians in the First Century spend their time, and God's money, in preaching the gospel, edifying the brethren, and helping Christians in need, or in building and supporting banquet halls and basketball courts? Bible authority for a practice must be determined by the proper means of determining whether it is scriptural: Do we have a direct command or statement authoring church sponsored social activities? Do we have an example in the scriptures that it is the work of the church to entertain and provide recreation for a church's members? And finally, do we have a necessary inference that ice cream and pizza parties and "jumping jacks for Jesus" are the mission and work of the church? If we do not have such authority, then it is an addition to God's word and thus sinful (Proverbs 30:6; Colossians 3:17).

## Defending the Faith: Part 8 by Jeff Capshaw

In these brief articles on Christian Apologetics (defending the faith), I have discussed two common methods: Classical Apologetics and Evidential Apologetics. The Classical method was adopted by the Early Church and relies heavily on reason to defend Christianity. Evidentialism has commonness with the Classical method, but it tends to rely more heavily on the use of historical evidences. Chief among its arguments is for the resurrection of Jesus.

This week's selection (the Cumulative Case method) and those to follow probably are less familiar. However, Christians interested in apologetics should be aware of them, but space limitations allow only for an entrée into the topics.

One line of evidence might be enough for some arguments, but it seems more reasonable that multiple lines of evidence are better to substantiate any claim. For example, if the oil in a pot needs to be heated to 375 degrees for deep frying, then the evidence provided by one accurate thermometer suffices. On the other hand, when listening for extremely faint gravitational waves rippling through space, it is good to have converging evidence from more than one detection device. Such was true with the recent LIGO locations in Washington and Louisiana. Both detected the spawning of radio waves created by the merging of two black holes in deep space 1.3 Billion years ago. Thus, two are better than one.

Proponents of the Cumulative Case method do not attempt formal arguments for Christianity as in logic or philosophy. Instead, according to Cumulative Case adherent, Paul D. Feinberg, "the model for defending Christianity is law, history and literature" (Five Views, p. 151). Well-known defenders of Christianity have adopted this approach: F. R. Tennant, Elton Trueblood, G.K. Chesterton and C.S. Lewis.

Feinberg enumerates several "tests for truth" for testing worldviews. He lists the following: consistency, correspondence, comprehensiveness, simplicity, livability, fruitfulness and conservation. Thus, the view of reality that manages to pass the above tests surely rises to the level of at least probable.

Since the mid-17th Century, too much authority has been given to formal arguments, and it simply is a myth of modern day materialism that conclusions based only on mathematical-like proofs alone are credible.

However, the Cumulative Case method has much to commend it, because it recognizes there are other legitimate and reasonable ways of providing soundness to arguments: ways different from formal proofs. Therefore, the Cumulative Case approach provides substantive reasons for the truth claims of Christianity.

If you are, or will be, a caregiver for elderly parents or another close family member living with Alzheimer's disease, you may experience some emotional stress – but you also need to be aware of the financial issues involved and what actions you can take to help address them.

You will find few "off the rack" solutions for dealing with the financial challenges associated with Alzheimer's. For one thing, family situations can vary greatly, both in terms of the financial resources available and in the availability and capabilities of potential caregivers. Furthermore, depending on the stage of the disease, people living with Alzheimer's may have a range of cognitive abilities, which will affect the level of care needed.

Here are some general suggestions that may be useful to you in your role as caregiver:

Consult with family members and close friends. It's extremely hard to be a solo caregiver. By consulting with other family members or close friends, you may find that some of them have the time and ability to help.

Consider obtaining durable power of attorney. If you possess a durable power of attorney for finances, you can make financial decisions for the person with Alzheimer's when he or she is no longer able. With this authority, you can help the individual living with the disease – and your entire family – avoid court actions that can take away control of financial affairs. And on a short-term basis, having durable power of attorney can help you take additional steps if needed. You'll find it much easier to acquire durable power of attorney when the individual living with Alzheimer's is still in the early stage of the disease and can willingly and knowingly grant you this authority.

Gather all necessary documents. You'll be in a better position to help the individual living with Alzheimer's if you have all the important financial documents – bank statements, insurance policies, wills, Social Security payment information, deeds, etc. – in one place.

Get professional help. You may want to consult with an attorney, who can advise you on establishing appropriate arrangements, such as a living trust, which provides instructions about the estate of the person for whom you're providing care and names a trustee to hold title to property and funds for the beneficiaries. You also might want to meet with a financial advisor, who can help identify potential resources and money-saving services. And a tax professional may be able to help you find tax deductions connected to your role as caregiver.


Finally, use your experience as a caregiver to remind yourself of the importance of planning for your own needs. For example, a financial professional can suggest ways of preparing for the potentially huge costs of long-term care, such as those arising from an extended stay in a nursing home.

Caring for an individual living with Alzheimer's has its challenges. But by taking the appropriate steps, you can reduce uncertainties – and possibly give yourself and your family members a greater sense of security and control.



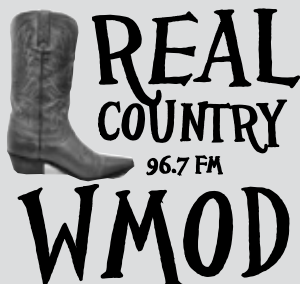
