And Then the Sheriff Said...

With the county's response to the lawsuit filed by Hardeman County Deputies made public last week, Hardeman County Sheriff John Doolen says the county has missed the point.

"The point is they are not being paid correctly," he said. "They don't pay the hours we send up there. They have an interpretation of the labor law and we have a different one. But ours has been consistent and theirs has changed three times since January."

The suit, filed May 29 by William C. Sessions of Heaton and Moore, P.C. of Memphis, was filed against the Hardeman County Government, including the Hardeman County Sheriff's Department, the Hardeman County Commission, and Mayor Jimmy Sain, saying overtime pay was due employees Patrick D. Perry, Justin Bryant, Thomas Cody Naylor, Cheri Baker, Chris Wilkerson, Michael Hatch, and Ethan Vasquez for work performed for the Hardeman County Sheriff's Department.

Promises, Promises

Last week's edition of the *Bolivar Bulletin Times* said we would cover the county answer to *John Doolen vs. Jimmy Sain*, filed July 16.

We'll see about it next week. The issue in this story was deemed more important at press time. We apologize.

"The deputies pay rate changes with each check," said Doolen. "Instead of an hourly rate, they put them on salary rate when it works to their advantage."

At the center of the issue, says Doolen, is the 43-hour work week deputies work, versus 40 hours before overtime kicks in on what the sheriff contends becomes an hourly rate. By law deputies fall under the 43-hour work week before overtime kicks in.

"The county is saying they are salaried employees, but then calculate their pay hourly based on a 43-hour week instead of a 40-hour

a week job," he explained.

A deputy making \$30,000 a year on a 40 hour week works out to \$14.42 an hour versus the \$13.41 they collect by the county calling it a 43 hour work week, explained Doolen.

And to call it a salary is somewhat misleading and one-sided, said Doolen, since their paycheck each pay period depends on their hours worked.

"We don't have the power to calculate hours paid," he added. "We can only send up the hours worked."

Last week, the answer filed on behalf of the county by W. Carl Spining and Michael T. Schmitt of Ortale Kelley Law Firm in Nashville, contends no county agency has reason to answer the suit, stating that the only defendant that can legally be sued is Sheriff John Doolen, as an individual and contends that since Sheriff Doolen as an individual is not named as a defendant in the suit, it should be dismissed.

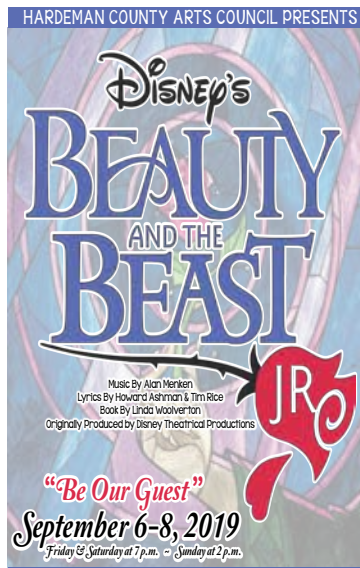
A Match Made at the Box Office

Community Health Center Gets Grant

The U.S. Department of Health and Human Services (HHS) announced \$1,998,370 in Quality Improvement Awards to 23 health centers in Tennessee, including \$46,000 for the Hardeman County Community Health Center for advancing health information technology and patient centered medical home recognition.

"President Trump's vision for healthcare aims to deliver Americans better value from the care they receive and, ultimately, better health. Community health centers have consistently delivered these kinds of results, including high-quality primary care at a significantly lower cost than their peers and above-average results in controlling chronic conditions," said HHS Secretary Alex Azar. "This week's awards recognize especially high-achieving health centers. America's health centers are essential to producing results on our actionable public health challenges, like HIV/AIDS and the opioid crisis, as well as to building a healthcare system that delivers better value and puts the patient at the center."

By providing patients access to high quality, value-based care, health centers are uniquely positioned to meet the nation's most pressing health care needs, as well as emerging health priorities. HRSA-funded health centers are the first line of care in combatting the nation's opioid crisis. 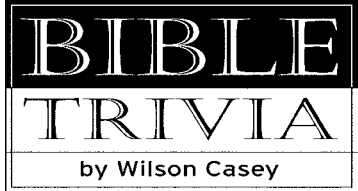

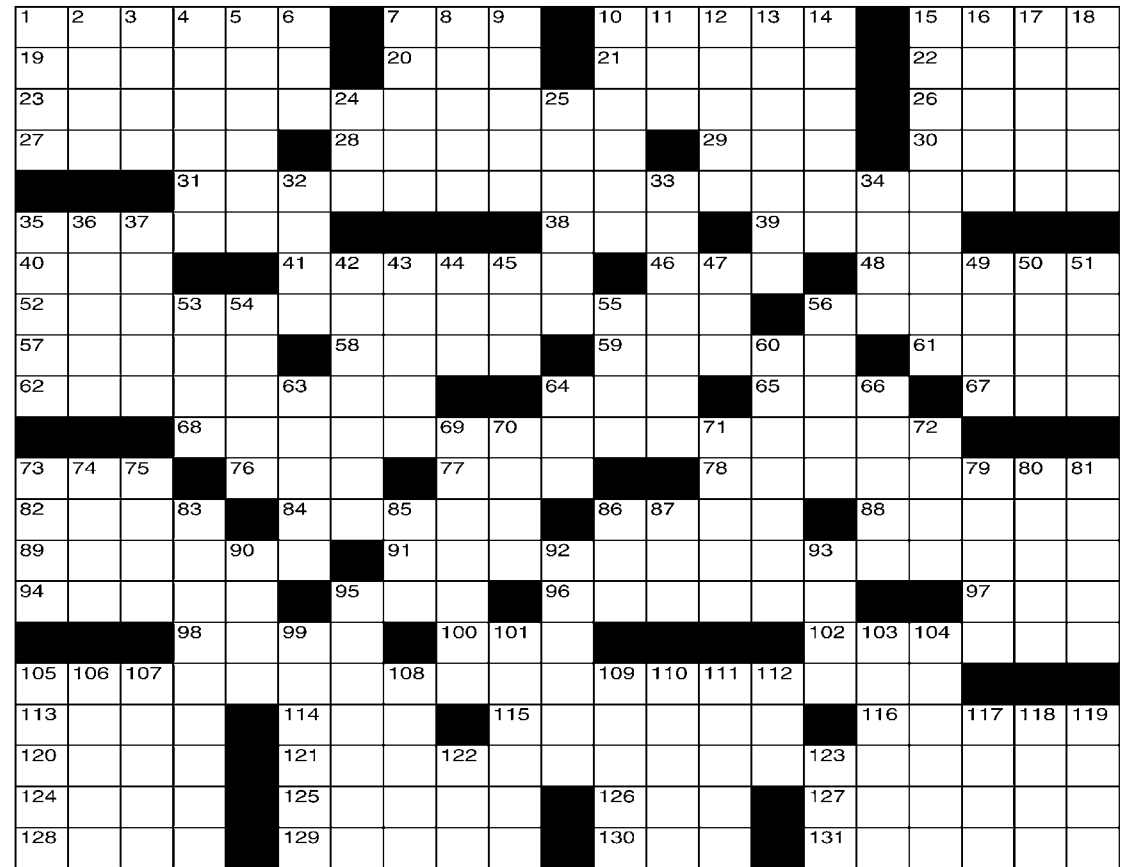

Leaving Your Job? What Happens to Your 401(k)?
If you're in the early stages of your working life – or even in the not-so-early ones – the chances are pretty good that you will change jobs at some point. When that happens, you'll probably leave a few things behind – but will one of them be your 401(k)?
Of course, you wouldn't really forget about your 401(k). (It does happen, however – over the period from 2004 through 2013, more than 25 million people left at least one 401(k) or similar plan behind when they left their job, according to the U.S. Government Accountability Office.) But you will have to do something with your account.
Essentially, you have four choices:
You can cash out your 401(k). It's your money, but if you take it out before you reach 59 ½, you will owe federal income taxes, plus any applicable state and local taxes.
Also, you will likely be charged a 10% penalty for early withdrawal. Perhaps even more important, if you liquidate your 401(k) when you change jobs, you'll be reducing the amount you'll have left for retirement.
You can leave your 401(k) with your old employer. If your former employer permits it, you can leave your 401(k) intact, even after you move to a different job. This might be appealing to you if you like the investment choices in your account, but you won't be able to make any new contributions. Plus, you won't face any immediate tax consequences.
You can move the money to your new employer's 401(k). You can consolidate your old 401(k) with one offered by your new employer, if allowed. You won't take a tax hit, and you might like your new plan's investment options. And you may find it easier to manage your funds if they're all held in one place.
You can roll your 401(k) into an IRA. You don't need the permission from any employer – old or new – to move your old 401(k) to an IRA. Your money will continue to grow on a tax-deferred basis, and an IRA offers you a virtually unlimited array of investment options – stocks, bonds, mutual funds and so on. You can make either a direct or indirect rollover. With a direct rollover, the administrator of your old 401(k) sends your money directly to the financial provider that holds your rollover IRA. No tax is withheld because you never actually take possession of the money. With an indirect rollover, you're technically withdrawing the money and moving it to the IRA provider yourself. (You've got 60 days to make this transfer.) You will face a withholding of 20% of your account's assets, but you may be able to recover most of this amount when you file your tax return. Still, for the sake of ease of movement and avoidance of all tax issues, a direct rollover may be more advantageous.
Which of these options is right for you? There's no one "right" answer for everyone. You'll have to consider several factors, and you'll certainly want to consult your tax professional before making any decision. But in any case, do whatever you can to preserve – and hopefully grow – your 401(k) assets. You'll need these resources to help fund the retirement lifestyle you want and deserve.

FAITH

Grace, Part 4 by Jeff Capshaw

This series started with three installments oriented toward the topic of grace. Last week's column began considering selected New Testament passages featuring grace, and that will be the course from now on.

In a nutshell, last week's article centered upon Paul's teaching about sin, the Law, the need for justification and the grace God gives to put sinners in the right standing with himself. Mankind in his natural state is sinful and is, therefore, under condemnation by the Law of God. That Law cannot justify sinners; it was never intended for that. Only God himself can declare sinners righteous in his sight.

How does God do that? He puts sinners right with himself on the merits of Christ's perfect obedience to the Law on sinners' behalf. Moreover, that righteous reckoning is brought about because of Christ's paying the full penalty for mankind's sin by dying on the cross in their place. That pretty much sums-up the teaching of Romans 1-5.

by Paul writes in Romans 5:1, "Therefore, since we have been

justified by faith, we have peace with God through our Lord Jesus Christ." Often overlooked, however, is what he says in 5:2 about grace. "Through him we have also obtained access by faith into this grace in which we stand . . ."

Notice that sinners put into the right standing with God (justified) are now in a position of "peace with God." That means there is the absence of hostility or enmity with God. Things are put to the rights between God and sinners for whomever believes in the Gospel. Not only is faith the way God considers sinners righteous, but faith in Christ also puts sinners in the permanent position or standing of "in grace".

Suppose a person secures a loan with a bank. As long as the note isn't paid off, then that person is in the "standing-of-debt." However, once the loan is paid off, then that person is in the standing of "paid-in-full." It is similar between God and sinners. Either they are in the standing of hostility or in the standing of peace with God by grace. There is no middle ground.

of grace in the remainder of Romans 5. Verse 15 says, the free gift of grace abounds to many sinners. Verse 17 says that through Jesus Christ, "the abundance of grace and the free gift of righteousness reign in life. . ."

To conclude chapter 5, Paul writes, "Now the law came in to increase the trespass, but where sin increased, grace abounded all the more, so that, as sin reigned in death, grace also might reign through righteousness leading to eternal life through Jesus Christ our Lord" (5:20-21).

Think about it this way. Our sin--though offensive to God and horrible--is a like a dripping water faucet. God's grace is like the Niagara Falls. Receive and rest in God's grace. From beginning to end, the Gospel is all about God's grace. That is why it is Good News!

Elizabeth enjoyed entertaining in her home, hosting many a spirited "Bid Whiz" card party, and serving you a steaming hot cup of very strong coffee! Her family and friends were extremely important to her. She was always a source of laughter, unwavering support, and wise advice.

Beyond creating a loving and happy home, Elizabeth was a working woman. She worked at the distinguished Blacks department store as an elevator operator. Later she was trained as an automatic spot welder for Waterloo Industries before retiring in 1991.

Truly a non-traditional career for women, she worked at Waterloo Industries for more than 25 years. You would recognize the quality of her workmanship in the infamous red Sears Toolboxes, her primary assignment. Elizabeth loved the outdoors and going fishing; she kept a beautiful manicured lawn and grew a bountiful garden.

Elizabeth had a special heart for caring for others. She cared for her ailing mother-in-law Tommie Lee and her sweet Aunt Carrie Horton, and her special friend, Willie Roby. She most recently found joy in taking her dear friend, Tillie Smith, to doctor's appointments and taking over food and meals until she could no longer drive. It's only when she herself became sick and could no longer help others, that she stopped caregiving. Not only did she have a caring heart, but she literally gave one of her kidneys to her brother, Louis Edward McTizic in 1978. Louis was the longest living kidney dialysis recipient at the time before he passed. Elizabeth herself lived another 40-plus years with just one kidney!

Elizabeth was not one to mince words. She spoke candidly and directly valuing honesty and the sometimes "hard truth" most people find difficult to face. But in the end, she was usually right on point with her advice and predictions, based on experience. 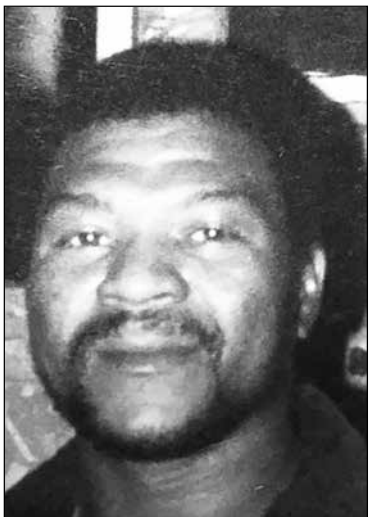

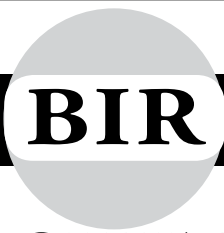

Bring Butterflies Back to Tennessee Gardens by Carolyn Tomlin

Driving down an off-the-beaten path in west Tennessee, a driver swirled and stopped immediately in front of me. After hitting my brakes, I realized it was my fault. I should have read her bumper sticker which stated: I BRAKE FOR BUTTERFLIES.



Ranging in colors from yellow, black, blue, and shades in between, you see them on country roads—suburban gardens—to sunny nature centers. Driving on the back-roads, butterflies (Lepidoptera) flutter above Queen Anne's Lace, Black-Eyed Susan and Purple Cone Flowers that grow along the roadside. Regardless of how often they appear, one never tires of their beauty. These marvels of nature fly by day and rest with their wings erect.

The ideal way to attract butterflies is for gardeners to provide both host and nectar plants. For example, Monarchs need milkweeds (any plant in the genus *Asclepias*), but every butterfly species has a plant or group of plants that it specifically needs for its caterpillars to eat. Zebra Swallowtails only lay their eggs on Paw Paw trees. Gulf Fritillaries prefer Passion Vine. Long-tailed Skippers choose native Wisteria and other bean family relatives."

The primary host plant for the Monarch is the Common Milkweed. If this plant does not die back in winter, cut back to the roots. Otherwise, the plant carries a disease than can harm Monarchs. New growth is excellent food for the Monarchs. With the overuse of chemicals and the milkweed that may produce a disease, the Monarch needs our help.

Nectar plants that grow well in the state include those above and native Honeysuckle, milkweed, Dwarf innia, Lantana, Mexican sunflower, Blazing star, Joe-pye-weed, and Phlox.

Often wildlife enthusiasts ask: How do I find out the best host and nectar plants that attract butterflies? Start with your local Extension System, websites for butterflies and local clubs or interest groups who focus on botany, wildflowers, butterfly gardening, or other nature-related clubs.

Aside from providing host and nectar producing plants, there are additional concerns Tennessee gardeners can control. Place saucers of moist sand or clean water daily around your plants. Smooth rocks or stone also provide a warm resting place." Any ideas for over-ripe fruit? Instead of discarding, slice bananas or apples and offer these tidbits for munching. Butterflies not only receive moisture, but the fruit provides energy.

A common problem affecting butterflies and non-harmful pests are chemicals and pesticides used to control weeds and insects. Use full-strength white vinegar to manage grass and weeds near nectar producing flowers. This will not eradicate tough foliage, but will help control without the use of dangerous ingredients.
