Sain Wins Second Term

Hardeman County Mayor Jimmy Sain got a second term on August 2, winning 49.9% of the vote, defeating Kandy Shackelford (35%) and Calvin Howell (15%). A total of 5,806 voted in the election, with 5,568 voting in the mayor's race.

Sain won 12 of 13 precincts, falling only in Lacy, where Shackelford was victorious.

"We've got a lot to do," said Sain. "And I'm hoping we can work together to get it done."

While the county got continuity at the top, the county commission changed a bit with five new members winning competitive races and with five republican candidates winning seats, four more than in 2014. The commission will have five republicans, six democrats, and five independents when they meet for the first time in September. Complete unofficial election results are on A10.



Doolen Re-Elected County Sheriff



Incumbent Sheriff John Doolen won his third term gaining 45% of the vote in defeating Bolivar Police Chief Pat Baker (34%) and Toone Police Chief Jerry Siler (21%) in a three-way race. Doolen won seven of the 13 precincts and early voting by more than 300 votes.

Baker took West Bolivar, Bolivar, Saulsbury, Hornsby, and Dixie Hills, while Siler took Toone and Silerton.

Swift and Davis Win Open Races

Two of the four county-wide offices went to newcomers as Casey Swift (top photo) and Billy Davis (bottom photo) won races over challengers in open races.

Swift, who worked for Superintendent of Roads David Sipes, beat Eddie Vandiver, winning 67% of the vote. Earlier in the year, Swift defeated Dale Dixon in the Democratic Primary.

Davis, who had the endorsement of Linda Fulghum, who served as Circuit Court Clerk for fifty years, defeated Taylor Sain and Tonya Perry in the general election. Davis too 46% of the vote, while Sain got 40%. Perry, who ran as a write-in, got 14%.

Celebrating Farmers Market Week



Tennessee's farmers markets create an economic and social bridge between the state's rural communities and its major population centers. There are many ways for you to celebrate this vital role during National Farmers Market Week August 5-11.

With 168 farmers markets listed on the Pick Tennessee website and mobile app, it is easy to find fresh foods and goods near you. Many markets will recognize the week with extra vendors, special guests and activities, food demonstrations, and even live music.

According to the United States Department of Agriculture (USDA), people who shop at farmers markets eat more fruits and vegetables and proximity to a farmers market is associated with a lower body mass index.

Significant economic benefits also reach to our most rural areas. Markets serve as incubators for small food and farm product businesses, giving rural entrepreneurs a platform to improve their products and business decision-making. The average American farmer receives about 90 cents for every dollar spent on food purchased at a farmers market. In an industry where the average farmer's age is over 60, 16 percent of all farmers market farmers are under 35.

Pick Tennessee is a free service of the Tennessee Department of Agriculture that connects consumers with Tennessee farmers, farmers markets, farm products, and activities, plus food and farm related products made in Tennessee.

The Tennessee's farmers markets directory can be accessed at www.PickTNProducts.org and via the Pick TN mobile app. Follow Pick Tennessee on social media for seasonal updates and information about farm related events, activities, and products.

The Bolivar Farmers Market began in 2008, as part of the Bolivar Downtown Development Corporation's (DEVCO) Revitalization program. See photo above. Bolivar's market is open each Tuesday and Saturday beginning at 7:30 a.m.

The Town of Grand Junction operates a Farmers Market on Fridays from 3:00-6:00 p.m. at the Old Cotton Gin on Highway 57.

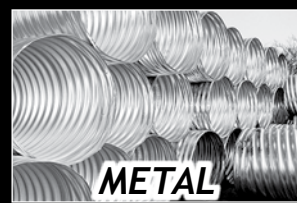

Tomato Pizza Rolls

Ingredients

- 2 cups warm water (105 degrees to 115 degrees F)
- 2 package active dry yeast
- 6 cups bread or all-purpose flour
- 2 1/2 teaspoons fine sea salt
- 1 large clove garlic
- 3 cups cherry tomatoes, halved and/or quartered
- 1/2 cup finely shredded Parmesan cheese
- 1/4 cup extra-virgin olive oil
- 1 teaspoon finely shredded lemon peel
- 1/2 teaspoon finely ground black pepper
- 2 – 4 ounces thinly sliced prosciutto o or bacon
- 1 cup basil leaves or 1 tsp dried basil
- olive oil

Directions

In a large bowl combine the warm water and yeast; let stand for 5 minutes. Add flour and 2 teaspoons salt, stir to combine. Turn out onto a lightly floured surface. Knead 6 to 8 minutes to make a moderately stiff dough that is smooth and elastic. Shape dough into a ball. Place in a lightly greased bowl; turn once to stiff surface of dough. Cover with a kitchen towel. Let rise at warm room temperature 1 to 2 hours, until doubled in size.

For sauce, while dough is rising, mince and mash garlic with a large pinch of salt to make a paste. In a bowl stir together garlic paste, tomatoes, Parmesan, 1/4 cup oil, lemon peel, pepper, and remaining 1/2 teaspoon salt.

Position racks in the upper and lower thirds of an oven. Preheat oven to 425 degrees F.

Place dough on a well-floured work surface. Stretch or roll dough to a 22 x 14-inch rectangle. Scatter prosciutto and basil leaves on dough. Place tomato sauce along the lengthwise center of dough. Fold lower third of dough over tomato sauce, then fold over upper third of dough. Cut dough crosswise in 10 pieces. Transfer rolls, cut sides up, to two baking sheets, spacing about 2 inches apart. Gently press dough to expose some filling.

Bake rolls 25 to 30 minutes, rotating baking sheets between racks midway through baking time, until crusts are golden and hollow sounding. To serve, drizzle rolls with olive oil and sprinkle with snipped fresh basil.

Defending the Faith: Part 4 by Jeff Capshaw

Insistence on the supremacy of Scripture in the believer's life is a constant refrain in this space. The Bible is also indispensable for those defending the Christian faith. However, it is only the Gospel that can bring unbelievers to true Christian belief. Yet believers may be encouraged, and unbelievers helped toward faith by Christian Apologetics.

Throughout Church History, numerous threats have also faced believers. For example, the Apostle Peter warned the Early Church: "but there were also false prophets among the people, just as there will be false teachers among you. They will secretly introduce destructive heresies, even denying the sovereign Lord who bought them—bringing swift destruction on themselves" (2 Pet. 2:1, NIV). Peter urges combining growth in grace, godly character and right doctrine as the antidote against lying teachers and scoffers.

But just as there have been numerous threats, so also Christians have adopted various methods for defending the faith. In this and upcoming articles, I will enumerate and briefly describe several well-known methods of Christian Apologetics. Readers are encouraged to look (as I have) at the excellent book edited by Steve Cowan: Five Views on Apologetics, Grand Rapids: 2000.

First is Classical Apologetics, because it was the method first adopted by Christian thinkers who applied reason to the defense of Christianity (N. Geisler, ed. The Baker Encyclopedia of Christian Apologetics, p. 154). Among other early adopters of this defense strategy are Justin Martyr, Tertullian, St. Augustine and St. Thomas Aquinas.

More contemporary examples include those with whom Christians are probably more familiar: William Paley, John Locke, C.S. Lewis, B.B. Warfield, John Gerstner, R.C. Sproul, William L. Craig, J.P. Moreland and Norman Geisler. Although Christians differ on the value of the Classical method, Christians will be helped by any of these thinkers.

Classical Apologetics (CA) is best known for providing rational arguments for the existence of God (i.e. The Cosmological, Teleological, Moral and Ontological arguments). CA is known also for providing historical evidence for supporting the truth claims of Christianity.

The success or helpfulness of any apologetic method is like beauty; it is in the "eye-of-the-beholder." If reasons to believe help someone, then it does no harm to provide reasons to believe. If evidence is needed, then there is no harm in providing evidence supporting Christianity. As with all theories and methods, however, each has its own strengths and weaknesses and will be more helpful to some than others.

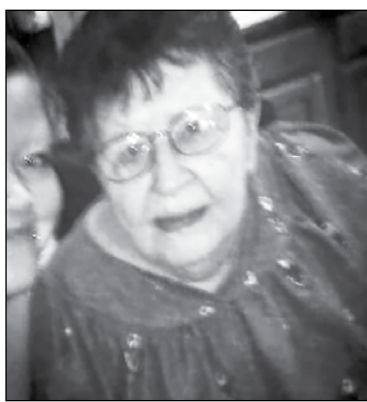

How Can You Help Your Kids Pay for College?

It's still summer, but we're getting close to a new school year. One day, though, "back-to-school" will mean "off to college" for your children. Will you be financially prepared to help your kids cope with the costs of higher education?

Your first step, of course, is to know what you're up against, so here are some numbers: For the 2017-18 academic year, college costs (tuition, fees, room and board) were, on average, nearly \$21,000 for in-state students at four-year, public schools and nearly \$47,000 for students attending private colleges or universities, according to the College Board. And you can probably expect even bigger price tags in the years to come.

To help prepare for these costs, you might want to consider putting your money in a vehicle specifically designed to help build assets for college, such as a 529 education savings plan. All withdrawals from 529 plans are free from federal income taxes as long as the beneficiary you've named uses the money for qualified college, trade school or graduate school expenses. Withdrawals for expenses other than qualified education expenditures may be subject to federal, state and penalty taxes on the earnings portion of your plan. (However, tax issues for 529 savings plans can be complex, so please consult your tax advisor before investing.)

You can generally invest in the 529 savings plan offered by any state, but if you invest in your own state's plan, you may be able to claim a tax deduction or receive a tax credit.

By starting your 529 plan early, when your children are just a few years old, the investments within the plan have more time for potential growth. Plus, you can make smaller contributions each year, rather than come up with big lump sums later on.

A 529 plan is not the only education-savings tool you can use, but it has proven effective for many people. Yet you may also want to consider ways to keep college costs down in the first place.

For one thing, your children may be eligible for various forms of financial aid. Some types of aid depend on your family's income, but others, such as merit-based scholarships, are open to everyone. But you don't have to wait until you get an offer from a school's financial aid office - you can explore some opportunities on your own. For example, many local and national civic and religious groups offer scholarships to promising young people, and your own employer may even provide some types of grants or assistance. Plus, your state also may offer other benefits, such as financial aid or scholarship funds. It can certainly take some digging to find these funding sources, but the effort can be worthwhile.

Here's another option for reducing college costs: Consider sending your child to a local community college for two years to get many of the "general" requirements out of the way before transferring to a four-year school for a bachelor's degree. Community colleges are typically quite affordable, and many of them offer high-quality programs.

A college degree is costly, but many people feel it's still a great investment in their children's future. And by taking the appropriate steps, you can help launch that investment.

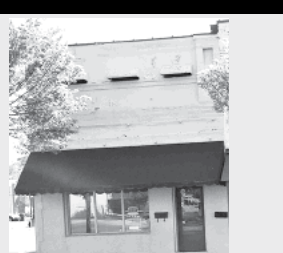

Tree Care in Summer is Important

Care for young trees during the summer, and they'll grow up to offer you protection from the sun for years to come.

As the fiercest weeks of summer continue, lawns filled with valuable trees and other perennial plants are at risk from scorching heat and, sometimes, limited rain. Commit to a watering plan to help protect your valuable trees, shrubs, and other plants to minimize damage. Young trees and plants that are new to the landscape will be those most in need of help through the summer.

The amount of water to give a tree depends on soil type, recent weather conditions, the age and type of tree, and nearby vegetation that could compete for that moisture. Intense heat during the summer can cause water to evaporate before it reaches deep roots. The ideal time to water trees and other perennial plants is in the morning when temperatures are cooler.

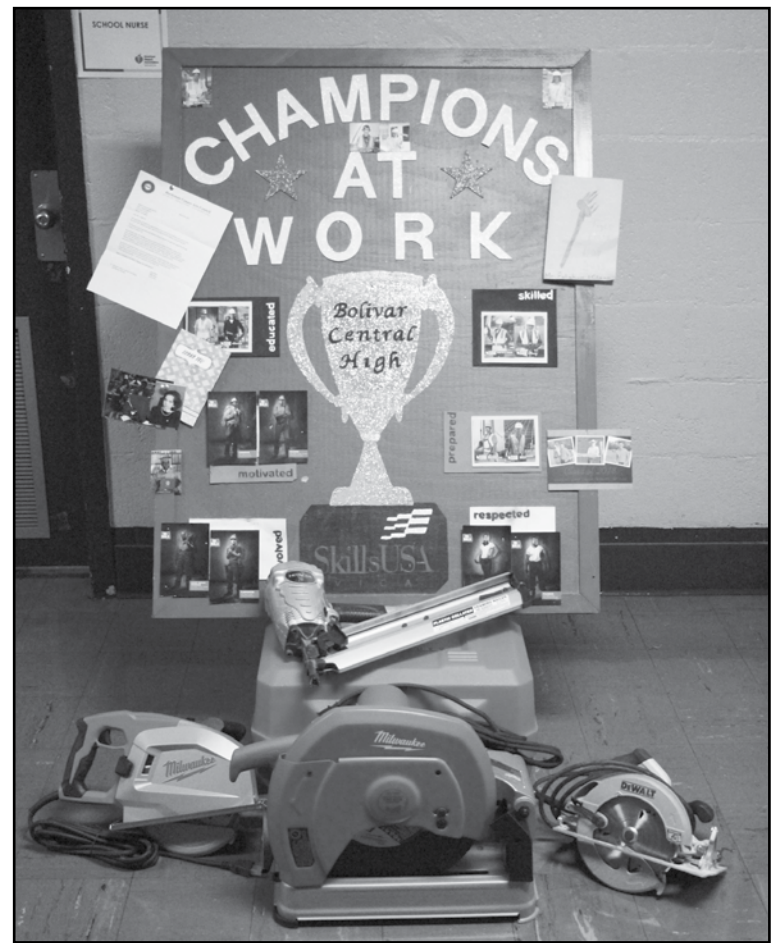
Ideally, water should be delivered slowly and at a steady rate, allowing water to be absorbed into the root zone rather than lost as surface runoff on compacted soils. An easy and affordable way to slowly water a tree is to fill a cleaned milk jug with water and poke a hole in the top and bottom so that the water can drip out of the container. This allows a steady release of water into the soil to be taken up by the roots.

Thoroughly water perennials periodically rather than giving them a little water every day. Offering smaller amounts of water daily causes plant roots to search upwards toward the limited water supply. Inadequate daily watering fosters shallow root systems and makes some plants susceptible to root rot. Pests can also be a threat when plants and trees are weakened by heat and inadequate water.

The Tennessee Department of Agriculture Division of Forestry offers a number of services to provide technical assistance and help municipalities establish self-sustaining urban forestry programs. SCHOOL HEALTH CLINIC



In an effort to keep students healthy and in school, HARDEMAN COUNTY SCHOOL SYSTEM and HARDEMAN COUNTY COMMUNITY HEALTH CENTER have partnered to provide a School Health Clinic to Hardeman County Schools. The goal of the School Health Clinic is to promote, protect, and maintain the overall health of school students and employees of the school system. Our number one goal is to help the children stay healthy and in class. It is our mission to promote quality healthcare in partnership with the patient's regular healthcare provider.

The School Health Clinic will treat a wide array of conditions such as common cold, cough, sore throat, earache, rashes, flu and flu-like symptoms; provide sports physicals and well-child exams; treat minor injuries and many other illnesses that can be visualized.

How can my child be seen at the clinic? In order for a child to be seen, a Parent/Guardian must sign a consent form. Students may be referred by the school nurse during the school day; other appointments can be made by calling the School Health Clinic directly at (731) 658-2902.

Who can be seen at the School Health Clinic? Students and employees of the Hardeman County School System can be seen at the School Health Clinic. Medical Insurance will be verified by School Health Clinic staff and billed by Hardeman County Community Health Center. If any Hardeman County School System student or employee does not have medical insurance, he/she may be eligible for and encouraged to apply for the Sliding Fee Discount Scale. Parents/Guardians or employees will receive a bill from Hardeman County Community Health Center for any amounts due.

Will transportation to the clinic be provided? No. Parents/Guardians will be responsible for providing transportation to and from the School Health Clinic location. In the future, students and employees of the Hardeman County School System will be able to be seen by telehealth at the school where they attend or are employed.

Where will the clinic be located? The clinic is located in Bolivar Elementary School which is at 445 Nuckolls Rd. Bolivar TN. 38008.

The School Health Clinic will open on August 8, 2018 and will be opened each school day from 8 am to 4 pm.
