Locals Build EMS Facility

Using local contractors and labor, the Hardeman County Emergency Medical Services got a new base of operations that opened last week.

"I'm ecstatic to be able to save the citizens money and provide such an awesome facility for our county," said Hardeman County Mayor Jimmy Sain.

The 22,400 square foot facility, built at a cost of approximately \$980,000 (according to Sain), used local contractors Donnie Spence Construction, Ethan Vickers Concrete, Ayers Electrical and Plumbing, Henderson Heating and Air, Grantham's Overhead Door/Insulation, and Shaw Trucking to complete the job, said Sain.

The building is rated as a Life Safety Category 4 Fire Rating, which equals any medical facility, 10 bays for EMS, four bays for the



Bolivar Fire Station, and full living quarters on both sides. The EMS facility has a 50-seat

training room and an emergency backup generator system. The building has been appraised

City Agrees to Purchase Sand Pit



The City of Bolivar passed a resolution by a 7-0 margin on December 10 to go forward with the purchase of the "Sand Pit" lake in East Bolivar with plans to create a recreation destination for the area.

The purchase of approximately 122 acres, with funds from the scaled-down Hatchie River Project at the former location of the Boat Dock on Highway 18 North, it will include the lake and area surrounding it on all sides.

Bolivar Mayor Julian McTizic hopes for the lake and surrounding area to attract tourism.

"We think it will be a very nice setting for families and groups to come visit," he said. "It's very much a place someone could use as a retreat to nature."

Councilwoman Tracy Byrum was not present for the meeting.

Luez Says Thanks Before Grand Opening

The Bolivar Downtown Development Corporation and the Luez Theatre Committee hosted contributors to the Luez Theatre project in Bolivar that redesigned the circa 1948 theatre.

The theatre will have their grand opening December 14, with plans to run movies four days a week, beginning with *The Grinch* (see back page for advertisement).

The Luez has new seats, a stage to accommodate musical acts, and a section upstairs that will be accessed for an upcharge. Future plans include wine and beer offered upstairs only, with seating restricted to those 21 and older.

Ticket prices are expected to be set at \$6 for children and seniors, \$8 for adults and \$15 for the upstairs seating.

Purchased by the Bolivar Downtown Development Corporation in 2013, the theatre has hosted a half-dozen events.

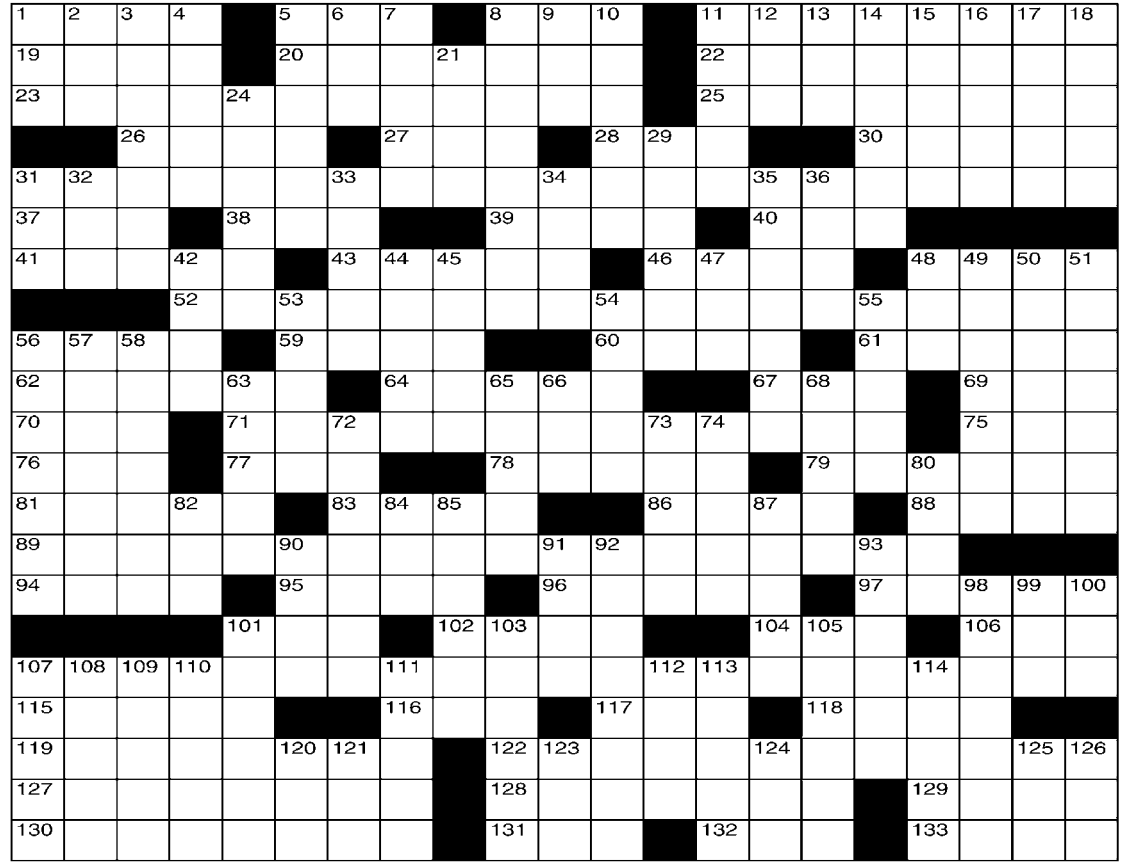

- 36 pretzel twists
- 36 semisweet chocolate mini morsels
- 18 red cinnamon candies

- Step 1 Freeze dough 15 minutes.

- Step 4 Bake at 350° according to package directions or until lightly browned. Remove from oven; press in 2 chocolate mini morsels for eyes and 1 red cinnamon candy for nose. Let cool 1 minute on baking sheets. Remove to wire racks; cool 20 minutes or until completely cool.
- Step 5 Christmas Tree Sugar Cookies: Omit pretzels, chocolate mini morsels, and cinnamon candies. Freeze dough 15 minutes. Roll dough to a 1/4-inch thickness on a floured surface, and cut with a 3-inch Christmas tree-shaped cookie cutter. Place 2 inches apart on ungreased baking sheets. Bake at 350° according to package directions or until lightly browned. Remove from oven, and cool as directed. Frost tops of cookies with ready-to-spread vanilla frosting, and sprinkle with red and green colored sugars and sprinkles.

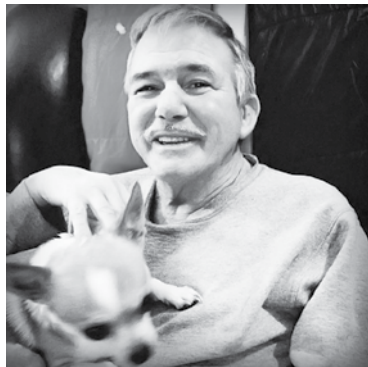

Rejoice! by Jeff Capshaw

Last week I touched on a couple of topics related to Church tradition by mentioning briefly the Church calendar and lectionary. The lectionary contains a collection of scripture readings appointed for Christian worship on a given day or occasion. Some Christian traditions use these aids regularly as an integral part of their worship. Others utilize them during the most significant Christian Holidays.

For example, this Sunday's (December 16) Epistolary reading is Philippians 4:4-7. Paul writes, *Rejoice in the Lord always; again I will say, Rejoice. Let your gentleness be known to everyone. The Lord is near. Do not worry about anything, but in everything by prayer and supplication with thanksgiving let your requests be made known to God. And the peace of God, which surpasses all understanding, will guard your hearts and your minds in Christ Jesus.*

This text embodies prominent

Advent themes. Certainly, it is a season for rejoicing, a season for thoughts of gentleness, especially pertaining to the "baby lying in the manger." Christmas is the season of longing for freedom from worry and for the peace of God to reign in our hearts. It is, moreover, a time for us to recommit to a humble reliance upon God, an attitude most clearly displayed in the spiritual practice of prayer.

Finally, the very last phrase, *Christ Jesus*, entails the long-awaited hope of Israel, the Messiah who is Jesus. It subtly reminds us of the Incarnation, that is God coming into time and space to be with us and for us humans as a human Himself.

I am reminded of a book written centuries ago by St. Anselm of Canterbury (1033/4-1109). The Latin title for his book is *Cur Deus Homo?* It usually is translated "Why God Became a Man." Hardly any question more deserves our pondering as we celebrate the stupendous, historical event to

Three Factors to Consider When Making Charitable Gifts

The holiday season is here, which means gift-giving is probably on your mind. In addition to making gifts to your family and friends, you also may be interested in contributing to charitable organizations. But before you donate financial assets, such as stocks, you will need to consider several factors, including taxes, your portfolio balance and the reputation of the charity. Let's look at these areas:

Taxes – Your donations to qualified charities (those that are considered 501(c)(3) organizations by the Internal Revenue Service) can give you tax deductions – if you itemize deductions on your tax return. However, due to recent tax law changes, the standard deduction for 2018 has almost doubled, to \$24,000 for married couples, and to \$12,000 for single filers. As a result, you may be less likely to itemize deductions, so you could have less incentive, at least for tax reasons, to make charitable gifts. However, if you give appreciated stocks, you may be allowed a charitable deduction for the full fair market value of the gift on the date of the transfer, even if your original cost was only a fraction of today's value. Plus, you may not be subject to the capital gains tax you might have to pay if you eventually sold the stocks.

Also, depending on your age, you might be able to use your traditional IRA as a charitable-funding vehicle. Once you turn 70-1/2, you generally must begin taking withdrawals – called required minimum distributions or RMDs – from your traditional IRA. (Roth IRAs are not subject to RMDs during your lifetime.) These RMDs from your traditional IRA are taxable, but you may be able to exclude up to \$100,000 of RMDs per year from your taxable income if you transfer the funds directly to qualified charitable organizations.

In any case, consult with your tax advisor before donating appreciated assets to a charity.

Portfolio balance – When you donate financial assets to a charity, you are also taking them away from your portfolio. This could be an issue, especially if you repeatedly donate the same types of assets. For example, if you're donating some growth-oriented stocks, will you lower the overall growth potential of your portfolio?

You may want to consult with a financial professional to ensure your charitable gifts will still allow you to maintain a portfolio balance appropriate for your goals and risk tolerance.

Reputation of the charity – You may want to do some homework to make sure you are giving to a reputable charity. Many experts on charitable giving say that a worthwhile charity should spend at least 75 percent of its income on programs, rather than administrative costs. You may be able to find this type of information on a charitable group's annual report and its website. You can also browse the web for the names of agencies that evaluate charitable groups.

By considering the aspects of charitable giving described above, you can get more satisfaction from your generosity – because you'll know that your gift not only supports a good cause, but also fits well into your overall financial picture.

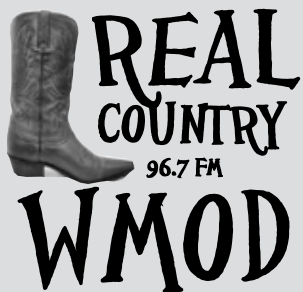
