So, I refused to drink it. I was called names commonly used to describe cowards in the 1970's by Dad, but I didn't care. I wasn't risking my life.

Clearly, there were opposing forces in my upbringing and attention to safety issues.

But I'm still here, so however they did it must have worked.

## Arrest Made in Stalking of Councilman

A Bolivar woman turned herself in to the Hardeman County Sheriff's Department on January 28, in response to a warrant issued for her arrest on January 26 on a charge of stalking Bolivar City Councilman Jonathan Joy.

Joy filed the complaint, saying Amelia Monroe Carlson followed him for a portion of the day on January 25, photographing him and his work truck on more than one occasion.

Prior to the arrest, Carlson had requested records on Joy, Bolivar City Councilman Melvin Golden and Bolivar Mayor Julian McTizic from the city and also requested employment records on Sergeant Gary McTizic from the Bolivar Police Department.

A later request made by Carlson asked for employment and law enforcement related records of Sergeant Chris Burkeen, Captain Shane Swift, Captain Jimmy

Fletcher, Captain Mike Jones, and Captain Eddie Henson.

Carlson also asked for the tag number and registration of Joy's vehicle from the Hardeman County Clerk's office, while identifying herself as working for a private investigator in Selmer.

When contacted, the investigator acknowledged Carlson worked for him, but denied she was working for him on any investigation of Bolivar City Officials or employees, and asked that his name and private investigation firm be withheld from any story related to the events leading to the stalking charge and arrest.

According to the Hardeman County Sheriff's Department report, an arrest warrant was issued on Friday, January 26 and numerous attempts were made to serve the warrant prior to Carlson turning herself in at 8:30 p.m. on January 28.

She was released at 8:30 a.m.

on January 29, on a \$2,500 bond. The charge of stalking (TCA 39-17-315) is a Class A Misdemeanor which carries a punishment of up to 11 months, 29 days in jail and a fine up to \$2,500. A court date of February 13, 2018 at 8:30 a.m. has been set.

## Republicans Add Six to Election

The Hardeman County Mayor's race gained one more as the Hardeman County Republican Party nominated Calvin Howell to run for the position at their caucus on January 29.

The Republicans said they plan to submit a letter to the Hardeman County Commission stating the results of their caucus and the candidates they plan to put forward in the six races this week.

Howell ran for Mayor in 2006, placing second to former Hardeman County Mayor Willie Spencer in a three-way race that also involved independent candidate Bobby Shelby.

Howell will challenge the winner of the Democratic Primary (at present time, only Jimmy Sain had pulled a petition to run in the Democratic Primary scheduled for May 1) and Hardeman County Chamber of Commerce Director Kandy Shackelford, who is running as an independent candidate.

Also tabbed by the party at the meeting on January 29 to run were incumbent Chris Bell from District 1, Position 1 and challengers Stan Doyle for District 2, Position 1, Bobby Hensley for District 4, Position 1, Justin Howell for District 5, Position 3, and Mark Gilliam for District 7, Position 2. Candidates chosen by the Republican Party will appear on the ballot for the County General Election in August.

By having a caucus, the Republican Party avoids having candidates pull petitions to run. Democratic and independent candidates must have petitions turned in to the Hardeman County Election Commission by February 15. Candidates will then have a week in order to withdraw their status as candidates.

The Hardeman County General Election is scheduled for August 2.

## Hardeman County Remembered by Lisa Coleman

Each day in the United States there are about 1.6 million people who live their lives with Rheumatoid Arthritis (RA); I am one of those people. So if you've ever wondered what someone with RA looks like, here I am.

I was diagnosed with RA when I was 17 years old and it was a native Hardeman Countian who made the diagnosis. Dr. Jerry Hornsby was my orthopedic doctor at the time and after running a few tests he told me that I have RA. Dr. Jerry also gave me some of the best advice ever about RA when he told me all those years ago that, "this will impact how you live your life, but it is important for you to do that - live your life, learn how to manage the illness, and don't let it manage you."

RA is actually a symptom of an Auto Immune Disease. The disease causes your body's immune system to attack healthy tissue and joints which leads to inflammation, swelling, and pain. Because this occurs without an injury or infection to the affected joints, it becomes part of the disease's process, leading to joint damage. Just recently I was asked how often I have pain with my RA; my answer is that I have pain every day, all day, all the time. Some days are worse than others, some days are not so bad. Through testing and evaluation, my doctors have determined that my "average daily pain threshold", on a scale of 1-10, is somewhere between a 6-7 each day. To me, RA is just part of who I am; I have brown hair, I like to read, I like photography, I love my family, friends, and my dachshund-girl Elsie; I have RA.

It was both a blessing and a burden to be given such a diagnosis when you are 17. I learned from a young age how to manage the disease, how to be active within the limitations of the disease, and to have a positive outlook in spite of the disease. The burden of it is that I have lived with this diagnosis, and will live with it, for all of



my life. I continue to be blessed with amazing physicians (my orthopedic doctor, Dr. Kelly Pucek, and my rheumatologist, Dr. David Boatright) who work with me to manage this disease and all of its quirks.

There is no cure for RA and its Autoimmune Disease, but in the last few years there have been more efforts to promote better understanding of the disease and how it affects those of us who live with it. February 2 is designated as "Bring RA Out of the Shadows Day" as a way to increase awareness of RA and how it affects lives of people you know. Punxsutawney Phil and his weather predictions can now share February 2 with those of us with RA.

I have RA, y'all, but I don't let it have me.

## Tales from the Yellow House

The Yellow House lacked many of the conveniences, or should I say any of them, that we seem to take for granted in this day and time. We had a couple of country conveniences for night time use only. We called the vessel a potty. There were several names for these buckets also. Some called them a Judy Pot; others a Slop Jar; and still others a Thunder Mug. Going to the pot at night was a luxury compared to high-tailing it out to the out-house at night when there was a foot of snow on the ground, or when it was raining cats and dogs (which, out of all the rains that I've seen in my life, I've never found any critters of the canine or feline family scattered about the yard after a shower). By the way, our pot was not a fancy one; it was an eight-pound lard bucket. The first one using it at night usually woke everyone up in the room from the loud pinging sound amplified by the tin bucket itself. You could always tell when the bucket was getting full by the sound. The fuller it got, the quieter the sound. I always dreaded going to the pot after hearing the quiet tones. That meant that I had to go outside and empty the contents, and that meant having to get warm all over again when I got back in bed.

I do believe that the winters at the Yellow House were colder than they are now. From November to about April, it always felt like there was nothing between us and the North Pole to protect us from

the wind but a barbed wire fence. When the winter weather drove us kids inside, we would entertain ourselves with games. Some which we made up, and some that were handed down through the ages. Some of them that we played, I cannot figure out why they were amusing, but anything out of the ordinary grind of daily life was amusing. Some of the games we played were; Old Granny Grunt; Aunt Mirarah Died; and My Ship's Coming In. We also played music. Mom played the fiddle and we always had an old Silvertone guitar around, that is until I bursted it on my Sisters head. It would still play though. My backside came out with the worse side of that episode. Even though we fought a lot, pity the person who tried to give either of us a bad time.

Love and sharing was part of the country ways. As we lived right beside the Southern Railway tracks, there was a constant flow of hobos that traveled the rails throughout the country. Seems like that every few days one would knock on the back door asking Mom if she could spare a bite to eat. She never refused any of them, even if most of the times she only had a cold biscuit and a drink from the well. One cold snowy night, there was a knock on the door. It was an elderly hobo, nearly frozen. Dad invited him inside and Mom fed him some left-overs from supper. He spread his ragged blanket in front of the fireplace and immediately went

to sleep. Dad slept in a chair that night while the hobo slept on the floor. I don't guess that Dad was taking any chances. He said that he couldn't let the man stay outside and freeze to death. The next morning after breakfast, a happy and thankful hobo said thanks and goodbye and was on his merry way to some unknown destination. He did give us kids a couple of red-lead pencils which to us was like someone giving us a new computer today. Our doors were never locked day or night. But two times a year, usually in the spring and fall, a hobo that we called Old Rusty would make his annual trek by our house. When we saw this particular hobo coming, we would run inside the house, turn the wooden latch on the door and peep from the curtains. Old Rusty as we called him, because he apparently had not taken a bath in years, was the spitting image of what we thought the booger man might look like. When us kids would act up, our parents would tell us that the booger man was going to get us, and I suppose we associated the Old Bugger with Old Rusty. As bad as we imagined Old Rusty to be, and as scared of him as we were, he never harmed anyone. And when he came to the back door, and said to Mom, "Lady could you spare a bite to eat?", Mom would cautiously hand him something through the crack in the screen door to eat. See you next week.

### BOLIVAR POLICE DEPARTMENT ANNOUNCES SAFE CAMPAIGN PARTICIPATION

The Bolivar Police Department is partnering with the Tennessee Highway Safety Office (THSO) for its fifth annual Seatbelts Are For Everyone (SAFE) campaign. This statewide initiative is designed to increase seatbelt usage and child passenger safety restraint usage through the implementation of occupant-protection programs, public events, and checkpoints throughout local communities across Tennessee. The SAFE campaign begins February 1, 2018, and concludes August 1, 2018.

"The Bolivar Police Department has participated in each S.A.F.E. campaign since the program's inception in 2013", said Bolivar Police Chief Pat Baker. he added, "Each year of our participation we have seen seatbelt usage increase not only in the City of Bolivar but throughout Hardeman County."

2018 will be the fifth year that the THSO has sponsored the SAFE campaign. Last year yielded the following results:

- 1,480 child restraint violations
- 16,571 seat belt citations
- 835 other seat belt enforcement activities

"In 2016, Tennessee's average seatbelt usage rate was 88.95 percent," said THSO Director Vic Donoho. "Last year, the state's usage rate decreased to 88.51 percent. Our goal this year is to achieve 100 percent seatbelt usage across Tennessee through the SAFE campaign and other occupant-protection initiatives."

In Tennessee, a disproportionate percentage of unrestrained fatalities tend to occur between the hours of 6:00 p.m. and 5:59 a.m. historically, approximately fifty percent of Tennessee's traffic fatalities are unbelted. That percentage increases to nearly sixty when nighttime crashes are examined. Therefore, participating agencies will focus special attention toward nighttime seatbelt enforcement during the SAFE campaign this year.

Recently I learned from interviews of Koreans what they thought of the death of a young pop star in their country who committed suicide. In the course of the interviews of the public, in addition to expressing concern for his life lost and the affect it may have on his fan base, five areas were identified by the public as to what they believed was behind his death and Korea holding the highest suicide rate for the last ten years throughout the world. ## The Nature of God's Silence #1

Back in the Reformation period of church history, there were two attitudes expressed by noted reformation leaders;

Martin Luther (1483-1546) took the attitude on God's silence that, "What is not against Scripture is for Scripture, and Scripture for it" (Newman 1902, 308) and Ulrich Zwingli (1484-1531) took the attitude on God's silence that what is, "not enjoined or taught in the New Testament should be unconditionally rejected" (Ibid., 308). Martin Luther's attitude allowed complete freedom to do anything not expressly prohibited in God's silence— while Ulrich Zwingli rejected or excluded anything not already expressed in the scriptures. The question comes, which is the proper attitude? Is God's silence permissive or prohibitive? Can we understand the nature of God's silence from God's word? There is certainly evidence in the examples of men carrying out the commands of God: Noah was told in Genesis 6:14-16, "Make for yourself an ark of gopher wood..." God specified the kind of wood to the exclusion of all other woods. Therefore, God did not have to say not to use poplar, cedar, maple or any other wood, God's silence itself prohibited them. Nadab and Abihu in Numbers 10:1-3, "...offered strange fire before the Lord, which He had not commanded them." The two priestly sons of Aaron, did not glorify God in offering a different fire than was commanded by God and died by fire from heaven (v. 2). God's silence on fires from a different source was not respected and we see clearly God's disapproval of their actions. King David in 2 Samuel 6:3, "They placed the ark of God on a new cart..." and "Uzzah put out his hand to the ark of God and took hold of it, for the oxen stumbled. Then the anger of the Lord was aroused against Uzzah, and God struck him there for his error; and he died there by the ark of God." (vs. 6-7) After that tragic event, David realized where they had gone wrong in 1 Chronicles 15:23, "Because you did not carry it at the first, the Lord our God made an outburst on us, for we did not seek Him according to the ordinance." Again, God prohibited the "new cart" that David devised to carry the ark.

## Lasagna Cups

- Ingredients:**
- 12 oz. raw extra-lean ground beef (4% fat or less)
  - 1/8 tsp. black pepper
  - 1/4 tsp. salt
  - 1 cup chopped onion
  - 1/2 cup chopped mushrooms
  - One 14.5-oz. can crushed tomatoes
  - 1/2 tsp. Italian seasoning
  - 1 1/2 tsp. chopped garlic
  - One 10-oz. package frozen chopped spinach, thawed and squeezed dry
  - 1 1/2 cups light/low-fat ricotta cheese
  - 1/4 cup (about 2 large) egg whites or fat-free liquid egg substitute
  - 1/8 tsp. ground nutmeg
  - 24 small square wonton wrappers (often stocked with the tofu in the refrigerated section of the supermarket)
  - 1 1/2 cups shredded part-skim mozzarella cheese

**Directions:**

Preheat oven to 375 degrees. Spray a 12-cup muffin pan with nonstick spray. Bring a large skillet sprayed with nonstick spray to medium-high heat. Add beef, pepper, and 1/8 tsp. salt. Cook and crumble until browned, about 3 minutes. Add onion and mushrooms. Cook, stir, and crumble until beef is fully cooked and veggies are soft, about 4 minutes. Add crushed tomatoes, Italian seasoning, and 1 tsp. garlic. Cook and stir until well mixed, about 1 minute. In a medium bowl, combine spinach, ricotta cheese, egg whites/substitute, nutmeg, remaining 1/8 tsp. salt, and remaining 1/2 tsp. garlic. Mix well. Press a wonton wrapper into the bottom and up along the sides of each cup of the pan. Evenly distribute half of the spinach-ricotta mixture among the cups (about 1 1/2 tbsp. each), and smooth out the surfaces. Top with half of the beef mixture (about 2 tbsp. each), and smooth out the surfaces. Top with half of the mozzarella cheese (1 tbsp. each). Place another wonton wrapper into each cup, lightly pressing it down and along the sides, letting the edges fall over the pan. Repeat layering with remaining spinach-ricotta mixture, beef mixture, and mozzarella cheese. Bake until spinach-ricotta mixture is hot, mozzarella has melted, and wrapper edges have browned, 10 - 12 minutes. MAKES 12 SERVINGS.



## What's the Investment Outlook for 2018?

By most measures, 2017 was a pretty good year for investors. But what can you expect in 2018?

It's difficult to precisely predict the immediate future of the financial markets. However, many signs point to improved global economic growth and rising corporate earnings – both of which are important drivers of stock prices. In the United States, economic growth may be more modest than in other regions, which could result in international stocks outperforming domestic ones.

Here's another consideration: Low interest rates typically benefit the financial markets – and unless inflation jumps sharply, the Federal Reserve will probably remain patient, only raising short-term rates slowly throughout 2018.

Despite these positive signs, there's also reason for caution. Political uncertainty and changes in economic policies may lead to increased market volatility. Another factor is the long-term history of the stock market, which includes a drop of 10% or more – technically called a "correction" – about once a year. We've gone two years since the last correction, so it would not be surprising if we saw one in 2018.

Given this outlook – which could be classified as "moderately optimistic" – what investment moves should you consider this year? Here are a few suggestions:

**Rebalance your portfolio** – The market's gains may have increased the value of your stocks so much that they now represent a greater percentage of your portfolio than you had intended – and you may not be comfortable with this increased presence.

**So, you may want to rebalance your portfolio** to achieve a suitable mix of stocks and bonds, based on your goals, risk tolerance and time horizon. As part of this rebalancing, and in an effort to help reduce the impact of market volatility, you may need to add investment-grade bonds and cash investments. (Of course, bonds carry some risks, too, including interest rate risk and credit risk.) The availability of cash will also make it easier for you to purchase stocks during a market downturn, when prices may be lower.

**Look beyond U.S. borders** – You may want to consider adding some international equity investments to your portfolio, if appropriate. As mentioned above, these stocks may do better than U.S. stocks in 2018, but regardless of performance, the presence of global stocks can help diversify your portfolio – and diversification can help decrease your overall risk level. (However, diversification can't guarantee profits or protect against all losses.) Keep in mind that international investing carries some inherent risks, such as those related to currency fluctuations and foreign political and economic events.

**Be aware of "big" versus "little"** – If you don't own many stocks of smaller companies, you might consider adding them to your portfolio. Smaller U.S. stocks have traditionally outperformed larger ones and may benefit from stronger economic growth and lower corporate tax rates. Be aware, though that small company stocks tend to be more volatile than those of larger companies. And, as with all stock investments, you may risk losing some or all of your principal.

**You may want to consult with a financial professional** to determine which of these moves, or any others, are right for you. You can't control the external factors affecting the financial markets, but you can take total charge of your own investment decisions – and in the long run, these decisions can help determine your success as an investor.





## OPINION

It appears, at least by some news sources, that the national economy is on the uptick. But how is our local economy doing? And how do we judge it? What information do we gather for planning and response - whether we find the local economy declining or growing? Unemployment rate seems a poor choice at local level. If someone moves out of the community for work - the local unemployment rate goes down but the income has moved - or migrated. What about economic migration as an indicator for economic wellness and planning? At the end of each year the IRS publishes income migration data for the prior calendar year. This information comes from our annual Federal Income Tax reporting. The income figure reported is Adjusted Gross Income (AGI). Migration, or lack of it, is based on the reported residence of income. The IRS reports this information at regional, state, and county levels. The IRS has been reporting this information since 1992. The IRS compliments the AGI data with population numbers from the United States Census Bureau. A Google search using keywords "income migration" will find this information at <https://www.irs.gov/statistics/soi-tax-stats-migration-data>. The Google search will also return various private websites that offer the information in more user friendly forms. One such site has an interactive map. What do the numbers say about our state? The answer is very good news. Tennessee is an income and population growth state ranking tenth in the nation in income growth. Since 1992 Tennessee has realized a net AGI gain of \$14.31 Billion and a population net gain of 368,788. Net gain meaning more income than outgoing. The gain would be significantly better if it were not for a large migration out of one Tennessee county into one Mississippi county. Large - as in HUGE! The AGI migration into Tennessee has come mostly from the states of California, Illinois, Michigan, Ohio, and New York - ranking in that order. Economically, Tennessee is healthy and vibrant - has been since 1992 - with no indications of slowing down. But what do the IRS numbers say about Hardeman County, Tennessee? The news is not good. Since 1992 Hardeman County has realized net loss of \$3.35 Million in AGI. Since 1985 Hardeman County has realized a net population loss of 792. If one digs into the data offered at <https://flows-mapper.geo.census.gov/map.html>, one will find that the Census Bureau population estimates for counties puts Hardeman with the greatest population loss of all 95 counties in Tennessee at a decline of 1812 residents. A close look at the numbers suggest the reasons for Hardeman County outgoing migration. It seems at least some of those things, giving reason for moving out of Hardeman County, are being worked on and that some progress is being made. But are there more immediate opportunities not being noticed and acted on? For example, one county in Tennessee stands head and shoulders above all for income and population moving into Hardeman County. Over \$28 Million in AGI has moved into Hardeman County from Shelby County. The next biggest AGI gain is from Tippah County, Mississippi at \$1.97 Million. If Hardeman County promoted itself to Shelby County residents is it possible the incoming AGI would be greater? Perhaps great enough to erase the negative net AGI migration? What about promoting Hardeman County to other states. Not all of them. Just the top five states where residents have moved to Tennessee. Those being California, Illinois, Michigan, Ohio, and New York. For example, the greatest AGI and population gains in Cumberland County, Tennessee have come from the states of Michigan, Florida, and Ohio. Is it possible that community leaders are more focused on long term solutions and overlooking the short term solutions? Or focused on iffy solutions and overlooking more promising? Or worse, more focused on gaining more revenue from the remaining residents of Hardeman County rather than acting and planning on reversing the exodus?


