This was the second Caesarean (I "helped" for Grace also) that I have witnessed and it pretty much went the same way the first one did...except that after it was all done he "tied the tubes."

He made a loop, tied the loop together about an inch before the curve, cut the tubes above the loop, *BURNED the free ends of the tubes* and then put them back where he got them from before doing the same to the other side.

But calling it "tying, cutting and burning the tubes" would probably be a needless use of words and gore. Hence, the abbreviated name, I suppose.

And even though it was eleven years ago, I remember it like it were yesterday.

BFD Awards Quick-Thinking Citizens

Three simple words can save lives during a fire: "Close the door!" Those words never had truer meaning for two residents in Bolivar than in the early morning hours of December 17, 2017, and January 2, 2018. On December 17, 2017, Mr. Robert Crisp was awakened at approximately 4:00 a.m., to fire in his home. Mr. Crisp ushered his family to safety and while exiting the house, he closed the door to the room that was on fire. "His actions in closing the door resulted in the fire being confined to one room," said Chief Price. On January 2, 2018, Ms. Frances Johnson received a phone call from her alarm company reporting a fire alarm in her laundry room. Upon checking the area, Ms. Johnson saw the fire, closed the door to the room, and exited the home immediately.

Chief Price praised Mr. Crisp and Ms. Johnson for their actions crediting them for saving their homes from devastating fire loss. On February 12, Chief Price presented Mr. Crisp and Ms. Johnson with a certificate of appreciation saluting them for their actions.

The first Pinewood Derby® was run in Southern California in 1953 by Cub Scout Pack 280C at the Manhattan Beach Scout House, where Cubmaster Don Murphy introduced the idea to his pack. The derby was publicized in Boys' Life magazine in October 1954 and was an instant hit. The rules set out for the very first race still stand today:

"The derby is run in heats – two to four cars starting by gravity from a standstill on a track and run down a ramp to a finish line unaided. The track is an inclined ramp with wood strips down the center to guide the cars."

Students Pledge to Drink More Water

February is Bringing Tap Back Month in Hardeman County Schools and hundreds of students and staff will pledge to drink more water and fewer sugary drinks putting them on a path to a healthier life.

The Tennessee Clean Water Network and Hardeman County School officials kicked off the Bringing Tap Back Month festivities by passing out free water bottles to the students at Whiteville Elementary School on February 13. The month-long Sodabriety kick off runs through March 16.

Refillable water bottles are being provided by Hardeman County Schools Coordinated School Health and will be distributed to all students and staff in Hardeman County Schools.

"We are very excited to kick off the Bringing Tap Back in Hardeman County," said Kimberly Pettigrew, Tennessee Clean Water Network's Director of Community Health Programs. "Tennessee Clean Water Network has installed 29 water bottle refill stations in the Hardeman County schools with grant funding from the Tennessee Department of Health's Project Diabetes Initiative. Mr. Randy Hill, Hardeman County Schools Maintenance Supervisor, provided additional funding for fountains and filters.

"It is important that students have easy access to clean, fresh water to overcome some concerns about drinking tap water. The Bringing Tap Back Project demonstrates the benefits of drinking more water and the resulting health benefits of reduced levels of obesity and diabetes in the community," Pettigrew added.

Joining Pettigrew at the kick off were Mr. Bobby Doyle, Deputy Director of Schools, Mrs. Lisa Raines, Hardeman County Schools Health Services Supervisor, Hardeman County School Board Members, and Whiteville Elementary Principal, Cedric Crisp. Also, part of the kick off were Hardeman County Schools employees who are spearheading the project in the county, Candice Gray, Coordinated School Health Coordinator and Randy Hill, Hardeman County Maintenance Supervisor.

Pettigrew said the Bringing Tap Back pledge is a simple and effective statement, "I will drink one less sugary drink a day for a month." To help the students keep their pledge, Pettigrew said the children in the lower school grades will learn the benefits of drinking water through daily announcements, infographics, and classroom activities.

"The high school students have developed what amounts to a school-wide marketing campaign to encourage peers to drink more water, and have really embraced the message," Pettigrew said.

According to Pettigrew 185 students and teachers signed the 30-day pledge.

Tennessee Clean Water Network's Bringing Tap Back Project has installed more than 227 water bottle refill stations in parks, schools and community centers across Tennessee. James and Jan Stack invited the seven Stack siblings and their spouses to their home on Saturday, February 3, for a sit-down dinner. They were excellent hosts and served delicious steak with several side selections. It was a most enjoyable night. Gwen Lindley, James' maternal aunt, was unable to attend.

Gilbert Lee and Frances Stack enjoyed several weeks in the Orlando/Kissimmee area enjoying warmer temperatures. They spent time walking around the community of Celebration, FL, a town built by Disney while Disneyland was being developed. This town was created to house those who worked for Disney. One evening, they attended the Al Capone Dinner Theater, a fun-filled event with buffet dinner and guest participation encouraged for the show. Several days, they enjoyed shopping. The Florida Mall, the largest mall in Florida, was especially welcoming with over 250 retail, dining and entertainment options. Another adventure they both enjoyed was Disney Springs, once known as Downtown Disney. It was an eclectic mix of unique shops, one-of-a-kind restaurants and lively entertainment.

During Valentine week of 2018, Anita (Pickett) Lambert agreed to share her story of meeting and falling in love with her husband, Larry. In 1966, Anita was at her grandmother's house and picked up the Chester County Independent and saw an article giving the addresses of two boys from Chester County who were in Vietnam. Anita said, "I thought it would be fun to write to a GI, so I copied down the addresses. The biggest problem was going to be getting money for stamps since we did not have a lot of extra in those days. I decided to eat only chips for lunch at school and use the rest to buy stamps. Larry and I wrote letters until he was discharged. We wrote about current events, our families, music and things we liked. In one of his letters he sent an application for a date with a GI. He kept asking me to send a picture. I finally scraped up money to send one. I guess I passed the test because when he got home he looked me up. At that time, we did not have a telephone, so he had quite an ordeal finding where I lived. Our first date was to the football game on October 3, 1968. We were married June 26, 1969. About 50 years later I can say we have learned the meaning of 'for better or worse, for richer or poorer, and in sickness or health'. God blessed us with two sons and two grandchildren. My advice to couples who ask is a quote from Mrs. Ruth Graham when she was asked if she ever thought about leaving Rev. Billy Graham and her reply was 'Leaving him, no. Killing him, yes'."

Jimmy Wade from Brighton, TN called to connect. Jimmy is now 79 years old and is disabled from an accident. He shared the story of driving a Trailways bus in the early 60's. In 1961, in Nashville, TN, he was the first employee to drive a bus carrying Freedom Fighters. He also shared that he dated Doris Butler from Silerton. He knew that Doris was my late sister-in-law. His parents owned and operated the Four Way Grocery and Florist on Hwy 100 in Henderson, TN. He remembered that the Stack brothers, sons of Alfred Stack, and Truett Siler often visited their store on Friday and Saturday nights just to hang out.

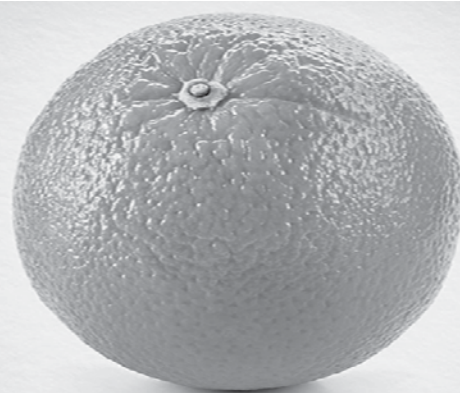

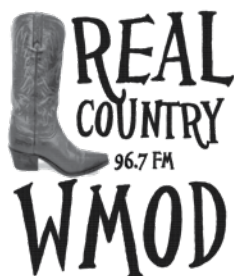

The Nature of God's Silence #3

Another aspect of our discussion of God's silence has to do with the matter of expediencies to carry out the commands of God. It is equally true that not all authority for what we do is specific, and God allows lawful expedients to help carry out the work we do for Christ's kingdom. When one takes the Lord's Supper on the first day of the week (I Cor. 11:23-29; Acts 20:7), there is the matter individual cups or trays being authorized generally to help facilitate that part of our worship. When we baptize someone, the baptism— even though not specifically mentioned in scripture— is a lawful expedient that aids the command of Mark 16:16 & Acts 2:38. When we sing praises to God in worship, one may use songbooks with musical notes & timing or use a powerpoint projector to aid in the same matter of "singing with grace in our hearts to the Lord." (Col. 3:16; Eph. 5:19) And what about the church building, rented hall, or some form of gathering place for the church to meet? Is it not the church acting lawfully in carrying out the command to assemble? (Heb. 10:25) After-all, These questions come up frequently in discussions like this on God's silence. What makes some alleged expediencies a violation and others lawful? It has to do with whether or not the expediency alters or changes the command to something different from what is instructed by God. Instrumental music for example, changes what is authorized from vocal singing to singing and playing on instruments of music. Although David used instruments in the Old Testament (2 Chronicles 29:25-27), there is no provision made for them in the New Testament— God is silent on the matter. Some look at recreation, entertainment, and social meals in a fellowship hall or gymnasium— sponsored by the church treasury— as just expedients to carry out the work of the church in our modern times. They would try to justify them on the basis of general authority, but the fact remains that God didn't give the church that work. There is no command, example, or necessary inference for such work— therefore it adds to what is already written (I Cor. 4:6; Proverbs 30:6). It must be with great care that we do not presume on God our own desires for God's house in the New Testament age (2 Samuel 7:1-7; I Peter 4:11).

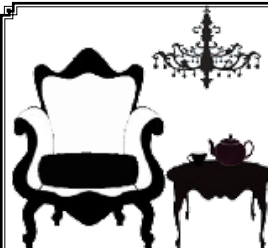
His early childhood and young-adult life was spent in Hardeman County around the Bowden Hill Church area but later he moved to

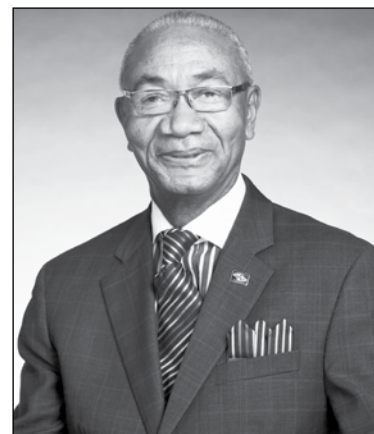

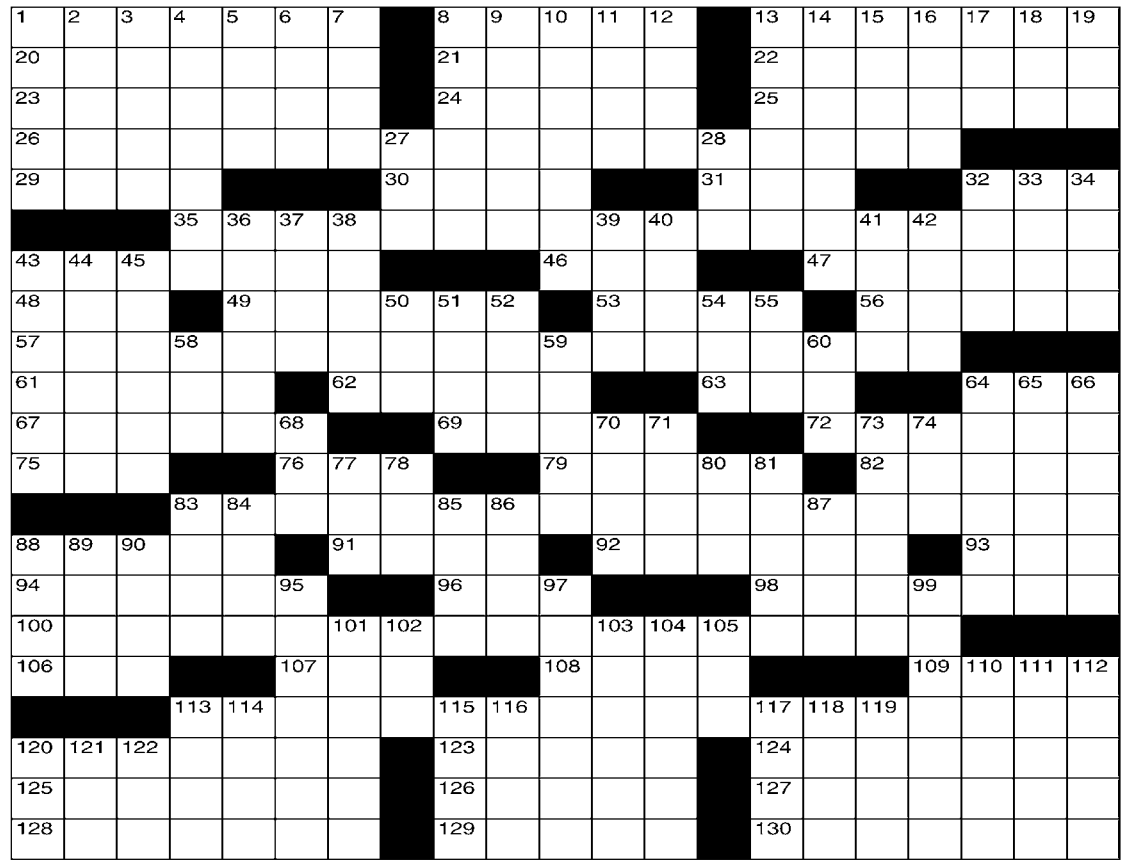

What Should You Do With Your Tax Refund?

You may not get much of a thrill from filing your taxes, but the process becomes much more enjoyable if you're expecting a refund. So, if one is headed your way, what should you do with the money?

The answer depends somewhat on the size of the refund. For the 2017 tax year, the average refund was about \$2,760 – not a fortune, but big enough to make an impact in your life. Suppose, for example, that you invested this amount in a tax-deferred vehicle, such as a traditional IRA, and then did not add another penny to it for 30 years. At the end of that time, assuming a hypothetical 7 percent annual rate of return, you'd have slightly more than \$21,000 – not enough, by itself, to allow you to move to a Caribbean island, but still a nice addition to your retirement income. (You will need to pay taxes on your withdrawals eventually, unless the money was invested in a Roth IRA, in which case withdrawals are tax-free, provided you meet certain conditions.)

Of course, you don't have to wait 30 years before you see any benefits from your tax refund. If you did decide to put a \$2,760 tax refund toward your IRA for 2018, you'd already have reached just over half the allowable contribution limit of \$5,500. (If you're 50 or older, the limit is \$6,500.) By getting such a strong head start on funding your IRA for the year, you'll give your money more time to grow. Also, if you're going to "max out" on your IRA, your large initial payment will enable you to put in smaller monthly amounts than you might need to contribute otherwise.

While using your refund to help fund your IRA is a good move, it's not the only one you can make. Here are a few other possibilities:

Pay down some debt. At some time or another, most of us probably feel we're carrying too much debt. If you can use your tax refund to help reduce your monthly debt payments, you'll improve your cash flow and possibly have more money available to invest for the future.

Build an emergency fund. If you needed a new furnace or major car repair, or faced any other large, unexpected expense, how would you pay for it? If you did not have the cash readily available, you might be forced to dip into your long-term investments. To help avoid this problem, you could create an emergency fund containing three to six months' worth of living expenses, with the money kept in a liquid, low-risk account. Your tax refund could help build your emergency fund.

Look for other investment opportunities. If you have some gaps in your portfolio, or some opportunities to improve your overall diversification, you might want to use your tax refund to add some new investments. The more diversified your portfolio, the stronger your defense against market volatility that might primarily affect one particular asset class. (However, diversification, by itself, can't protect against all losses or guarantee profits.)

Clearly, a tax refund gives you a chance to improve your overall financial picture. So take your time, evaluate your options and use the money wisely.

OUR COUNTY

Hardeman County Remembered by Lisa Coleman



As I often say, there is all sorts of amazing history right here in our own backyard of Hardeman County, and this week's column is a story of a part of our shared history.

This is a photo from the 1898 reunion of Veterans of the Civil War and the Spanish-American war that was an annual event held in English, Indiana. If you look very closely in the center of the photo, you will see the only known photographic image of Lucy Higgs Nichols. Lucy had quite an amazing story.

Lucy was born a slave in Mississippi and as a very young girl was sold to an owner in Hardeman County. By 1862, much of Hardeman County was occupied by the Union Army, with a fairly large encampment near Bolivar that included members of the 23rd Indiana. Nichols had learned, somehow, if she could get to one of the Union camps that she might be safe. She had her child escaped and made their way to the 23rd Indiana camp, where they were taken in. She nursed the sick soldiers, cooked and washed for the officers, and traveled with the regiment for the remainder of the war, going across Tennessee and into Mississippi, Georgia, South Carolina, Virginia, and Washington D.C. before mustering out with the regiment in Indianapolis at the end of the war.

Lucy and her child were adopted by the men of the 23rd Indiana and they affectionately called her "Aunt Lucy" and she called the men "my soldiers". Much of Lucy's life after the war is not known and was often filled with heartbreak as family members died and her own health troubled her. She attended as many of the veterans reunions as she could, and she was made an honorary member of the Grand Army of the Republic in 1892.

In late 1892 Congress passed a special act that would allow nurses who served in the Civil War to apply for pensions. In 1893, the men of the 23rd Indiana began a campaign to apply for a pension on Lucy's behalf. It took them five years, but a special act of Congress in 1898, signed by President William McKinley, recognized Aunt Lucy as a Civil War nurse and she was paid an Army nurse's pension of \$12 per month for her work and service during the war. She continued to attend reunions with "her soldiers" until her own health began to decline. She died in 1915 and was buried in New Albany, Indiana with full military honors and with some of "her soldiers" in attendance.

Lucy's story is a remarkable story of bravery, faith, hope, perseverance, and service to others. She is one of those people whose story I have learned that I would like to sit down with and talk to her for a while. What courage and faith it took to leave the life of a slave with the hope of finding a better life for her and her young child. I would love to hear her tell the stories of her life and the men who were "her soldiers".

Y'all, everybody has a story and their lives intertwine with history sometimes in remarkable ways. The story of Aunt Lucy and her soldiers are surely proof of that.

Fourth Sunday Service Schedule for February 25

The Hardeman County Commission for Black History will culminate its Annual events on Sunday afternoon, February 25, 2018 at 3:00 p.m. at Zion Temple Worship Center (COGIC) in Bolivar, Pastor Wendell Sain. The keynote speaker for the Fourth Sunday County-wide worship service will be Pastor Robert Parham, pastor of Greater Springfield Baptist Church, Bolivar. Pastor Robert A. Parham: A Spiritual Leader from the Heart.

Rev. Robert A. Parham, the son of the late Thomas and Ethel Parham, was born and reared with his six brothers and sisters in Bolivar, Tennessee. He was educated in the schools of Hardeman County and joined the Oak Hill M.B. Church in Bolivar at an early age. He is presently married to the former Hortense Ferguson of Bolivar, Tennessee. He is a paid Silver-Life member of the NAACP.

Parham joined the U.S. Army in 1954 and two years later, he enlisted in the U.S. Navy. He served two years ashore in Vietnam in the Navy Contracts Office in Saigon and another year as a "Nam" aboard the USS Mt. Katmai, an ammunition ship. He received a Navy Commendation medal for his service in Saigon and four good conduct medals during his military career. The time he spent in the Navy taught him the importance of being on time as well as affording him the opportunity to travel to some 18 countries where he learned how to interact with people of different backgrounds and lifestyles. He retired after twenty years of service in the armed forces. He attributes much of his ability to interact with others to his military career and travel experiences.

In 1982 Parham was called into the ministry. His first appointment as pastor was at St. Paul Baptist Church in Medon, Tennessee. He was later called to Greater Springfield Missionary Baptist Church in Bolivar in 1987. His calling to pastor Greater Springfield marked a milestone in the history of the church. For the first time, the membership elected a native Hardeman County resident as pastor. He received a degree in theology from the American Baptist Theological Seminary in Nashville, Tennessee. He has served as treasurer of the Volunteer Chaplains Association and president of the Hardeman County Ministerial Association. He is also on the board of the Bolivar Housing Authority.



OPINION

As the new year begins, it is customary for us all to set resolutions for the new year, for how we will improve ourselves and our habits. Have you ever thought about how you might better your community in 2018? Undoubtedly, there are numerous ways to serve others, both individually and collectively, but a surefire way to strengthen your whole community is to stay local. I bet that phrase makes you think about patronizing small businesses in the area, but may I suggest that it also applies to your own community hospital.

Just like small businesses, community hospitals depend daily upon being chosen by local citizens for their healthcare needs. And also like small businesses, a difference of just a few customers (patients) per day can often make the difference between sustainability and failure. However, when patients choose to seek care out of town for services that can be provided locally, hospitals suffer tremendously and have to begin the heart-wrenching process of considering which services to downsize or close. We have suffered through this too often here in the West Tennessee region over the last five years, with at least six hospitals having to close their doors or drastically reduce services. Let me be clear that the plight of rural hospitals has been significantly impacted by federal reimbursement changes and state legislative decisions, but most, if not all, of these closed facilities also suffered from extremely low utilization rates. Basically, for one reason or another – some justified, but often unnecessary – patients chose to leave their own communities and seek healthcare in larger cities, to the detriment of the local hospital.

In my observations of these rural hospital closures, I have seen a consistent mentality amongst residents who find themselves without a local hospital: they took it for granted and assumed it would always be there, if they ever needed it, but many of them never used its services or even graced the doors, when it was open. Likewise, these same folks are now shocked and devastated by the prospect of the closest emergency department being 20 or 30 miles away, which not only worsens outcomes in medical emergencies but also puts strain on local clinics and EMS providers. Furthermore, the impact on employment rates and community economic development, especially new industry recruitment, may be felt for decades.

Fortunately, your community has a high quality and financially strong healthcare resource in Bolivar General Hospital. In addition to having full-time hospitalist services, skilled nursing beds for short rehab stays, advanced imaging capabilities, and a sleep study lab, Bolivar General has been awarded special grant funding to address health disparities and chronic disease states (like diabetes and heart disease) in the Hardeman County region. It is led by experienced, hometown healthcare executives with a heart for Bolivar and the surrounding area, guided by a dedicated local community advisory board.

So, make a resolution this year that, the next time your healthcare provider orders laboratory or imaging (x-ray or CT) studies that can't be performed in his/her office, or you find that it is time for your routine screening examination, like a mammogram or colonoscopy, call your local hospital to get your test scheduled there. If you find yourself or your loved one in need of emergency care, stay local and choose Bolivar General's Emergency Department – you'll find the very same expert medical care as in larger cities, but most often with shorter wait times and familiar, friendly faces. And if you are blessed enough to not require any medical care, I encourage you to go visit your friends and neighbors in the hospital...and eat the delicious, homestyle cooking in the hospital cafeteria. I'm certain you will be impressed with what your community hospital has to offer.

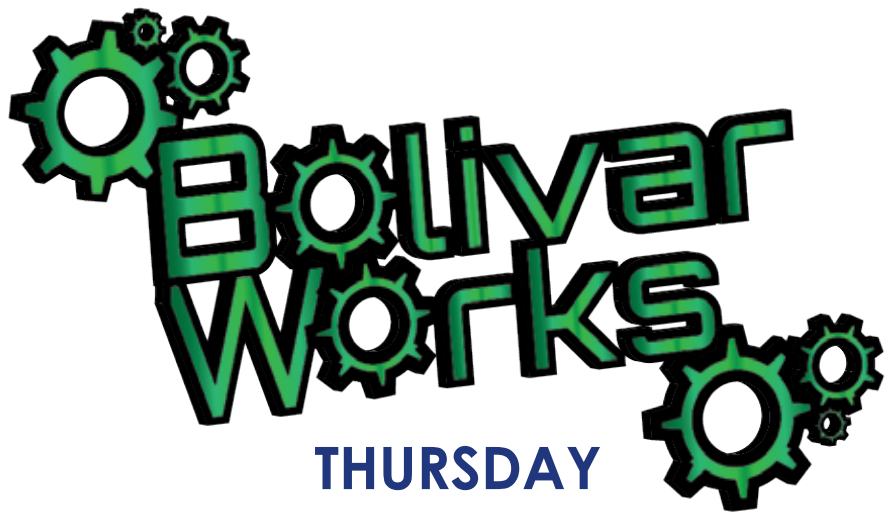
