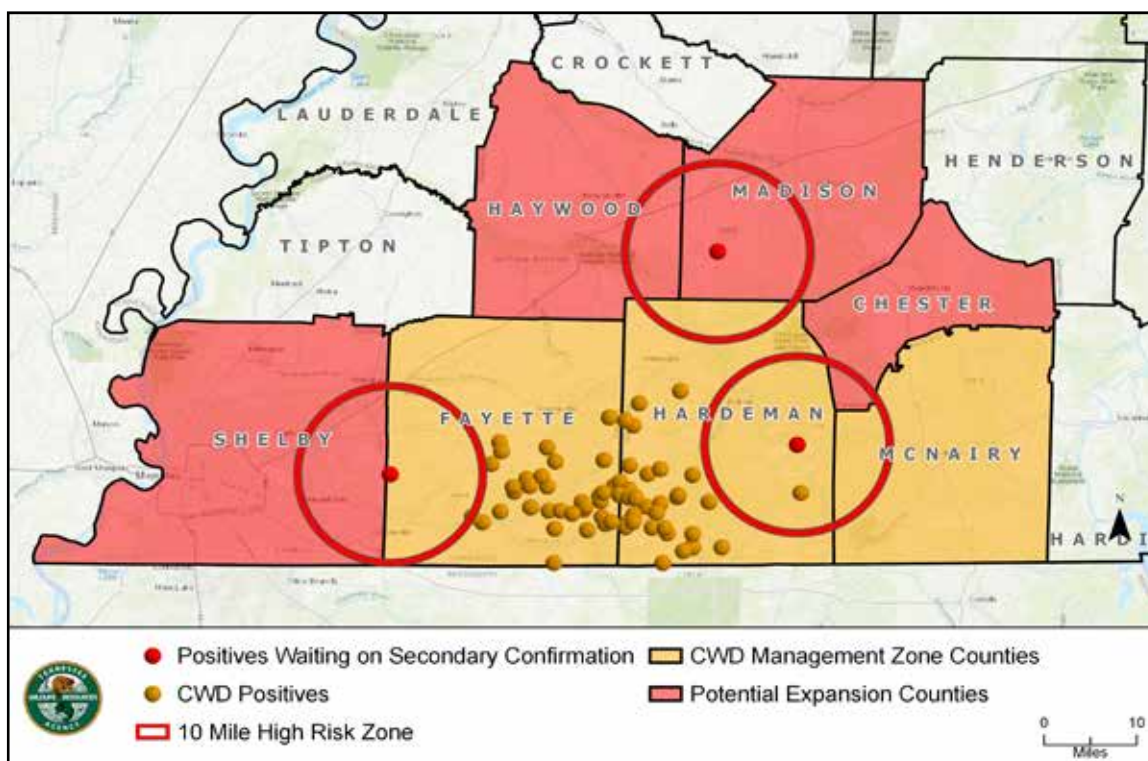
## County Full of CWD Deer

The Tennessee Wildlife Resources Agency has announced the total number of deer testing positive for chronic wasting disease (CWD) has climbed to 91 in Fayette and Hardeman Counties. Three additional deer, if confirmed by secondary testing, would expand the CWD zone.

Two of the deer receiving secondary testing are from Hardeman and Fayette Counties and if confirmed, would bring Chester and Shelby Counties into the CWD Management Zone due to the proximity to those counties. The remaining deer is from Madison County, and if confirmed, the location of that deer would add Madison and Haywood County to the zone. (See map for details).

Although Madison, Chester, Shelby, and Haywood Counties are currently outside TWRA's

## Whiteville Expenses Questioned

A Whiteville city alderman is asking questions and says he's not getting the answers he would like. Former Mayor James Bellar, who has served as an alderman since 2018, questioned expenses on a convention trip to Florida for a Whiteville city administrator.

"I was told he went to a convention in Florida and I became concerned," he said. "I asked the recorder the next day for copies of all the invoices involved and I immediately saw some problems."

Bellar, who was Mayor of Whiteville for 22 years and has been an alderman, vice-mayor and treasurer for 11, says the hotel records don't match up and having the city administrator take his wife was a violation of the town's travel policy, which according to Bellar, says family members cannot go.

Mayor Aubrey Phillips disputed the statement, saying, "When he was mayor he always told employees to take their family on trips like this. We can't find a travel policy. The only travel policy he's barking about is the one in his hand. We don't have a travel policy. I didn't see a problem with it."

"My concern was that he went in a police vehicle. I was expecting to see a plane ticket," said Bellar. "No employee in Whiteville has ever drove a vehicle that distance except the police department going to Chicago with regards to an assault case. To drive that distance on municipal business is unheard of it and leads to questions," Bellar added.

Phillips said that the vehicle used wasn't a police vehicle, but a city owned car his employee drives full-time.

"He went in a vehicle that it is city owned, said Phillips. "It is an SUV with lights, not a police car, but a city vehicle. The car he drove doesn't make traffic stops. The police weren't short a vehicle."

Bellar also cited, in his view, problems with hotel invoices, toll records on the way there that don't match the return trip, and the lack of specifics on the per diem for meals. "The mayor refused to give those to me. He (the administrator) was paid \$413.00 for that. If he ate at good restaurants that might be in-line but the hotels provide breakfast and I am sure the event

### UT-Extension Begins Five Year Health Program

Last fall, the Centers for Disease Control and Prevention awarded University of Tennessee Extension a five-year grant to improve access to healthy foods and physical activity opportunities for all communities in Hardeman County. The purpose of the project is to make environmental changes that make it easier for people to achieve a healthy weight. Amy Elizer, Ed. D., and Sherri Shelby will be working on the grant through the phases of needs assessment to implementation over the next five years. In the first year, community needs and assets will be assessed in the county's nine communities.

Amy Elizer (top photo) worked with Madison County Extension for 20 years as the family and consumer sciences agent. For eight years, she also served as the county director. During that time, she implemented numerous health and nutrition projects. Her office will be located at the Hardeman County Chamber of Commerce, a partner organization for the grant. Sherri Shelby (lower photo) previously worked in Fayette County for 14 years as the family and consumer sciences agent before transferring to the Hardeman County office. While in Fayette County, Sherri provided nutrition and health programming in the schools and the community.

In February, Dr. Elizer and Mrs. Shelby will be meeting with government and community groups in all nine cities and towns to make people aware of the need to participate in the upcoming needs assessments. ### County Full of CWD Deer continued from A1

CWD Management Zone, CWD Coordinator Chuck Yoest, does not anticipate any changes to hunting regulations there for the remainder of the current 2018-19 deer hunting season.

"Changing the regulations now would be premature as we are getting new information daily," Yoest said. "Once all the results have come back from our recent CWD sampling efforts, and all positive deer have been mapped, we will then develop a long term management plan including changes to hunting regulations.

"I imagine some people perceive the increased total of positives and the potential of expansion of the zone as an indication the disease is rapidly growing," Yoest continued. "It is instead due to TWRA's swift and focused sampling efforts in the affected area and being transparent and timely about the results as they are received."

TWRA, with assistance from hunters, has collected more than 2,000 samples in the CWD Management Zone and surrounding counties since CWD was first detected on December 14 in Fayette and Hardeman Counties. The Agency is still awaiting results on approximately 800 samples, and anticipates collecting a couple hundred more samples during the last week of the extended hunting season in the CWD Management Zone.

### Tales from the Yellow House by Lee McAlpin



While a kid growing up at the Yellow House, we lived honoring a set list of ground rules and no-no's. None which stunted our growth or left any negative effects on us. I did have some marks on my behind (big red ones) that lasted a couple of days. These I deserved for defying some of the said no-no's. The paddlings or whuppings (the country way of saying whippings), that we received never reached the severe or abuse stage, the biggest hurt was our feelings and just knowing that we were caught. I know too that it hurt Mom and Dad to have to give us the paddlings. The disciplinary spankings usually drove into our young hard heads a warning not to do it again. I wonder what would have happened if I had told Mom or Dad that if they whipped me I would call the police. I can almost feel my back side heating up at that thought. Let me say that I am so against any kind of child abuse. If you want to see me mad, just mention incidents of child abuse and abuse of an old person. But also let me add here that a good fanny warming is not abuse. It straightened me out a lot of times.

We weren't allowed to use any of the D words such as dang, darn, dag-nabbit and certainly the other

D words. Those were considered really bad, bad no-no's. We were not allowed to use any of the curse words that you hear on TV, and read about in today's media. I knew several men when I was a kid that cursed every other word. Someone told me one day that these people did not know enough of the English language to carry on a conversation. The word "sex" was never used in mixed company. The country folk used the words "family way" in place of the word "pregnant." We were taught to say Mr. and Mrs. when addressing any adult, and to say yes ma'am, no ma'am and yes sir, no sir. We were not allowed to holler and make a lot of noise on Sunday, or when there was sickness in the community, or when there was a death. We could run and play, but we had to be quiet about it. If we did get a little loud during these times, Mom would come to the front door and say, "Ya'll quieten down now, people will think that you are a bunch of heathens." I didn't know what a heathen was at that time, but I did not want to be labeled as one. We had to say "please," "thank you" and "may I?" Another no-no was that we could not run around the house or community with our un-

derwear showing. It was embarrassing especially at school if this happened. Every kid would point at you laughing and say "I see London, I see France, I see so and so's underpants."

You were teased the rest of the day. We had to wear belts (one thing that I still do not like to do), especially if I'm wearing jeans. We had to keep our pants pulled up around our waist. If we let our pants bag down, some one would say, "Pull your pants up, it looks like a heard of cows has moved out of the seat of your pants."

Another custom at our house was that when company came to visit, the adults ate first and then the kids. I was always thrilled to have company, but I was saddened knowing that the only pieces of chicken left on the platter would be necks, backs and wings. By mentioning these things, I am not saying that I am anywhere close to being an angel having been brought up under these conditions. I stumble, I fall, I make mistakes, I have many faults, but I believe that these no-no's helped mold me into a somewhat better person that maybe I would not have been without them.

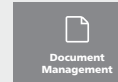

## Insurance Can Protect Your Aspirations

Some life insurance plans offer long-term care coverage, either through a special "rider" or by accelerating your death benefit, but you might also want to consider a traditional long-term care insurance policy.



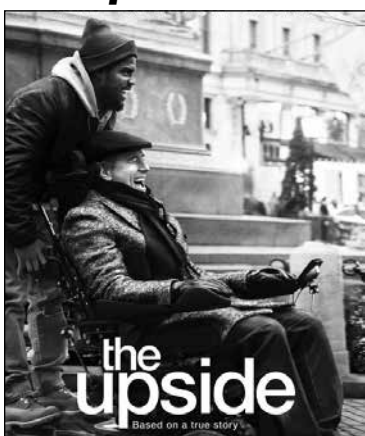

## Light of the World: Sermon on the Mount-Part 2

by Jeff Capshaw

The Sermon on the Mount explains to Jesus' disciples how "the rubber meets the road." Christ's followers need to be mindful of the "A-B-C's" of the Christian life: what it looks like to live worthy of the calling to which they have been called (Ephesians 4:1).

Last week I considered Jesus' *salt of the earth* metaphor. Although believers should have a preserving, enhancing or even a disinfecting affect on culture (salt's affects), there may be a more significant point: the near worthless value of non-salty salt. In the same way that "unsalty" salt isn't of much value, neither are disciples who are not living according to Christ's prescriptions in this sermon.

Jesus' next metaphor is light. He said, "you are the light of the world. A city set on a hill cannot be hidden. Nor do people light a lamp and put it under a basket, but on a stand, and it gives light to all in the house. In the same way, let your light shine before others, so that they may see your good works and give glory to your Father who is in heaven." (Matthew 5:14-16).

Jesus' first light example is a vivid image of near impossibility. About 60 miles south of Seattle is Mount Rainier. At 14,411 feet to the summit, it is the most topographically prominent mountain in the contiguous United States. If the city of Seattle were on top of that mountain, it would be nearly impossible to hide. Similarly, we don't cover our electric lamps with black 5-gallon buckets. Instead, we set them on tables and hang shades on them to direct light from the bulb to illuminate our surroundings.

Thus, disciples committed to living-out Jesus' prescriptions in the sermon will be conspicuous, just like a city on a high mountain. Furthermore, the good works of Jesus' disciples will serve their ultimate purpose: bringing glory to the Father in Heaven. In the

These teachings provide concrete ways to keep believers from being worthless like unsavory salt, to bring needed light to a dark world by properly reflecting an accurate opinion of God.

Grief, pain of mind produced by loss, misfortune, injury or evil of any kind; sorrow, regret ~Webster's Dictionary. It also is an individual and unique journey for every person. Losses may be cumulative over one's lifetime. A person may experience loss in area of health, dreams, expectations, possessions, etc. Grief is universal, we all will eventually walk the journey with grief. Grief is more than emotional onslaught, though it does involve emotion, it is not the whole of a person's effect on their system. Yes, we may experience anxiety, guilt, sadness, anger, shock, worry, fear, confusion, brain fog, or depression emotionally. We may also experience pain, sleep disruption, shakiness or trembling, lethargy, dizziness, dry mouth, crying, numbness shortness of breath or exhaustion physically. We might question our faith in God, the purpose of life or death, question the purpose of pain and suffering or blame God spiritually. 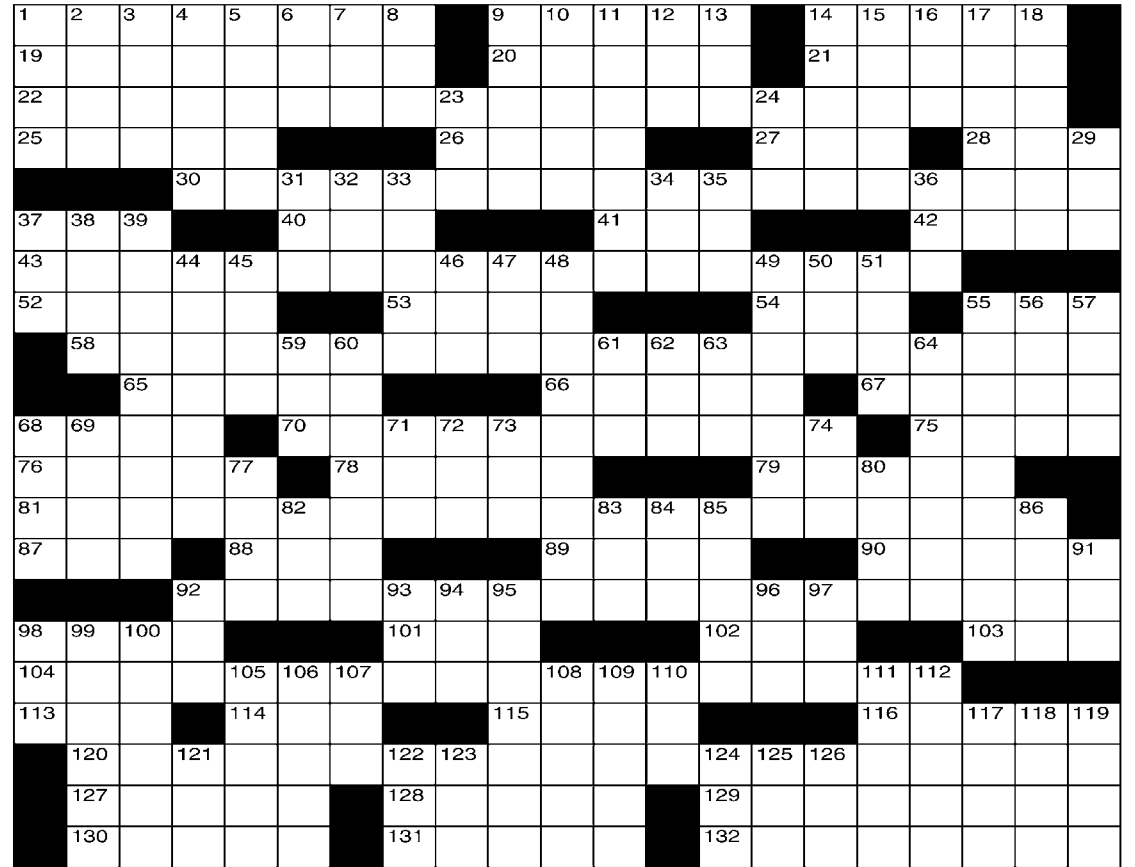

also provided some meals. The town should not pay for the wife's meals." "For expenses, we use what the state is doing," said Phillips, "Which is \$51 per day. The State of Tennessee told him he needed to go to this training. We applied for a grant and got it. It wasn't the city's expense at all," said Phillips. "He spent \$1,700 and the grant was for \$2,000. It didn't cost the city anything. In fact, he stayed at a different hotel to save money."

In his investigation, Bellar said he found out some details. "The recorder told me the town paid a registration fee of \$875.00. Just out of curiosity I checked round-trip air fare and Southwest from Memphis to Palm Beach is \$354.00. The flight time is three hours as opposed to 15 hours driving."

Bellar says he is acting on his desire to protect the town. "I really don't know what could be gleaned from attending a meeting at a very high-class resort in Palm Beach that will improve the lives of the single moms and retirees in Whiteville. My biggest problem is that some of the aldermen don't care or are too timid."

"He's just sorry over losing the election," said Phillips. "We had a grant that covered his trip and we used the state rate for meals. The State of Tennessee said he had to go. He (Bellar) is making a big deal out of nothing."

"I told the mayor, 'you have a problem with this and better clean it up,'" added Bellar.

Bellar was Mayor of Whiteville until the 2016 elections, when he lost to Aubrey Phillips by a 122-81 margin, with Leon Crisp getting 80 votes. Bellar was elected as an alderman in 2018, but he said he will never run for Mayor again. "I take the job too seriously and my health would not let me," he explained.

The highlight of the service was the viewing of the film, "Selma" which was coordinated by Bethany Miller and Willie Spencer, Jr. This movie demonstrated that one dream can change the world. Dr. King rallied his followers on the historic march from Selma to Montgomery, Alabama (some 50 miles) in the face of violent opposition, an event that became a milestone victory for the civil rights movement in 1965. The group had to stay focused with the plan in order to negotiate, in order to demonstrate and in order to resist. The spiritual songs of old such as Precious Lord and Walk With Me Lord gave the people of the non-violent movement the courage and hope to march on against injustice and inhumanity. The Edmund Pettus Bridge is a memorable site even today as we remember the struggle to secure equal voting rights for all people before it was signed into law. It was a march of protest and a march of progress. The question was asked, when will we be free and the answer was soon.

The children of Antioch (known as David Larry's Angels) under the direction of Renee' Brown performed a very meaningful praise dance to the tune of We Are One. # Rudesill Gets 800<sup>th</sup> Coaching Win

As the Bolivar Central Lady Tigers cruised to a 64-36 win over Ripley on January 29, it had another significance: Bolivar Central Head Coach Rick Rudesill's 800th coaching win.

"It's so many more people than just the kids tonight," said Rudesill. "And everybody enjoyed it knowing they were a part of it. It was kind of a surprise to our players, but I did let them know today at school what was going to happen tonight. But even the kids from the 700th win are in that picture and they can always see they were there that night."

Rudesill's 700th win came in 2015 against McNairy Central, with the boys victory over the Bobcats.

The 52-year old Rudesill came to Bolivar Central in 1996-1997 after five years at the University School of Jackson. After six years with the boys, he also took over the Bolivar Central girls program in 2002-2003.

His team at USJ, beginning in 1991-1992, was 65-75, and his overall record at Bolivar Central is 736-451.

With an overall coaching record of 801-526, Rudesill's teams have won 60% of their games, and has a 62% winning record at Bolivar Central.

His boys teams have won three state championships, in 2003-2004, 2004-2005, and 2009-2010. His girls teams have made the Murfreesboro final eight twice.

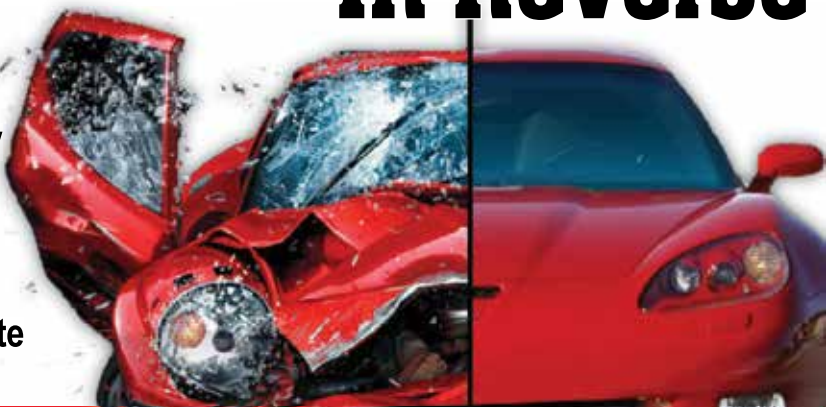
