The Extinction of the DINOS

If you're a Democrat in Name Only (DINO), the clock is ticking on your masquerade.

The Hardeman County Democratic Party Primary Board will hold a public meeting January 9, 2018 at 6:30 p.m. at the Whiteville Community Center at the corner of Main and Woodland in Whiteville.

All candidates for county offices who pulled petitions to run as Democrats will be reviewed to determine qualification as a Democrat. Candidates who do not meet the base criteria of having voted Democrat in three of the last five state and federal primaries may present their cases as to why they should be a Democratic candidate. The public is invited as well as all candidates.

A second and final meeting will be held following the close of the filing period for those who have not picked up petitions as of January 9.

The committee is moving as

only six of the 26 spots are without a potential candidate in the 2018 Hardeman County Elections.

The committee will have the opportunity to approve the 20 candidates who have either filed or picked up petitions as democrats, including incumbent Mayor Jimmy Sain. *See story below.*

Incumbents running for re-election are Commissioners Chandra Lake, Commissioner Elmer Cobb, Johnny Weems, Mike Madden, Jim Daniel, John Vickers, and Mac Vaughan. Other county incumbents running are County

Clerk Jerry Armstrong, Sheriff John Doolen, Road Supervisor John Mitchell, Road Supervisor Kenny Pulse, Register of Deeds Lily Barnes, Trustee Mary Powell, and Road Supervisor Matt Knight.

New candidates are Casey Swift, Charles Vandiver, and Dale Dixon for Supervisor of Roads, Charles Gatlin, Tonya Perry, and Billy Davis for Circuit Court Clerk, and Jerry Siler and Pat Baker for Sheriff. Running for County Commission are Donna Pinner, Gary Barber, Ocie Wallace, Albert McKinnie, and Brandon Burvee.

Still without a candidate to pick up qualifying petitions are county commission seats currently held by Chris Bell (District 1, Position 1), Jackie Sain (District 1, Position 2), Vincen Morrow (District 3, Position 2), Elvis White (District 3, Position 3), Johnny Lanier (District 5, Position 1) and Bobby Doyle (District 7, Position 1).

The Republicans are expected to caucus, which would take care of Commissioner Chris Bell's (District 1, Position 1) candidacy, if he were to choose to run.

Elections opening on January 5 include three aldermen's spots in Whiteville, six Hardeman County School Board positions, and representative offices of Democrat Johnny Shaw (80th District) and Ron Gant (94th District).

If a candidate has concerns as to whether or not he meets the baseline criteria to run as a Democrat, he or she should contact Evelyn Robertson at 731-254-8508.

Tales from the Yellow House by Lee McAlpin

I was still living at the Yellow House when I went into the ninth grade at Middleton High School. The Pocahontas school only had grades 1st. through 8th. During my eighth grade year at Pocahontas, I took an interest in basketball. We had outdoor courts and played a few of the country schools in the area. I was determined that I was going to make the team when I got into high school.

My sister, Joyce, was already on the cheerleading team at Middleton. I found a wide slab in the wood pile and nailed it upon the trunk of the huge oak tree in our front yard. To this slab I affixed a metal barrel hoop. I had

found an old basketball in a junk-pile that had a layer or two of the outer covering missing. I was set for my practice. I had no air pump, but I learned that if I placed the ball in front of the fireplace for awhile, some air would magically appear in it. I would go back outside and it was good for a few dozen dribbles.

I wore all the grass off the yard of my front yard gym. My determination paid off, not in my freshman year, but I made the team in my sophomore, junior and senior years.

I got to play in the state tournaments in Johnson City, TN. I remember we boarded the streamlined Tennessean train in Middleton for our trip. The whole town turned out at the depot for our sendoff. We had sleeping bunks in the Pullman cars for our overnight trip. There were a couple of teams from Memphis also on the train. They all had their fancy pajamas, and all of us proud M.H.S. Tigers were running around in the Pullman car aisles, bare-tail in our Haynes, BVD's and whatever. No one had a pair of PJ's. We got quite a few snickers from the city boys whose tails we had beat in the regional tournaments in Memphis a few days before.

I remember my first year on the team. We would go out of town to play a game and afterwards the bus would stop at a truckstop for the team to eat. I never had any money to eat, so a lot of times I would fake being asleep and stay on the bus while the others ate. But when I got home I would rake the cold grease from the top of a pot of beans or peas, grab me a pone of cornbread and chow down before going to bed. I'm sure that peas and cornbread gave me more energy than hamburgers and fries.

I cannot ever remember Dad owning a vehicle. I was lucky because my cousin Billy Harris, who was on the team, had a car and I bummed rides with him all through high school. As well as I liked basketball, I probably would have walked the six miles to Middleton just to play ball.

I suppose growing up poor (and I am in no way ashamed) made me thankful for each little thing that comes my way. I'm still poor by some standards, but again I'm so rich. It don't take much to make me happy. As long as I have God, family, friends and a dog, I'm happy as a dead pig in the sunshine, as the old country saying goes.

Oh yeah, I forgot food. Got to have my country soul food. Can't forget that.

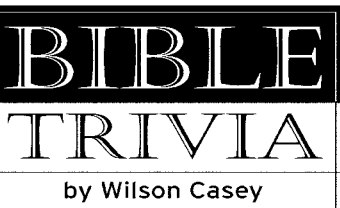

 - 1 tablespoon honey
 - 1 tablespoon oregano, crushed
 - 1 1/2 teaspoons chili powder

usage comes from the Greek word *exousia*, which is defined as the, "Rightful, actual, and unimpeded power to act, or to possess, control, use, or dispose of something or somebody."

The Bible teaches us that Jesus, as the head of the church (Colossians 1:18; Ephesians 5:23), has the right or power to command us (Matt. 28:18). We are under Jesus' authority to direct and command us in His ways, not our own. The Bible is the source of where we find Jesus' words for us to follow. Time is a Key Factor in Investing

With the arrival of the New Year, many of us will pause and ponder the age-old question: "Who knows where the time goes?" And, as is always the case, none of us really do know. However, wherever the time goes, it will usually be a key factor in your success as an investor.

Time can affect how you invest, and the results of your investing, in different ways:

Growth potential – Contrary to myth, there's no real way to "get rich quick" when investing. To build wealth, you need patience – and time. If you own quality investments with growth potential, and you give them years – in fact, decades – to increase in value, your perseverance may be rewarded. Of course, there are no guarantees, and you'll need the discipline to withstand the inevitable downturns along the way. But in describing how long he likes to keep his investments, renowned investor Warren Buffet says his favorite holding period is "forever."

Targeted goals – To accumulate resources for retirement, you need to save and invest throughout your working life. But along the way, you'll probably also have some shorter-term goals – making a down payment on a home, sending your children to college, taking a round-the-world trip, and so on. Each of these goals has a specific time limit and usually requires a specific amount of money, so you will need to choose the appropriate investments.

Risk tolerance – The element of time also will affect your tolerance for risk. When you have many decades to go until you retire, you can afford to take more risk with your investments because you have time to overcome periods of market volatility. But when you're on the verge of retirement, you may want to lower the risk level in your portfolio. For example, you may want to begin moving away from some of your more aggressive, growth-oriented investments and move toward more income-producing vehicles that offer greater stability of principal. Keep in mind, though, that even during retirement, you'll need your portfolio to provide enough growth opportunity at least to help keep you ahead of inflation.

Thus far, we have looked at ways in which time plays a role in how you invest. But there's also an aspect of time that you may want to keep out of your investment strategies. Specifically, you might not want to try to "time" the market. The biggest problem with market timing is it's just too hard. You essentially have to be right twice, selling at a market top and buying at the bottom. Also, as humans, we appear to be somewhat wired to think that an activity – especially a long-running activity – will simply continue. So, when the market goes up, we seem to expect it to keep rising, and when the market drops, we think it will continue dropping. This can lead to big mistakes, such as selling after a major market drop even though that can be the time when it may be much smarter to buy because prices are low.

As we've seen, the way you interact with time can affect your investment efforts. So, think carefully about how you can put all the days, months and years on your side. Time is the one asset you can't replenish – so use it wisely.

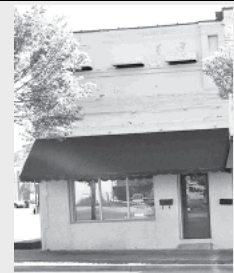

Hardeman County Remembered by Lisa Coleman

This blast of wintry weather has reminded me of some winter days when I was a child and how we turned ice and snow into something of an adventure. It was more than 40 years ago when we had a major ice storm in the winter of 1974 (this is a photo of me around that time).

The biggest memory, and the best, I have of those cold, cold days was spending them with my family at my Granny Kiestler's old house. We did not have electricity for three or four days; she didn't either but she had one of those huge old gas heaters, you know the kind that took up the entire corner of a room. My brother and I loved to play in her old house, and one of its main attractions to us was the marvelously (we thought) slanted floor. If you positioned yourself just right under the bedroom window, you could send a whole fleet of cars across the floor and down to their eventual stopping place under the sofa. As children we didn't understand that the slanted floor was some kind of foundational problem, we thought it was just a great

car freeway right in her house. It was also good for playing jacks because it taught you to be super-quick – if you weren't that slanted floor would cause things to start going the opposite way.

That ice storm kept us all together there at her house and we played games and she told us stories about growing up on a farm just outside of Cloverport. We cooked soup and other things right on top of that old heater and I thought we were just right in the middle of a great adventure for sure. I was in the early years of my "Little House on the Prairie" phase and I just knew we were living like they had in the Big North Woods. I also thought we were sort of like hobos on a train since some of what we cooked we ate right out of a can. At night we had candles and Granny's old kerosene lanterns for light, and when it was time for sleep we bundled up under blankets and quilts I knew that my Mom and Granny had made. Is there any better sleep than under the fabric that has been lovingly pieced together by familiar hands?



After a few days, the temperatures started to rise, the electricity came back on, and we went back home. Every time we have cold, cold weather I remember those winter days that were warmed by our love and togetherness. One of my favorite Laura Ingalls Wilder quotes sums up the memories of those winter days spent together, "It is the sweet simple things of life which are the real ones after all."

Y'all enjoy winter days and warm memories.

Expensive Phone Calls in School Zones

Everybody will have to adjust to a new state law that makes talking on a cell phone — while holding a device — illegal in an active school zone before and after school is in session.

But it's not just a texting thing. It's a talking thing, too. If the phone is in your hand, that is.

The law states that it's a Class C misdemeanor, punishable by a fine of up to \$50, for a person to knowingly operate a motor vehicle in any marked school zone in Tennessee, when a warning flasher or flashers are in operation, and talk on a hand-held mobile telephone while the vehicle is in motion.

Now, all is well if the telephone is equipped with a hands-free device, for drivers 18 years of age and older.

But, a driver under age 18 is breaking the law talking either using a hands-free or handheld while driving through an active school zone.

According to sources, lawmakers thought about legislation that outlawed driving while talking on a handheld phone at any time.

The law took effect January 1, 2018.

What the Legislature Voted to Approve:

Subject to certain exemptions, this bill makes it a Class C misdemeanor offense, punishable only by fine of up to \$50.00 and court costs up to \$10.00, for a person driving a moving motor vehicle to use a handheld mobile telephone to make or receive a phone call while driving in a marked school zone if:

- (1) Proper signs are posted with a warning flasher or flashers in operation; or
- (2) The use of a hand-held mobile telephone occurs during a period of 90 minutes before the opening hour of a school or a period of 90 minutes after the closing hour of a school.

The use of a hands-free device will not violate this bill.

The following persons are exempt from this bill:

- (1) Law enforcement officers, campus police officers, public safety officers, emergency medical technicians, emergency medical technician-paramedics, firefighters, and emergency management agency officers, when in the actual discharge of official duties; and
- (2) A driver who, while using the mobile telephone device, reports to local authorities a fire, traffic accident, road hazard, reckless or unsafe driving of another, or a criminal act believed to be perpetuated against the driver or another person.

A traffic citation that is based solely upon a violation of this bill is a moving traffic violation.

This bill requires the department of transportation to utilize the department's permanent electronic overhead informational displays located throughout this state to provide periodic messages to the motoring public as to the provisions of this section.

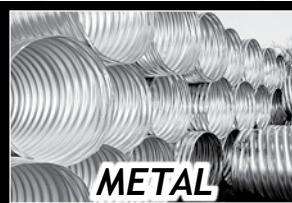

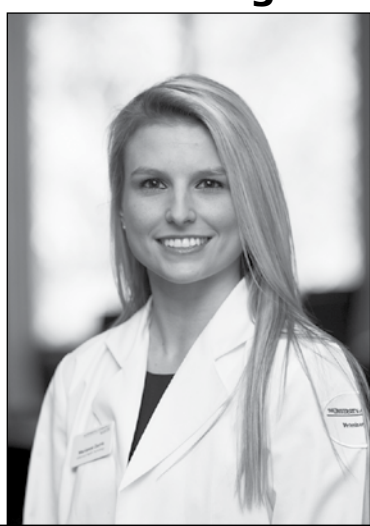
