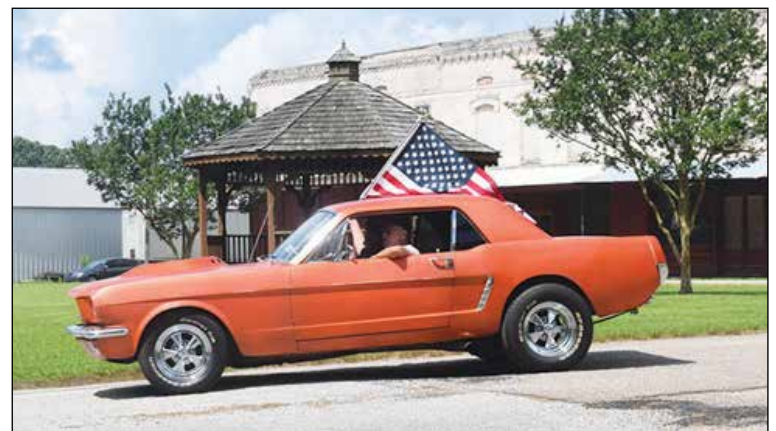

- Pre-installation conference with general contractor and installer must be held ten days prior to starting work.
- Power sweep entire floor to remove any dirt and debris from sanding.
- Ensure all cracks are filled and leveled with an epoxy fill material.
- Paint must be capable of withstanding high temperatures from hot tires, guaranteed to stay bonded, and resistant to delamination.
- Paint must be slip-resistant and bonded to concrete floor
- Paint shall not fade when wet.
- A minimum of two coats of paint should be applied for maximum durability.
- Paint color will be Oxford Gray or similar color as approved by the fire chief.
- Contractor should be prepared to issue a minimum five-year guarantee and warranty on all work and on the paint applied.
- Work MUST be completed within three days of start date.

Interested bidders should contact Fire Chief Lynn Price to arrange for viewing of existing floor and to obtain exact measurements. Bidders will be responsible for obtaining their own measurements for quote purposes.

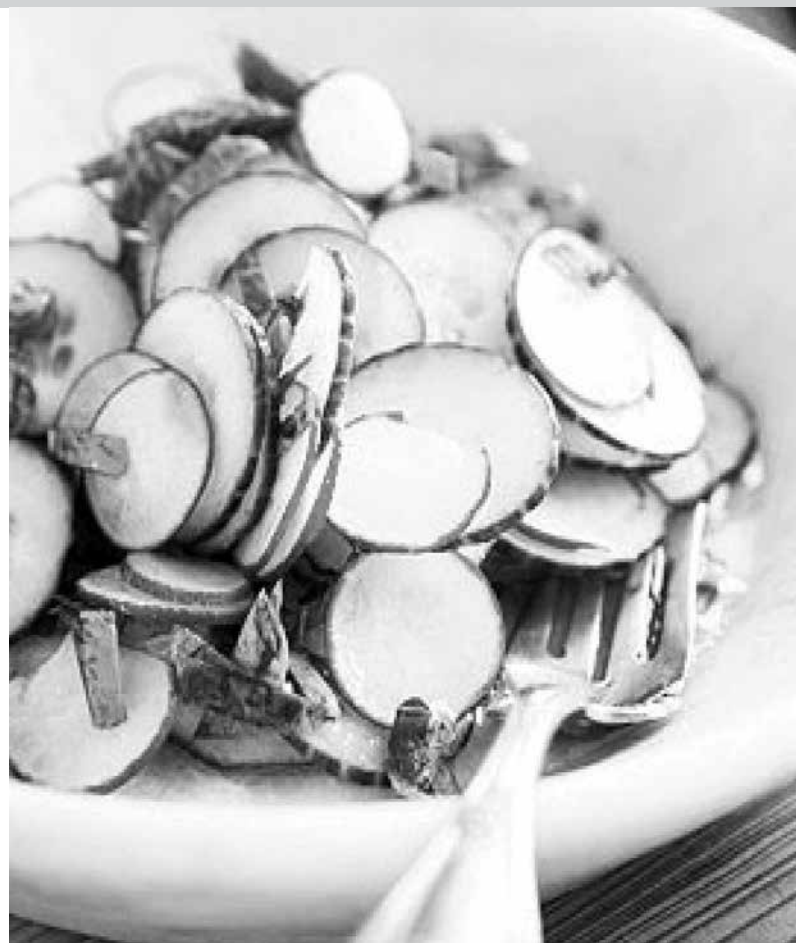

# FAITH

## Jesus as God, Part 8 by Jeff Capshaw

In this series of articles, I have loosely and selectively moved in canonical order through the New Testament and commented on texts relevant to the divinity of Christ. This week's comments center upon a text from the book of Titus. It is one of three "Pastoral Epistles" Paul wrote to a ministerial protégé.

At the beginning of Titus 1, Paul reminds Titus of his appointment. He says, "this is why I left you in Crete, so that you might put what remained into order, and appoint elders in every town as I directed you . . . (1:5). Then, in chapter 2, he exhorts Titus toward one of the most important responsibilities of any teaching elder. "But as for you, teach what accords with sound doctrine" (2:1). "Sound doctrine" or teaching may also be understood here as "healthy" doctrine: certainly, appropriate for the Church, the "body of Christ."

Next, we come to the second division of Titus 2. For a bit of context, here Paul models what

sound doctrine looks like. He says, "for the grace of God has appeared, bringing salvation for all people, training us to renounce ungodliness and worldly passions, and to live self-controlled, upright, and godly lives in the present age, waiting for our blessed hope, the appearing of the glory of our great God and Savior Jesus Christ . . ." (2:11-13).

Most of this brief paragraph is about grace for holiness of life, but that same grace also gives us patience to wait for Christ's return and the ushering in of the end times. Yet, it is verse 13 that relates to the theme of this series: "our great God and Savior Jesus Christ." According to the notes on this verse (Titus 2:13), the Reformation Study Bibles says, "this is one of the clearest affirmations in the New Testament of the deity of Christ." I concur.

Often, key passages—especially related to historically and highly controversial doctrines—will have variant Greek readings.

These variants may more or less alter the meaning of a passage. Interestingly, in surveying eight critical editions of the Greek New Testament from the mid-16th century to the present, only one differed in a minor detail with respect to the phrase, "our great God . . . Jesus Christ." Constantin von Tischendorf's 8th edition only strengthened this already clear affirmation of Christ's deity. Historically, no reading found mitigated it.

Thus, I close with this quote from the 5th century Bishop, Theodoret of Cyrus (423-457). "Here he [Paul] calls the same one both Savior and great God and Jesus Christ." It's that simple and that profound.

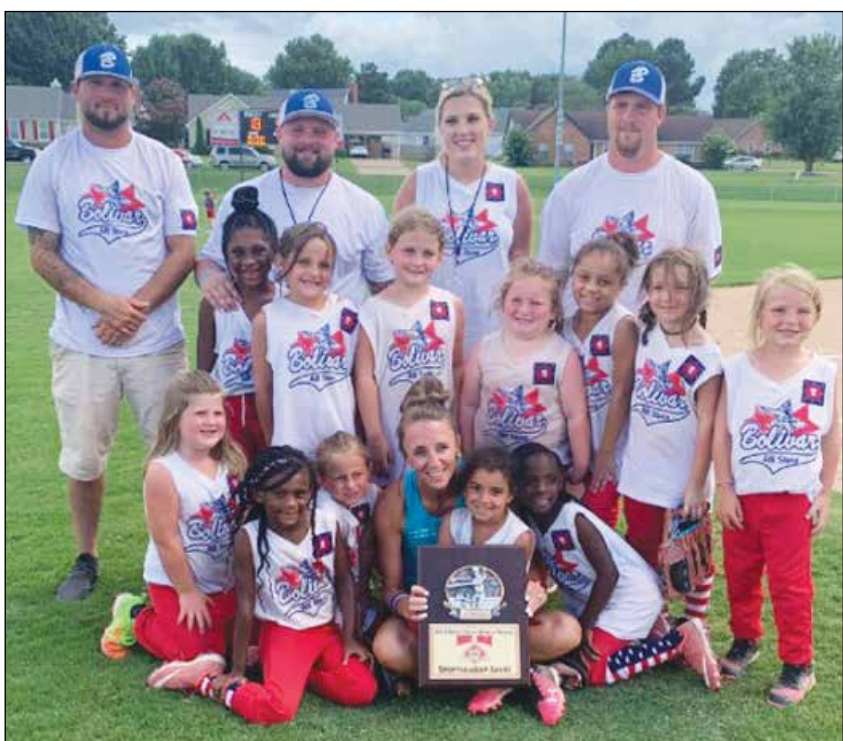
The 8U squad began the tournament with two losses on Saturday, but rebounded for two wins on Sunday and an eventful 5th place finish out of a total of fifteen teams.

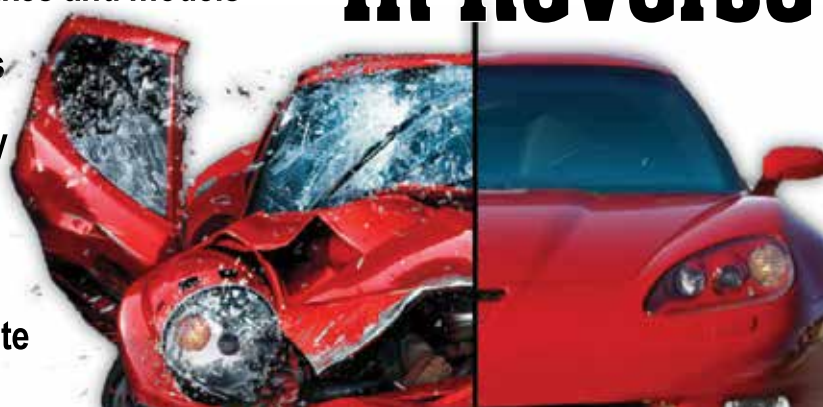

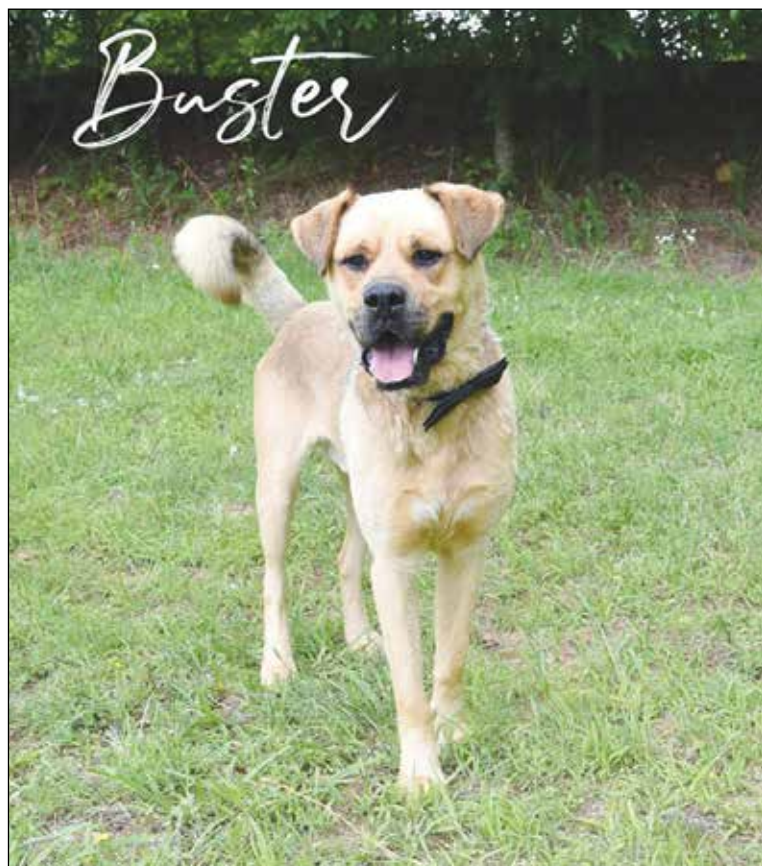

# APTA Turning Back the Clock

The Hardeman County Association for the Preservation of Tennessee Antiquities (APTA), facing deteriorating conditions at their one of their cornerstone pieces of property, have begun to make plans to bring it back.

"We are currently doing restoration work on the inside of The Pillars again. Over 50 years ago, Jimmy and Barrett Stevens took on this project on a very rundown house and made it into something grand!" said Cissy Pierce. "A house museum from the John Houston Bills family which tells of an extraordinary pioneer family in West Tennessee and the formation of Hardeman County. After our serious roof leak this past winter we are once again restoring."

The APTA has asked Brad Grantham to chair of this project. Grantham, who restored the Luez Theatre in Bolivar as one of his most recent projects, is working with insurance companies and exploring grants for repair, according to Pierce.

The timing of the project comes as a moment where the history of Bolivar and Hardeman County is in

danger of being lost to the community, as membership in the APTA statewide and local chapters has waned in the past few years, according to Pierce.

The APTA will host a "Tea" at The Pillars from 2:00-4:00 p.m. for people to come view the house, see the damage and hear about the restoration project. The public is not only welcome, but encouraged to attend.

Bolivar's first and oldest brick home was once a small Federal style structure built by the Lea Family, New England-based publishers, in 1826. The original furnishings at The Pillars came to Bolivar via steamboat along the Hatchie River. The modest original home was purchased in 1837 by regional cotton magnate Major John Houston Bills and enlarged it to its present-day style.

According to the diary of John Houston Bills, frequent visitors to the home included General Sam Houston, Andrew Jackson, David Crockett, and the Rt. Rev. Leonidas Polk. During the Civil War, gen-

erals from both sides visited and stayed in the home as well as many other guests.

On the north side of the house is a one-room wood frame cottage built during the Civil War for daughter Evalina McNeal Bills to reside in while her husband was serving in the Confederate Army. On the south side is a two-story building that served as a kitchen and dairy, and the old ice house is south of the kitchen and underground.

When the Bills family no longer used the kitchen and dairy, it became the first lending library in Bolivar and was also used for art classes. The Bills family donated The Pillars to the Association for the Preservation of Tennessee Antiquities (APTA) who continue to preserve and operate the home and grounds today. It is available by appointment for occasions such as ceremonies, receptions, reunions, and other special events.

Dr. Debra Messenger-Smith and Dr. Dedrick Messenger both recently garnered awards from the Greater Nashville Alliance of Black School Educators. Smith received the Principal of the Year Award and her brother earned the Teacher of the Year nod. Both, products of Bolivar Central High, are the children of Reverend Glen and Helen Messenger.

“When I was in the first grade, I told my mom I wanted to be a teacher,” shared Messenger-Smith. “My teacher was Miss Scott. She was an excellent, firm teacher. For me, teaching and being an instructional leader is a gift. I thank God for the many roles I have served in as an educator. Although, I was a principal for 16 years, I never forgot I was once a teacher.”

Messenger-Smith recently retired from Metro Nashville Public Schools (MNPS) after 30+ years in the education field. ### Changes in Hardeman County Bus Routes

Hardeman County Schools is making some changes in our bus routes for the 2019-2020 school year. Below are the schools and routes that will be affected. We ask that you review this information carefully and call us at 731-658-3444 if you have any questions about which bus your student will be riding and the approximate time for pick up in the mornings. We also ask that you be patient with our drivers as we implement these changes to our routes. These changes are also posted on the district website at: [www.hardemancountyschools.org](http://www.hardemancountyschools.org) Thank you.

Below are changes in bus routes for the Toone and Bolivar zones that may impact your students.

- Buses #1 and #5 are being eliminated.
- Bus #31 will pick up current route plus students zoned for Toone on Pine Top, Harris and Isaac Jordan Roads
- Bus #9 will cease to pick up on McNeal Street, which runs in front of the Columns. Bus #9 will pick up Hwy 125 North, Fitts-Ross Rd, Ebenezer Rd, Hwy 100 toward Bolivar from Pine Top Rd, Naylor Rd and Cloverport Rd, which are zoned for Bolivar. Bus #9 will continue to pick up students on Main Street, entering Bolivar on Hwy 18 North. This includes most of Bus #1’s old route.
- Bus #58 will cease to pick up on Elmview Street. Bus #58 will pick up the rest of its current route, adding McNeal Street, Madison Street, Butler Street, West Jackson Street and the area around Bolivar Municipal Center, North Washington Street and the area around the Bolivar Library. These areas include parts of Bus #1’s and Bus #9’s route in Bolivar.
- Bus #60 – Current Route and add Elmview Street, which is off of Sain Rd.
- Bus #6 will keep current route and will add Walton Road and Vildo Road, between Old Hwy 64 and New Hwy 64. Bus #6 will not pick up students north of New Hwy 64. These are students that were a part of bus #5’s and bus #13’s old routes.
- Bus #13 will no longer pick up on Vildo road between Old Hwy 64 and New Hwy 64, the area beside/behind the Hardeman County Fairgrounds and will no longer pick up on Jackson Street or Lee Street. Bus #13 will pick up all of Vildo Road, north of New Hwy 64, and Walton Road, North of Hwy 64. This is part of Bus #5’s old route. In addition, Bus #13 will pick up on Pleasant Creek Lane, which is across from Joe’s Restaurant.
- Bus #11 will continue its current route and add Jackson St. and Lee St.
- Bus #25 will cease to pick up students behind Jervis, Young Road and Roger Avenue. Bus #25 will pick up all students in the Country Club Area, including Hines Blvd, Stevens Road, Lucy Black Rd, Nuckolls Rd, Janet Rd, Blue Bonnet Ln, Karen Drive and El Capitan. This includes parts of Bus #5’s old route
- Bus #56 will pick up all students for BCHS, BES & BMS on Tate Rd, Young Rd and Roger Avenue, including all the area behind Jervis.

Below are changes in bus routes for the Grand Junction zone that may impact your students.

- Buses #18 and #53 are being eliminated.
- Bus #61 will pick up the area around Grand Junction Elementary School, west side of Grand Junction, area around the Grand Junction Library, west of Grand Junction on Hwy 57, Hwy 18 to Hwy 368, Hwy 368, area around CO-OP, Smith Drive and Holder Road.
- Bus #41 will pick up in Saulsbury, south of College Street, Indian Creek Road and Park Swain Road.
