He was grateful I had stopped by to keep him company. I was grateful he had a torn MCL. About 2:00 p.m. or so, I very carefully snuck out the side door and made my way home.

I've only broken three noses since, none of them mine, and none of them on purpose. Well, maybe one, kind of.

But none since 1988.

on US Highway 64, then turning onto Lucy Black Road. After turning onto Lucy Black Road, patrol units attempted to disable the suspect vehicle, causing the suspect vehicle to temporarily exit the roadway, traveling through the grassy area next to the roadway.



"The suspect vehicle then re-entered Lucy Black Road, traveling south. Upon running the stop sign, the suspect vehicle entered the intersection of US Highway 64 and Lucy Black Road. After entering the intersection, the suspect vehicle impacted a Bolivar Police patrol unit. After impacting the Bolivar patrol unit, the patrol unit from Whiteville Police Department was able to disable the suspect vehicle, coming to rest in the roadway, facing north.

"All suspects were taken into custody. The Tennessee Highway Patrol is currently investigating the vehicle crash."

Taken into custody, after receiving medical attention by the Hardeman County EMS, were Jasmin Moore, 28, of Whiteville,

Olivia Harris, 25, of Middleton, and Kimberly Kelly, 27, of Whiteville.

Moore, according to the Hardeman County Sheriff's Department, was asked to remain in his vehicle when spotted in Whiteville, but chose flight instead, at times driving east in the westbound lane on Highway 64 toward the City of Bolivar.

Sheriff John Doolen spoke of the decision to pursue Moore, saying Moore had more than a dozen

offenses, warrants and/or violations of probation on his record, including charges of burglary, escape, child abuse, and assault, as well as various drug charges.

"Normally, we don't need to chase. But someone with multiple warrants and a danger to the community, we are going to chase them and catch them."

Bail totalling \$270,000 was set for Moore, who remained in custody at press time.

proud to claim him," said Hardeman County Mayor Jimmy Sain.

Jeter, assigned to the 4th and 39th Battalion of the 9th Infantry as a 19-year old in 1968, was promoted to Sergeant and over his tour earned four Bronze Stars, three Air Medals, four Army Commendation Medals, a Purple Heart, a Silver Star, a National Defense Medal, a Sharpshooter (rifle m-14) Medal, Expert (rifle m-14) Medal, First Class Gunner (machine gun M60) Medal, Vietnam Service Medal, and the Combat Infantryman Badge. He is one of Tennessee's most decorated Vietnam Veterans.



Jeter was wounded during a firefight and received shrapnel to the neck and face from a bomb. Jeter refused medical attention until he got his unit evacuated from the area.

Upon returning home, Jeter served as a member of the Tennessee National Guard, was a Bolivar Firefighter for 27 years, and was Hardeman County Sheriff for eight years.

used to bring containers back to the recycling center as needed instead of being restricted to seventy loads per month, as currently provided by a private company, C&P Waste.

The county paid 10% of the \$156,220 price tag for the vehicle, as required by the 2019 Waste Reduction Grant.

Brown estimates the move will eventually save the county more than \$50,000 per year.

After the purchase of open top boxes and compactors by the county, an employee will be added to the county payroll in order to service the centers.

Pecan Pie Muffins

- Ingredients**
- 1/2 cup all-purpose flour
 - 1 cup light brown sugar, packed
 - 1 cup chopped pecans
 - 2 large eggs
 - 11 tbsp real butter (about 1 1/3 sticks) melted

Instructions

Preheat your oven to 350F degrees.
Place 9 cupcake paper liners into regular muffin pan and spray each of the liners with nonstick cooking spray.
In a bowl, combine the flour, brown sugar and pecans until mixed well.
In a separate bowl, beat the eggs until foamy and then add melted butter. Stir well.
Combine the egg mixture with the flour mixture.
Stir until moistened.
Spoon the batter into the muffin cups. You will need to fill them to almost full.
There is no leavening agent (like baking powder or baking soda) in these to make them rise. Bake for about 20-25 minutes (it took closer to the 25-minute mark in my oven.) Optional: Around the 15-minute mark, pull them out and sprinkle with chopped pecans or place one pecan half on each one, then play them back into the oven to finish baking.
Bake until a toothpick inserted into the middle comes out clean.

Jesus as God, Part 9

This week we continue to meander through the New Testament, highlighting texts related to the deity of Christ. According to the New Testament and as interpreted by early Church tradition, Jesus possessed two natures: both human and divine.

For example, the Creed of Nicaea (325 AD) reads, "We believe . . . in one Lord Jesus Christ, the son of God, begotten of the Father as only begotten, that is, from the essence [reality] of the Father." It continues about Jesus, "God from God, Light from Light true God from true God, begotten not created of the same essence as the Father."

Because of the Greek terminology (*homoousion*) in the original, technical terms emerged to clarify the orthodox understanding of Christ's two natures. In English, it is called the "hypostatic union." According to Van A. Harvey's, Nicaea's Christological statement defended against the Arians who departed from the orthodox position. They claimed Jesus was subordinate to and not of the same divine nature as God the Father.

Even some of today's religious groups take this position: Jehovah's Witnesses, The Church of Jesus Christ of Latter-Day Saints (Mormons), Unitarians and others. But as Ecclesiastes says, "What has been will be again, what

has been done will be done again; there is nothing new under the sun" (1:9 NIV). Thus, it is important for followers of the biblical Jesus to know the difference. Not only is the deity of Christ a critical tenet of the faith, but it also aids our understanding of scriptural passages like the ones discussed in this series.

Another important passage on Christ's deity is Hebrews 1:1-3. It says, "Long ago, at many times and in many ways, God spoke to our fathers by the prophets, but in these last days he has spoken to us by his Son, whom he appointed the heir of all things, through whom also he created the world. He is the radiance of the glory of God and the exact imprint of his nature, and he upholds the universe by the word of his power (ESV).

The author of Hebrews says that Jesus is "the exact imprint of his [God's] nature" (1:3b). As mentioned in an earlier article, this is similar to what Paul says in

Colossians 1:15; "the Son is the image of the invisible God." All analogies ultimately break down, but the point of similarity in both passages is one is a replica of the original.

Jesus is a replica of God, but he is more than that. He is very God of very God. According to Leon Morris' comments on the Hebrews passage, "the Son is such a revelation of the Father that when we see Jesus, we see what God's real being is." 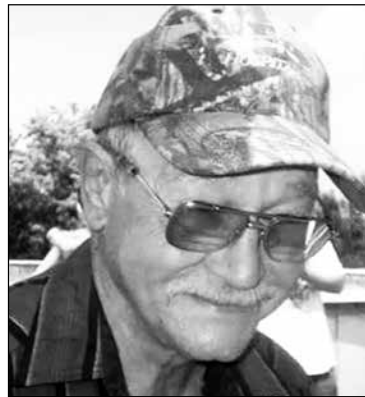

HEARING TO BE HELD AUGUST 20 ON A PROPOSED HAZARDOUS WASTE TREATMENT PERMIT FOR KILGORE FLARES COMPANY, LLC

The Tennessee Department of Environment and Conservation (TDEC) Division of Solid Waste Management (DSWM) will conduct a public hearing August 20, 2019 to receive comments on its proposal to issue a hazardous waste treatment permit to Kilgore Flares Company, LLC. The Kilgore facility (EPA ID TND981026594) is located in Hardeman County on Keller Road in Toone, Tennessee, 38381.

Kilgore is comprised of the main production plant and the approximately 240-acre Test and Treatment Facility (TTF) that includes a 5-acre Hazardous Waste Open Burn Area (HWOBA). Kilgore has manufactured pyrotechnic devices (e.g., distress signal flares, location markers, and illuminating rounds) for the U.S. Department of Defense (DoD) and commercial users at its main production plant since 1962. Hazardous waste generated from the production of the pyrotechnic devices in the main production plant is transported 1 mile to the HWOBA on Keller Road for treatment by burning. Hazardous waste has been treated in the same manner at the 5-acre HWOBA since approximately 1989, under Interim Status.

Based on review of the application and as authorized pursuant to Tennessee Rule 0400-12-01-07(7), DSWM determined the application complete and has drafted a permit. DSWM proposes to issue the permit under the authority of the Tennessee Hazardous Waste Management Act of 1977, as amended, Tennessee Code Annotated, Section 68-212-101 et seq., and Rule Chapter 0400-12-01, Hazardous Waste Management. In accordance with Rule 0400-12-01-.07(7)(e), this notice provides a 45-day comment period, beginning on the date of this publication. A fact sheet has been prepared that provides additional information about the site and the proposed permit.

The proposed HWOBA permit will allow Kilgore to replace its twenty-one (21) 1,500-pound capacity open burn pans with ten (10) redesigned 3,300-pound capacity open burn pans. Each of the redesigned carbon steel burn pans will be situated aboveground over curbed concrete pads and on elevated stands. The removal and the construction of the burn pans will be done in two phases so that treatment of waste will not be interrupted. The construction will be finished within a year of the permit issuance.

Per the proposed permit, the daily treatment capacity may not exceed 3,300 pounds of waste pyrotechnics per day. Open burning will occur only between the hours of 9 a.m. and 2 p.m., not to exceed 5 days a week.

Corrective action conditions for the Solid Waste Management Units (SWMUs) and Areas of Concern (AOCs) are also included as part of the draft permit. Kilgore shall be required to investigate any releases of hazardous waste or hazardous constituents pursuant to this permit at the facility regardless of the time at which waste was placed in a unit and to take appropriate corrective action for any such releases. The draft permit also requires Kilgore to comply with all land disposal restrictions and air emission standards applicable to this facility and to certify annually that on-site generation of hazardous waste is minimized to the extent practicable.

The draft permit identifies 12 SWMUs and 2-AOCs. SWMUs 2, 6, 7, 8, 9, 10, 11, 12, and AOC-1 were approved for No Further Action. The draft permit proposes final remedies for SWMU 1, 3, 4, and 5 and AOC-2, requiring institutional controls consisting of warning signs, a no digging policy, site security, inspections, and financial assurance. Legacy groundwater contamination at SWMU 1 is being addressed as part of AOC-2. Once Kilgore closes or discontinues operation of SWMU 1, all investigations and final remedies will be addressed under the corrective action program. For AOC-2, the proposed permit requires the monitoring of 10 wells across the site for volatile organic compounds. DSWM has written Statements of Basis summarizing the remedies.

The facility is in operation and will continue operating under Interim Status until a final permit decision is made. If the permit is issued, it will allow the facility to continue to treat hazardous waste in the open burn units for up to ten years. Pending consideration of any contrary information received, it is the present intent of DSWM to issue this permit.

A public hearing will be held at 6 pm on Thursday, August 20, 2019 at the Toone Elementary School, 160 Neely Street,, Toone, TN 38381, with a public informational session starting at 5:30 pm. This informational session will have a question and answer format where the public can inspect and discuss the draft permit, the fact sheet and other materials one-on-one with DSWM staff and representatives of the applicant. There will be an opportunity for public comments to be recorded or written and submitted during this time. The formal public hearing will begin at 6:00 pm CDT and the question and answer format will end. Public comments will be collected for the hearing record without response from DSWM during the hearing. DSWM will explain its tentative decision to issue the permit, after which the applicant will describe the facility. DSWM will then receive oral comments on the draft permit from the public.

DSWM invites the public to review and submit comments on the draft permit at the hearing or anytime during the 45-day comment period ending on September 3, 2019. Electronic copies of the application, draft permit, fact sheet, and Statement of Basis are available to review online at tn.gov/environment/notices/kilgore and at the DSWM Central Office in the Tennessee Tower, 312 Rosa L. Parks Avenue, 14th Floor, Nashville, TN 37243 (615-532-0780). Paper copies are available for review at the Bolivar-Hardeman County Library, 213 North Washington Street, Bolivar, TN 38008 (731-658-3436) and at the TDEC Jackson Environmental Field Office, 1625 Hollywood Drive, Jackson, TN 38305 (731-512-1300).

Comments must be received by 4:30 p.m. CDT, Tuesday, September 3, 2019 to assure consideration.

After considering all comments, DSWM will make a final decision to either issue or deny the permit. Notice will be given to the applicant and each person who has submitted written comments or requested notice of the final decision. At the time of a final decision, a Response to Comments addressing all significant input received on the draft will be made available to the public. The final decision shall become effective upon signing by the Director of DSWM.



Changes in Hardeman County Bus Routes

We ask that you review this information carefully and call us at 731-658-3444 if you have any questions about which bus your student will be riding and the approximate time for pick up in the mornings. Below are changes in bus routes for the Toone and Bolivar zones that may impact your students.

- Buses #1 and #5 are being eliminated.
- Bus #31 will pick up current route plus students zoned for Toone on Pine Top, Harris and Isaac Jordan Roads
- Bus #9 will cease to pick up on McNeal Street, which runs in front of the Columns. Bus #9 will pick up Hwy 125 North, Fitts-Ross Rd, Ebenezer Rd, Hwy 100 toward Bolivar from Pine Top Rd, Naylor Rd and Cloverport Rd, which are zoned for Bolivar. Bus #9 will continue to pick up students on Main Street, entering Bolivar on Hwy 18 North. This includes most of Bus #1's old route.

Bus #58 will pick up the rest of its current route, adding McNeal Street, Madison Street, Butler Street, West Jackson Street and the area around Bolivar Municipal Center, North Washington Street and the area around the Bolivar Library. These areas include parts of Bus #1's and Bus #9's route in Bolivar.
- Bus #60 - Current Route and add Elmview Street, which is off of Sain Rd.
- Bus #6 will keep current route and will add Walton Road and Vildo Road, between Old Hwy 64 and New Hwy 64. Bus #6 will not pick up students north of New Hwy 64. These are students that were a part of bus #5's and bus #13's old routes.
- Bus #13 will no longer pick up on Vildo road between Old Hwy 64 and New Hwy 64, the area beside/ behind the Hardeman County Fairgrounds and will no longer pick up on Jackson Street or Lee Street. Bus #13 will pick up all of Vildo Road, north of New Hwy 64, and Walton Road, North of Hwy 64. This is part of Bus #5's old route. In addition, Bus #13 will pick up on Pleasant Creek Lane, which is across from Joe's Restaurant.
- Bus #11 will continue its current route and add Jackson St. and Lee St.
- Bus #25 will cease to pick up students behind Jervis, Young Road and Roger Avenue. Bus #25 will pick up all students in the Country Club Area, including Hines Blvd, Stevens Road, Lucy Black Rd, Nuckolls Rd, Janet Rd, Blue Bonnet Ln, Karen Drive and El Capitan. This includes parts of Bus #5's old route
- Bus #56 will pick up all students for BCHS, BES & BMS on Tate Rd, Young Rd and Roger Avenue, including all the area behind Jervis.

Below are changes in bus routes for the Grand Junction zone that may impact your students.

- Buses #18 and #53 are being eliminated.
- Bus #61 will pick up the area around Grand Junction Elementary School, west side of Grand Junction, area around the Grand Junction Library, west of Grand Junction on Hwy 57, Hwy 18 to Hwy 368, Hwy 368, area around CO-OP, Smith Drive and Holder Road.

Sales Tax Holiday Starts July 26

Tennessee's 14th annual Sales Tax Holiday, which is set to begin next weekend, will offer items exempt from sales and use tax, including clothing that costs \$100 or less per item, such as shirts, pants, jackets, socks, shoes, dresses, etc. Also included are school and art supplies with a purchase price of \$100 or less per item, such as binders, books, backpacks, crayons, paper, pens, pencils, and rulers, and art supplies, such as glazes, clay, paints, drawing pads, and artist paintbrushes. In addition, computers with a purchase price of \$1,500 or less are exempted. This includes laptops as well as tablets, as long as they are not intended for business use.

The holiday will begin at 12:01 a.m. on Friday, July 26 and ends at 11:59 p.m. on Sunday, July 28. Tennessee State Senator Dolores Gresham was one of the sponsors of the legislation which enacted the tax relief holiday.

"This sales tax holiday has been a tremendous success," said Senator Gresham. "It has stimulated sales each year, while providing citizens sales tax relief on clothing and supplies needed for students returning to school."

Composting Organic Materials For Free by Carolyn Tomlin

For gardeners who compost, we're seeing garbage in another way. Raw materials that were once throw into the garbage bucket or disposal are now designated to the compost bin.

Think about this: if a household discards 50 pounds a week of fruit and vegetables peelings, shredded newspapers, green grass clipping, and dry leaves, that comes to 200 pounds for a 4-week month. For a year, that is 2,600 pounds, over a ton of black gold. And what if ten families in your community adopted this lifestyle? You have a staggering amount of 26,000 pounds of waste that would never see the landfill. But the greatest advantage is this nutrient rich product would enrich the soil in your flower and vegetable beds. Or, become valuable mulch to amend your soil. In a matter of weeks, you'll see the difference in both ornamentals and edibles. Imagine what a difference a few months could make in the soil composition?

If this method is new for you, look at these specific ideas for starting your own compost.

Some gardeners prefer an open bed and others a closed container. Requiring plenty of hot sun and water both can be successful. Like in real-estate, location is everything. Is there an area in your yard that receives open sun? Avoid shady areas as the internal temperature of the compost needs to be hot to the touch. In making my compost bed, I found that the internal temperature rose to 110 degrees F. on a day when the thermometer reached



60 degrees. In an open bed, start by placing a thick layer of pine needles or dry leaves, which will be the carbon layer. Water generous before adding the next layer. The pine needles or leaves allow air to flow in the pile. Next, add a layer of nitrogen, which are green grass clippings. Water, again. On top of the green grass, empty that kitchen bucket of raw vegetable and fruit peelings, egg shells, coffee, and tea grounds. Never add meat or dairy products as this will attract rodents. Water, well. Follow by a layer of shredded newspaper. Avoid any with color print as the dye can be toxic to plants. If you don't have a home shredder, it's a "must" for the home gardener. Cut several sections into about 8-inch widths to feed into a shredder. Don't forget to ask friends and neighbors to save their papers.

Once you've made these layers, cover with a tarp and weigh down with bricks or pieces of scrap lumber. After 3 days, remove the tarp,

lifting and redistributing the compost with a turning fork. Cover again and repeat until the soil is of the desired consistence. Depending on the sun and internal temperature, you'll have a supply of nutrient rich compost for both ornamental and edible plants for your Tennessee garden.

Another method is an enclosed compost bin. Follow the same steps for an open bed. I found the closed container more difficult to rotate the layers with a turning fork. However, a container that can be rocked or rolled would solve this problem. If your yard is small, a compact compost bin is more attractive than a tarp covering a pile. A bin can blend in with your garden, especially if low plants are placed nearby. Keep the holes in the bin open so air can circulate.

NASCAR legend Dale Earnhardt Jr. will speak at Freed-Hardeman University's annual benefit dinner December 6. The annual event raises funds for FHU scholarships.

Earnhardt is a third-generation driver in the first-family of NASCAR racing. Race fans have selected him a record 14 consecutive times as NASCAR's Most Popular Driver. His appeal, however, is not limited to race fans, as Earnhardt has appeared on Harris Interactive's annual survey of America's Top 10 Favorite Athletes.

After 18 years behind the wheel, Earnhardt retired from full-time racing in 2017 with 26 career victories. He had qualified for the NASCAR play-offs eight times between 2004 and 2015.

"Racing to the Finish: My Story" was released in October 2018. The memoir details how his accident in 2016 transformed him and led to his retirement decision. For the first time, he reveals his experience with concussions, hoping to encourage others with similar injuries to seek treatment.

Earnhardt is also active in a variety of charities and non-profit organizations. The Dale Jr. Foundation is dedicated to giving underprivileged individuals the resources needed to improve their confidence and education. Make-a-Wish has recognized Earnhardt as one of the few individuals who have facilitated 200 wishes for children battling terminal or life-threatening illnesses.

FHU's annual benefit dinner is typically the state's largest single-night fundraiser. For the past 19 years, it has generated more than \$1 million annually.

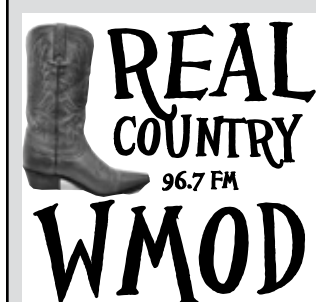

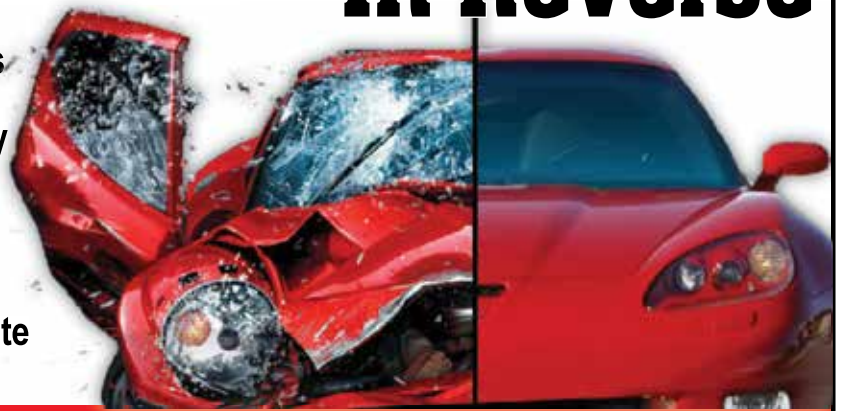


