Sheriff Sues County

The lack of much of a dispute from the Hardeman County Sheriff's Department during the 2019-2020 budget talks turned into full-on protest as Hardeman County Sheriff John Doolen filed a lawsuit on July 16 against Hardeman County, asking for funds for "deputies, jailers, and staff, and to acquire essential crime fighting equipment."

It was filed by on behalf of Doolen by attorney Roy Herron, former Chairman of the Tennessee Democratic Party, a Tennessee State Senator for the 24th district for 16 years and for 10 years before that he was the State Representative for the 76th District.

Herron's press release noted that the lawsuit does not seek a raise for Doolen, as his salary is set by state law.

Doolen's request of \$1.4 million for salaries during the 2019-2020 budget talks was answered this June with \$952,477 from the Har-

deman County Budget Committee, down from a 2018-2019 budget amount of \$957,364 that was passed (in the corresponding line items) in June of 2018.

What CTAS Says About It

"The sheriff has sole discretion to request the number of assistants he believes are 'actually necessary to the proper conducting' of his office, as well as the salaries he feels are necessary to attract and retain them." Shelby County Deputy Sheriff's Ass'n v. Gilles, 972 S.W.2d 683, 686 (Tenn. Ct. App. 1997).

If the sheriff chooses to petition a court for additional deputies or assistants or for greater salaries than the budget adopted by the county legislative body allows, the sheriff must file the petition with the state trial court exercising criminal jurisdiction in the county, either continued on A9

Tennessee County Technical Assistance Service (CTAS) said that petitioning the court for "number of employees and the salaries of those employees," was allowed, but asking for "maintenance of vehicles or equipment" was not included as actionable in the statute.

By statute, Doolen was required to name Hardeman County Mayor Jimmy Sain as the defendant, in his official capacity as mayor. See "What CTAS Says About It" for more information.

This past year's budget talks were dominated by the discussion of funding the Hardeman County Schools, which ended with the county commission passing the schools budget at the same rate as the previous year, overruling the budget committee's recommendation in the process.

The county has thirty days to respond to the suit, and as of press time, had yet to do so.

Hardeman County Hee Haw's Night of Music at the Luez Theatre sold out, with all 200 tickets to the one-night show on August 5 going to the public.

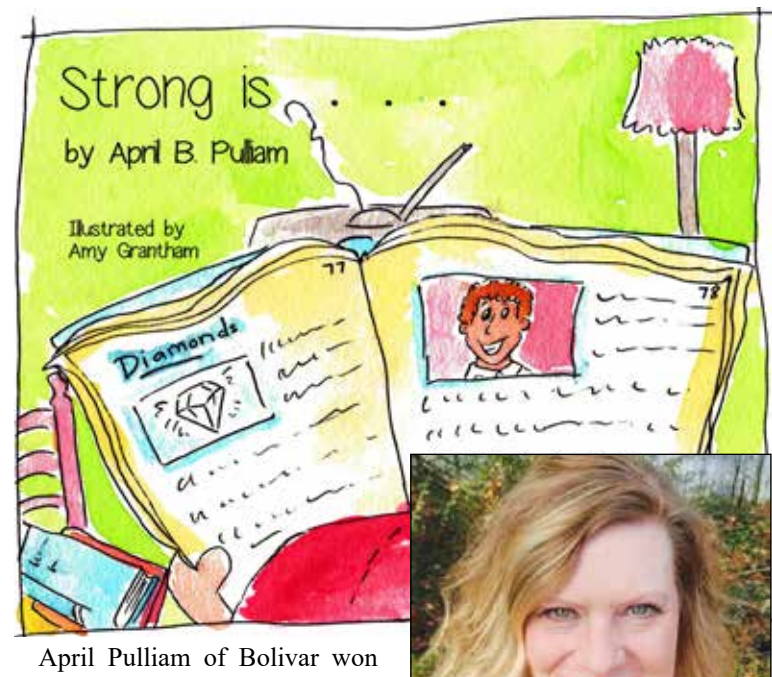
Eighteen performers will entertain on the stage at the Luez Theatre, performing songs that they have done during productions of Hee Haw in past years.

Hardeman County Lake Project - What's The Story?

At a May 14, 2019 county budget committee meeting, comments were made about the prospect of a lake project. The May 14th comment suggested the project "...was about to happen..." and that a \$40 million bond issue could occur to fund the lake. The bond issuance comment was later described as "hypothetical" by an elected official complaining about social media sharing. The mention of the lake project was part of introduction into discussion on school funding. The May 14 comment prompted this listener to find out more about the lake project. Talking to various members of the public found very little information - and even less facts.

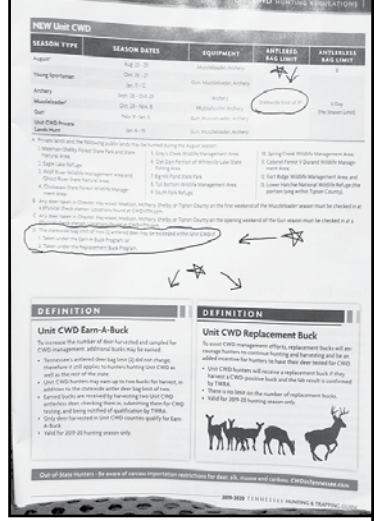
The lake project has been mentioned in several public meetings. It has also appeared in newspaper articles. There was mention of a Tennessee Department of Economic and Community Development (TNECD) grant to fund study for a lake. Given the public funding and being a subject in public meetings and printed media - the issue is clearly open to the Tennessee Public Records Act (TPRA). So the information search centered on public records requests to public offices. Since the May 14th comment said that a hurdle had recently been passed with the United States Army Corp of Engineers (USACE) - a request under the Federal Freedom of Information Act (FOIA) was submitted to the USACE regional office to get details. The next requests were submitted under the TPRA to TNECD, University of Memphis Sparks Bureau of Business and Economic Research (SBBER), Hardeman County, and the office of Governor Bill Lee. Documents received began revealing what appears to be an untold story and narrative. At first, there was resistance from the county to comply with requests by email - but subsequent requests, citing Tennessee Law requiring acceptance and response by email, was met with cooperation. But some received documents were incomplete. Since the documents were sent by one public office to another public office - requests could be submitted to both the sender and the receiver for the same documents. At state level - the received documents were complete. At county level - the received documents were incomplete.

After several weeks involving several public records requests to several public offices - much has been learned. Some things learned have been revealing. Some information is confusing. The information from the governor's office about a March 8, 2019 meetings suggested the possibility that some parts of the lake project effort is not including commissioners, appointed lake committee members, and consultants being paid by public funds. Also, perhaps representing - or misrepresenting - private interests. Some of the overall information is disturbing without additional facts. Effort to get additional information has been denied. The use of public records requests, all property submitted, has for the most part been encouraging. The only disappointment has been at the local level. The county has denied documents claiming attorney/client privilege. In public documents requests to county government - attorney/client privilege applies only to attorney work product in anticipation of litigation [Arnold v. City of Chattanooga]. Correspondence from the attorney and an annual report from the county clearly indicate the documents are intended for permit application - not litigation. The effort to get the denied documents will continue. Received public documents show a large volume of documents and correspondence is being produced by the attorney that is deserving of public knowledge. These documents likely should be in the hands of our representative commissioners and those county residents appointed to the Lake Committee. Not held in privacy.

I encourage others to get involved in this issue. To become familiar with and use the rights given under the Tennessee Public Records Act. Public involvement will influence a more open and transparent government. It will ward off suggestions by elected officials of filing lawsuits against members of the public for harassment. 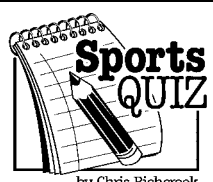

Chicken Fried Steak with Sawmill Gravy

- Ingredients: 6 pieces cube steak about 2 pounds salt and freshly ground black pepper to taste, 1 cup all-purpose flour divided use, 25 saltine crackers crushed, 1 teaspoon seasoned salt, 1 tsp garlic powder, 1/4 teaspoon cayenne pepper, 2 eggs, 1/3 cup milk, vegetable oil or shortening
For the sawmill gravy: 1/4 cup all-purpose flour, 1 1/2 to 2 cups whole milk

Instructions: For the steaks: If your cubed steak is more than 1/2" thick, you'll want to pound it out until thin. This will provide additional tenderizing as well as allowing for more even cooking. Season cubed steaks lightly with salt and pepper. On a plate, place 1/2 cup flour - set aside. In a shallow bowl, mix remaining 1/2 cup flour, saltine cracker crumbs, seasoned salt, garlic powder and cayenne pepper. In another shallow bowl, whisk together eggs and 1/3 cup milk. Dredge cubed steak in flour...then dip in egg mixture...and then finally coat with saltine cracker mixture. Continue the same procedure for the rest of the steaks and place them on a large baking sheet. Heat about 1/2-inch vegetable or shortening in a large pan (preferably cast iron) over medium heat. Note: I prefer shortening for these but use the oil you prefer. Cook steak in 2 batches for about 5 minutes per side. Continue with the rest of the steaks. Remove steaks to a paper towel-lined baking sheet to drain excess oil. For the sawmill gravy: Once steaks are finished cooked, remove excess oil from pan (leaving about 1/4 cup remaining). Add 1/4 cup flour to pan. Whisk and cook over medium heat for 1 minute. Gradually whisk in milk and cook until thick. Whisk constantly and season to taste with salt and freshly ground black pepper. Pour gravy over steaks.

Mr. Willie (Buddy) Golden, Sr. of Bolivar passed away on Thursday, July 4, 2019 at home. Has born in Whiteville to the late Henry and Mary Eliza Norment Golden.



His funeral service was held on Saturday, July 13, 2019 at Union Hill MB Church with Pastor Jerry Crisp in charge. Burial was in the church cemetery and Dixie Funeral Home was in charge of the professional service.

He accepted Jesus Christ at a young age and joined Union Hill MBC where he served faithfully as a Deacon and Trustee until his health failed. In his honor the church finance room was named the Golden Room.

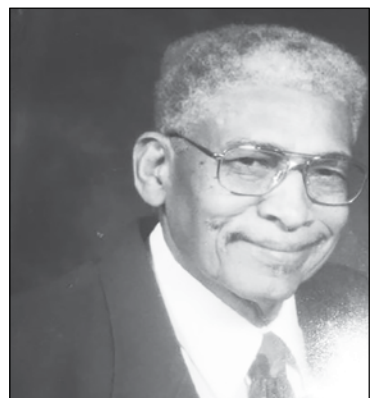

Jesus as God, Part 10 by Jeff Capshaw

As this series has shown, there are many passages in the New Testament which affirm the divine nature of Jesus. However, it is necessary to skip over some NT books; namely, 1 and 2 Peter, as well as I, II, and III John: all fertile ground for exploration. Nonetheless, it is fitting to close this 10-part series with a column based on the last book of the Bible: Revelation.

Although titled "The Revelation of John," it is more accurate to consider the opening of the book: "the revelation of Jesus Christ, which God gave him to show to his servants the things that must soon take place" (Revelation 1:1).

There is a dozen or more passages in Revelation that either explicitly or, at least, implicitly affirm Christ's deity, but space permits only a cursory treatment of a particular refrain attributed to Jesus in the book: the familiar phrase "alpha and omega" or "first and last."

According to Wikipedia, the term Alpha and Omega comes

from the phrase "I am Alpha and Omega" (Koiné Greek: "ἐγὼ εἰμι τὸ Ἄλφα καὶ τὸ Ὠμέγα"), an appellation of Jesus in the Book of Revelation (verses 1:8, 21:6, and 22:13). The first part of this phrase ("I am the Alpha and Omega") is first found in Chapter 1 verse 8 ("1:8") and is found in every manuscript of Revelation that has 1:8." Furthermore, it also has an interesting Old Testament background.

According to G.K. Beale's 1999 Commentary, The Book of Revelation, "there is general acknowledgment that the Apocalypse (Revelation) contains more OT references than any other NT book . . ." (p. 77). For example, and for our immediate purpose, Isaiah writes, "thus says the LORD, the King of Israel and his Redeemer, the LORD of hosts: 'I am the first and I am the last; besides me there is no god'" (44:6). According to Isaiah then--as was revealed to Moses (Exodus 3:14) if there is no "other g-o-d," then there is only "one G-O-D." That

is Yahweh, the God of Ancient Israel, the God of Abraham, Isaac, and Jacob and the Father of the Lord Jesus Christ.

As we saw in the first article of this series, the same author of Revelation, the Apostle John, said in chapter 12 of his Gospel that the Yahweh whom Isaiah saw in his temple vision (Isaiah 6:1ff) was, in fact, Jesus. Recall that John writes, "Isaiah said this because he saw Jesus' glory and spoke about him" (John 12:41).

Specifically, the Alpha-Omega phrase speaks to God's sovereign rule over all of history, and John applies this divine attribute to Jesus Christ in the book of Revelation. Thus, John's understanding of Jesus is consistent in both books. Jesus Christ is God.

Sadly there remains a stigma against mental illness that our society and culture have not overcome. While society continues to struggle about acceptance that a growing number of people have mental illness, people are seriously hurting in silence. It is this silence aspect that is elusive and difficult to grasp in order to help those who are hurting. One such group struggling to cope to overwhelming degrees are those who go on to commit suicide. If you know someone who appears severely depressed days without number, having expressed a helpless, hopeless outlook, has discontinued former ritualistic patterns of activity, displays a disruption in eating and sleeping and has expressed a desire to die or no longer any desire to live or lack of purpose to the point that those close to him or her would be better off without them, then this should be a huge wake up call that person needs immediate intervention.

The difficulty exists as there is a large segment of the population that internally feel the way described above, but outwardly do not display any of these warning signs. For many their internal struggle remains a secret, hidden from those who are closest to them and interact with them on a regular basis. I can think of three such cases in the past three or four years that readily come to mind. In each of these individuals they possessed great talent and potential for the future if their family and friends were interviewed. Yet, in a moment, in a twinkling of an eye (or so it seems) they took their life and those who remain in this world who loved them so are left hurting and devastated as well as puzzled to answer the 'why'? Can Your Family Benefit From a Special Needs Trust?

If you have a child or another family member with disabilities, you obviously have concerns and questions. How can you help your loved one achieve the greatest quality of life possible? Can you arrange for adequate services? What's the best way to pay for them? Can you get some financial help?

Fortunately, you are not alone. Your disabled family member may well be eligible for several government programs. But these programs won't cover everything, so you may want to help close the gaps. Naming a trustee – You could name a trusted family member or friend as a trustee. This choice works well for many people, but it does have the potential to cause familial conflicts. Another possibility is to name a trust company, which can provide professional management, expertise and continuity of administration. You can even name an individual and a trust company as trustees, combining the personal touch of a family member with the technical and administrative skills of a professional trustee.

Funding the trust – You can fund the trust during your lifetime or have it activated upon your passing. You don't have to be the sole donor, either – you can structure the trust so other family members can contribute to it. And a trust can be funded with many types of assets – securities (stocks and bonds), IRA proceeds, insurance death benefits and more.

While it's important you understand the fundamentals of a special needs trust, it's not a do-it-yourself endeavor. In fact, creating this trust can be complex. For one thing, there are a few different types of special needs trust, so you'll need to determine which is right for your needs. Also, it's important to be familiar with the requirements of various federal, state and local benefit programs for people with disabilities. For these and other reasons, it's essential to work with a local estate-planning professional who knows the regulations in your area. criminal court or circuit court. The petition or application for authority to appoint or employ one or more additional deputies or assistants must be heard and determined by a judge (or chancellor) serving the judicial district in which the petition or application is filed. Public Chapter 276 of the Acts of 2005.

The petition must be filed by the sheriff within 30 days after the date of final adoption of the budget for the fiscal year. No order increasing expenditures shall be effective during any fiscal year if the petition is filed outside the 30-day window unless the order is entered into by agreement of the parties. Also, a new officeholder has 30 days from taking office to file a petition and any order entered with respect to such petition may be effective during the fiscal year in which the petition was filed. T.C.A. § 8-20-101(b).

The statutory scheme enacted by the General Assembly for staffing and compensating the sheriff's office through a salary suit is clear. The sheriff must demonstrate that he or she cannot properly and efficiently conduct the affairs and transact the business of his or her office by devoting his or her entire working time thereto; and, the sheriff must show the necessity for the number of deputies and assistants required and the salary that should be paid each. *Boarman v. Jaynes*, 109 S.W.3d 286, 291 (Tenn. 2003). The sheriff is not required to demonstrate an inability to maintain his or her office by using the efforts of his or her staff as constituted and compensated at the time of the filing of the salary suit. *Boarman* at 291. Once the necessity of employing deputies or assistants is established, the appropriate trial court is empowered to determine the number of deputies and assistants needed and their salaries.

In the petition, the sheriff must name the county mayor as the party defendant. The county mayor is required to file an answer within five days after service of the petition, either admitting or denying the allegations of the petition or making such answer as the county mayor deems advisable under the circumstances. The petition and the answer are to be docketed, filed, and kept as permanent records of the court. The court must promptly in term or at chambers have a hearing on the application, on the petition and the answer. The court will develop the facts, and the court may hear proof either for or against the petition. The court may allow or disallow the application, either in whole or in part, and may allow the whole number of deputies or assistants applied for or a less number, and may allow the salaries set out in the application or smaller salaries, all as the facts justify.

The trial court does not have the authority to order retroactive pay for personnel hired by the sheriff prior to the filing of the petition to hire and employ deputies.

Either party dissatisfied with the decree or order of the court in the proceedings set out above has the right of appeal as in other cases. Pending the final disposition of the application to the court, or pending the final determination on appeal, the sheriff may appoint deputies or assistants to serve until the final determination of the case, who shall be paid according to the final judgment of the court. T.C.A. § 8-20-106.

The cost of the suit is paid out of the fees of the sheriff's office.

Joy Set to Appear July 26

Bolivar Citycouncilman Jonathan Joy is scheduled to appear before Judge J. Weber McCraw in Circuit Court on July 26, with a court date for a trial currently set for September 9, 2019.

Joy was charged in May with one count of theft over \$1,000 and one count of official misconduct. Joy allegedly overbilled Hardeman County for the sale and installation of five air conditioning units. Joy, who is the owner of Joy Heating & Air, was hired to install new air conditioners at multiple county facilities between August 2017 and June 2018.

Investigators determined that Joy installed air conditioners that were rated for less tonnage than what the county ordered, and then billed the county for products with more tonnage. For example, in January 2018, Joy installed a 6-ton air conditioning unit at the Hardeman County Health Department, and then invoiced the county for a higher priced 7.5-ton product.

Investigators determined that Joy overbilled the county \$1,609 for the sale and installation of five air conditioning units.

Joy, who was elected to city council in 2017, will be up for re-election in 2021. If convicted, Joy would be removed from the council, according to the City of Bolivar charter.

Changes in Hardeman County Bus Routes

Hardeman County Schools is making some changes in our bus routes for the 2019-2020 school year. Below are the schools and routes that will be affected. We ask that you review this information carefully and call us at 731-658-3444 if you have any questions about which bus your student will be riding and the approximate time for pick up in the mornings. We also ask that you be patient with our drivers as we implement these changes to our routes. These changes are also posted on the district website at: www.hardemancountyschools.org Thank you.

Below are changes in bus routes for the Toone and Bolivar zones that may impact your students.

- Buses #1 and #5 are being eliminated.
- Bus #31 will pick up current route plus students zoned for Toone on Pine Top, Harris and Isaac Jordan Roads
- Bus #9 will cease to pick up on McNeal Street, which runs in front of the Columns. Bus #9 will pick up Hwy 125 North, Fitts-Ross Rd, Ebenezer Rd, Hwy 100 toward Bolivar from Pine Top Rd, Naylor Rd and Cloverport Rd, which are zoned for Bolivar. Bus #9 will continue to pick up students on Main Street, entering Bolivar on Hwy 18 North. This includes most of Bus #1's old route.
- Bus #58 will cease to pick up on Elmview Street. Bus #58 will pick up the rest of its current route, adding McNeal Street, Madison Street, Butler Street, West Jackson Street and the area around Bolivar Municipal Center, North Washington Street and the area around the Bolivar Library. These areas include parts of Bus #1's and Bus #9's route in Bolivar.
- Bus #60 - Current Route and add Elmview Street, which is off of Sain Rd.
- Bus #6 will keep current route and will add Walton Road and Vildo Road, between Old Hwy 64 and New Hwy 64. Bus #6 will not pick up students north of New Hwy 64. These are students that were a part of bus #5's and bus #13's old routes.
- Bus #13 will no longer pick up on Vildo road between Old Hwy 64 and New Hwy 64, the area beside/behind the Hardeman County Fairgrounds and will no longer pick up on Jackson Street or Lee Street. Bus #13 will pick up all of Vildo Road, north of New Hwy 64, and Walton Road, North of Hwy 64. This is part of Bus #5's old route. In addition, Bus #13 will pick up on Pleasant Creek Lane, which is across from Joe's Restaurant.
- Bus #11 will continue its current route and add Jackson St. and Lee St.
- Bus #25 will cease to pick up students behind Jervis, Young Road and Roger Avenue. Bus #25 will pick up all students in the Country Club Area, including Hines Blvd, Stevens Road, Lucy Black Rd, Nuckolls Rd, Janet Rd, Blue Bonnet Ln, Karen Drive and El Capitan. This includes parts of Bus #5's old route
- Bus #56 will pick up all students for BCHS, BES & BMS on Tate Rd, Young Rd and Roger Avenue, including all the area behind Jervis.

Below are changes in bus routes for the Grand Junction zone that may impact your students.

- Buses #18 and #53 are being eliminated.
- Bus #61 will pick up the area around Grand Junction Elementary School, west side of Grand Junction, area around the Grand Junction Library, west of Grand Junction on Hwy 57, Hwy 18 to Hwy 368, Hwy 368, area around CO-OP, Smith Drive and Holder Road.
- Bus #41 will pick up in Saulsbury, south of College Street, Indian Creek Road and Park Swain Road.
- Bus #42 will pick up the area on and around Van Buren Road from Lake Hardeman Road to Hwy 57 in Saulsbury. Bus #42 will not pick up/drop off on Hwy 57.
- Bus #45 will pick up on Hwy 18 South to Hwy 368 and will pick up on the roads adjoining Hwy 18 between Hickory Valley and Hwy 368, which are zoned for Grand Junction and/or Middleton High School.
- Bus #47 will pick up all students on Hwy 57, who are zoned for Grand Junction Elementary/Middleton High School and live in the Grand Junction Zone.
- Bus #19 will pick up students on College Street, Sparkman Road, Smith Road, April Subdivision, Greenville Subdivision and other adjoining roads between Saulsbury and Grand Junction.
- All Students will transfer at Grand Junction Elementary School at 7:15 AM.
- Buses #19, #45 and #47 will transfer students to Middleton High School.
- High School students from Bus#42 will transfer to Bus #19, Bus #41 will transfer to Bus #45 and Bus #61 will transfer to #47.

Below are changes in bus routes for the Middleton zone that may impact your students.

- Buses #20 and #26 are being eliminated.
- Bus #43 & #48 will continue to pick up students from Bus #26, as they picked up for the 2018-2019 school year.
- Bus #21 will pick up all students from Buses #20 and #21 on Hwy 57 toward Pocahontas and the Pocahontas area.
- Bus #21 will no longer pick up between the railroad tracks and Middleton Elementary School.
- Bus #27 will pick up/drop off students between Middleton Elementary School and the railroad tracks, Pinecrest Lane and Southwest Lane.

Below are changes in bus routes for the Whiteville zone that may impact your students.

- Buses #35 and #46 are being eliminated.
- Bus #59 will pick up all students south of Whiteville Elementary School, including Whiteville-Newcastle Road. Bus #59 will no longer pick up/drop off North of Hwy 64.
- Bus #50 will run current route and add Hwy 64 west leaving Whiteville, Day Care on Hwy 64, Ferguson Road and Mt. Moriah Street.
- Bus #16 will run current route plus all of the "In-Town" pickups to Mt. Moriah, including Maple Street, Cross Avenue, Simmons Street and Martin Luther King Jr. Street. Bus #16 will not pick up or drop off on Web Street
- Bus #44 will pick up its normal route on Hwy 100 and Vildo Road and will add Web Street, Seller Street and area around the old Whiteville H.S.
- Bus #54 will pick up all students north of Whiteville on Hwy 179 and the adjoining roads, past Mt. Moriah Street.
- Buses #16 and #50 will transfer students to Bolivar Central High School.

Tales from the Yellow House by Lee McAlpin

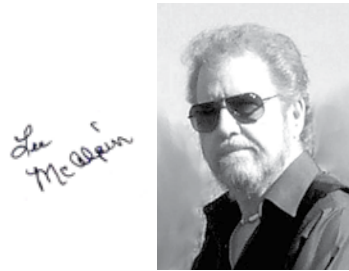
The latter part of August at the Yellow House was sweltering hot like it is today. In weather like this, as I mentioned before, immediately after breakfast, Mom would begin covering the four eyes of the cook stove with black iron pots and skillets in preparation of preparing the daily meals before the temperature reached it's peak for the day. The house was filled with the aroma of the contents of those cooking utensils which kept me hungry all day. Fresh cabbage, peas, beans, potatoes, corn, and usually fatback simmered all morning long. At dinner time (lunch), the family sat down to a rib-sticking, delicious lunch of the produce from the garden. We knew that what we had for dinner would also be what we had for supper, (dinner), served at room temperature.. It was just too hot to fire the old stove up for the evening meal. After dinner, Mom would group the bowls of food in the center of the dining table and cover them with a white table cloth where they sat until the supper meal. We never suffered any effects from E Coli, botulism, ptomaine poisoning or such. Many days in the summer months, the stove had a fire in it all day long while Mom canned all the vegetables and fruit to store for the winter months. She canned everything from corn on the cob to pork sausage. I don't see how she stood the heat, but I guess that we were all somewhat accustomed to it. I remember a lot of times, I would walk into the kitchen where she was cooking. She would stop, wipe her brow and remark, "Seems like all I do is stand in this hot kitchen".

Later in life, when she had air conditioning in her kitchen, I would ask her if she remembered saying that phrase a lot. She would just smile and nod her head. Moms are so precious and giving, most times not thinking of themselves in order for the sake of their families. Mom would spend hours peeling and slicing apples to dry in the



sun, and shelling peas. She would put the dried apples in a flour sack, along with a pod or two of red pepper, to ward off any wandering insects. She also stored the dried peas the same way. She canned some of the best spiced apple quarters and chow chow that I have ever eaten. Sometimes after the canning season was over, I would ask her to open a jar of this and that. She would tell me that we had better save it for some cold snowy day in the coming winter. And on one of them "cold snowy days in winter," she would open the jars up and prepare a mouth watering country meal for all the family. As I've mentioned before, we did not have any indoor plumbing, but we did have some outdoor plumbing. Our kitchen sink was outside the back door of the kitchen nailed to the wall. Being the innovative sort that country people are, Dad attached a funnel shaped tin bucket to the outside wall on the left of the kitchen door, attached a long metal pipe to the bottom of it and ran the pipe out across the yard into the edge of the cotton patch. You could open the door and pour the dish water into the bucket and it was carried away to the cotton patch. No sewage bills here, and it made a great place to dig big fat earthworms for our fishing trips. My youngest sister Joyce and I usually had the dishwashing chores. We used two dish pans for

the process. One for washing and one for rinsing. I was the dryer. I just never could get into dishwashing. I did get into a lot of trouble while drying the dishes. I couldn't resist the temptation of splashing a little water in sister's face, or popping her with the dry towel. And she was happy to see me get into trouble. While I was getting my punishment, she would stand aside and giggle, which made me want to do it all over. I remember a few times that prior to my punishment with the switch for a no-no that I might have done, I would run around the house with Mom and the switch steadily a few paces behind. I would gain ground and bend over, look under the house (no underpinning) to see where her legs were located and play cat and mouse with her. That worked for awhile until my oldest sister came out the back door and they cornered me between them, where I gave up. The whooping was twice as bad at these times because I got my deserved licks for the deed I done, and extra licks for running. So goes the life of a country boy.

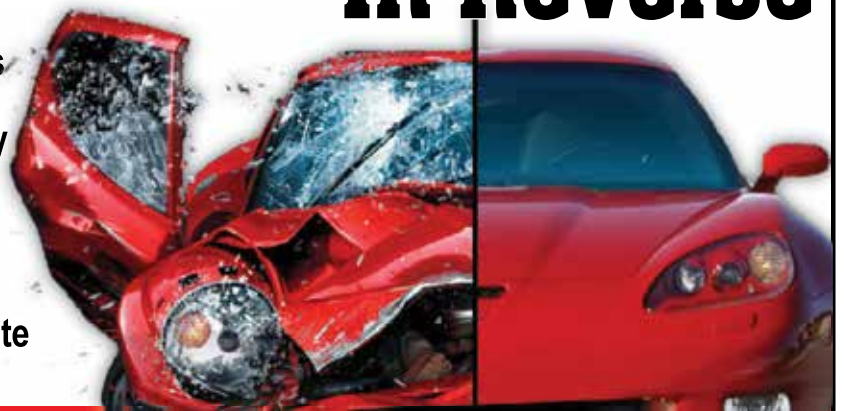


