We checked, and mom says you can chew gum. But mom says you can't lick your fingers, wipe sweat with your hand, or whistle with your fingers.



Picking Up Where They Left Off

Hardeman County Sheriff John Doolen's lawsuit against Mayor Jimmy Sain will continue on June 30, but a lot has changed since the February 27 hearing on the Motion to Set Aside the Consent Order was first heard.

Among the changes is Judge J. Weber McCraw will not continue to preside over the hearing, as requested by Doolen's attorney, Roy Herron of Dresden.

Replacing McCraw will be Tony Childress of the 29th Judicial District. Appointed as Chancellor in 2008, Childress is a UT-Martin graduate (1988) and received his law degree from the University of Memphis in 1992.

McCraw's order of recusal said that while he disputed "many of the assertions for recusal presented by the petitioner (Doolen)" he In Case You Were Out of Town In July of 2019, following the passing of the 2019-2020 budget, Hardeman County Sheriff John Doolen sued for more support.

The issue was seemingly settled in October 2019 after Cary and Herron came to an agreement and Cary presented it to the county commission in a special called meeting as the sheriff's department, who originally sought and sued for approximately \$1.4 million dollars, settled for \$102,000.

At the October 8 meeting, the vote went 13-1 in favor of ending the lawsuit with the settlement.

While both sides claimed lack of adherence to the settlement terms, Attorney Amber Griffin Shaw filed a Motion to Set Aside the Consent Order on behalf of Sain on February 10, citing numerous problems with the consent order, including a delay in respondent's filing of a response, the lack of a hearing within a reasonable time frame, and fees that they felt were extraordinarily high in the case.

Prior to the hearing, Shaw said an offer was made to settle the case without the hearing, but it was declined.

would step aside "...in order to avoid any appearance of personal bias or prejudice in this matter."

Another change is that there is a whole new budget to deal with. In July of this year, the Hardeman County Commission passed the 2020-2021 budget, with numbers for the sheriff's department very much alike the figures that triggered the lawsuit in 2019. Doolen has thirty days from the passage of the budget (June 16) to file an objection.

Also, it is unknown if the resumption of the hearing will attempt to clear up the perceived inconsistencies in the testimonies of Sain and Cary on February 27 (see inset), which appear to have very little to do with the actual substance of the motion in question.

The June 30 hearing will take place in either Bolivar City Hall or the county courthouse, as the Hardeman County Criminal Justice Center is not available on that date.

Suffering as a Christian

by Jeff Capshaw

The Apostle Peter is a favorite New Testament character for many. He wasn't highly educated, and he was brash, bold, and rough. Peter was a simple fisherman. Yet, in the providence of God, he wrote two New Testament letters that bear his name (I and II Peter). In both he wrote to people who were undergoing persecution and difficult times in their lives. Sound familiar?

One author described the background to I Peter this way. He probably wrote the letter from Rome A.D. 62–63 during Nero's reign. The letter is addressed to Christians scattered in "Pontus, Galatia, Cappadocia, Asia, and Bithynia" (1:1). This is an area north of the Taurus Mountains in Asia Minor (modernday Turkey). These territories had been impacted by Greco-Roman culture and had been under Roman control from the mid-first century B.C.

A key theme in the book entails enduring with hope during persecution, during suffering. That is easily applicable today, although few American Christians undergo real persecution. Nonetheless, it isn't exaggerating to suggest that these are hard times, and they cause various forms and intensity levels of suffering. What does Peter have to say about that?

"Beloved, do not be surprised at the fiery trial when it comes upon you to test you, as though something strange were happening to you. But rejoice insofar as you share Christ's sufferings, that you may also rejoice and be glad when his glory is revealed. If you are insulted for the name of Christ, you are blessed, because the Spirit of glory and of God rests upon you. But let none of you suffer as a murderer or a thief or an evildoer or as a meddler. Yet if anyone suffers as a Christian, let him not be ashamed, but let him glorify God in that name" (1 Peter 4:12-16).

Several brief lessons are embedded here. First, especially for a comfort society like ours, don't be surprised when hard times come; that's just life and not strange. A second theological lesson is this. When believers suffer, they share in the sufferings of Christ. Paul says this in 1 Corinthians 12:26: "if one member suffers, all suffer together; if one member is honored, all re-

joice together." Thus, believers are never truly alone in hard times, although it may feel like it.

Third, since believers are going to suffer at some point in life, Peter urges them to not suffer for wrong behavior. Rather, genuine hope and God's grace come when believers suffer unjustly but patiently, even during circumstances beyond their control or simply for being a Christian

Remember that believers one day will sing and truly agree with America's poet, Bob Dylan. "Tis the song, the sign of the weary. Hard times, hard times, come again no more. Many days you have lingered all around my cabin door. Oh hard times, come again no more."

Finally, "and after you have suffered a little while, the God of all grace, who has called you to his eternal glory in Christ, will himself restore, confirm, strengthen, and establish you" (1 Peter 5:10).

Can You Lower Your "Reliance Rate" During Retirement?

If you have decades to go until you retire, you don't need to panic over volatile financial markets - you have plenty of time to regain lost ground and potentially achieve more growth in your investment portfolio. But what if you are nearing retirement or already retired? After all, you will probably need to draw on your investments to pay for some of the costs associated with housing, food and the many other expenses you incur in daily life. So, is a down market cause for alarm?

It shouldn't be. And you can help reduce your stress level by understanding your "reliance rate." As its name suggests, your reliance rate tells you how much you rely on your portfolio - rather than other sources, such as Social Security or a pension - to meet your income needs during retirement. So, for example, if you need \$60,000 each year, and \$40,000 comes from your portfolio, your reliance rate is 66

Your reliance rate can influence your emotions and investment behavior. A higher reliance rate may tempt you to make emotional decisions during a market decline, since your portfolio is supplying more of your needs. However, if you respond to a steep market drop by making dramatic changes to your portfolio, you may actually increase the likelihood that your money may not last. This is especially true if you move a large portion of your portfolio to cash, as cash does not typically provide growth potential to help keep up with inflation.

There is no "recommended" reliance rate for everyone, But, as a general rule, the higher your reliance rate, the more sensitive your portfolio may be to fluctuations in investment prices. What can you do, then, to either lower this rate or, at least, moderate the risk level attached to it? Here are some suggestions:

Adjust your expenses. During retirement, some of your expenses, such as commuting and other costs associated with work, will go down, but others - particularly health care - will go up. You can't control all these expenses, but the more you can keep them under control, the less pressure there will be on your investment portfolio to provide you with income.

Review your plans for Social Security. You can file for Social Security benefits as early as 62, but your monthly checks will then be reduced by about 30 percent from what you'd receive if you waited until your full retirement age, which is likely between 66 and 67. You can receive even more if you wait until 70, at which point your benefits will "max out." So, if you can afford to push back the date at which you start taking Social Security, you could lower your reliance rate.

Keep cash and short-term investments in your portfolio. Try to keep about one year's worth of living expenses in cash or cash equivalents, and about three to five years' worth of expenses in certificates of deposit and other short-term income-producing vehicles. Having these assets available can help you avoid liquidating long-term investments when their prices are down.

Your investment portfolio will certainly be a key source of your retirement income. And by understanding how reliant you are on your portfolio, and the options you have for reducing this reliance, the better prepared you'll be to withstand the inevitable market downturns.
