Public Pulls a No-Sh

The Bolivar City Council passed the 2018-2019 budget on June 25, but not without some early 4th of July fireworks from the city council on the subject of raises in front of only three audience members.

Joy, who said employees in Brownsville and Selmer make more than Bolivar workers, was adamant the city council needed to open the coffers.

"Looks like y'all don't want to give them nothing," he said. "Let's not leave them out of the budget. They are the budget."

Councilman Larry McKinnie, who is the Budget Chairman, told Joy he was missing a piece of the picture.

"Have you looked at the benefits we provide like healthcare? Our employees pay almost nothing."

"They're making nothing," Joy snapped back.

Councilman Tommy Woods tried to bring a moment of calm, saying, "If the money's not there, it's not there. If it is there, let's knowns in areas such as the EMS talk about it."

Council Wonders About EMS Building

The City of Bolivar's budget talks took a side road as Mayor Julian McTizic told the story of the EMS Building being constructed on Lucy Black Road just west of Bolivar.

According to the narrative provided by McTizic, in 2014, the City of Bolivar began to search for an annex for the fire department, but for various reasons, came up empty.

The election of Mayor Jimmy Sain in Hardeman County led to Bolivar entering a partnership with the county to share a building to be constructed on Lucy Black that would house the EMS and an annex for Bolivar Fire and Rescue. The city council entertained Sain's idea and passed it in 2015, charging then-Mayor Barrett Stevens with signing the agreement.

Three years later, the building is still in progress and McTizic is waiting for the cost.

"The council agreed in 2015 to pay 25% of the cost of construction and I have asked the county multiple times to see the contract, but I haven't seen it yet," said McTizic. "We have set aside \$20,000 each year in the budget to pay for it."

"It's a county building," continued McTizic. "I have no idea of the progress or the cost involved. We are not involved with the construction. We are waiting to see the signed contract from 2015 or waiting for a lease agreement."

The cost in 2015, according to McTizic, was estimated at \$800,000.

future change in dispatch administration and costs, Mayor Julian McTizic was apologetic but firm in his assertion that the money was not there to give raises.

"No one on the council is against employees and giving them more. But this amount (estimated \$80,000 surplus) isn't money in the bank. It's just on paper," he said, adding that in the 2017-2018 budget projected revenues fell short almost \$200,000 and actual expenses were \$10,000 more than budgeted.

After a heated discussion, but without Joy making a motion to give raises, the council passed the budget by a 5-2 margin, with Joy and councilman Melvin Golden voting against it.

The second reading of the budget ordinance allows for public comment on any aspect of it, but only three members of the public were in attendance at the meeting.

Councilwoman Suzanne Rhea did not attend the meeting.

Some of these include intersections of Highways 138 and 100, Highway 138 and Kilgore Rd., and school zone lights at Highway 138. I initiated the Backpack for Kids Project along with Emily Parks and Warner Ross. This project was instrumental by providing any child in need with ready to-eat meals and snacks when at home on weekends. Additionally, I oversaw the project of building a helicopter pad in continued on All






If you needed dessert (I mean, why not?), they had a large assortment of candy bars and ice cream.

Apparently my love of costumes and Americana started early as is evidenced by this photo of me in the 4th grade. I was chosen to be Uncle Sam in our school pageant because I was the tallest person in the 4th grade (and trust me, it was a big deal to be taller than the boys and I'm sure I reminded them of that very thing). I recited a poem about America and my Mom made my costume (I still have it) and we made the hat together out of poster board and construction paper.

The character of "Uncle Sam" became a nickname for the United States government after the War of 1812. A gentleman named Samuel Wilson was a meat packer in New York, and he supplied barrels of beef to the Army during this war; the beef began to be referred to as having come from "Uncle Sam" because of the U.S. stamped on the side of the barrels, and the name stuck. The iconic image we all associate with Uncle Sam – the white-haired, stars and striped-clad gentleman – was created by cartoonist Thomas Nast. (Nast, by the way, also created the iconic images of Santa Claus that many of us associate with that jolly old elf.) Uncle Sam began recruiting for the U.S.

Army during World War I, after he had a slight makeover by another artist, James Montgomery Flag, who tweaked the clothes and had Uncle Sam pointing at the viewer with his now famous "I Want You" slogan.

The document that became the starting point for our freedoms was written by the Committee of Five which included Benjamin Franklin, John Adams, Thomas Jefferson, Roger Sherman, and Robert R. Livingston: Jefferson penned the majority of the document as he was regarded by his peers.

ingston; Jefferson penned the majority of the document as he was regarded by his peers in the Continental Congress to be their most eloquent writer. The 56 men who signed the document (who, by the way, in signing the document committed acts of treason against the King of England) were all ages and came from a variety of backgrounds – just like the new country itself, made up of people from far flung places who all came in search of their own freedoms.

As we celebrate our country's birthday this year take a few minutes during your celebrating this weekend and remember the patriots who declared the truths and tenets of a new nation, this place we all call home.

Let freedom ring, v'all.








Tales from the Yellow House by Lee McAlpin


At the Yellow House we made do with what we had. Country people have the knack for devising innovative things to help "make do." We did not own a cow, but we had neighbors who did. One particular family who lived across the creek, or branch as we called it, had a couple of cows. On days that they could spare an extra gallon of milk, they would hang a white bed sheet on the northwest corner of their house to let us know to bring our jug over. It was a welcomed sight on the mornings we looked and seen that sheet blowing in the breeze. The good wholesome milk that came straight from the teat to the bucket, to the consumer. No pasteurization here, the whole, real thing it was, and good unless the cows had dined on bitterweed plants prior to the milking. Mom did not have a churn, but she made butter. She would fill a half-gallon fruit jar with milk, screw on the lid and with one hand on the lid and the other on the bottom of the jar, she would swing the jar from right to left sloshing the milk inside until chunks of butter would form on top. She would ladle these chunks out and repeat the process until she had enough to mold a little mound of butter. She would take a fork and sculpt little designs on top of the butter. Now that is a good example of "make-do". With no fridge, at night Mom would place the jug of milk inside of the well bucket and lower the bucket just below water level in the well. This would keep the milk from going blinky as we called it, or going bad. The fresh thick buttermilk would leave a big circle of white around our mouths. We would crumble a pone of cornbread in the buttermilk and dine on that delicious meal. One man that I knew would




cut up onions and raw Irish potatoes in his milk and cornbread. And the butter was great stirred into a plate of soghrum molasses and sopped with a biscuit.

The ice man made his rounds past our house once a week. I believe it was from the Bear Ice and Coal Company in Bolivar. If we had any surplus money, Dad would hang the ice card on the front porch, top number denoting the pounds of ice that we wanted. He stored it in a wash tub and covered it with a white cloth and an old quilt. He would have to hide the ice pick to keep us kids from picking off a flake now and then. We did not own an ice cream freezer either. But Dad made do. When he couldn't borrow a hand crank freezer, he would put the milk, flavorings, etc., in an eight pound lard bucket, surround it with ice inside of a larger bucket, salt the ice down, and with his hands on the bucket pail, twirl the lard bucket round and round until the hardened mixture started to adhere to the sides of the bucket. He would open the

lid and scrape the sides down and continue to spin it until it reached ice cream consistency. Five hungry mouth watering kids stood holding their cups and spoons and asking every second spin if it was ready yet. We would eat it so fast, hoping for second servings, that it would freeze what we called that little funny thing in the roof of our mouths that would cause an Excedrin # 2 headache. I heard someone mention it recently as brain freeze. It was one of our biggest treats of the summer. I just checked my fridge and I don't have one smidgen of ice cream. Don't want to, but I've just got to drive to the supermarket for a gallon to satisfy my ice cream craving.

5. The statement was also made that you want to have all the agencies in Hardeman County work better together but just a few weeks ago I just read an article in this newspaper that implies that in truth you're the great divider in a memorandum drafted and signed by you that stated that you did not want county deputies called to incidents in your city. I challenge you to open your crime statistics to an independent auditor or the state comptroller's office and see if they reconcile with those numbers you have presented.

6. One of the greatest expenses the County Government bares is the Jail/CJC. With you having no known experience in correctional administration, how will you prevent the jail from starving the county in the short and long term. A city and a county government runs entirely different and you should be advised that the Sheriff is the Head of his office and not a department Chief there is no city administrator to bail you out and buffer between you and the mayor. As a Sheriff the buck truly stops with you.

In summary we have a very capable, honest and approachable Sheriff. Sheriff John Doolen doesn't become everything a voter wants just a year before election time. He has remained the same for the entire time he has been a resident of Hardeman County which is over 20 years.

deceiver (2 Corinthians 11:14; Revelation 12:9), he is the cause of the majority of life's ills. For those who think there is no such thing as this character I am referencing as Satan, this is a moot point. Worldview- Part 10 by Jeff Capshaw

For the last nine weeks, I discussed components of the Christian worldview. In this final installment, I briefly summarize them.

Everyone has a worldview: whether they are conscious of it or not. Worldviews ought to answer life's fundamental questions: origin, meaning, morality and destiny. Furthermore, a worldview works like a pair of colored spectacles, like Google maps, and a connect-the-dot puzzle. Thus, worldviews filter all reality, help us navigate life and make sense of things.

I urged Christians to assume two non-negotiable starting points: the existence of the triune God of Scripture and the authority of the Bible. Moreover, a Christian ought to assume that both are selfattesting and self-authenticating, because there are no higher ultimate authorities to prove them. In spite of this circularity, these two interdependent starting points are not viciously circular. Actually, all thinkers assume their premises to draw conclusions.

Scripture is totally distinct from the rest of His creation, but all creation is contingent upon Him. Therefore, that distinction must not be blurred or conflated.

Additionally, Christians must affirm the Lordship of Christ over all creation; this includes his Lordship in every area of knowledge. Since Christ is the Creator of all things visible and invisible, it is incumbent upon believers to submit to his Lordship in their thinking also: not just in their behavior.

Christian thinkers should also reject autonomous thinking. Genuine autonomy is a futile attempt to proceed as though no deeper religious motives exit. However, it is impossible to theorize apart from some divinity (religious) belief, whether the divinity is named or implied. Since any alleged autonomy is merely "pretended," Christians ought unapologetically to proceed with an intentional confession of and submission to the mind of Christ.

Another principle inherent in a Christian worldview is antithesis. between belief and unbelief and, therefore, between belief and any compromise of biblical truth. Still further, since there are only two ways of interpreting any fact (either Christian or non-Christian), then the believer must reject all claims of neutrality. On a distinctly Christian worldview, there simply is no such thing as neutrality.

Finally, it seems the Christian worldview would preclude finding any common ground for dialog with opposing worldviews. However, this isn't the case. Since all worldviews are espoused by humans who are created in the image of God, believers must rely on the Word of God and those truths anchored in their worldview to appeal to the image of God in all opponents.

In sum, failing to keep the above in mind or yielding to temptation to compromise them, will lead the believer to one or both unpardonable philosophical sins: arbitrariness and or inconsistency. After all, it is the unbeliever who is self-deceived and suppresses the truth, but the Christian has access

Paul was speaking about his own life when he said, "Not that I speak from want, for I have learned to be content in whatever circumstances I am." (Philippians 4:11) So many people in our society live lives that could only be described as "discontented." They are never satisfied, never content with where they are in circumstances of life. They are



always searching for things that will make them happy and bring fulfillment; and to them, life is a never-ending struggle to see who has the most stuff. The scriptures teach us NOT to be discontent, but to be content in **1 Timothy** 6:6-8, But godliness actually is a means of great gain when accompanied by contentment. For we have brought nothing into the world, so we cannot take anything out of it either. If we have food and covering, with these we shall be content." Contentment has value!

Contentment frees up valuable time.

Can we imagine saying no to the rat-race to get more and more? Can we imagine what it would be like to say to ourselves, "I have enough" or "I'm good." That is the freeing power of contentment with God. It frees us from the slavery to feel compelled to always want more than you have. When we get to a state of contentment, we will have the time back that would otherwise be spent working 2-3 jobs or overtime just to keep up a lifestyle of discontentment. Not only is it an expensive drain on our finances, but it robs us of valuable time we need with our family and especially with work in God's kingdom. The Bible teaches us that we need to be "redeeming the time" (Ephesians 5:16), and we cannot do that effectively if we all of our time is spent in pursuing more and more. Instead of always shopping and hanging out at the malls to look for more stuff, why not use that time productively in Bible study, evangelism, visitations, attend more gospel meetings, and so forth?

Contentment would reduce our stress level.

One of the major problems of discontentment is that it is very stressful! It is tiring and stressful to work extremely hard to pay for things we can't afford otherwise. A good rule of thumb would be: If what we're doing is stressing us and draining us emotionally or physically, than maybe it's not worth the price of discontentment. Doctors tell us that stress can be dangerous to us physically- as it is one of the major causes of health problems in America today. Not to mention the fact that when we are stressed, we are no fun to be around. It is not a pleasure to be in the company of someone who is uneasy and always stressed out. And if people in the world see Christians that way, then our influence will not be seen in a positive light (Matthew 5:13-16). Maybe what we need is to be content with what we have already, and be blessed and not stressed!



Next, Christian thinkers must keep the Creator-Creature distinction in mind. The God of Since the Bible claims to be absolute truth, there is an antithesis in all of reality: the diametrical opposition

to the truth and the testimony of the Holy Spirit.







Guidelines for Fireworks from Bolivar



The City of Bolivar and the Bolivar Police and Fire Rescue reminds citizens that within the Bolivar city limits, fireworks may only be discharged or set off between the hours of 12:00 Noon and 10:00 p.m., except for New Year's Eve.

Within the city limits of Bolivar, you may only discharge or set off fireworks at your own business or residence.

Igniting and/or final firing or exploding of fireworks shall be done entirely within the property lines of your own property!

• Do not throw fireworks from any automobile or any other moving vehicle, regardless of whether the vehicle is in motion.

• Do not set off fireworks with 100 feet of any gasoline pump, gas station, or any building where gasoline or volatile liquids are sold or stored.

• Do not set off fireworks within 100 feet of a hospital, nursing home, or school.

• Do not throw any ignited fireworks at any motor vehicle, at any person, or at any group of persons.

Potomac Horse Fever Confirmed in Tennessee

The State Veterinarian is advising all horse owners to be alert as Potomac horse fever has been confirmed in a horse in Davidson County, Tenn.

Freshwater snails are the source of the bacteria that causes Potomac horse fever. Horses may be exposed when drinking from creeks or rivers, and can then suffer from colic, fever, and diarrhea. Potomac horse fever has not been found to directly transmit from horse to horse.

Another potentially deadly disease, strangles, was confirmed in four horses at a private facility in

Shelby County last month. This disease is a contagious upper respiratory tract infection that causes lymph nodes to swell around the head and neck, possibly leading to coughing, difficulty swallowing, airway obstruction, or death. Other symptoms can include nasal discharge, fever, and depression. According to the veterinarian treating the Shelby County horses, all are improving and are under voluntary quarantine until they fully recover.

Neither strangles nor Potomac horse fever are a threat to human health.

"Potomac horse fever and strangles are serious infections, and if you notice any signs of illness in your horses, you should contact your veterinarian immediately," State Veterinarian Dr. Charles Hatcher said. "With these confirmed cases in Tennessee, we urge horse owners to be sure their horses are protected by using best management practices, which includes consulting with your local veterinarian for appropriate vaccination needs and schedules."

Dr. Hatcher also suggests the following recommendations for horse owners to prevent disease:

- Regularly disinfect stalls, water buckets, feed troughs, and other equipment
- Eliminate standing water sources where disease-carrying insects may gather and breed

• Avoid co-mingling your horses with other, unfamiliar horses

The State Veterinarian and the staff at the Tennessee Department of Agriculture's C. E. Kord Animal Health Diagnostic Laboratory are strongly committed to supporting horse health. The laboratory offers veterinarians advanced testing to confirm several equine diseases, including influenza, leptospirosis, salmonellosis, clostridiosis, herpesvirus, West Nile virus, and equine protozoal myeloencephalitis. USDA to Help Producers in Tennessee Prepare for Addition of Seed Cotton to Two Key Safety Net Programs

culture (USDA) is sending acreage history and yield reports to agricultural producers in Tennessee with generic base acres covered by the Agriculture Risk Coverage (ARC) and Price Loss Coverage (PLC) programs. Farm Service Agency State Executive Director Dennis H. Beavers said the information will help producers decide the best options for how to allocate generic base acres, given the addition of seed cotton as a covered commodity in the programs.

The Bipartisan Budget Act of 2018 amended the 2014 Farm Bill, adding seed cotton as a covered commodity under the ARC and PLC programs. This week, FSA will start sending information on current generic base acres, yields and 2008-2012 planting history.

Per the Act, FSA is using the

The U.S. Department of Agri- period 2009 through 2012 to compute the conversion of generic base acres to seed cotton base acres. Also, FSA is using 2008 through 2012 to calculate yield updates to seed cotton. The updates are an important part of preparing agricultural producers in Tennessee and other states to make decisions on allocating generic basic acres and updating yields for seed cotton.

> This summer, producers will have an opportunity to allocate their generic base acres and update their seed cotton yield.

All producers electing to participate in either the ARC or PLC program will be required to make a one-time, unanimous and irrevocable election, choosing between price protection and county revenue protection for the 2018 crop year for seed cotton only. Producers who elected ARC with the individual farm option will continue with that option since that election is applicable to all base acre on the farm. The final step to participate requires producers with farms with seed cotton base acres to sign contracts for ARC or PLC for 2018 this summer.

The anticipated timeline is:

• June 29: Producers are mailed letters notifying them of current generic base acres and yields and 2008 to 2012 planting history.

• July: An online decision tool for ARC and PLC becomes available. Producers have opportunity to update yields and allocate generic base acres for ARC and PLC.

• Late July: ARC and PLC onetime elections occur for seed cot-

• Late July: ARC and PLC signup for 2018 starts for farms with seed cotton base acres.
