Bolivar Gets a "Dear Julian" Letter

It appears the once proposed sharing of a building by Hardeman County and the City of Bolivar is all over but the final paperwork, as Bolivar's request for modifications to the building on Lucy Black Road in Bolivar have been addressed with a letter from the Hardeman County Properties Committee.

In a letter dated February 25, Hardeman County Mayor Jimmy Sain sent a letter to Mayor Julian McTizic, which stated, "In 2016, the City of Bolivar Council voted to lease a proposed fire station facility from the county once constructed. The Engineering company of TLM and Associates were instructed to build a sub-station for the Bolivar Fire Department. The facility was designed and completed on December 7, 2018. The design plans, as required by law, were on display at all times inside

And a Perfect Audit from the State

Bolivar Mayor Julian McTizic announced during the monthly meeting of the Bolivar City Council that the State of Tennessee had given the city a clean audit.

"I'm proud of our employees and department heads," said McTizic. "Especially Lisa Dellinger, our CMFO."

The audit, the first one completed and released since McTizic took office in 2017, had no findings during the 2017-2018 budget year.

between the city and county began in 2015, when the City of Bolivar Industrial Board voted in February to donate the land in the Bolivar Industrial Park for the project, the Bolivar City Council voted to pay up to \$500 for planning for the facility during their March 2015 meeting. The council then voted unanimously, in July of 2015, to approve a lease agreement between the city and the county.

Current city council members present at the July meeting and approving the measure were Tracy Byrum, Todd Lowe, Suzanne Rhea, and Larry McKinnie. Julian McTizic, a city councilman at the time, was not at that meeting. And according to McTizic, who replaced Barrett Stevens as mayor in 2017, the lease agreement was never signed.

the building during construction. Any and all changes to the plans were submitted to the Tennessee Fire Marshall for approval and Chief Lynn Price and Sarah Rice were copied on every report. At no time did the City of Bolivar attempt to correct, submit changes, or disagree on any changes to the plans. Chief Price and Sarah Rice toured the facility frequently as it was constructed. To this date, the City of Bolivar has not occupied or paid any lease payment on the

facility.

"The Hardeman County Properties Committee now has entered negotiations with another tenant. Please respond by March 5th with the city's intentions concerning the facility. Enclosed is an invoice for the approved \$500.00 share of the cost of plans," the letter concluded.

The Bolivar City Council voted during their meeting on March 7 to pay the \$500, but took no other action.

The Governor Comes to Whiteville



Governor Bill Lee made a visit to Hardeman County on March 8, as he attended a round table discussion at the Tennessee College of Applied Technology (TCAT) in Whiteville.

In the round table discussion were Lee, Hardeman County Mayor Jimmy Sain, Hardeman County Schools Superintendent Warner Ross, Tennessee State Senator Dolores Gresham, State Representatives Ron Gant and Johnny Shaw, Lone Oaks Director Ben West, TCAT President Jeff Sisk, Hardeman County Chamber of Commerce Director Laura Hall, and Hardeman County Industrial Board member Larry Crawford. Many educators and local officials attended as well.

It was the first visit Lee, who has made education a big part of his first few months in office, has made to a TCAT since his election.

And Brings Plans for the Schools

One of Governor Bill Lee's first initiatives for his administration that brings education to the forefront was started as he rolled out the Communities in Schools (CIS) program.

Superintendent of Schools Warner Ross, while not knowing the full details of the program, is excited the state is taking an interest.

"We don't know a whole lot about the CIS right now. Only that we will receive support for MHS and BCHS in the form of this program. Our team expects to get more information in the coming weeks. This is an initiative of Governor Lee's State of the State address and his work towards helping "distressed" counties. We welcome his support! I am very encouraged by the Governor's initiatives for CTE/STEM programming for all counties and especially opportunities for our county. His initiatives fit very well with programming and partnerships we have been developing over the past three years," he said.

According to the press release, Communities In Schools (CIS) of Tennessee is an affiliate of the nation's leading non-profit integrated student support network.

Working in partnership with the principal, CIS of Tennessee hires a team member to work directly in the public school to remove the non-academic barriers that keep students from coming to school and being successful in the classroom. The CIS mission is to surround students

Twelve Walk Away from Bus Accident

Eight teenagers, two college students and two adults walked away with only minor injuries when their church van spun out of control on Interstate 840 near I-40 on Saturday night, March 9.

"All weekend long, we were talking about moments God gives us to use for his glory. We had one share the Gospel at the hospital," said Pastor Josh Clark. "We need to take advantage of every moment."

The Parrans Chapel group, returning from "Lift Tour," in Chattanooga, were in a bus loaned to them by Dixie Hills Baptist in Bolivar. Another vehicle, which had the women and girls, were behind them.

"There were storms, wind, and water on the road," explained Clark, who was driving the van. "A big gust shoved us and when I corrected we went into a fishtail, went off the road and tipped over."

Clark said, with the van on its side, most of the group went out the ceiling hatch to escape the van. Most of the group went to the hospital, where they were treated and released.

"Everyone was banged up and some required stitches. But it could have been much worse."

Loving Our Enemies-Sermon on the Mount: Part 8

by Jeff Capshaw

Last week I discussed the principle of not retaliating whenever another betrays, dishonors, hurts or flat-out disrespects us. True discipleship avoids anything resembling thug life. It isn't about getting even or taking "an eye for an eye," etc. Instead, Christ calls disciples to behave in counter-intuitive ways.

I cited Craig Keener's commentary which says, "turning the other cheek summons disciples to neglect their honor and let God vindicate them when he wills" (5:39). Yes, it is hard, but later in the sermon, Jesus reminds his hearers . . . "strait is the gate, and narrow is the way, which leads unto life, and few there be that find it" (Matthew 7:14). In this week's lesson, we are confronted with "straight and narrow" sayings: loving our enemies.

He said, "you have heard that it was said, 'You shall love your neighbor and hate your enemy.' But I say to you, love your enemies and pray for those who persecute you, so that you may be sons of your Father who is in heaven" (5:43-45). Here is another instance of thinking or feeling that I should do X, but

instead--as a Christian--I should do Y. It is counterintuitive.

For example, there is a scientific principle known as the Mpemba effect. Under certain circumstances, a warmer body of water will freeze faster than a cooler body in the same environment. It doesn't seem to make sense. Similarly, Jesus calls believers to set aside our natural inclinations, our intuition, our gut feelings or even common sense in order to take the high, moral ground. Loving and even praying for our enemies is another classic example of "Jesus stuff." Our sinful nature desires to seek revenge toward our enemies but not Jesus, and he provides several reasons for this.

First, he reminds us that God himself is good to those who are unjust. God causes the sun to shine and the rain to fall on the unjust and the righteous (5:45). Second, he reminds us that it isn't hard to love those who love us; even society's lowest in Jesus's day (tax collectors) do that.

Finally, Jesus says that showing the courtesy of greeting others is something that unbelievers do (5:47). That is not a big deal. But loving and praying for someone

who is actively opposed or hostile toward us? That is a big deal. That is heroic behavior, exactly the kind to which believers are called. It preaches the Gospel to your enemies and strengthens you.

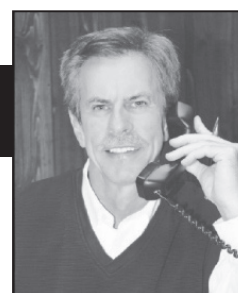

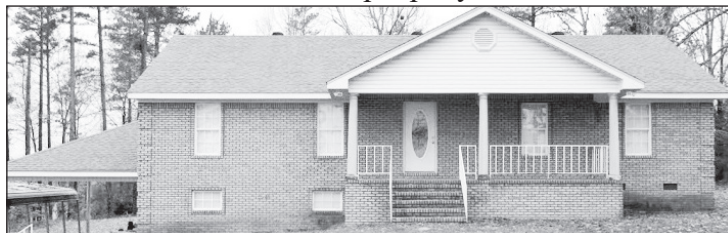

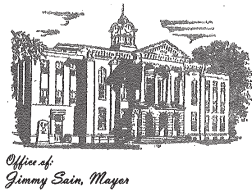

Bolivar Gets a "Dear Julian" Letter continued from A1

In December of 2018, the county opened the 22,400 square foot facility, built at a cost of approximately \$980,000, for an EMS/Fire Station annex combination building, but Bolivar balked at completing the deal, citing an inadequate workspace, including lack of floor drains, for the fire station and a need for more work to be done to get it ready for them, using a report from the University of Tennessee Municipal Technical Advisory Service (MTAS) as their guide.

Dear Mayor McTizic;

In 2016, the City of Bolivar Council voted to lease a proposed fire station facility from the County once constructed. The Engineering company of TLM and Associates were instructed to build a sub-station for the Bolivar Fire Department. The facility was designed and completed on December 7, 2018. The design plans, as well as the building during construction, were on display at all times inside the Fire Marshall for a time of...

The MTAS report, dated December 2018, highlighted the changes needed, such as 1. Drains in the apparatus bay floors, 2. A slip resistant apparatus floor, 3. No asphalt and no concrete apron at the apparatus bay exit, and 4. The lack of a straight path from the parking lot to the road. Twenty-three other suggested changes were in the MTAS report.

"It never was designed to be a full-blown fire station," said Sain. "The MTAS report details what it would take to have a full-blown fire station. This was always designed to be a sub-station. But we are good with the building and have other uses for it."

Seven schools in West Tennessee were chosen, including Bolivar Central and Middleton High Schools.

Participating school districts will not pay for CIS of Tennessee to serve their schools for the three-year pilot program. Recently the Piney Grove Solid Waste Convenience Center that served the Silerton, Piney Grove and Ebenezer communities was suddenly closed. The reason given by Mayor Sain was that the property had been sold and the new owner demanded that the equipment be moved within 24 hours. The notice of closure was posted on Thursday indicating that the last day of operation would be the following Saturday, three days later. More than a month later, some of the county's equipment and the fence are still in place.

Local residents began searching for a new location to re-build and three possible sites for leasing were identified after talks with owners. Then we were told the center would not be replaced. Instead, we could use a soon-to-be new and improved center at Hornsby or we could use the Toone facility. It is 25.0 miles round trip from by house to the Toone facility; Hornsby is farther. Many of our area residents are elderly and live farther from a "convenience center." We already notice waste being thrown along Hwy 125 and other roads, in streams such as Piney Creek, and other environmentally damaging areas. Burn barrels are appearing in yards and residents are illegally burning trash.

Residents of this area feel that we have been treated unfairly. We will continue to work to get a local place to properly dispose of our solid waste.
