HARDEMAN COUNTY, TN -- In an effort to continue to save on the Hardeman County budget, county deputies may be offered 40 acres and a mule in lieu of pay, according to an unnamed county official.

"We realize this is an antiquated practice dating back to the end of the Civil War," said the official. "It's just that sometimes it seems we have more mules than money."

It is unclear whether the deputies who reside outside the county would be allowed to ride the mules home with them on a daily basis.

It's a difficult decision.

"I mean, maybe if we had offered it to them when we hired them we should continue to honor it unless we offer an increase in pay or something, to offset the difference," said the official. "But, honestly, if we just pull it out from under their feet with no notice, what are they going to do? Call a cop?"

Monitoring the mules location at all times while the deputy is off duty, is an issue as well.

"We can't have these people just using the mule like it's theirs," said the official. "After all, think of the unbelievable riches that might be realized by going to the grocery store or picking up their kids from school on a company mule. I mean, who knows, somebody might build a vacation home at the beach or open a Swiss bank account on the money they make from keeping an oath to protect and serve. We can't have that."

You Say You Want a Resolution?

The Hardeman County Commission on March 21 considered several resolutions as they head toward budget season in Hardeman County.

The commission considered resolutions involving policy in each department and the use of company vehicles for private purpose by the Hardeman County Sheriff's Department deputies who live outside the county.

Another resolution discussed by the commission was the policy of how officers and support staff in the sheriff's department would take compensatory time off in exchange for holidays worked. If an officer works a holiday, they're entitled to a different day off but Doolen says finding the time to let them have the hours to make up for working the holiday, is very difficult as his staff size does not allow it. The commission discussed a policy drawn up by the mayor's office that would have any employee take their compensatory vacation time for holiday days

"When Can We Do This Again?"

The Hardeman County Commission voted on March 21 to begin meeting every month instead of every other month, beginning in the next fiscal year.

The issue was raised after more than two hour session that included numerous resolutions on issues that had been raised in the past two months.

"After tonight we're not scheduled to meet for eight more weeks," said Mark Gilliam, who brought the idea to the commission. "And by then we're not going to remember what happened tonight."

After Hardeman County Mayor Jimmy Sain, County Attorney Charles M. Cary, and County Clerk Steve Armstrong cautioned the commission on issues relating to the change such as the budget and the lack of agenda items, Gilliam made the motion to begin meeting monthly starting in July. It was seconded by commissioner Justin Howell. On the roll call vote, three commissioners, Chandra Lake, Chris Bell, and Johnny Lanier were the only commissioners who voted against the change.

worked within 60 days, or lose it all together. Doolen said this was not enough time to accomplish it.

"I would have to increase staffs," said Doolen. "And that has always been the problem."

After much discussion, the issue was tabled.

Also discussed by the commission was the resolution to adopt of a county-wide personnel policy that can apply to all departments. While a few departments have signed off on it, a few, notably General Sessions Court Clerk Billy Davis and Highway Department head Casey Swift were still consider-

ing it and the issue was tabled.

The sheriff's department has stated they intend to have their own policy. By law, a department can have their own policy, but must submit it to the county attorney and it must be placed in the record by the county clerk.

The commission gave approval to lower the price of more than 500 lots the county owns in Grand Valley Lakes, Candlewood Lakes, and Woodrun to \$1 each in order to hopefully get them on the tax rolls in those respective communities. Previously priced at \$10.00 each, the fee of \$1.00 each does not include the recording fee for the deed, which would still be required.

Hardeman County Attorney Charles M. Cary was approved to remain in his position as legal adviser for the county for another two year term in a unanimous vote.

Commission Asks Sheriff Doolen to Make Policy Change

The difficulty Hardeman County Sheriff John Doolen has described in keeping staff got more difficult at the March 21 meeting of the county commission when the sheriff was asked to stop the practice of allowing sheriff's deputies to take a patrol car home if they live outside the county. The request, in the form of a non-binding resolution, was passed 14 votes for and one against, as only commissioner Bobby Wright voted no. Commissioner Mac Vaughn was not present at the meeting.

The already-in-place practice of allowing officers who live in the county to take their patrol cars home was not a part of the discussion.

While it is true the resolution that was passed by the county com-

mission cannot force the sheriff to change the policy, Doolen said the vote was not helpful in his efforts to keep staff happy.

"This is something we do for our underpaid staff," said Doolen in protesting the resolution. Doolen, who estimates four officers could be affected by this move, said the county is already having trouble keeping officers as the City of Bolivar and surrounding counties offer more pay to deputies.

Doolen said an incoming officer starts at \$27,000 a year, or \$30,000 dollars a year if they have graduated from the academy, which is in some cases more than \$10,000 less than is being offered to start at other places.

None of the resolutions consid-



ered or passed by the commission are legally binding to the sheriff's office as the county commission controls the budget, but not the poli-

cies the sheriff's department uses. When asked if he intended to honor the commission's resolution, Doolen had no comment.

Bolivar Middle Earns 5-Star Status

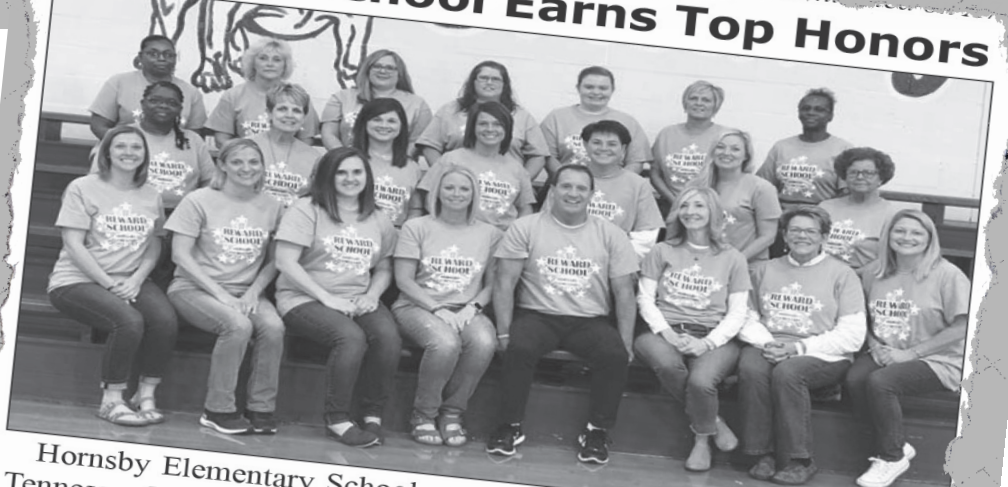
Bolivar Middle School celebrated reaching the highest status possible for the 2017-2018 year, a Level 5 rating.

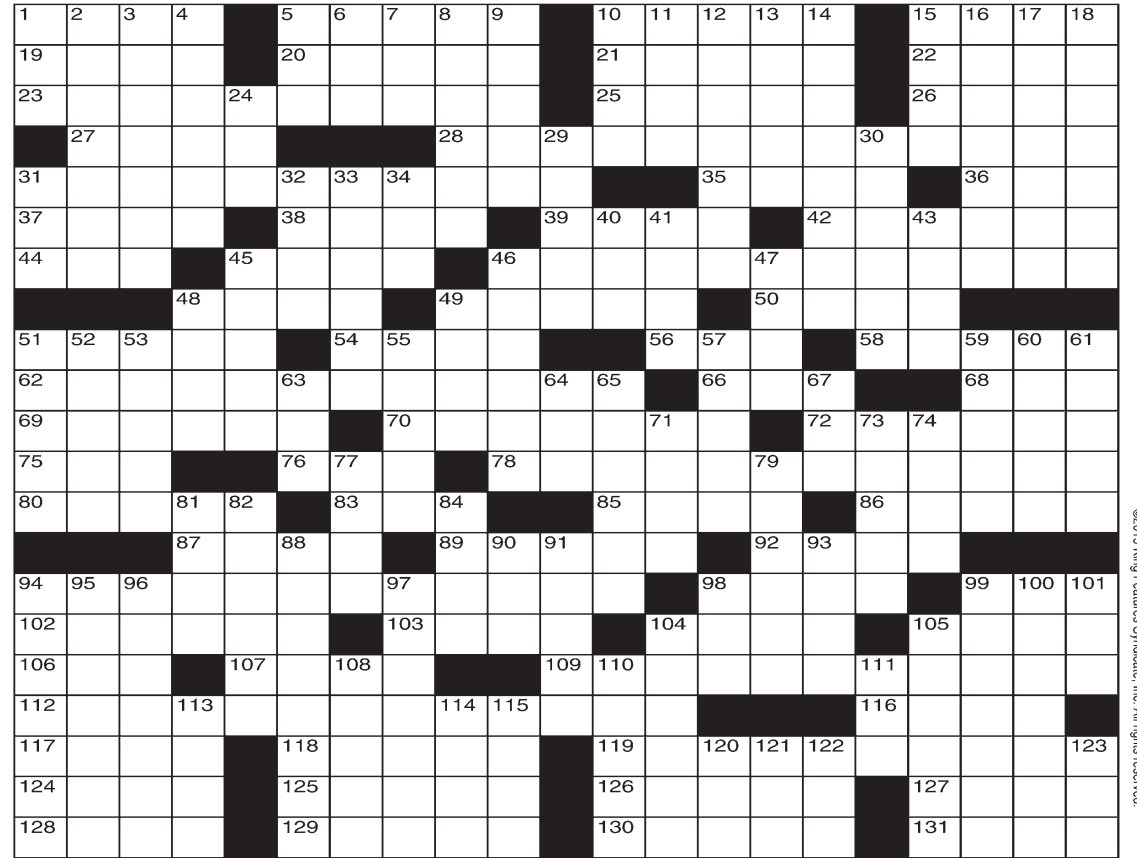

Clear-Eyed about Possessions

Sermon on the Mount: Part 10

by Jeff Capshaw

In Matthew 6:19-34, Jesus places significant emphasis on possessions. His teaching may be captured in two statements. First, don't value possessions enough to seek them. Second, don't value possessions enough to worry about them. This week, I will offer a few thoughts on the former concern of seeking possessions and will take up the latter concern next week.

The thrust of Jesus' teaching in the sermon is a call for radical dependency on God. It is hard to imagine any area of life that challenges our dependence upon God more than our attitude toward possessions (especially money) and the accompanying feelings of security they can bring. This week's lesson is organized around two commands and an image of the eye.

First, Jesus said, "do not lay up for yourselves treasures on earth . . ." (6:19), because they are temporal and subject to be lost. In antiquity, people would bury precious metals in containers which could rust or where thieves might find and steal them. Likewise, precious apparel could be stored in ways that moths could destroy them. Similarly, one can work an entire lifetime accumulating money and possessions, only to die

never having invested it in anything that really matters or makes a difference in world.

Instead, Jesus urges his followers to "lay up treasures in heaven" (6:20), because they are investments that can never be lost. They are investments that truly matter. Simply put, Jesus urges disciples to value what God values: eternal things. Disciples should value loving others, giving to the needy, praying for God's Kingdom, forgiving people, as well as other of Jesus' teaching in the sermon.

Next, Jesus uses a cryptic parable that his contemporary audience would surely have understood. He said, "the eye is the lamp of the body. So, if your eye is healthy, your whole body will be full of light, but if your eye is bad, your whole body will be full of darkness. If then the light in you is darkness, how great is the darkness (6:22-23)! In other words, a "good eye" or "clear eye" is a "single eye," a figurative expression for looking on others with generosity instead of fixating on the selfish accumulation of temporal possessions.

Finally, here is the wisdom of Jesus that hardly needs explanation. In the same way it is impossible to serve two bosses, one cannot possibly serve both God and

It is believed by some perhaps many that bereavement is a passive activity. Yet, bereave by its definition is active not passive. It happens to us. Bereave means "to deprive, to dispossess or strip from". Someone has said quite astutely, death and bereavement are "choice-less events." One writer puts it this way, "Oh you tears! oh you tears! till I felt you on my cheek, I was selfish in my sorrow, I was stubborn, I was weak; You have given me strength to concur, to stand erect and free, and know that I am human by the light of sympathy." Sorrow is indeed a merciful relief to the soul that is bereaved. Those who are willing to walk with them in sympathy are willing to suffer with them and this makes their painful journey easier. 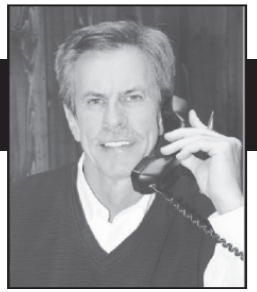



What Should You Do With an Inheritance?

Arrests Made in Three Days in Murder Case

In a joint investigation with the Hardeman County Sheriff's Department, Special Agents from the Tennessee Bureau of Investigation have arrested five individuals on multiple charges in relation to a homicide in Middleton.

At the request of 25th District Attorney General Mark Davidson, on March 22nd, TBI Agents joined Hardeman County deputies in investigating the death of Deon Edward Turner (DOB: 02/18/1988) and the serious injury of a female at a home in the 700 block of Brints Chapel Lane in Middleton. During the course of the investigation, agents developed information that identified Kaci Burcham, Terry Martindale, Michael Mayfield, Betty Sparks and Steven Sparks as the individuals responsible for the crime.

On Monday, law enforcement officers charged Burcham (DOB: 08/25/1999), Martindale (DOB: 12/29/1998), Mayfield (DOB: 10/12/1999), B. Sparks (DOB: 10/05/1973), and S. Sparks (DOB: 12/04/1995) with one count each of First Degree Murder, Possession of a Firearm during the Commission of a Felony, Aggravated Assault, Especially Aggravated Burglary, Especially Aggravated Robbery, Attempted Criminal Homicide, Criminal Homicide, and Attempted First Degree Murder. All five are currently in the Hardeman County Jail. No bonds have been set.

Spring Advice: Calibrating Your Sprayer

It is that time of year again when weeds are starting to green up and take over lawns. To combat weeds, most people choose to spray their lawns with various herbicides. To ensure adequate control of weeds, sprayers must be calibrated.

Calibrating your sprayer ensures the desired amount of herbicides are being applied and that label requirements are being followed. Calibration can be done quickly with a few simple steps that require minimal tools. Tools needed are a stopwatch, two flags, and a measuring cup. Below are the steps to calibrate a boom sprayer.

Calibrating Boom Sprayers-A Simple Method

1. Select a course length based on nozzle spacing (from chart below)

Nozzle Spacing (inches)	20	22	24	26	28	30	32	34	34	38
Course length (feet)	204	185	170	157	146	136	127	120	113	107

2. Measure out course in yard to be sprayed.

3. Measure time (in seconds) to drive course. Use a comfortable speed and/or gear. Take the average of three trips. If equipped, make a note of engine speed (rpm).

4. Park tractor with engine running at same rpm and catch the output of one nozzle for the time found in Step 3. Use clean water for this step.

5. Measure output from one nozzle in ounces. This measurement will tell you the sprayer output in gallons per acre.

6. Determine acres that can be covered in one tank. This will be tank volume (gallons) divided by sprayer output (gallons from Step 5).

7. Multiply acres from Step 6 by desired herbicide rate. This result will give the amount of herbicide to add to a full tank.

Some quick tips:

To increase flow rate: Increase pump pressure, change to a larger nozzle, or decrease speed.

To decrease flow rate: Decrease pump pressure, change to a smaller nozzle, or increase speed.

Tales from the Yellow House by Lee McAlpin

The warm spring days beckoned us kids from the pent-up confines of the Yellow House to the outside, where we shucked our brogans and ran unshod throughout the yard like a herd of mustangs. We hardly ever wore shoes during the spring and summer months. Hardly ever would a summer go by without one of us kids stepping on a nail, piece of broken glass, or a rusty piece of tin or metal. When that happened, Mom would bathe the wound with coal oil (kerosene), wrap it with a piece of bleached out flour sack, and we were back outside ripping and roaring again. No doctor, no tetanus shots, just coal oil and Moms T.L.C. I remember my youngest sister stepping on a piece of broken glass and ripping a nasty gash beneath one of her big toes. To this day that digit stands up like the head of a logger head turtle.

We spent most of our daylight hours outside. We didn't have bikes, wagons, skateboards, etc., but we did have a couple of auto and truck tires. Sometimes one of us would curl up inside a truck tire (I remember my Dad called them casings), and let someone roll us down a hill. Now that was fun, putting aside a few scrapes and bruises. Tree climbing was another sport that we enjoyed. I had two favorite climbing trees. One was a sweetgum, and the other was a wild cherry. I would



climb to the top limb and spend an hour daydreaming and looking out across the countryside. One day I witnessed a murder in the road beneath the cherry tree and I never climbed that tree again. Have you ever climbed to the top of a long, lean, slick, slim sapling and grab the top of the tree and bailed out? There is no electronic game that can equal that thrill.

There were some red clay gullies near our old house where we would indulge in the sport of gully sliding. We would climb to the top of the hill, sit down and slide to the bottom. It's kinda rough on the posterior, especially when you happen to slide across a sassafras root on the way down. And Moms lye soap would remove all the red clay stains from our pants.

Two of our neighbor friends who lived across the tracks from

us built a Flying Jenny. There was a stump in their yard about three feet tall. They drove an iron bolt in the center of the top of the stump. They drilled a hole in the middle of a ten foot two by four and placed that atop the stump and greased it with axle grease. Two of us would sit on each end of the plank, and someone would supply the power to spin the contraption. It was a great ride, but the sickening aftermath left me laying on the ground puking. Not regurgitating, but plain old puking. I wonder sometimes how we survived it all, but we somehow did.

Mills says his team is a mixture of old and young.

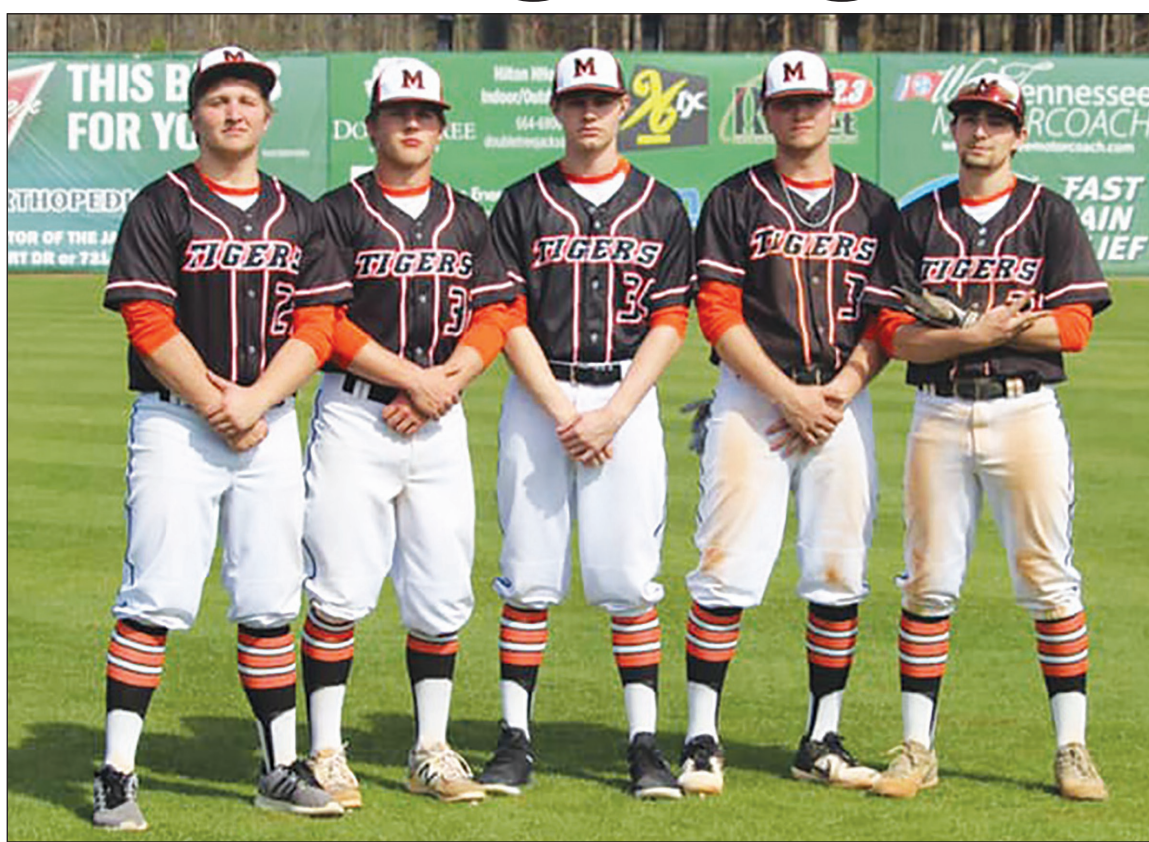
"We have five seniors, four juniors, and lots of sophomore and freshmen. We routinely start two sophomores and have one freshman who is always in the mix in the lineup."

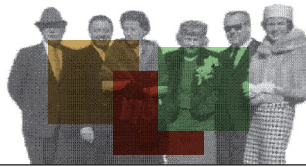

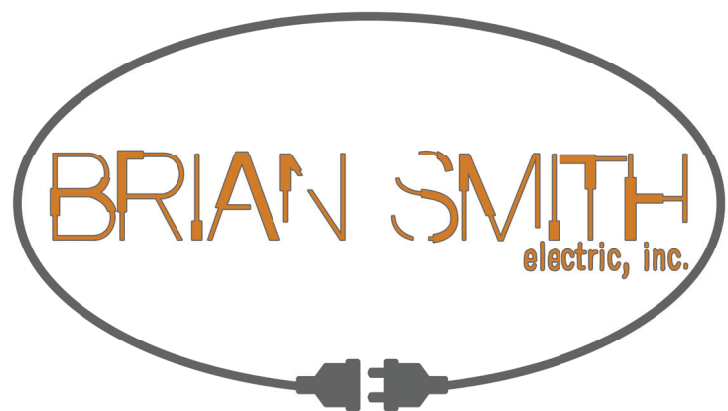

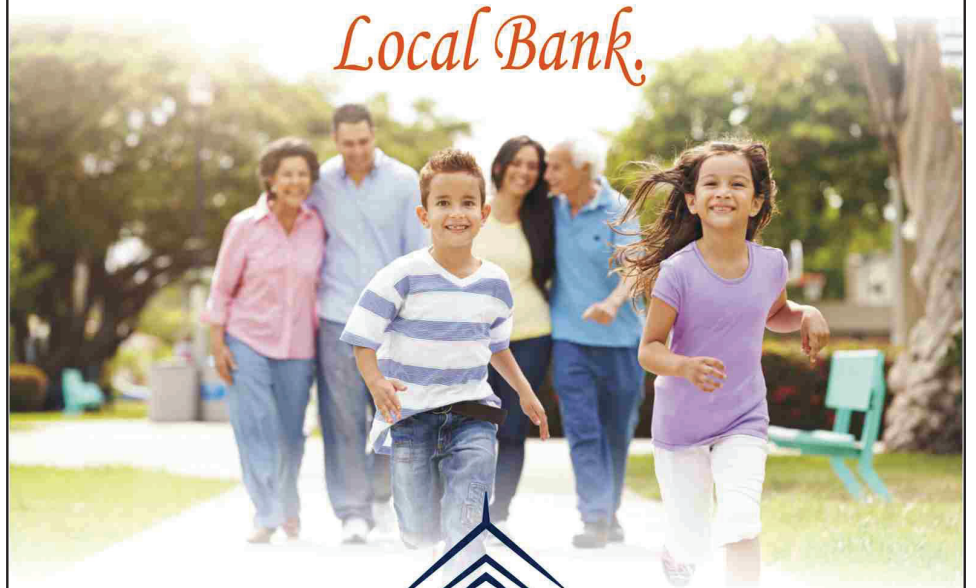
