Schools Hopeful of Support

With an eye to the future and a fear of a repeat of the 2018-2019 fiscal year budget cuts by the Hardeman County Commission, Hardeman County Superintendent of Schools Warner Ross says this year is critical to the success of the school system.

"We haven't invested in our schools," said Ross. "We are doing what we are required to do, even with less money. But we can't progress without support."

Ross points to plans in the works for programming at Lone Oaks Farm that could attract as many as an estimated 200 kids who would still graduate with their student body at either Bolivar Central or Middleton High School, but would get a unique experience that could attract students to stay in Hardeman County.

"Kids could take charge of their learning experience. This could give us a more prepared workforce and open up other possibilities,"

said Ross, adding the school board has been traveling to areas around the state that are successful in this field.

But to offer that, Ross says, the schools can't have a replay of last year's budget cuts by the county commission.

"Losing four cents (on the tax rate) a year ago wasn't easy to absorb. We have just as many schools, classes and teachers. It cost the same to run, if not more, than the year before. But what happened is the county got more money and the schools got less," said Ross.

"I hate we built the Criminal Justice Center off the backs of schools. But even so, with some nurturing, we can grow. And we have to. Our county is listed as distressed, and education needs to be the centerpiece. But we can't do anything without the support of the county commission," adding he hasn't found an instance that the schools got an increase in support since at least 2004.

"We need partners. County, state, and from the technology centers," he said, adding the schools need to pay attention to the strategies Governor Bill Lee has brought into play in his first year as governor. "Give our kids options. Support the schools."

Hardeman County Mayor Jimmy Sain says discussing plans right now for the budget is premature.

"We haven't gotten into the budget yet. We haven't had our first meeting. We've been gathering data," he said, adding that the later the committee begins work, the more accurate the numbers will be.

The Hardeman County Budget Committee consists of three county commissioners and two Hardeman County residents. Jerry Watkins, Chairman, and Junior Jimmerson are the non-commissioners on the committee, with commissioners Johnny Lanier, Jackie Sain, and Chris Bell rounding out the group.

D.A. Closes Christopher Case

Citing a lack of evidence of a chargeable criminal act, 25th Judicial District Attorney Mark Davidson has closed the case related to the Tennessee Bureau of Investigation's (TBI) probe into the death of Brian Christopher Lawler.

"I've reviewed the TBI file on the case and there is nothing criminal about it that is chargeable," said Davidson. "There will not be any charges filed. It appears to be a suicide."

Brian Christopher Lawler, 46, a resident of Hardeman County, passed away on July 29, 2018 in Memphis. Son of Jerry "The King" Lawler, Brian was in the Hardeman County Jail after being arrested in early July on charges of DUI and felony evading arrest.

According to a statement from the Hardeman County Sheriff's Department on July 29, Brian was discovered after hanging himself in his Hardeman County Criminal Justice Center cell on Saturday, July 28; he was given CPR and air-lifted to the MED in Memphis, where he passed away.

Lawler was best known for his career in the World Wrestling Federation (now known as WWE), where he performed as Brian Christopher and Grand Master Sexay and won 44 titles within the United States Wrestling Association.



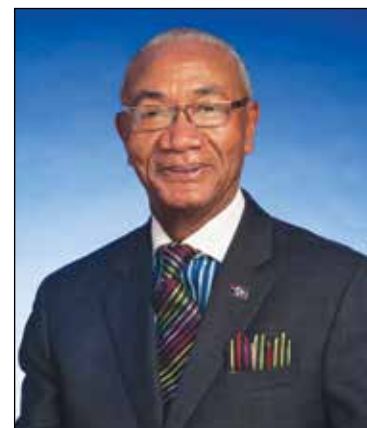

Ingredients

- 2 tablespoons vegetable oil
- 1 red bell pepper, cut into 3/4-inch pieces
- 1 medium onion, coarsely chopped
- 1 celery rib, cut into 1/2-inch pieces
- 2 garlic cloves, very finely chopped
- 1/4 teaspoon cayenne pepper
- Salt and freshly ground pepper
- 1/2 -pound andouille sausage or spicy kielbasa, halved lengthwise and sliced crosswise 1/2 inch thick
- 2 tablespoons all-purpose flour
- 4 cups chicken stock or canned low-sodium broth
- 2 thyme sprigs

- 1 scallion or 2 green onions, thinly sliced
- 1 tablespoon finely chopped parsley

Directions

1. In a large saucepan, heat the vegetable oil until shimmering. Add the red bell pepper, chopped onion, celery, chopped garlic and cayenne. Season the vegetables with salt and pepper and cook them over moderately high heat until they are softened, about 2 minutes. Add the sausage to the vegetables and cook, stirring occasionally, until lightly browned, about 5 minutes. Sprinkle the flour on top of the sausage and vegetables and stir until evenly coated. Add the chicken stock and thyme sprigs and simmer over moderate heat for 10 minutes.
2. Add the shrimp and scallion to the saucepan, season lightly with salt and simmer, stirring, until the shrimp are opaque and cooked through, about 2 minutes longer. Discard the thyme sprigs. Stir the parsley into the gumbo and serve at once.
3. Serve With: Rice or crusty bread.

An Eye for An Eye: Sermon on the Mount-Part 7

by Jeff Capshaw

So far in this series, I have discussed the problem/situation that Jesus is confronting (wrong-headed interpretations of the Old Testament), how the Sermon is structured (around Jesus' commands), to whom it is addressed (his followers/disciples) and several selected topics. Those include the images describing followers of Jesus (salt and light), Jesus' view of Scripture's authority (ultimate), the need to deal with the heart issues of anger and lust as well as divorce.

This week we find Jesus' teaching regarding permissible or legal retaliation against others. It begins, "You have heard that it was said, 'An eye for an eye and a tooth for a tooth.' But I say to you, do not resist the one who is evil. But if anyone slaps you on the right cheek, turn to him the other also" (Matthew 5:38-39). Jesus is alluding to Deuteronomy 19 (and elsewhere), and the context is of a judicial witness falsely accusing another Israelite of some wrong-doing:

a great dishonor.

The Ancient Near Eastern legal remedy (lex talionis) was common at the time of Moses, and the punishment was to resemble the offense committed in kind and degree. Its primary intent was twofold: to rid the community of evil and to serve as a deterrent from falsely accusing someone who might receive punishment unjustly (Deuteronomy 19:16-21).

Yet, Jesus' remedy for evil is different. It is counter intuitive. It's the real "Jesus stuff"! Here, as elsewhere, Jesus targets the root of the matter: evil in the heart. Resisting evil with evil or returning a slap with a slap in the face doesn't prevent evil; it perpetuates it. Yet, caution is urged not to press this statement too far.

Suffice it to say, however, Jesus probably isn't referring to someone's having his jaw broken or his head bashed with a baseball bat. Obviously, protecting one's physi-

cal well-being from serious injury or guarding a life, for that matter, is common sense. This is probably more of a "insult slap" than a serious thumping.

The upshot of Jesus' teaching here is, as Craig Keener says, "turning the other cheek summons disciples to neglect their honor and let God vindicate them when he wills (5:39)." Here is one way the "rubber can meet the road." Here is real Jesus stuff. The next time someone dishonors you, betrays you or downright does your wrong, don't retaliate. Ask for God's grace to let it go. Let Him vindicate you. Instead of striking back, forgive. As the 1970's Alka-Seltzer commercial said, "try it you'll like it." Jesus will.

Tolstoy wisely said, "Only people who are capable of loving strongly can also suffer great sorrow, but this same necessity of loving serves to counteract their grief and heals them." This is accomplished by allowing others to comfort us in our sorrow. Some people today need to learn to cope with sorrow from traumatic events that arise in their life. Some people have lost the skill to know how to cope with loss. In my humble judgement too many people have allowed themselves to be led by emotion and not by their cognitive rational mind coupled with emotion, based on facts, evidence gathered that leads them to certain conclusions. Loss and grief that comes from it, while a common denominator to all is also expected to be shared as is love. Frequently I have heard people say, "I am a very private person." Healing and interacting socially with others comes with sharing. Also, be observant with your whole system and changes that are ongoing. Accept them as you also accept the new reality in your life. 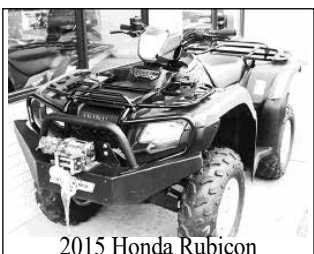

Women May Need to Make Extra Financial Moves

International Women's Day will be observed on March 8. Around the world, special events will celebrate the cultural, social, political and economic achievements of women. However, this last area – economic progress – is one that still causes concern, and rightfully so, because women still face gender-related challenges. How can you deal with them?

To begin with, you need to recognize the nature of these challenges. While many factors are actually responsible for women facing more economic pressure than men, two stand out in particular:

Gender wage gap – It's still around, despite some progress toward equality. The U.S. Census Bureau has found that full-time, year-round working women earn about 80% of what their male counterparts earn. Other studies show a slightly smaller gap.

Caregiving responsibilities – Women typically take more time away from the workforce than men, both to raise children and then, later in life, to take care of aging parents. These absences can result in lost wages, lower Social Security benefits and fewer contributions to 401(k) and similar retirement plans.

So, given these realities, what can you do to improve your own financial outlook? Here are a few suggestions:

Increase your contributions to your retirement plan. Every time your salary goes up, increase the amount you contribute to your 401(k) or similar retirement plan. At a minimum, put in enough to earn your employer's match, if one is offered. These plans offer potential tax-deferred earnings, and since your contributions are typically made with pre-tax dollars, the more you put in, the lower your taxable income.

Invest for growth. Some studies show that men may invest more aggressively than women – though not necessarily more successfully. However, while you do need to invest wisely, you can't ignore the need for growth. Consequently, you should consider including a reasonable percentage of growth-oriented investments in your retirement and other investment accounts, with the precise amount depending on your individual goals, risk tolerance and time horizon.

Look for income even while serving as caregiver. Of course, you may never become the primary caregiver for your elderly parents – but even if you do, it doesn't necessarily follow that you must forego all earned income. If it's possible, you could seek to go part-time at your current job, or request some type of telecommuting arrangement. And as long as you have some earned income, from somewhere, you can still contribute to an IRA.

Manage retirement plan withdrawals carefully. Once you're retired, possibly to become a full-time caregiver, you can take penalty-free – though still taxable – withdrawals from your 401(k) as early as age 55, provided you meet certain conditions. Once you're 59-1/2, you can take penalty-free withdrawals from a traditional IRA, though the money will be taxable. While you can withdraw contributions you made to a Roth IRA at any time, tax- and penalty-free, you'll have to wait until 59-1/2 to take out your earnings free of taxes and penalties. And you'll need to find a sustainable withdrawal rate so you can reduce the risk of depleting these accounts too early.

As a society, we are still working toward equality for all people – including economic equality. As a woman, however, you can't afford to wait until that day arrives, so you need to be proactive in seeking and maintaining your financial security.

SNAP Program Offered in Hardeman County

Supplemental Nutrition Assistance Program (SNAP), formerly known as the Food Stamp Program, is a national program. SNAP is just one of the many programs offered to help connect people with resources they need. In addition to providing food assistance to those who need it, SNAP also provides information on how to eat healthy and be active.
SNAP is for people and families with low income but anyone can apply. If qualifications are met, the benefits will be distributed within 30 days after the application is submitted. It may be possible to get assistance sooner if the applicant has little or no money. A person with SNAP benefits will receive an Electronic Benefit Transfer (EBT) card and they will use it like a debit card to buy food. These benefits will be renewed monthly but the amount of SNAP benefits received varies depending on income, expenses, and family size.

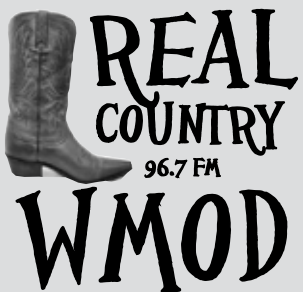

Bolivar Central and Middleton released their football schedules last week, as both Tiger teams look to improve upon years in which they missed the TSSAA playoffs.

Hardeman County Schools Give Attendance Awards

Attendance is a major factor in student achievement. Excessive absenteeism is a key indicator that a child will drop out of school prior to graduating. In a recent study, twelve-year-old students who missed 17 or more days of school dropped out before graduation at a rate of 85 percent. Failing to get a diploma can have devastating consequences. On average, a person with a high school diploma will earn almost twice as much as a high school dropout. In today's rapidly changing times, and education is vital for economic stability.

Chronic absenteeism is a problem that affects the whole community, not just students who are chronically absent and their families and youth. For these reasons, we encourage you to ensure your child attends school every day that school is in session unless there is a valid reason for missing. Tardies to school and checkouts should be avoided if at all possible.

• A child is considered chronically absent if he/she misses two or more days a month. That includes unexcused and excused absences.

• Attendance matters as early as kindergarten. Studies show that children who miss too many days in kindergarten and first grade have trouble mastering reading.

• By grade 6, chronic absence is a proven warning sign that a student is at risk of dropping out.

• By grade 9, good attendance can predict graduation rates even better than eighth-grade test scores.

Because attendance is so important for each student and Hardeman County as a whole, Hardeman County Schools hosted its first "Why Attendance Matters" video and bulletin board contest September 3, 2018. Schools were invited to submit a 3-5 minute video that conveys the contest theme "Why Attendance Matters." The winning entries came from First place, Grand Junction Elementary, Principal Linda Buggs; Second place, Bolivar Middle School, Principal Mary Ann Polk; Third Place, Middleton High School, Principal Darlene Cardwell.

Also, Parent Teacher Conference in the fall and spring semesters help bring awareness to parents and students, emphasizing the connection between attendance and achievement promoting a culture of attendance all day every day.

Hardeman County Schools has joined a nationwide effort to celebrate Attendance Awareness Month, September 2019. During Attendance Awareness month, we are asking school leaders, community advocates, parents and students to help promote the value of good attendance because attendance matter to us all.

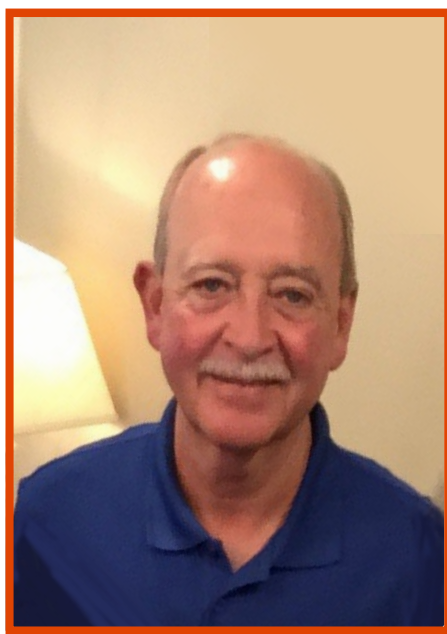

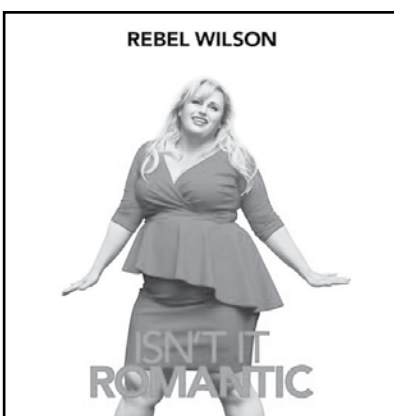
