It's County Budget Season!

The Hardeman County budget will be presented to the Hardeman County Commission on June 2 in a virtual meeting format using Zoom, but plans are to hold the first traditional meeting since February for a public hearing and final vote on the 2020-2021 budget later in the month.

Hardeman County Mayor Jimmy Sain says it's difficult to predict revenue in the coming year, but is certain revenues will be down because of the COVID-19 virus economic shutdown.

"We were down \$30,000 last month in sales tax. It may end up about \$70,000 less for the year than projected because of the virus," he said.

Sain expects the Hardeman County Schools to have their numbers ready by the June 2 first reading.

If passed on June 2, the next meeting is expected to be scheduled for June 16. The final reading would include a public hearing prior to the final vote, which would seem to require the meeting to be held in the traditional fashion in an open courtroom format. If passed on the second reading, it would make the budget official.

Last year both the schools rate of \$1.46 and the county rate of \$2.55 remained the same, but not without much discussion and a last minute change. The commission even-

tually rejected the budget committee's vote to set the rate at \$1.40 while offering equivalent dollars that would have gone to debt service, instead voting to set the rate at \$1.46 with no other provisions.

With the uncertainty, Sain has asked Hardeman County department heads to try to keep their spending the same as in the previous year.

"We are asking them to hold to last year's numbers," said Sain.

The 2019-2020 fiscal year, while about to come to a close, is still unsettled due to the July 2019 lawsuit filed by Sheriff John Doolen against Hardeman County Mayor Jimmy Sain, seeking more funding for his department. A hearing to settle the dispute went unfinished on February 27, and remains in limbo because of a suspension of court proceedings due to the COVID-19 restrictions. How an eventual ruling on the 2019-2020 budget in favor of either side could effect maintenance of effort remains unknown.

The county rate has not changed from \$2.55 since Sain took office in 2014. The Hardeman County Budget Committee consists of commissioners Jackie Sain, Chris Bell, and Johnny Lanier, with Junior Jimmerson and Chairman Jerry Watkins rounding out the committee.



The first reading and vote traditionally is passed without much resistance from the commission. Last year's vote went 16-0 in favor at the first reading, but a vigorous discussion and a 12-4 vote was the margin at the final reading.

Zoom is a cloud platform for video and audio conferencing, collaboration, chat, and webinars across mobile devices, desktops, telephones, and room systems.





FAITH

Benefitting from Hard Times

Hard times come in different forms. Someone loses a job, struggles financially for a period, contracts a long-term illness, suffers a season of depression or anxiety, loses a loved one, etc. Except for a brief period following 9/11, Americans have not collectively experienced such hard times, since the Great Depression or World War II. Currently and collectively, however, it is a season of hard times for all Americans.

Everyone can benefit personally from this season, especially those who take the Scripture as having authority over their lives. One of the hallmarks of human nature is to avoid pain and to seek pleasure. There are different theories behind that instinct, but that is beside the point here. Most of us know by experience that overcoming difficulties is often unpleasant. By the same token we know by experience that, once we do overcome adversity, we are often the better for it. We grow in character, learn valuable life lessons, and gain wisdom from those experiences.

There is a significant text in the New Testament that directly addresses this very topic. It applies both to personal and collective suffering, because we undergo hard times personally, and because this text was addressed to a group of first-century believers. It is found in Romans 5. The chapter opens with one of Paul's classic statements on Justification. That means that God declares sinners righteous by their faith in the finished work of Christ. That declaration also places believers in a state of "standing in grace." One of the benefits of obtaining God's grace is the ability to undergo suffering for personal

growth.

Paul writes, "not only that, but we rejoice in our sufferings, knowing that suffering produces endurance, and endurance produces character, and character produces hope, and hope does not put us to shame, because God's love has been poured into our hearts through the Holy Spirit who has been given to us" (5:3-5, ESV).

This is why the Christian worldview makes the most sense out of suffering or hard times. Believers can have great hope, even amid great suffering! Why? According to Paul, suffering produces in us endurance, the ability to withstand hardships. Just like a runner builds up physical and aerobic endurance, suffering produces both personal and spiritual endurance in believers. In turn, that same spiritual endurance produces stronger character in us, and then comes hope.





OUR COUNTY

Tales from the Yellow House by Lee McAlpin

While growing up at the Yellow House, we were accustomed to many odd home remedies and superstitions. The superstitions were practiced only for fun and play, at least most of them. The home remedies were taken more seriously. One of the home remedy staples around our house was rabbit tobacco. The scientific name being *Gaphalium Obfusifolium*. It is said that the Cherokee Indians used this plant often and called it Life Everlasting. In the fall we would go out into the fields for our annual rabbit tobacco gathering. When we had a cold or chest congestion, Mom would make a tea from the leaves and we would take a dose for our coughs and whatever. I do know that it actually works. I keep a batch of the leaves on hand even today. While having a bout of the crud recently, I chewed several cuds of the stuff and it definitely stopped my cough and eased my affliction. And many times us kids would slip behind the house and roll some of the leaves in a brown paper wrapper and smoke it. It has been said that smoking the leaves will relieve asthma. Coal oil (kerosine) was used for all cuts. It must have worked, because we never had a tetanus shot and we never lost life or limb. Many times when we had the croup, Mom would put a drop of coal oil and turpentine on a spoonfull of sugar and give it to us to relieve our malady. There were other remedies that were used which most times worked. They say that half of the cure is believing in the cure itself. I remember seeing a young boy wearing a piece of lead on a string around his neck. This was supposed to prevent nose bleeds. Some of the more stranger remedies that I have heard of is to break off the head of a Bessybug



and squeeze a few drops of blood in the ear for earache. And a more bizarre remedy is to take a few drops of chamber lye and put it in the ear. Now who would dare put anything from a bed pan in his or her ears. Tie a pair of scissors to a string and dropped down the back of the collar, with a penny under the tongue is supposed to stop nosebleed. For a stye, run the tip of a black cats tail over the eye. Headache, bury clippings of your hair under a rock. Athletes Foot, tie a string around a toe, step in cow manure. Sore throat, tie a dirty sock around your neck. Warts, steal a neighbor's dishrag and bury it in the woods.

Some of the superstitions that some people practice and believe in are odd to say the least. One of them is if you tie a knot in the corner of a sheet, it will stop whippoorwills from singing. Some people carry a buckeye in their pockets for good luck and for rheumatism relief. The black cat crossing the road in front of you is said to be bad luck, or walking under a ladder. And there is the seven years of bad luck associated with breaking a mirror. The eating blackeyed peas on New Years for good luck. One trick I heard about with this practice is that you are supposed

to leave three peas on your plate and put them in your left pocket. With all the blackeyed peas that I have eaten all my life, I should have a continuous string of good luck. My Dad believed in planting by the signs. And Mom believed that if you made saurkraut when the signs were in the bowels, that the kraut would turn black in the jars. I saw this happen one time, whether it was from the signs or not, I do not know. One last superstition. One old one says that if the full moon shines on a woman's navel, she would become, as the nice old saying goes, "In a family way." I'm sure that the moon can affect the oceans tide and serve as a landing pad for our astronauts, but I think that's the limit.

There are literally thousands of home remedies and superstitions. Some of the old home remedies do work and I use them occasionally, but the superstitions, that's another story. But as I mentioned before, to each his own.






