One for the Price of Two

Widespread indifference was the biggest story as the Hardeman County Democratic Primary finished their business with a thud on May 1.

The number of voters (3,042) in the Democratic Primary was the lowest turnout since at least 1978 (see chart to the right) and 2,574 voters less (a 47% decrease) than the worst turnout of any year in the last forty years.

The primary did decide four contested races:

Moving on from the most populated race was Billy Davis for Circuit Court Clerk as he defeated Tonya Ellison Perry and Butch Gatlin. Davis will now face Republican Taylor Sain in August.

The only other county-wide race in the Democratic Primary was won by Casey Swift, who defeated Dale Dixon and will now face Eddie Vandiver in the General Election for

Superintendent of Roads.

Democrats faced off in two county commission races, with Hornsby Mayor Mack Carter defeating Larry Minter. Carter will now face Republican Mark Gilliam, and Independents Brandon Burvee and Darren Grantham for District 7, Position 2. The other contested race in the Democratic Primary saw Gary Barber defeat Donna Bugg Pinner. Barber will face Republican Stan Doyle for the District 2, Position 1 spot.

Other county commission races that will take place in August are Barbara Fitzhugh (D) vs. Chris Bell

(R); Mike Madden (D) vs. former Bolivar Mayor Barrett Stevens (I); Albert McKinnie (D) vs. Bobby Hensley (R); and Elmer Cobb (D) vs. Bobby Wright (R).

Those who ran unopposed in the primary but will have work to do this summer include incumbent Mayor Jimmy Sain (D), who will face Republican Calvin Howell and Independent candidate Kandy Shackelford; incumbent Hardeman County Sheriff John Doolen, will face Bolivar Police Chief Pat Baker and Toone Police Chief Jerry Siler; and incumbent Road Supervisor Matt Knight will face

Whiteville Mayor Aubrey Phillips.

Nine county commissioners need just one vote in August to keep their office for the next four years: Jackie Sain (I), Johnny Weems (D), Chondra Lake (D), Charles Morrow (D), Elvis White (D), Johnny Lanier (I), Mac Vaughan (I), John Vickers (I), and Bobby Doyle (I).

County officeholders who will not have an opponent in August are County Clerk Jerry Armstrong (D), Register of Deeds Lily Barnes (D), Trustee Mary Powell (D), and Road Supervisors John Mitchell (D) and Kenny Pulse (D), who all ran unopposed for the Democratic nomination and will be unopposed in August as well.

The Hardeman County Election Commission is expected to certify the results on May 8. See *All for complete unofficial results.*

Hardeman County Remembered by Lisa Coleman

When I enter an old church there is a feeling of the gathering of the saints that worshipped there before me. Whether the building is wood or brick, magnificently appointed or eloquently simple, I think of all the prayers that have been prayed there. Surely the presence of the Lord is in such places.

One of my most favorite old churches happens to be in Hardeman County - St. James Episcopal Church which has stood on the corner of Washington & Lafayette Streets for 182 years. When I sit in an old church like St. James, the phrase about "a great cloud of witnesses" always comes to mind; I think of the joyous celebrations and the mournful cries that have happened there.

The stained glass windows in St. James are marvelous. To me, they are most brilliant with the early morning sun bringing them to life or when they are lit by candlelight. I think I have an affinity for the windows because they are my first memory of visiting that church as a child. I don't remember the reason for the visit, but I remember the



windows were lit by candlelight and were magical to my child's eye.

Windows in the church are dedicated to the Reverend Daniel Stephens (who organized the church), Ann McNeal, Pitzer Miller, and General Otho French Strahl and his adjutant, Lt. John Henry Marsh. Lt. Marsh had grown up in Hardeman County and he and General Strahl were both baptized by Bishop Charles Todd Quinard. The General presented a "splendid horse" to the Bishop and after the

end of the war, the horse was sold and the funds were used to purchase the memorial window to the two officers. General Strahl and Lt. Marsh were both killed at the Battle of Franklin on November 30, 1864. All of the windows were beautifully restored in 1959 and retain their original, lovely beauty today.

Y'all, remember all those who came before us, and think of them next time you sit on an well-worn church pew.

County Awards Announced at Banquet

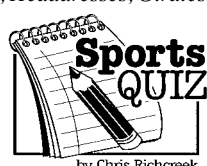

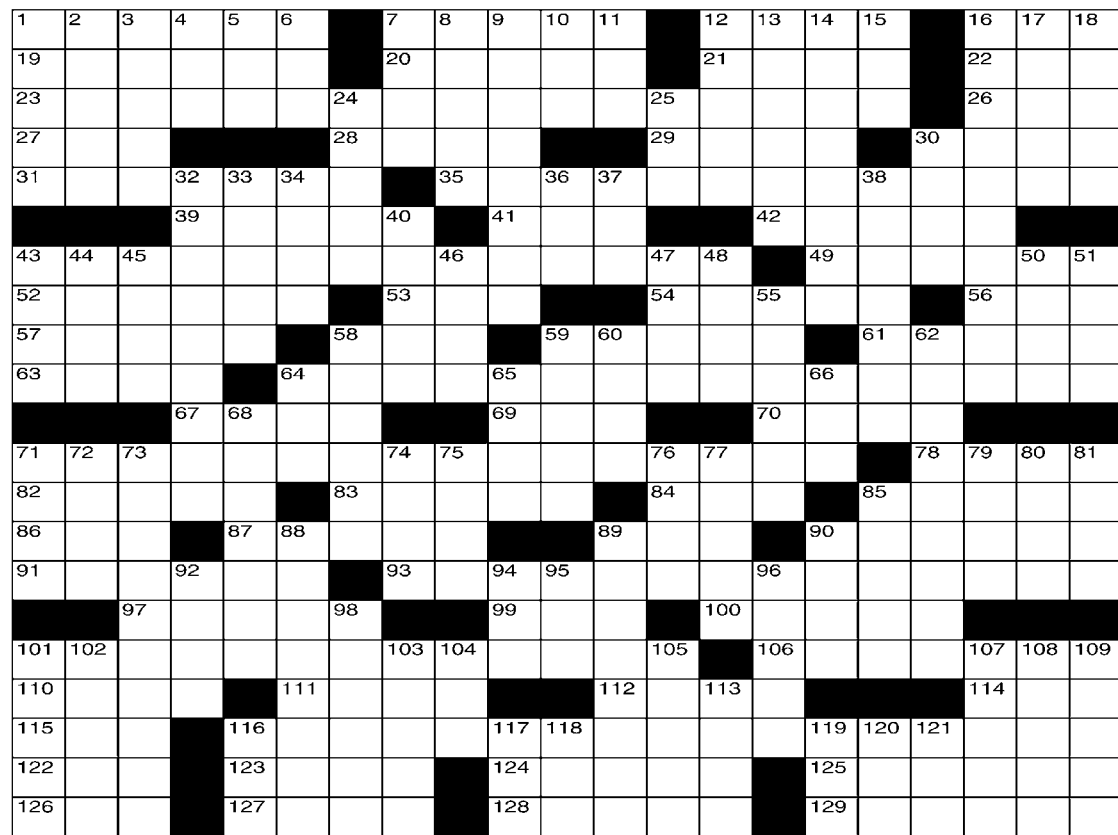

Sunrise: Give & Receive by David Coy

One perception that seems to be consistent with a majority of people that do not seek support and assistance outside of themselves or their family system, they do not feel the need or want outside help. A second option may be they are too private or proud to ask for assistance. In the gospel accounts of Jesus life and ministry he said, "It is more blessed to give than to receive." (Acts 20:35). But within this verse is the exhortation in so laboring you ought to help the weak. Jesus said, "I showed you all things..." The verb here means to show by example, that is, to give object lesson, by deed as well as by word. (Vincent's & Robertson's) Thus Jesus was saying that as he has given example so they (his disciples) were to follow his example.

Where this applies to our discussion is in this statement, "but how can there be any gifts

to whom the blessing can come unless there are those who are willing to receive? It takes two halves to make a whole.' A giver and receiver. The conclusion must be, that many people who wish to give to those who are in sorrow of heart, as kindly compassionate service because they genuinely care, are unable to. The giver is not willing to engage in giving of a blessing and being one half of a whole.

Thus one loses out in the receiving of a blessing and the other in the opportunity to give a blessing. As a result both lose out in a blessing. George Peabody said, "It is sometimes hard for

Worldview 2 by Jeff Capshaw

Last week I introduced the topic of "worldview" for this and the coming weeks. In summary, a worldview is "a particular philosophy of life or conception of the world." One's worldview ought to have answers to the big, age-old questions like the following. "From where did we come?" "What is life's meaning?" "How should we live?" "What happens after we die?" Moreover, a worldview ought to possess internal consistency. Finally, a comprehensive worldview ought to have explanatory power with respect to all reality, and one ought to be able to live one's worldview proudly.

I also suggested that a worldview works like a pair of spectacles, a Google Maps app or a connect-the-dots puzzle. Thus, a worldview guides us in how we see ultimate reality, how we navigate life and how we makes sense of the world. Some worldviews (e.g. Nihilism doesn't allow for that assumption, and certain Eastern worldviews hold that reality is merely an illusion). Simply put, these views hold that our minds either create their own realities or that we can't really trust our minds or our other senses.

For now and in the coming weeks, I will be discussing selected aspects of a distinctly Christian worldview. That isn't

to say there are not other types of worldviews: both religious and non-religious. But since I am of the Christian tradition, and since most readers probably are too, then I will proceed from that perspective. Occasionally, I will point-out tenets of other worldviews, especially those which outright deny God's existence or don't know if there is a divine being per se.

Since nobody plants their feet in mid-air when constructing an argument, one must start on some foundation. Just like SpaceX's rockets require a launching pad, so also worldviews require a launching pad: a baseline for discussion. The starting point for

a distinctly Christian worldview is two-fold. Think of one foot planted firmly upon the first truth taken for granted, and the other foot planted upon a second truth taken for granted. Both are equally important and are non-negotiable.

Assumption 1: The Trinity God of the Christian Scriptures exists.

Assumption 2: The sixty-six canonical books of the Christian Bible are the authoritative, infallible Word of God.

Next week I will explain why that is the case, in spite of there being an obvious circularity to them. In the meantime, consider whether any worldview escape reasoning in a circle?"

Notice the HCSB on **I Peter 1:17, "And if you address as Father the One who judges impartially based on each one's work, you are to conduct yourselves in fear during the time of your temporary residence."**



It is good for us to remind ourselves why we should not treat this world as our permanent place of residence. God gives us several reasons in the scriptures, as to why, we should not long to stay on the earth beyond our days.

I. Christians Are Called Out Of This World.
Paul said in **II Thessalonians 2:14, "to which He called you by our gospel..."**

The gospel is the power & the means by which we have been called out of Satan's kingdom (the world) and into Christ's kingdom (**Colossians 1:13; Revelation 1:9**). The church is from the Greek word ekklesia, which literally means "called out ones." Vine's tells us it is, "from ek, "out of," and klesis, "a calling" (kaleo, "to call").

(Vine's Expository Dictionary of Old and New Testament Words, p.42) And this is precisely the reason why we can say, with Paul and the church at Philippi, **"For our citizenship is in heaven." (Philippians 3:20)**

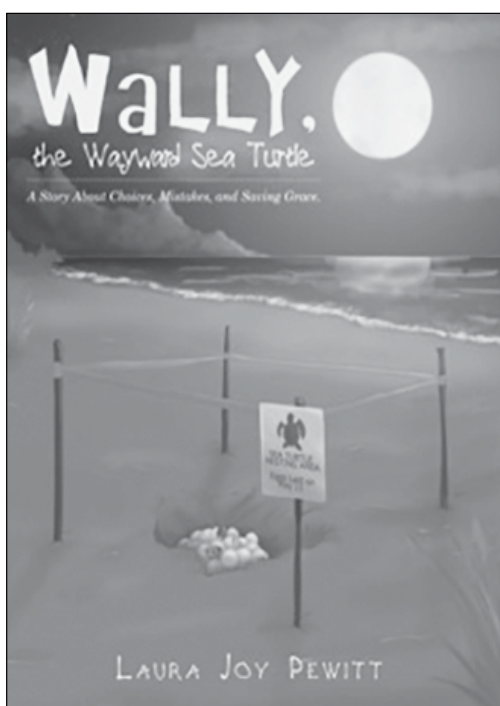
