## ThyssenKrupp in World Finance News

The eyes of the world's financial markets turned to Middleton and ThyssenKrupp this past week.

Finland's Kone has hired German law firm Hengeler Mueller ahead of a planned takeover bid for ThyssenKrupp's elevator division, according to a story by the news service Reuters on September 9.

Kone's strategic interest in the business, which analysts say could be worth as much as 17 billion euros (\$19 billion) and which ThyssenKrupp has put up for sale as part of a broader restructuring, is at the center of the move.

Kone is seen as a likely bidder after its Chief Executive Henrik Ehmrooth said the elevator division was a "perfect fit" in a newspaper interview.

ThyssenKrupp Elevator is one of the largest elevator companies in the world, with sales of nearly \$3.8 billion and more than 34,000 employees at more than 800 locations.

According to an article on Bloomberg.com, combining Kone and ThyssenKrupp would "create an industry behemoth with more than 16 billion euros (\$17.7 billion) of sales. Though weaker than Kone's, ThyssenKrupp's elevator earnings have tended to far outstrip what the unwieldy German conglomerate makes from its other businesses. Its future should be bright too."

The opinion piece added, "Europe has three world-beating elevator makers. Reducing the trio to two has clear benefits for the companies. What's in it for customers isn't quite so obvious."

The article further explains that only 8% of the world's elevators are located in North America, with Europe and China having 73% of them.

The Tennessee Department of Economic and Community Development has assured Hardeman County officials of their attempt to make sure any move would keep the plant in Hardeman County.

## State Health Department Cautions Against Vaping

The Tennessee Department of Health has reported six cases of suspected serious respiratory disease among people who use electronic cigarettes or other vaping devices. The Centers for Disease Control and Prevention and U.S. Food and Drug Administration are investigating a cluster of severe pulmonary disease among people who use e-cigarettes or vape, with 215 cases reported to date in 25 states.

"Tennessee health care providers are reporting to us any patients they treat for severe respiratory symptoms who report vaping in the weeks before they got sick," said TDH State Epidemiologist Tim Jones, MD. "We're investigating to look for common factors and collect information on specific components or brands of vaping products that may be the source of the illness."

Patients across the country associated with this outbreak have had symptoms including cough, shortness of breath and/or chest pain, growing worse over a period of days or weeks before admission to the hospital. Other symptoms may include fever, fatigue, nausea, vomiting and/or diarrhea. In many but not all cases, patients have acknowledged recent use of tetrahydrocannabinol or THC-containing e-cigarette products. Most of the cases are among adolescents and young adults.

This page will be updated weekly by 3:30 p.m. Central time each Thursday with any additional cases reported.

Electronic cigarettes and other vaping devices are not approved by the FDA for smoking cessation. Smokers who are attempting to quit should use evidence-based treatments including counseling and FDA-approved medications. ## Team Mica Hosts Event in Bolivar

Team Mica, a component fund of The Community Foundation of Middle Tennessee, held their annual Hardeman County 5K event on September 7.

The evening featured many events to raise money and awareness for Team Mica's mission of creating awareness of suicide prevention by collaborating with area organizations in Tennessee.

Survivor Ginger Tester gave the address to the attendees.

*Thanks to Pathways Behavioral Health and Team Mica, they're here to help educate and communicate the importance of suicide prevention and mental health awareness, providing resources and connecting people with people who can help...but I have to be honest with you. I don't want to be here. Apart from the die hard 5Kers, enthusiasts, and the little ones here today, I don't think anyone wants to have to be here. I'm what they call a survivor.*

*I lost Jencie Ann, my only daughter, in July of 2015. She took her life. She was 18 (pictured above).*

*Experts and statistics say that puts me at a higher risk of doing the same thing... No kidding. Some days are ok, and some are not, but all of them have triggers... I can't visit the shops we went to.... music ... perfume.... someone's style, hair color or resemblance... without a trigger. Last week I attended a funeral, a young woman walked past me, and I had to catch my breath.... I began to cry because of her hair color and style... At least I was at a funeral where people are often seen crying. But I'm not always that lucky.*

*Breaking down is no good wherever you are, but especially in public. Sometimes it's awkward. But that's why we're here today, to raise awareness. You see, for some, life is too painful to continue to endure... but life without them is too painful to continue to endure as well and that's where I find myself sometimes. I'm not alone. As I look around, I see the faces of those who have been left behind too... other mothers, fathers, daughters and sons, aunts, uncles, cousins, business assoc, friends... That puts us all at a higher risk.*

*And each of us process it differently ... deal with it in our own way and in their own time... and some of us who are just really starting to learn how process it in a healthy way and heal, and we need help. That's another reason why we're here today, to get people connected to people who want to help and have been trained to help. Not everyone who takes their own life has a mental illness, and not everyone with a mental illness with end their lives themselves.*

*Learning to recognize the signs of a suicidal person and taking that first step to help them is so important. You don't have to be trained to reach out and help. If you don't know what to say, try "I'm sorry... I'm here to talk or listen... and follow up with them, become active in their lives. Just talk about it.*

*I want to leave you with words from Jencie's Family....*

*Jencie's cousin, who has lost at least five loved ones to suicide, wanted me to share this: Reaching out to loved ones and maintaining that open relationship is so important. If you're the one who is suffering, you don't have to do this alone. This world needs you, your loved ones need you, and if you go through with this, your loved ones will never be the same without you.*

*Jencie's Aunt: Beautiful young girls just don't go kill the selves nor do others.. if we don't eliminate the STIGMA of Mental Illness. Many more young people will die before they can reach their potential.*

*Talk about it.*

*Jencie's Grandmother urges people to: Educate yourself, recognize the symptoms and take action to confront it.*



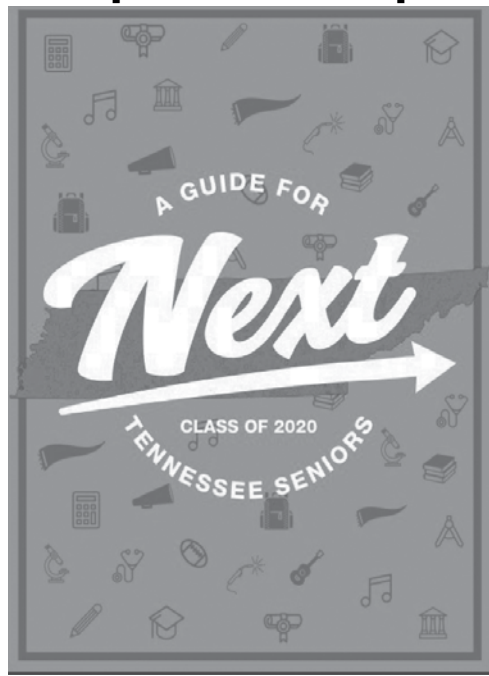
## GEAR UP Provides More than a Map of the Campus

Every senior at both Bolivar Central and Middleton High School is receiving a new tool to use this school year to prepare them for whichever path they decide to follow after graduation. It is called *Next: A Guide for Tennessee Seniors*, and the Class of 2020 is the first to have it in Tennessee.

Funded through the state's GEAR UP grants and created by staff at the Tennessee Higher Education Commission, *Next* is designed to help seniors decide on and prepare for what comes next for them – in other words their first destination after high school. It not only provides information for those headed straight to college but also for those headed to the military and those going immediately into the workforce.

The user-friendly guide covers financial aid and college scholarships, military service and ROTC alternatives, job applications and interviews. It is even designed so that each student can add personal information and keep track of his/her own progress along a chosen post-graduation path.

Parents as well as seniors will find useful information and additional resources to help them navigate senior year and beyond. Whatever a senior has in mind for life after graduation, *Next* is sure to help.



## OPINION

As your State Treasurer, my job is to responsibly manage our state's financial resources. My personal goal is to lead all Tennesseans toward sound financial management in their own lives. I believe the key to improving the financial outlook of Tennesseans begins with getting our young people on the path to post-secondary education which helps qualify them to enter the 21st-century workplace that Tennessee needs. That path begins with saving.

By proclamation, Governor Lee has declared September as College Savings Month in Tennessee to encourage Tennessee families to save and invest for the future cost of higher education. The Tennessee General Assembly has supported the TNStars College Savings 529 Program since its inception in 2012 because of the importance of having a highly-educated workforce. It matters whether our young people are able to afford higher education.

The cost of higher education is more than just tuition. The additional costs for books, supplies and even computers is leading our young people to take on the burden of loans. The US Department of Education has deemed student loan debt to be a crisis. Currently, there is more than \$1.5 trillion in student loan debt, making it the second highest consumer debt category, behind mortgage debt.

Saving can help free students from the burden of loans. By saving early, you can let compounding interest work for you by increasing your savings over a long period of time, rather than trying to pay off student debt with growing interest rates while living on an entry-level salary. Even saving a little can have a great impact on a child's future!

As of June 30, 2019, 16 children in Hardeman County have a dedicated TNStars account. . These families have saved a combined \$60,287 in the TNStars College Savings 529 program for future higher education. To help families in Hardeman County save even more, the state provides four-to-one matching grants through the Tennessee Investments Preparing Scholars (TIPS) program. If qualifying families save \$125 per year in a TNStars account, the TIPS program would provide \$500 in matching contributions annually, for up to three years.

A family of four with an annual household income of \$64,000 could qualify for the TIPS matching grant program. With the average household income in Hardeman County at \$18,124 many families would qualify for the TIPS program. 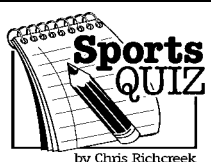

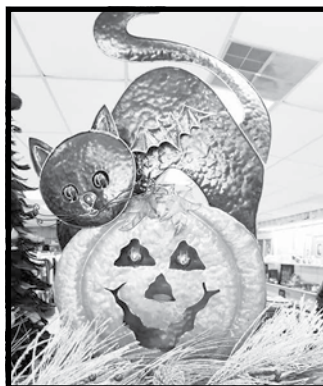

# FAITH

## Grace, Part 7 by Jeff Capshaw

Last week's reflection centered upon Romans 6:1-4. First, although believers stand completely justified by grace in God's sight, that doesn't give them a license to sin. Second, the "baptism into death" image Paul uses illustrates the mystical, spiritual union believers share in Christ.

Second, in the same way that Christ was crucified, buried and raised from the dead physically, so also believers are spiritually crucified, buried and raised to walk in newness of life. This is a theological truth to believe. There is no other analogy apart from the sacramental, baptismal one that Paul uses here which better aids our understanding of this important doctrine.

The theological aspects of grace are important to understand. However, there is also a practical component of grace. That is grace for afflictions, for struggles or for the trials of life. In II Corinthians 12, Paul shares extraordinary personal experiences which he didn't fully grasp himself. For example, he mentions "visions" and "revelations" from the Lord, of being "caught up in the third heaven," of "paradise" and so on. Furthermore, he says, "and he (probably

Paul himself) heard things that cannot be told, which man may not utter" (v.5).

Paul then shares a personal struggle. He said, "a thorn was given me in the flesh, a messenger of Satan to harass me. . ." (v. 7). Notice his attitude about it. He didn't think that it was a bad thing, a punishment from the Lord. Instead, it was "to keep me from becoming conceited" (v. 7). There is much debate about his "thorn in the flesh," but he partly indicates what it was. Some think, based on another passage (Galatians 4:15), that it was poor eyesight. Maybe it was, but regardless, Paul construed it as "harassment from Satan.

He tells how he besought the Lord to remove the struggle; "three times I pleaded with the Lord about this, that it should leave me" (v. 8). Notice that the Lord didn't deliver even the great Apostle. Rather, the Lord told Paul, "My grace is sufficient for you . . ." (v.9).

What can we learn from this passage? First, even the great Apostle, who wrote much of the New Testament, preached the Gospel "from Jerusalem all the way around to Illyricum" (Romans 15:9), did signs and won-

ders, had extraordinary visions and so on, had personal struggles. Christians today should expect no less. The Christian life is hard at times.

Second, even though we might beg the Lord to remove our hardships, in his infinite wisdom and divine sovereignty, the Lord knows what is best for his children. Paul saw his struggle as something good and gracious from the Lord.

Finally, how should believers cope with their struggles? The same way Paul did: by the grace of God. That sounds almost trite, but for a Christian, there isn't another proper path. However, we often resort to other potentially harmful remedies. We turn to self-medication, self-distractions, spending, bad relationship, etc. If you are going through a difficult time, then try God's way; try asking for and resting in God's Grace. According to Scripture, it is sufficient.

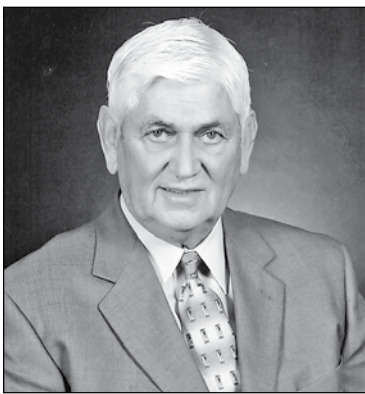
## TRAVIS COX KENNEDY MARCH 26, 1934 ~ SEPTEMBER 6, 2019

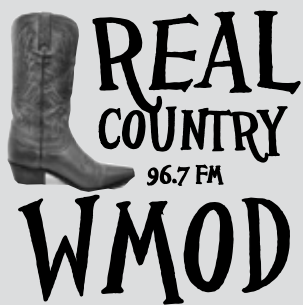

Earnhardt is a third-generation driver in the first-family of NASCAR racing. Race fans have selected him a record 14 consecutive times as NASCAR's Most Popular Driver. His appeal, however, is not limited to race fans, as Earnhardt has appeared on Harris Interactive's annual survey of America's Top 10 Favorite Athletes.

After 18 years behind the wheel, Earnhardt retired from full-time racing in 2017 with 26 career victories. He had qualified for the NASCAR play-offs eight times between 2004 and 2015.

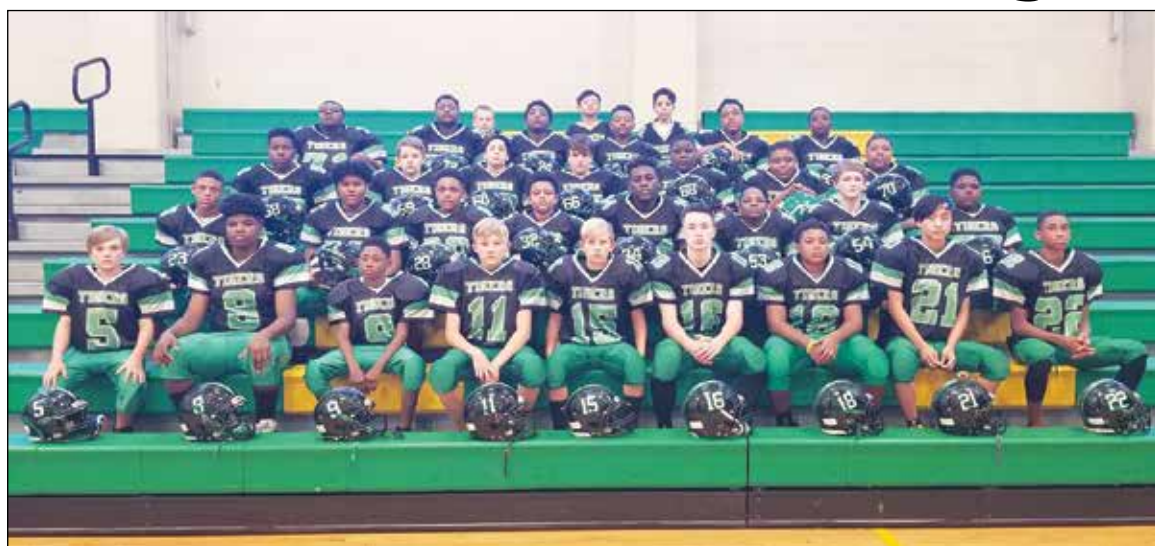
Bolivar (0-3, 0-1) will host Jackson North Side at home on September 13.

## Putting Your Garden to Bed by Carolyn Tomlin

As days grow shorter, nights grow longer. Temperature fall, frost lingers. A sudden freeze finishes the bright colored annuals that bloomed in your garden. Fresh vegetables are only a memory. Soon, snow covers the ground.

Don't let old-man winter catch you unprepared. You can close the growing season by "putting your garden to bed." Here are some tips for preparing your garden, protecting tender bulbs, and saving seeds for next year's blooms and food.

### MUCH ADO ABOUT MULCH.

For safeguarding plants, think "mulch"—loads of mulch. Often called "black gold" by gardeners, this is especially important for recent plantings. Hopefully, you saved summer grass clippings by piling them up and rotating with a turning fork weekly. If not, run your lawn mower over fallen leaves. Rake and cover plants with approximately 10-inches of mulch. Pine needles are another source. Leaves and grass clippings are nature's way of using resources nature provides.

**DIVIDE AND CONQUER.** Perennials—the mainstay of the garden, need attention before winter. Tidy the edge of borders, cut back plants, and remove old stems and leaves. As outdoor-flowering chrysanthemums, flocks and other perennials become dormant, lift root clumps and store in boxes of old soil in a frost-free place. Use these parent plants for new cuttings next spring.

**DIG IT UP.** What to do with those expensive bulbs that added splashes of color to your summer garden? Such as caladiums, elephant ears, and cannas? Now, we're talking stewardship! Instead of purchasing new bulbs or tubers next spring, bring them indoors. Plus, these bulbs have grown and are larger than when first planted. Before the ground freezes, cut stalks and carefully dig and lift bulbs. Clean and store in sand, peat or sphagnum moss in a frost-free, dark place—such as a basement. Check occasionally for signs of mold. Spray with an approved fungicide if needed.

**SAME PLACE—NEXT YEAR.** Remove leftover summer annuals from porch pots and yard. Pull up vegetables, such as vines, stalks, and other plants. Removing roots insures workable soil for next summer's garden. Run through a shredder for compost. Avoid composting any plants that are diseased or infested with insects. Instead, place in heavy-duty garbage bags and discard. Clean the area by raking to remove leaves and other debris that may harbor insect eggs or bacteria-causing disease.

**A PENNY SAVED.** Save flower seeds from any mature pods, such as marigolds, zinnias or impatiens. And if you've grown prize-winning vegetables, choose a selection of seeds from these specimens. Dry seeds by spreading seeds on newsprint and organize by varieties. A farmer's tip: Store in glass baby food jars in your refrigerator until time to start seeds indoors for next spring's garden.

Whether you're a serious or amateur gardener, both you and your plants will "sleep" better knowing their roots are protected and you're a good steward of the earth God provided.
