Five Votes Erase 500 Feet

Bolivar Mayor Julian McTizic broke a 4-all tie to allow beer to be served in restaurants in Bolivar, regardless of location, at the regularly scheduled meeting on Tuesday, September 11.

"I'm proud of the council people who stood firm against various pressures to pass this change," he said. "I'm anticipating the development in the entire city and in downtown. I commend them on the hard decision they made for business in our community."

Voting to eliminate the 500-foot space between restaurants that served beer and any church, school, or day care center were Melvin Golden, Todd Lowe, Suzanne Rhea, and Page Walley. With the vote deadlocked, Mayor McTizic clinched the passage with his vote.

Already in place and not part of the debate was the ability of bona fide restaurants to have liquor and wine both inside and outside of the 500-foot space. Beer was the only issue at hand.

Prior to the vote, a public hearing was held to allow the citizens to speak.

"I understand this is a serious and difficult decision," said Matt Boatwright. "But I do not want you to pass this. I don't want us to build our city on the backs of people who abuse alcohol. Not everyone struggles, I understand. But we have an opportunity to stand another way."

In August, the council voted 4-3 on the first reading to allow the measure to go to the second phase. With Todd Lowe absent from that meeting, Tracy Byrum was the fourth vote, but voted against it on the final reading along with Tommy Woods, Larry McKinnie, and Jonathan Joy.

After the passage on the first reading, the membership of First Baptist Church in Bolivar passed a resolution asking for the council to keep the 500-foot barrier, touching on issues such as "impressionable children and youth," a "disruption to the daily ministry in God's places of

worship," and the condemnation in "the Word of God" against "strong drink," to name a few of the points that were approved and sent to each city council member.

Pastor John Jicka of First Baptist also spoke at the meeting, asking for a "no" vote and a group to be formed to work out a compromise.

"Make this decision because you love the Lord," he asked. "We treasure our refuge. Please don't take it away. Most pastors don't want this. Let's start over."

Councilman Joy challenged Jicka on the compromise issue, stating that a meeting was held with pastors with no tangible results.

Restaurants who serve alcohol in any form are still required to have more than 60% of their business come from food, not alcohol.

Earlier in the evening, the Bolivar Downtown Development Corporation voted unanimously to support Bolivar's efforts to change the ordinance.

Historical Treasure Goes Up for Auction by Ken Savage

One of Bolivar's hidden jewels, The Gardens, lies at 212 West Sycamore Street and will be up for public auction on September 22. Lynn Jackson Auctions and Real Estate will offer the 3000+ square foot home and many other items connected with the house beginning at 10:00 a.m.

The home is just a couple of blocks from the Hardeman County Courthouse, yet it sits secluded on 5 1/4 wooded acres of land.

The Gardens was designed and built by noted architect and builder, Fletcher Sloan. Fletcher Sloan and half brother Samuel Sloan (also a famous Philadelphia architect) came to Bolivar before the Civil War. They both had designed The McNeal Place in Bolivar. Fletcher Sloan then designed St. James Episcopal Church, and after the war, designed many of the buildings and houses in this area including this Swiss Chalet style home, The Gardens in 1871. The home was considered to be several years ahead of its time in design. Fletcher Sloan also designed many southern churches and courthouses including the ones in Bolivar, Tennessee, Holly Springs and Oxford, Mississippi.

The Gardens was originally built for noted Bolivar attorney, Frank Fentress and his family. Woodson J. Savage, Sr., Bolivar merchant was the second owner of the home in 1914. In 1924, Mr. Savage purchased the old iron fence that was erected around the Hardeman Courthouse in 1870. He installed the fence around the large park like grounds that surrounds the home. Susan Bradley Young and her family became the third owners of this home and property in 1971. Then in about 1976, Patricia Vincent bought the home and lived there until her recent passing.

City of Bolivar Donates Tech to Bolivar Elementary



As a part of their 2018-2019 budget, City of Bolivar Mayor Julian McTizic and the City Council partnered with Bolivar Elementary to provide a Chromebook Cart. The cart includes 25 Chromebooks and includes a cart that stores and charges the devices. The Chromebook Cart will be housed in the library and used across multiple classrooms, Principal James Rutherford said, "We are very excited that Mayor McTizic and his team chose this idea to help our students and school. There are so many things that third graders will be able to use this technology to do. Our students are already excited and using the Chromebooks every day." The donation of the Chromebook Carts supplements the Hardeman County Schools technology plan and specifically focuses on 3rd graders across the district. The Chromebooks are small, basic laptops that connect to the Internet using Google's Chrome operating system.

With a Chromebook, students can tap into the power of the Internet—and because the devices include keyboards, students build essential keyboarding skills, required by many state standards, as they research, collaborate, learn, and create. School Board Chairman Bobby Henderson worked with Mayor McTizic during the spring to develop this idea. Henderson noted that, "Mayor McTizic was on board and very receptive to helping our schools do more with technology."

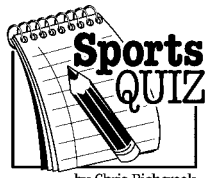

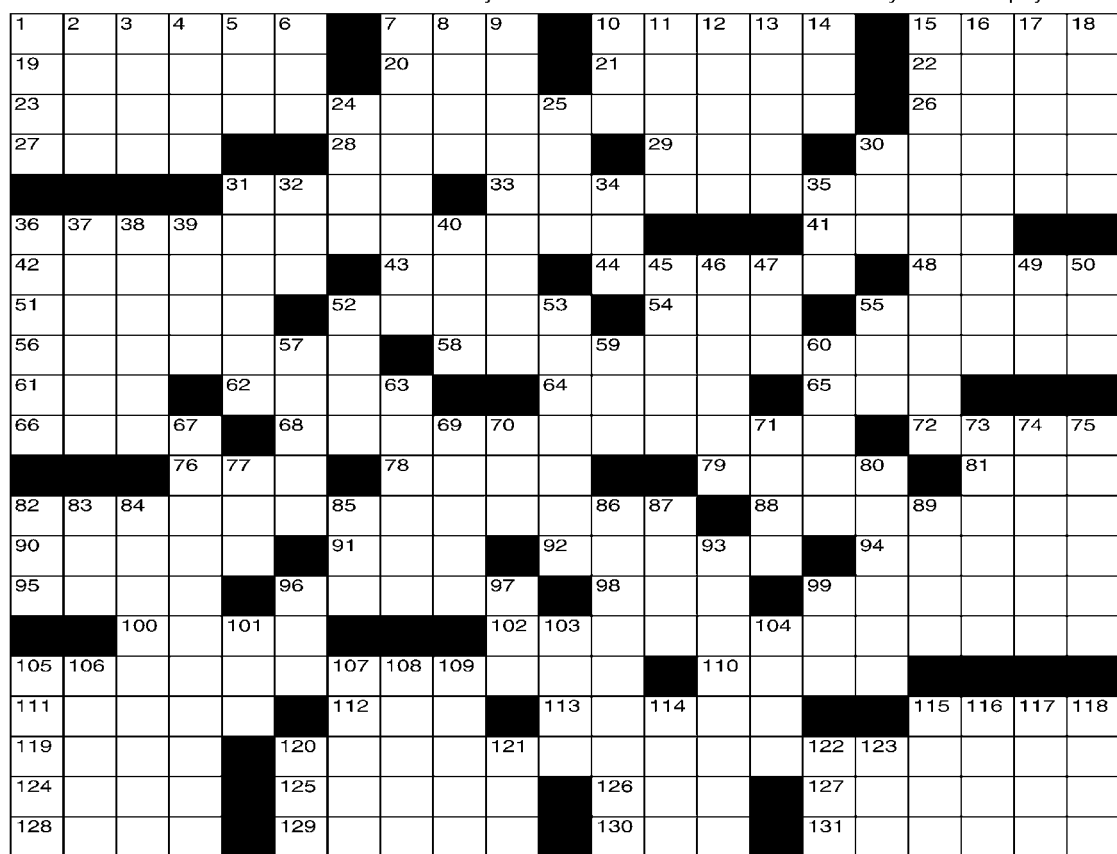

Breakfast Egg Cups

Ingredients

- 1 can cooking spray
- 6 large egg
- 1/4 cup milk
- 1/8 teaspoon salt
- 1/8 teaspoon black pepper, ground
- 1 medium bell pepper, red
- 3/4 cup spinach
- 1-ounce cheddar cheese

Directions

Spray a muffin tin with cooking spray and set aside. Preheat oven to 375°F. Whisk the eggs and milk together in a bowl. Season with salt and pepper. Dice the bell pepper into small pieces. Stack the spinach leaves, roll them up, and slice them thin. (This method is called chiffonade.) Add the peppers, spinach, and shredded cheddar to the egg mixture. Fill muffin cups 3/4 full and bake for 20-25 minutes until centers are set and no longer runny. Allow to cool slightly before serving.

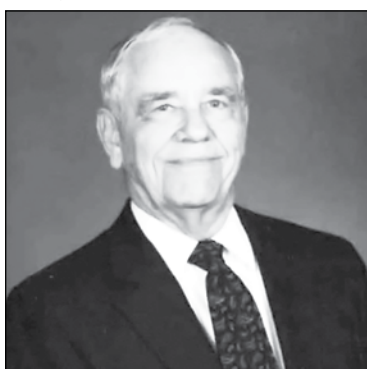

Sunrise: Shared Pain by David Coy

Think too of all who suffer as if you shared their pain (Hebrews 13:3 J.B. Phillips). This is how we would describe the idea of supporting our family, friends and neighbors as they struggle with loss in their life as they learn to cope with the way their life is now. Someone once well said that we should not get so caught up in what we wish our life was or would be, that we lose sight of the blessings that are right in front of us and all around. When we are in the midst of our journey with grief, we sometimes may lose focus on how blessed we are because we are fully engrossed and overwhelmed in our sorrow. I remember a previous client who felt so forlorn at the loss of their soul mate, they lost focus of all the family members who depended upon them and as a result were a support as they learned to cope with their new reality.

The beauty of the above passage is the emphasis is a two-fold development of showing brotherly love (Greek, philadelphia) which has been translated variously as fraternal affection, love of brothers and sisters, or brotherly kindness. First, because we also are vulnerable and we equally could have been in the other's position of sorrow. Second, because we want to treat others in the same

Amos: A Prophet for Us - Part 1 by Jeff Capshaw

A few weeks ago, I had occasion to give a talk from the Prophet Amos in the Old Testament. So, in the light of that and due to the ongoing socio-political foment in our nation, Amos seems like both a fertile and relevant source for us here.

Before diving into the text of Amos, however, I will take 2 or 3 weeks to lay some necessary ground work, hopefully enabling us better to understand his text. This week I will allay some common misconceptions about the nature of Scripture itself. Next, I will take space to discuss Amos the man, the literary structure of his book and the historical background of his times. Then the balance of the articles will discuss some key and relevant themes from Amos: a prophet for us today.

First, it is crucial for us to

take a step back and ask a basic question. What is the nature of Scripture? Yes; it purports to be the very Word of God, and surely Orthodox Christians take that claim most seriously. But what else?

Some read the Bible as though it were primarily an encyclopedia: an ultimate authority on everything from "soup to nuts." Others read the Bible as though it were a modern textbook on Cosmology, Geography, World History, Mathematics, Physics, Psychology, Sociology and so on. It is not! Loosely, the Bible is a religious book. It is a book structured around the motif of God's making a Covenant with his people: first with Ancient Israel and then with the Messiah and His Church.

Additionally, the overarching narrative of the Bible is structured

in a 3-fold way: Creation, Fall and Redemption. Seen this way, one may more competently read Scripture as it was designed. It is an extraordinarily well-told story with a distinctive Beginning-Middle-End. Another helpful, big picture idea is the overall message of the Bible; namely, that *God is Building a Kingdom of Redeemed People for His Glory*. It is hard to stress the importance of the two above paragraphs. If we always keep these simple clues in mind, they will save us from coming to grief and bewilderment later.

Finally, the Bible is comprised of three constituent parts. It is a work of Ancient Literature, selective, Ancient History and Biblical Theology: nothing more and nothing less. Next week, in fuller preparation for our study in Amos, we will explore what those three aspects of Scripture entail.

For a variety of reasons the gospel of Jesus Christ contains good news for all of mankind! In fact, the Greek word euangelion, from which the word gospel comes from, literally means "good news" or "good message." The message of the gospel contains not only the divine love of God demonstrated, but also provides the answers to man's greatest needs! The gospel has: (1) Facts to be believed (1 Cor. 15:1-4), (2) Commands to obey (Rom. 6:17-18; 2 Thess. 1:7-9), and (3) Promises to be enjoyed (Acts 2:38; Col. 1:5).

(1) The Gospel is God's Means of Saving Mankind.

God did not want man to be lost in sin and be punished—so He sent His only Son to die on a Roman cross, as a sacrifice for our sins (Isa. 53:4-12). And right before Jesus left to go back to the Father, He gave His disciples the mission to preach the good news of salvation made possible through His blood. Mark 16:15-16 records, "And He said to them, 'Go into all the world and preach the gospel to all creation.' 'He who has believed and has been baptized shall be saved; but he who has disbelieved shall be condemned.'" You see, Jesus had to die to be the offering and shed His blood on our behalf (1 Peter 1:18-19; Hebrews 9:12-14)—But that is what the facts of the gospel message center upon. The response of man to the message is all-important in determining whether we are saved or lost. The wrong response is to disbelieve and disobey God's message of love for mankind. It is the very reason Paul felt an extreme obligation to preach the gospel to all who would listen to him. Paul said, "I am under obligation both to Greeks and to barbarians, both to the wise and to the foolish. So, for my part, I am eager to preach the gospel to you also who are in Rome. For I am not ashamed of the gospel, for it is the power of God for salvation to everyone who believes, to the Jew first and also to the Greek. For in it the righteousness of God is revealed from faith to faith; as it is written, 'But the righteous man shall live by faith.'" (Romans 1:14-17) God placed the power of salvation in believing and obeying the gospel. It is God's way of making men righteous before him as we live by faith. The good news is that God provided a way—when man had no way to save himself by himself! But the fact that Christ died on a cross saves no one without the response that the gospel requires of obedience (Hebrews 5:9). Obeying the gospel begins with faith (Rom. 10:17), continues on to repentance (Acts 17:30), gladly confesses Christ (Rom. 10:10) and is concluded in Baptism (Acts 2:38) to receive the forgiveness of sins that can only come from God.

Can You Benefit From an Annuity?

Retirement isn't cheap. You may have heard that you will need 70 percent to 80 percent of your pre-retirement income, but the real figure might even be higher, depending on your circumstances. And retirement isn't short, either - you could spend two or three decades as a retiree. Taken together, these factors highlight the need to identify as many sources of retirement income as possible - and one of these sources might be an annuity.

A fixed annuity is an insurance product that allows you to make a lump-sum investment and can provide insured payments to you for a designated number of years, or for life. A fixed annuity guarantees a rate of interest for a stated period that will be unaffected by market fluctuations. Your principal investment and the specified interest rate are guaranteed based on the claims-paying ability of the issuing company.

A fixed annuity offers some key benefits, including the following:

No contribution limit - No IRS contribution limits apply to non-qualified annuities - that is, annuities held outside a tax-advantaged retirement plan, such as a defined benefit pension plan, Section 403(b) plan (TSA) or an IRA. This can be especially valuable if you are already close to retirement age and think you might be short on savings.

Tax deferred accumulation - The interest you earn is tax deferred and will compound annually, meaning your money may accumulate faster than it would if it were placed in a taxable investment. Earnings will be taxed at your ordinary income rate once you start taking withdrawals, and withdrawals prior to age 59-1/2 may be subject to a 10% federal tax penalty. (You will want to consult with your tax advisor before withdrawing from your annuity.)

Income for life - You can take your annuity payout as a lump sum or choose to receive payments for a set number of years, or for the rest of your life. Your income amount will be determined by the value in your contract and your life expectancy.

Death benefit - If your annuity is still in the "accumulation" phase at the time of your death (meaning you haven't yet begun collecting payments), it might provide a death benefit to the beneficiary you've named. Typically, this lump sum will be the greater of your account balance or the total of all premiums paid, although some annuities provide additional options. Be aware, though, that the death benefit may be taxable.

As is the case with all investments, a fixed annuity does have some caveats. Most important, an annuity is a long-term investment - if you pull money out within the first several years after your purchase, you likely will face some prohibitive surrender charges. These charges decline each year, typically reaching zero after seven years. Such withdrawals also may be subject to a market value adjustment.

One more thing to keep in mind: Different annuities come with different fees, and the higher the fee, the lower your "real" return will be. Consequently, you will want to compare fees before investing.

If a fixed annuity is appropriate for your situation, you may find it can join your other income pools - Social Security, 401(k), IRA, etc. - to provide you with the resources you need to enjoy the retirement lifestyle you've envisioned.

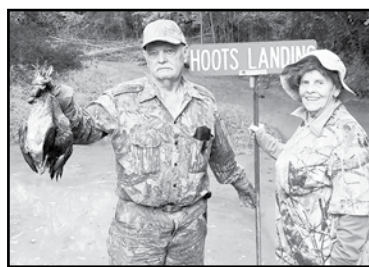

Whiteville Gets Grant for City Park

The Town of Whiteville will receive \$75,520 to create an eight foot wide ADA-compliant trail that circles the exterior of the city park and will connect to an existing restroom and picnic area as part of almost \$1.5 million in grants from the Tennessee Department of Environment and Conservation.

"I am pleased to welcome these funds into communities," said Senator Gresham. "Parks and recreation activities and facilities help bring communities together, encourage healthy activity, and provide many other great services to families and individuals in our communities."

"I appreciate the work of local officials in securing these funds and look forward to seeing the many improvements that will result from these investments," added Gresham.

A Little More Money in Our Pockets

Tennesseans took home a little more money in their paychecks last year according to the latest data released today by the Tennessee Department of Labor and Workforce Development (TDLWD).

The median wage earned for all Tennessee occupations increased by 3.16 percent between May 2016 and May 2017 to \$33,870.

"It's always a positive to see wages increase, by any amount," said TDLWD Commissioner Burns Phillips. "The state's economy is thriving and more money in a person's paycheck is going to help that continue."

The largest occupational groups in the state were office and administrative, sales and related, food preparation and serving, transportation and material moving, healthcare practitioners and healthcare support, and production occupations.

Healthcare practitioners and technical occupations employed 193,000 workers, while healthcare support occupations had employment of 75,000 workers. Both groups combined made up nearly 9.2 percent of Tennessee's jobs, which is greater than the national average of 9.0 percent. Annual median wages for healthcare practitioners and technical occupations, the largest of the two healthcare occupations groups, varied within the state from \$60,200 in Memphis, to \$46,360 in Morristown.

Assemblers and fabricators led the production occupations group in Tennessee.

Tales from the Yellow House by Lee McAlpin

Occasionally, on a hot lazy summer day at the Yellow House, if Mom could scrape up 35 cents from our continually strained budget, she would send me and brother Don down the railroad tracks to Mr. Emmett Shea's store. Our trip was to purchase seven delicious RC Colas at five cents each. One for each member of our family. The reason that we bought the RC's was that they were somewhat larger than the other colas. This was a treat that we did not get too often. The bottles were cold when we left the store, but were luke warm by the time we got back home. I was very careful in opening mine, fearing that it would spew out and I would lose a precious drop of the soda. I would sip my RC slowly in order to make it last as long as I could.

At Mr. Shea's store, you could buy anything from a horse collar to a stick of Cuttyhunk Blueing (used to whiten clothes in rinsing water). When you entered the confines of the store, you were bombarded with a potpourri of smells, a mixture of medicine, candy, fertilizer and such. Some odors made you hungry, some made you sneeze, and some made you wonder just where they came from. Mr. Shea would trade groceries and items from his store for chickens and eggs. He had several chicken coops outside in the back of his store where he kept the chickens. Most of the stores in Pochahontas would sell wares on credit to their customers. I would spend a lot of time in front of the candy and cookie section. Just looking of course. Most of the time, I was so broke that I could not buy enough cloth to make a flea a tuxedo. During cotton hoeing and picking season, I could spare a nickel or dime out of my earnings for a treat. There were big lemon cookies, two for a penny. That was one of my purchases when I had a few cents. Another one was little individually wrapped blocks of candy that we called kisses. They cost



one penny and were six to a pack. A rare treat was an RC cola into which you dumped a package of Planters peanuts. Now, that was a feast. I still like to do this, but I cannot find an RC anywhere. There were little round cardboard tubes of peanuts, some of them would have a penny, nickel or dime inside. And Fleers Double Bubble was a penny a chew. That was one of my favorites because it would last such a long time, plus each block would contain a comic strip, and with Fleers, you could blow a bubble that when it burst, it would cover your whole face. Also you could stretch it a couple of feet from your mouth. That brings me to the time Larry Brinkley and myself wrote a song called Double Bubble which Larry recorded on the Magic Record label. The Fleer Double Bubble Company flew Larry and me to Philadelphia to do a show at their company picnic where we performed the song. While visiting their facilities, they showed us a block of bubble gum that weighed one ton. A lot of chews there. They also shipped us boxes and boxes of bubble gum to help promote the song. My jaws were worn out for about a year from chewing bubble gum. While at the company, they took us into New York City where we performed at the Golden Key Gaslight Club on Fifth Avenue. Every time I chew a piece of gum, memories come calling; starting from the Yellow House to New York City and

points in between. What would we do without memories?
