## Let's Talk About COVID-19

Hardeman County continues to lead the state in testing for counties with more than 25,000 people, but the percentage of positive cases and deaths lead the bordering counties in West Tennessee as well.

Through stats obtained from tn.gov's COVID-19 dashboard through August 31, Hardeman County is the highest in testing at 49.5%, the highest in percentage of the population who have tested positive, and has the highest percentage of their population who have deaths linked to the pandemic.

The State of Tennessee reports they have tested 33% of their population, which is equal to Fayette, but ahead of all other surrounding counties except for Hardeman County. According to politico.com, Tennessee is 10th in the nation in the amount of tests conducted.

Of the five counties that border Hardeman, the least amount of testing has been in McNairy County at 22%. Not

surprisingly, McNairy is also the lowest in percentage of positive cases among the overall population (those tested and those not tested) at 2.1%.

Madison is next in the least amount of testing at 23%, followed by Chester at 25%, Haywood at 31%, and Fayette at 33%.

In finding positive cases, Hardeman County has had 4.9% of their overall population test positive, following by Haywood at 4% and Fayette, Madison, Chester, and

McNairy all come in around 2%, roughly equal to the percentage of positive cases reported by the State of Tennessee.

Five of the six counties in the study have percentage of population's deaths linked to COVID-19 higher than the State of Tennessee, with only Fayette County equal to the state percentage, at .02%. Hardeman County has the highest percentage of deaths linked to the virus at .08%.

Masks have not been mandated in any bordering counties, except Madison County.

Hardeman County Schools reacted to the high numbers of positive cases this past week, announcing they will continue the AB schedule until further notice. See A8.

The Hardeman County Community Health Center also announced this week that free COVID-19 testing is available at their locations in Bolivar, Henderson, and Stanton.

Tennessee Small Business Development Center in Jackson. The office is funded by Jackson State Community College and the U.S. Small Business Administration and housed at the Jackson Chamber.

Through virtual online meetings, the couple worked with Brad Young, a small business consultant at the center, as they went through the steps of getting a business plan, financing, permitting, equipment and other things necessary to start a business. "We really appreciated the help and enjoyed working with them," Falls said.

"They have worked so hard over the last six weeks to get this together," said Monique Merriweather, director of the small business center. "They followed instructions and simply went to work and did what it took to realize their dream."

When zoning became an issue with the first location they chose for the restaurant, the Fallses found a second location in Bolivar's historical district, Merriweather said. "They remained level-headed and determined to start their restaurant."

Besides buying as much of their food locally as possible, the couple plans to give back to the community in another way. "A percentage of all of our sales will be donated to Communities in Schools, a local nonprofit that works with families in need to help children succeed," Jeannie said.

Cornell, who works in manufacturing, was born and raised in Hardeman County. Jeannie is pursuing an associate degree in general studies at Jackson State with a goal of becoming a registered nurse. They have two children.

People can order and pay for their food online. Those coming to the restaurant will order at the counter and can watch their food be prepared. They can opt for carryout or eat at the restaurant.

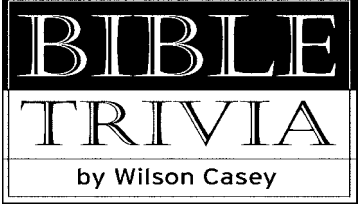

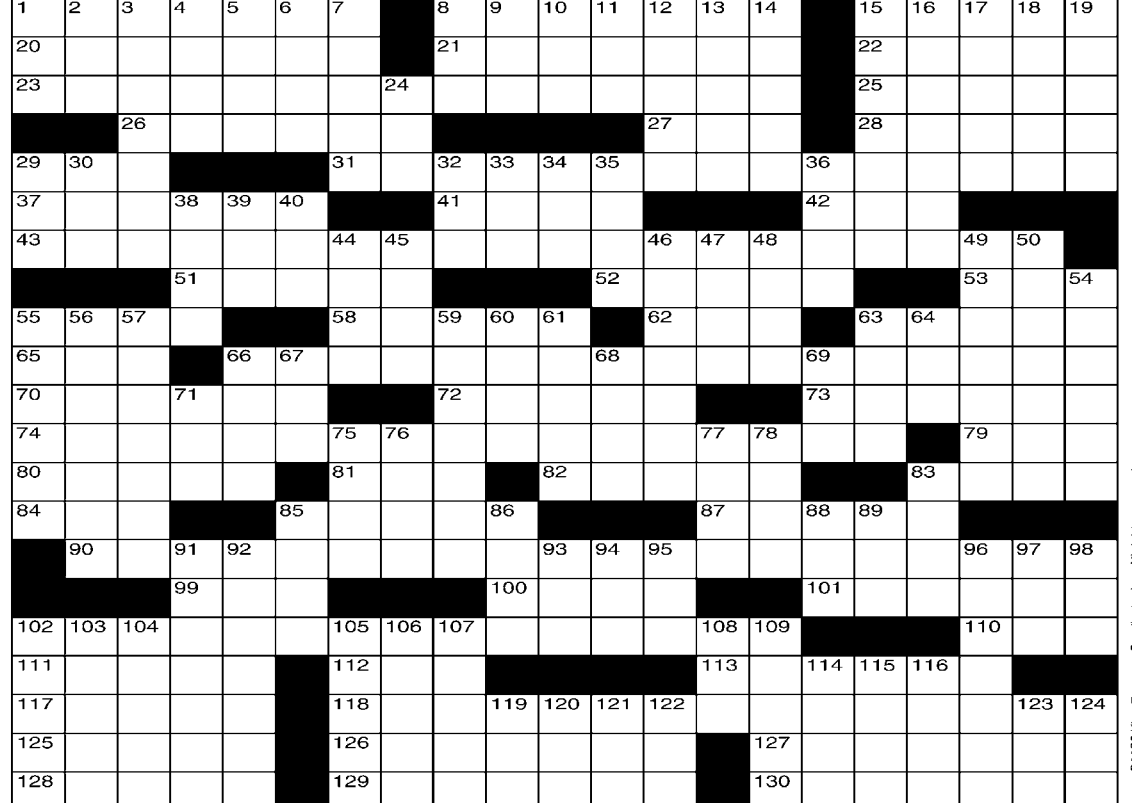

## Sausage Crescent Rolls

- Ingredients**  
 1 pound fresh, ground spicy pork sausage  
 1 (8 ounce) package cream cheese  
 2 (8 ounce) packages refrigerated crescent rolls  
 1 egg white, lightly beaten  
 1 tablespoon poppy seeds

**Directions**  
 Step 1: Preheat oven to 350 degrees F (175 degrees C).  
 Step 2: In a medium skillet, lightly brown sausage and drain. While sausage is still hot, add cream cheese and stir until cheese is melted and mixture is creamy. Cool completely.  
 Step 3: Separate crescent rolls and arrange into two rectangles. Form log of sausage mixture lengthwise down center of each rectangle. Fold over the long sides of pastry to cover sausage log. Place on ungreased cookie sheet, seam down. Brush with egg white and sprinkle with poppy seeds.  
 Step 4: Bake 20 minutes until crust is golden.

Linda Sue King Bishop, age 65, of Bolivar, passed from this life at her sister's home near Toone on Friday morning, August 28, 2020.

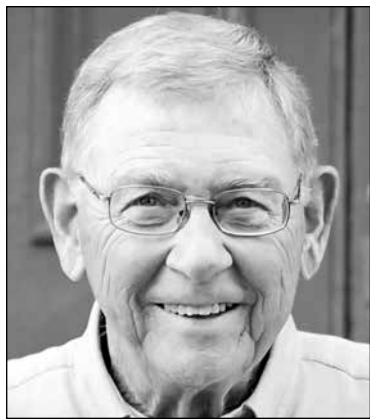

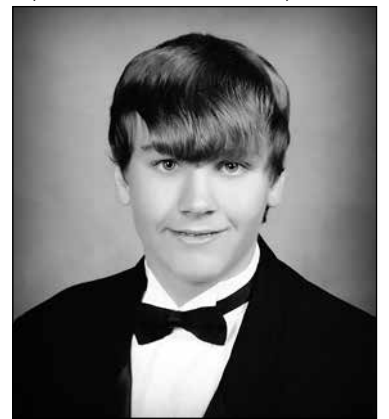

## More on Wisdom

The last few articles centered upon wisdom. After all, in these crazy times, who doesn't need it? Everyone needs thinking skills, as well as the skill to know what action to take in a particular situation. That's what the biblical notion is; it is skillful thinking and behavior.

The best illustration of "wisdom-as-skill" comes from the Old Testament. When Solomon was preparing to build the temple of the Lord he said, "So now send me a man skilled to work in gold, silver, bronze, and iron, and in purple, crimson, and blue fabrics, trained also in engraving, to be with the skilled workers who are with me in Judah and Jerusalem, whom David my father provided" (2 Chronicles 2:7). The word used for "skilled" to work, and "skilled" workers in the above text is the same word as wisdom in the Old Testament.

The Old Testament is the primary, literary source for wisdom in the Judeo-Christian tradition. Further, there is a collection of books in it known as the Wisdom Books. They are Job, Psalms, Proverbs, Ecclesiastes, and the Song of Solomon. So,

for this and a few forthcoming lessons, selected texts from the book of Proverbs' teaching about wisdom will be the focus.

It is important to know that all of the Old Testament Wisdom books are written in ancient Hebrew poetry. However, it doesn't work like English poetry. There are many features to it, but its primary hallmark is a kind of rhyming in thought and not in sound like many English poems do. Simply put, Hebrew poetry uses a device called parallelism. Without going too far afield here, it's a poetry that often says the same thing in different ways or uses parallelism to highlight a particular meaning.

The first passage briefly to consider is found in Proverbs 1. It's a poetic introduction informing the reader of the Proverbs' purposes. It says, "the proverbs of Solomon, son of David, king of Israel: to know wisdom and instruction, to understand words of insight, to receive instruction in wise dealing, in righteousness, justice, and equity; To give prudence to the simple knowledge and discretion to the youth—Let the wise hear and increase in learning, and the one who understands

obtain guidance, to understand a proverb and a saying, the words of the wise and their riddles" (vv. 1-6).

The Old Testament often uses different words and phrases within the same neighborhood of meaning. This is certainly true of Wisdom Books. Just about every phrase in the above passage is in the domain of skillful thinking and/or behavior. Although "righteousness, justice, and equity" may seem far afield, surely a person who practices these isn't a fool: the opposite of wise.

Notice also the concepts of "insight, instruction, knowledge, and discretion." All these all within the purview of being skillful in thought and/or deed. So, do you consider yourself wise? If so, then following the primary exhortation in the passage; listen to Proverbs and increase your skill.

## Jones Named to All-NMCC Decade Team

Former Middleton Basketball player Cherelle Jones was named among six outstanding scorers and rebounders to the Northeast Mississippi Community College's All-decade Team for its tradition-rich women's basketball program.

Student-athletes that competed for the Lady Tigers between the 2009-10 and 2018-19 seasons plus won Mississippi Association of Community Colleges Conference (MACCC) All-State Honors qualified for a spot on this prestigious lineup.

Players were chosen based upon the overall impact they made on their respective team plus statistical analysis. Consideration was also given to any significant accomplishments each student-athlete made after leaving Northeast.

A panel of six individuals, which included athletic department staff and members of the local media, participated in this process. The selections were made with no regards to specific positions.

Pieced together 13 double-doubles in 24 total games during her sophomore campaign...Had five-in-a-row to begin the year...Her 22 points against Snead State (Ala.) tied a career-high that she set during the Lady Tigers' season opener versus Wallace State-Hanceville (Ala.)...Grabbed a career-best 20 boards in a triumph at Holmes on February 14, 2019...Won two consecutive MACCC Player of the Week awards...Tallied 10.4 points and 9.4 rebounds per contest...Notched season-best 17 points twice in triumphs at Arkansas Baptist and Coahoma...Jones is currently on the active basketball roster at Jackson State.

### Tigers Fall in a Heartbreaker

Looks were deceiving on Friday night at R.A. Butler Field in Bolivar as the Tigers (0-2) suffered a heartbreaking 20-14 loss to Scotts Hill.

With 2:15 left in the ballgame, it looked pretty good.

The Tigers, who led 14-12, had the ball on the Scotts Hill 36-yard line facing a third and eight. Even a failed attempt at a first down would give them an opportunity to pin the Lions deep in their own territory.

Then came a false start. Then another. And still one more, putting the Tigers back in their own territory with a third and 23.

Still, it looked pretty good. Even a failed attempt at a first down would give Bolivar a chance to make the Lions drive most of the field if they were to have a chance.

And then all of a sudden, it didn't look so good. A sweep to the left saw the ball stripped from Cuaron Price and head toward the Scotts Hill end zone, where it was recovered at the 23-yard line.

Scotts Hill scored on the next play and converted the two-point try to lead 20-14.

But we still had a chance. A celebration penalty had Scotts Hill back at their own 25 to kick off.

And when they tried to squib it, it was caught by Bolivar at the 38 yard line.

We still had a chance. But four passes later, including one dropped at the goal line, it was over.

The Tigers fell behind early in the contest as Scotts Hill took the



opening drive the length of the field, scoring with 9:55 left in first quarter.

Bolivar scored with 9:38 left in the second quarter, as Rice threw a 17-yard pass to Jar'quavious Poplar to tie the score at six, where it remained until halftime.

Bolivar then took the second half kickoff and took nine minutes and 15 seconds, with Rice throwing again to Poplar for a score to make it 14-6. Scotts Hill countered with a score with 9:56 remaining, and the score stood at 14-12 until the final moments of the contest. Bolivar totaled 198 yards on the night, 106 of them in

the air. Bolivar Head Coach Montrell Craft felt his team fought better, but didn't get the job done in other areas.

"The effort was better. But it's effort and discipline. They fought to the end, but we needed to execute better," he said.

The Tigers lost three fumbles on the night compared to only one turnover for Scotts Hill. The Tigers season turnover ratio is minus six.

## Bolivar Middle Hosts Tennessee State Museum Exhibit

Bolivar Middle School presented To Make Our Voices Heard: Tennessee Women's Fight for the Vote, a new traveling exhibition, on display from August 19-31. The exhibition, created in partnership with the Tennessee State Museum and the Tennessee State Library and Archives, explores the history of the woman's suffrage movement, Tennessee's dramatic vote to ratify the 19th Amendment in 1920, and the years that followed.

"As a member of our local Hatchie Chapter of the DAR, I presented a program on the role Tennessee played in the Suffrage Movement at our last chapter meeting. I am thrilled to be able to show the students in Hardeman County this Exhibition. We will create a virtual tour for all the schools in the county, as well as display the exhibition here at Bolivar Middle School," explained Deana Sain, Library Media Specialist. All students went through the exhibit with their respective social studies teacher: Mr. Lowe, Mr. Steinsultz, or Mr. Stone. Mr. Stone also did a presentation for Amber Moore, Hardeman County Election Commission Administrator, and Sheila Dellinger, Bolivar City Administrator.

The exhibition is constructed of multiple dynamic panels, offering guests a touch-free experience of archival images, engaging stories and introductions to the leaders of the fight for and against the cause of woman's suffrage. The stories begin by detailing the early challenges of racial and gender discrimination and continuing to the organization of African American and white women's associations to encourage political engagement.

Visitors also learned about Febb Burn of

McMinn County, whose letter to her son, Harry T. Burn, resulted in a last-minute vote that helped change women's history in the United States forever.

The exhibit included a Tennessee map, highlighting suffragist activities across the state.

"Tennessee's role in becoming the 36th and final state to ratify the 19th Amendment not only solidified women's right to vote but propelled women across the country to opportunities and futures they never thought possible," said Chuck Sherrill, State Librarian and Archivist with the Tennessee State Library & Archives. "The hope of the committee is this centennial celebration will do the same all across our state."

In coordination with this traveling exhibit, the Tennessee State Museum in Nashville will soon open Ratified! Tennessee Women and the Right to Vote, an extensive 8,000 square foot exhibition exploring the Women's Suffrage movement in Tennessee through archival images and documents, artifacts, films, interactive elements, and programming.

An online component of the exhibition, Ratified! Statewide! highlighting the suffrage movement in every Tennessee county is available now at tnmuseum.org.

"As we commemorate the historic vote that took place at Tennessee's State Capitol in August of 1920, we want to honor those individuals who played key roles in the journey to gain voting rights for women," said Ashley Howell, Executive Director of the Tennessee State Museum. "We are thrilled to have the opportunity to share these stories across the state."

## Health Department Reports Scam Attempt

The Hardeman County Health Department has been notified of a potential scam in which people are contacted by telephone by someone asking for personal information.

The scam involves calls to potential victims from a number that displays as the Hardeman County Health Department. The caller asks potential victims for information including their Social Security number.

The health department does not contact people phone messages to request personal information such as health insurance information or Social Security numbers, and warns everyone not to share any personal information in this manner. Patients who have made appointments for services at a local health department may receive an automated call to remind them of their appointment, but these calls will not ask for insurance information or other personal details. Health department representatives do not contact people who are not patients to request such information.

The Hardeman County Health Department has notified law enforcement about this matter. Anyone with questions or concerns about an unauthorized release of or request for health insurance or other personal information should contact his or her local law enforcement agency.


The Tennessee Department of Commerce & Insurance's Division of Consumer Affairs reminds consumers to never give personal information such as name, address, Social Security number, credit card information or medical information to a stranger over the phone. Consumers who believe they have been the victim of a scam are urged to report what happened to federal or state agencies.
